8 COMMITTEE SUBSTITUTE

9 An Act relating to state government; amending 74 O.S.
10 2021, Section 291.2, which relates to the Board on
11 Legislative Compensation; specifying ex-officio
12 members; providing for Executive Director of the
13 Legislative Office of Fiscal Transparency to provide
14 certain services; providing an effective date; and
15 declaring an emergency.

16 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

17 SECTION 1. AMENDATORY 74 O.S. 2021, Section 291.2, is
18 amended to read as follows:

19 Section 291.2 A. The Board on Legislative Compensation created
20 by Section 21 of Article V of the Oklahoma Constitution shall meet
21 on the third Tuesday of October in every odd-numbered year at nine
22 o'clock a.m. in the State Capitol Building, at which meeting the
23 Board shall review the compensation paid to members of the State
24 Legislature and, if necessary, change the compensation.

1 B. The Board may, at the call of its chairman or upon a
2 majority vote of its membership, hold such additional meetings as
3 are necessary to carry out its official duties.

4 C. Any change in legislative compensation shall be made by the
5 Board no later than the third Tuesday of November in said odd-
6 numbered year.

7 D. Five members of the Board shall constitute a quorum and a
8 majority vote of such quorum shall be necessary for the Board to
9 act. The appointed members of said Board shall serve terms which
10 run concurrently with the terms of the respective appointing
11 authorities and shall serve at their pleasure. The Director of the
12 Office of Management and Enterprise Services and the Chair of the
13 Oklahoma Tax Commission shall serve as ~~Secretary to the Board~~ ex-
14 officio members of the Board as required by Section 21 of Article V
15 of the Oklahoma Constitution.

16 E. The Executive Director of the Legislative Office of Fiscal
17 Transparency shall serve as secretary to the Board and provide staff
18 support to the Board.

19 F. The Board shall elect such other officers as they deem
20 needed from their membership.

21 G. No member of the Board shall be a lobbyist as required to be
22 registered pursuant to the Oklahoma Campaign Compliance and Ethical
23 Standards Act.

24 SECTION 2. This act shall become effective July 1, 2022.

1 SECTION 3. It being immediately necessary for the preservation
2 of the public peace, health or safety, an emergency is hereby
3 declared to exist, by reason whereof this act shall take effect and
4 be in full force from and after its passage and approval.
