BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

2 EDUCATION

SECTION 1. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2022, the sum of One Billion Four Hundred Seventy-one Million Three Hundred Eighty-four Thousand Two Hundred Seventy-one Dollars (\$1,471,384,271.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 2. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Education Reform Revolving Fund created in Section 34.89 of Title 62 of the Oklahoma Statutes, the sum of Eight Hundred Seventy-five Million Two Hundred Eighty-nine Thousand Six Hundred Thirty-one Dollars (\$875,289,631.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 3. The State Board of Education is hereby authorized to expend during the fiscal year ending June 30, 2022, from the Common Education Technology Revolving Fund of the State Treasury, the sum of Forty-seven Million Three Hundred Seventy-two Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 4. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the

Mineral Leasing Fund of the State Treasury for the fiscal year
ending June 30, 2022, the sum of Five Million Two Hundred Twentyfive Thousand Dollars (\$5,225,000.00) or so much thereof as may be
necessary for the financial support of public schools.

SECTION 5.
