the Education Reform Revolving Fund, the County  
Improvements for Roads and Bridges Fund, the  
Maintenance of State Buildings Revolving Fund, the  
State-Tribal Litigation Revolving Fund, the Oklahoma  
Quick Action Closing Fund, and The State Emergency  
Fund; stating amounts of the appropriations; stating  
purposes and restrictions; authorizing certain  
expenditures; and providing an effective date.

1 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

2 EDUCATION

3 SECTION 1. There is hereby appropriated to the State Board of  
4 Education from any monies not otherwise appropriated from the  
5 General Revenue Fund of the State Treasury for the fiscal year  
6 ending June 30, 2022, the sum of One Billion Four Hundred Seventy-  
7 one Million Three Hundred Eighty-four Thousand Two Hundred Seventy-  
8 one Dollars (\$1,471,384,271.00) or so much thereof as may be  
9 necessary for the financial support of public schools.

10 SECTION 2. There is hereby appropriated to the State Board of  
11 Education from any monies not otherwise appropriated from the  
12 Education Reform Revolving Fund created in Section 34.89 of Title 62  
13 of the Oklahoma Statutes, the sum of Eight Hundred Seventy-five  
14 Million Two Hundred Eighty-nine Thousand Six Hundred Thirty-one  
15 Dollars (\$875,289,631.00) or so much thereof as may be necessary for  
16 the financial support of public schools.

17 SECTION 3. The State Board of Education is hereby authorized to  
18 expend during the fiscal year ending June 30, 2022, from the Common  
19 Education Technology Revolving Fund of the State Treasury, the sum  
20 of Forty-seven Million Three Hundred Seventy-two Thousand Two  
21 Hundred Ninety-nine Dollars (\$47,372,299.00) or so much thereof as  
22 may be necessary for the financial support of public schools.

23 SECTION 4. There is hereby appropriated to the State Board of  
24 Education from any monies not otherwise appropriated from the

1 Mineral Leasing Fund of the State Treasury for the fiscal year  
2 ending June 30, 2022, the sum of Five Million Two Hundred Twenty-  
3 five Thousand Dollars (\$5,225,000.00) or so much thereof as may be  
4 necessary for the financial support of public schools.

5 SECTION 5. There is hereby appropriated to the State Board of  
6 Education from any monies not otherwise appropriated from the  
7 Mineral Leasing Fund of the State Treasury for the fiscal year  
8 ending June 30, 2020, the sum of Three Million Five Hundred Twenty-  
9 four Thousand Four Hundred Six Dollars (\$3,524,406.00) or so much  
10 thereof as may be necessary for the financial support of public  
11 schools.

12 SECTION 6. There is hereby appropriated to the State Board of  
13 Education from any monies not otherwise appropriated from the  
14 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
15 fiscal year ending June 30, 2022, the sum of Twenty-six Million  
16 Seventy-seven Thousand Five Hundred Dollars (\$26,077,500.00) or so  
17 much thereof as may be necessary for the financial support of public  
18 schools.

19 SECTION 7. There is hereby appropriated to the State Board of  
20 Education from any monies not otherwise appropriated from the  
21 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
22 fiscal year ending June 30, 2020, the sum of Eight Million Three  
23 Hundred Seventy-three Thousand Five Hundred Ninety-two Dollars

1 (\$8,373,592.00) or so much thereof as may be necessary for the  
2 financial support of public schools.

3 SECTION 8. There is hereby appropriated to the State Board of  
4 Education from any monies not otherwise appropriated from the  
5 General Revenue Fund of the State Treasury for the fiscal year  
6 ending June 30, 2022, the sum of One Hundred Eight Million Nine  
7 Hundred Nineteen Thousand Twenty-six Dollars (\$108,919,026.00) or so  
8 much thereof as may be necessary for the support of public schools  
9 activities.

10 SECTION 9. There is hereby appropriated to the State Board of  
11 Education from any monies not otherwise appropriated from the  
12 General Revenue Fund of the State Treasury for the fiscal year  
13 ending June 30, 2021, the sum of Sixty Million Dollars  
14 (\$60,000,000.00) or so much thereof as may be necessary for the  
15 purchase of textbooks and instructional materials.

16 SECTION 10. There is hereby appropriated to the State Board of  
17 Education from any monies not otherwise appropriated from the  
18 General Revenue Fund of the State Treasury for the fiscal year  
19 ending June 30, 2022, the sum of Three Hundred Forty-seven Million  
20 Eighty-one Thousand Six Hundred Forty-four Dollars (\$347,081,644.00)  
21 or so much thereof as may be necessary for the Certified Employee  
22 Health Benefit Allowance.

23 SECTION 11. There is hereby appropriated to the State Board of  
24 Education from any monies not otherwise appropriated from the

1 General Revenue Fund of the State Treasury for the fiscal year  
2 ending June 30, 2022, the sum of One Hundred Eighty-eight Million  
3 Four Hundred Fifty-five Thousand Three Hundred Seventy-seven Dollars  
4 (\$188,455,377.00) or so much thereof as may be necessary for the  
5 Support Personnel Health Benefit Allowance.

6 SECTION 12. There is hereby appropriated to the State Board of  
7 Education from any monies not otherwise appropriated from the  
8 General Revenue Fund of the State Treasury for the fiscal year  
9 ending June 30, 2022, the sum of Fifteen Million Twenty-seven  
10 Thousand Six Hundred Forty Dollars (\$15,027,640.00) or so much  
11 thereof as may be necessary for administrative and support functions  
12 of the State Department of Education.

13 SECTION 13. There is hereby appropriated to the State Board of  
14 Education from any monies not otherwise appropriated from the  
15 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
16 fiscal year ending June 30, 2022, the sum of Two Million Eight  
17 Hundred Ninety-seven Thousand Five Hundred Dollars (\$2,897,500.00)  
18 or so much thereof as may be necessary for transfer to the School  
19 Consolidation Assistance Fund.

20 SECTION 14. There is hereby appropriated to the State Board of  
21 Education from any monies not otherwise appropriated from the  
22 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
23 fiscal year ending June 30, 2020, the sum of Nine Hundred Thirty  
24 Thousand Three Hundred Ninety-nine Dollars (\$930,399.00) or so much

1 thereof as may be necessary for transfer to the School Consolidation  
2 Assistance Fund.

3 SECTION 15. There is hereby appropriated to the State Board of  
4 Education from any monies not otherwise appropriated from the  
5 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
6 fiscal year ending June 30, 2022, the sum of Two Million Eight  
7 Hundred Ninety-seven Thousand Five Hundred Dollars (\$2,897,500.00)  
8 or so much thereof as may be necessary for transfer to the Teachers'  
9 Retirement System Dedicated Revenue Revolving Fund.

10 SECTION 16. There is hereby appropriated to the State Board of  
11 Education from any monies not otherwise appropriated from the  
12 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
13 fiscal year ending June 30, 2020, the sum of Nine Hundred Thirty  
14 Thousand Three Hundred Ninety-nine Dollars (\$930,399.00) or so much  
15 thereof as may be necessary for transfer to the Teachers' Retirement  
16 System Dedicated Revenue Revolving Fund.

17 SECTION 17. There is hereby appropriated to the Oklahoma Arts  
18 Council from any monies not otherwise appropriated from the General  
19 Revenue Fund of the State Treasury for the fiscal year ending June  
20 30, 2022, the sum of Three Million Four Thousand Two Hundred Five  
21 Dollars (\$3,004,205.00) or so much thereof as may be necessary to  
22 perform the duties imposed upon the Oklahoma Arts Council by law.

23 SECTION 18. There is hereby appropriated to the State Board of  
24 Career and Technology Education from any monies not otherwise

1 appropriated from the General Revenue Fund of the State Treasury for  
2 the fiscal year ending June 30, 2022, the sum of One Hundred Thirty-  
3 four Million Six Hundred Forty-one Thousand Seven Hundred Twenty-  
4 three Dollars (\$134,641,723.00) or so much thereof as may be  
5 necessary to perform the duties imposed upon the State Board of  
6 Career and Technology Education by law.

7 SECTION 19. There is hereby appropriated to the State Board of  
8 Career and Technology Education from any monies not otherwise  
9 appropriated from the Oklahoma Education Lottery Trust Fund of the  
10 State Treasury for the fiscal year ending June 30, 2022, the sum of  
11 Three Million One Hundred Eighty-seven Thousand Two Hundred Fifty  
12 Dollars (\$3,187,250.00) pursuant to paragraph 2 of subsection F of  
13 Section 713 of Title 3A of the Oklahoma Statutes for allocation by  
14 the State Board of Career and Technology Education for the education  
15 and general operating budgets of the institutions and for other  
16 programs, construction, renovations or repairs administered by the  
17 State Board of Career and Technology Education.

18 SECTION 20. There is hereby appropriated to the State Board of  
19 Career and Technology Education from any monies not otherwise  
20 appropriated from the Oklahoma Education Lottery Trust Fund of the  
21 State Treasury for the fiscal year ending June 30, 2020, the sum of  
22 One Million Twenty-three Thousand Four Hundred Thirty-nine Dollars  
23 (\$1,023,439.00) pursuant to paragraph 2 of subsection F of Section  
24 713 of Title 3A of the Oklahoma Statutes for allocation by the State



1 Board of Career and Technology Education for the education and  
2 general operating budgets of the institutions and for other  
3 programs, construction, renovations or repairs administered by the  
4 State Board of Career and Technology Education.

5 SECTION 21. There is hereby appropriated to the Office of  
6 Educational Quality and Accountability from any monies not otherwise  
7 appropriated from the General Revenue Fund of the State Treasury for  
8 the fiscal year ending June 30, 2022, the sum of One Million Sixty-  
9 seven Thousand Two Hundred Nine Dollars (\$1,067,209.00) or so much  
10 thereof as may be necessary to perform the duties imposed upon the  
11 Office of Educational Quality and Accountability by law. Of those  
12 funds appropriated, the sum of Sixty Thousand Dollars (\$60,000.00)  
13 shall be deposited in the Teacher Certification Scholarship  
14 Revolving Fund created pursuant to Section 6-187C of Title 70 of the  
15 Oklahoma Statutes. Of those funds appropriated, the sum of One  
16 Hundred Eighty Thousand Dollars (\$180,000.00) shall be deposited in  
17 the Education Leadership Oklahoma Revolving Fund created pursuant to  
18 Section 6-204.3 of Title 70 of the Oklahoma Statutes.

19 SECTION 22. There is hereby appropriated to the Office of  
20 Educational Quality and Accountability from any monies not otherwise  
21 appropriated from the Special Cash Fund of the State Treasury the  
22 sum of Five Hundred Thousand Dollars (\$500,000.00) or so much  
23 thereof as may be necessary to perform the duties imposed upon the  
24 Office of Educational Quality and Accountability by law.

1 SECTION 23. There is hereby appropriated to the Oklahoma  
2 Educational Television Authority from any monies not otherwise  
3 appropriated from the General Revenue Fund of the State Treasury for  
4 the fiscal year ending June 30, 2022, the sum of Three Million Two  
5 Hundred Four Thousand Four Dollars (\$3,204,004.00) or so much  
6 thereof as may be necessary to perform the duties imposed upon the  
7 Oklahoma Educational Television Authority by law.

8 SECTION 24. There is hereby appropriated to the Oklahoma State  
9 Regents for Higher Education from any monies not otherwise  
10 appropriated from the General Revenue Fund of the State Treasury for  
11 the fiscal year ending June 30, 2022, the sum of Five Hundred  
12 Eighty-five Million Two Hundred Thirty-seven Thousand Twenty-four  
13 Dollars (\$585,237,024.00) or so much thereof as may be necessary for  
14 allocation by the Oklahoma State Regents for Higher Education  
15 pursuant to the provisions of Article XIII-A of the Oklahoma  
16 Constitution for the education and general operating budgets of the  
17 institutions and for other programs, construction, renovations or  
18 repairs administered by the Oklahoma State Regents for Higher  
19 Education. Of those funds appropriated, the sum of Three Million  
20 One Hundred Forty-nine Thousand Eight Hundred Ninety-seven Dollars  
21 (\$3,149,897.00) shall be transferred to the Oklahoma Tuition  
22 Equalization Grant Trust Fund to implement the provisions of the  
23 Oklahoma Tuition Equalization Grant Act.

1 SECTION 25. The Oklahoma State Regents for Higher Education are  
2 hereby authorized to expend during the fiscal year ending June 30,  
3 2022, the sum of Forty-seven Million Three Hundred Seventy-two  
4 Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) from the  
5 Higher Education Capital Revolving Fund of the State Treasury for  
6 allocation by the Oklahoma State Regents for Higher Education  
7 pursuant to the provisions of Article XIII-A of the Oklahoma  
8 Constitution for the education and general operating budgets of the  
9 institutions and for other programs, construction, renovations or  
10 repairs administered by the Oklahoma State Regents for Higher  
11 Education.

12 SECTION 26. The Oklahoma State Regents for Higher Education are  
13 hereby authorized to expend during the fiscal year ending June 30,  
14 2022, the sum of Forty-seven Million Three Hundred Seventy-two  
15 Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) from the  
16 Oklahoma Student Aid Revolving Fund of the State Treasury for  
17 allocation by the Oklahoma State Regents for Higher Education  
18 pursuant to the provisions of Article XIII-A of the Oklahoma  
19 Constitution for the education and general operating budgets of the  
20 institutions and for other programs, construction, renovations or  
21 repairs administered by the Oklahoma State Regents for Higher  
22 Education.

23 SECTION 27. There is hereby appropriated to the Oklahoma State  
24 Regents for Higher Education from the Master Teacher Program Fund

1 (Fund 713), the sum of Eighty-six Million Six Hundred Thousand  
2 Dollars (\$86,600,000.00) or so much thereof as may be necessary for  
3 allocation by the Oklahoma State Regents for Higher Education  
4 pursuant to the provisions of Article XIII-A of the Oklahoma  
5 Constitution for the education and general operating budgets of the  
6 institutions and for other programs, construction, renovations or  
7 repairs administered by the Oklahoma State Regents for Higher  
8 Education.

9 SECTION 28. There is hereby appropriated to the Oklahoma State  
10 Regents for Higher Education from any monies not otherwise  
11 appropriated from the General Revenue Fund of the State Treasury for  
12 the fiscal year ending June 30, 2022, the sum of Eleven Million  
13 Seven Hundred Sixty-four Thousand Eight Hundred Twenty-three Dollars  
14 (\$11,764,823.00) or so much thereof as may be necessary for  
15 expenditures for concurrent enrollment pursuant to Section 628.13 of  
16 Title 70 of the Oklahoma Statutes.

17 SECTION 29. There is hereby appropriated to the Oklahoma State  
18 Regents for Higher Education from any monies not otherwise  
19 appropriated from the Oklahoma Education Lottery Trust Fund of the  
20 State Treasury for the fiscal year ending June 30, 2022, the sum of  
21 Twenty-two Million Eight Hundred Ninety Thousand Two Hundred Fifty  
22 Dollars (\$22,890,250.00) pursuant to paragraph 2 of subsection F of  
23 Section 713 of Title 3A of the Oklahoma Statutes for allocation by  
24 the Oklahoma State Regents for Higher Education pursuant to the

1 provisions of Article XIII-A of the Oklahoma Constitution for  
2 construction, renovations or repairs administered by the Oklahoma  
3 State Regents for Higher Education or for any other purpose  
4 authorized by paragraph 2 of subsection F of Section 713 of Title 3A  
5 of the Oklahoma Statutes.

6 SECTION 30. There is hereby appropriated to the Oklahoma State  
7 Regents for Higher Education from any monies not otherwise  
8 appropriated from the Oklahoma Education Lottery Trust Fund of the  
9 State Treasury for the fiscal year ending June 30, 2020, the sum of  
10 Seven Million Three Hundred Fifty Thousand One Hundred Fifty-three  
11 Dollars (\$7,350,153.00) pursuant to paragraph 2 of subsection F of  
12 Section 713 of Title 3A of the Oklahoma Statutes for allocation by  
13 the Oklahoma State Regents for Higher Education pursuant to the  
14 provisions of Article XIII-A of the Oklahoma Constitution for  
15 construction, renovations or repairs administered by the Oklahoma  
16 State Regents for Higher Education or for any other purpose  
17 authorized by paragraph 2 of subsection F of Section 713 of Title 3A  
18 of the Oklahoma Statutes.

19 SECTION 31. There is hereby appropriated to the Oklahoma State  
20 Regents for Higher Education from any monies not otherwise  
21 appropriated from the General Revenue Fund of the State Treasury for  
22 the fiscal year ending June 30, 2022, the sum of Four Million Two  
23 Hundred Thirty-two Thousand Nine Hundred Seventy-four Dollars  
24 (\$4,232,974.00) or so much thereof as may be necessary for the

1 general operating budget of the Administrative Offices of the  
2 Oklahoma State Regents for Higher Education.

3 SECTION 32. There is hereby appropriated to the Commissioners  
4 of the Land Office from any monies not otherwise appropriated from  
5 the Commissioners of the Land Office Fund of the State Treasury for  
6 the fiscal year ending June 30, 2022, the sum of Eight Million Three  
7 Hundred Seventy-nine Thousand Two Hundred Seventy-six Dollars  
8 (\$8,379,276.00) or so much thereof as may be necessary to perform  
9 the duties imposed upon the Commissioners of the Land Office by law.

10 SECTION 33. There is hereby appropriated to the Oklahoma  
11 Department of Libraries from any monies not otherwise appropriated  
12 from the General Revenue Fund of the State Treasury for the fiscal  
13 year ending June 30, 2022, the sum of Four Million Three Hundred  
14 Forty-six Thousand Three Hundred Fifteen Dollars (\$4,346,315.00) or  
15 so much thereof as may be necessary to perform the duties imposed  
16 upon the Oklahoma Department of Libraries by law.

17 SECTION 34. There is hereby appropriated to the Physician  
18 Manpower Training Commission from any monies not otherwise  
19 appropriated from the General Revenue Fund of the State Treasury for  
20 the fiscal year ending June 30, 2022, the sum of Six Million Five  
21 Hundred Forty-six Thousand Eight Hundred Seventy-seven Dollars  
22 (\$6,546,877.00) or so much thereof as may be necessary to perform  
23 the duties imposed upon the Physician Manpower Training Commission  
24 by law.

1 SECTION 35. There is hereby appropriated to the Physician  
2 Manpower Training Commission from any monies not otherwise  
3 appropriated from the Special Cash Fund of the State Treasury the  
4 sum of Four Hundred Thousand Dollars (\$400,000.00) or so much  
5 thereof as may be necessary to perform the duties imposed upon the  
6 Physician Manpower Training Commission by law.

7 SECTION 36. There is hereby appropriated to the Board of  
8 Trustees of the Oklahoma School of Science and Mathematics from any  
9 monies not otherwise appropriated from the General Revenue Fund of  
10 the State Treasury for the fiscal year ending June 30, 2022, the sum  
11 of Six Million Eight Hundred Eleven Thousand Three Hundred Seventy-  
12 three Dollars (\$6,811,373.00) or so much thereof as may be necessary  
13 to perform the duties imposed upon the Board of Trustees of the  
14 Oklahoma School of Science and Mathematics by law.

15 SECTION 37. There is hereby appropriated to the Oklahoma Center  
16 for the Advancement of Science and Technology from any monies not  
17 otherwise appropriated from the General Revenue Fund of the State  
18 Treasury for the fiscal year ending June 30, 2022, the sum of  
19 Fifteen Million Two Hundred Ninety-six Thousand Five Hundred Forty-  
20 two Dollars (\$15,296,542.00) or so much thereof as may be necessary  
21 to perform the duties imposed upon the Oklahoma Center for the  
22 Advancement of Science and Technology by law. Of those funds  
23 appropriated, the sum of Seven Million Six Hundred Eighteen Thousand  
24 Six Hundred Seventeen Dollars (\$7,618,617.00) shall be deposited in

1 the Research Support Revolving Fund, created pursuant to Section  
2 5060.11 of Title 74 of the Oklahoma Statutes, provided One Million  
3 Five Hundred Thousand Dollars (\$1,500,000.00) of these funds shall  
4 be dedicated to Applied Research and Development for Industry  
5 Innovation. Of those funds appropriated, the sum of Two Million  
6 Seven Hundred Fifty-nine Thousand Three Hundred Eight Dollars  
7 (\$2,759,308.00) shall be deposited in the Seed-capital Revolving  
8 Fund, created pursuant to Section 5060.21 of Title 74 of the  
9 Oklahoma Statutes.

10 FINANCE

11 SECTION 38. There is hereby appropriated to the Oklahoma  
12 Department of Commerce from any monies not otherwise appropriated  
13 from the General Revenue Fund of the State Treasury for the fiscal  
14 year ending June 30, 2022, the sum of Twenty-two Million Seventy-

5 (\$10,000,000.00) for the purpose of security enhancements at the  
6 State Capitol Complex and the Governor's Mansion.

7 SECTION 142. There is hereby appropriated to the Maintenance of  
8 State Buildings Revolving Fund (Fund 283) from any monies not  
9 otherwise appropriated from the General Revenue Fund of the State  
10 Treasury for the fiscal year ending June 30, 2021, the sum of Seven  
11 Million Five Hundred Thousand Dollars (\$7,500,000.00) or so much  
12 thereof as may be necessary to implement the provisions set forth in  
13 Section 908 of Title 62 of the Oklahoma Statutes.

14 SECTION 143. There is hereby appropriated to the State-Tribal  
15 Litigation Revolving Fund created pursuant to Section 1 of Enrolled  
16 House Bill No. 2951 of the 1st Session of the 58th Oklahoma  
17 Legislature from any monies not otherwise appropriated from the  
18 General Revenue Fund of the State Treasury for the fiscal year  
19 ending June 30, 2021, the sum of Ten Million Dollars  
20 (\$10,000,000.00) to be budgeted and expended as authorized by law.

21 SECTION 144. There is hereby appropriated to the Office of the  
22 State Treasurer from any monies not otherwise appropriated from the  
23 Cash-flow Reserve Fund (Fund 090) of the State Treasury, the sum of  
24 Five Million Dollars (\$5,000,000.00) or so much thereof as may be

1 necessary for the modernization of the treasury management software  
2 system.

3 SECTION 145. There is hereby appropriated to the Oklahoma  
4 Department of Emergency Management and Homeland Security from any  
5 monies not otherwise appropriated from the General Revenue Fund of  
6 the State Treasury for the fiscal year ending June 30, 2021, the sum  
7 of One Million Six Hundred Thousand Dollars (\$1,600,000.00) for the  
8 purpose of expanding weather radar infrastructure in the state.

9 SECTION 146. There is hereby appropriated to the Oklahoma Quick  
10 Action Closing Fund created pursuant to Section 48.2 of Title 62 of  
11 the Oklahoma Statutes from any monies not otherwise appropriated  
12 from the General Revenue Fund of the State Treasury for the fiscal  
13 year ending June 30, 2021, the sum of Twenty Million Dollars  
14 (\$20,000,000.00) to be budgeted and expended by the Governor as  
15 authorized by law.

16 SECTION 147. There is hereby appropriated to The State Emergency  
17 Fund, created pursuant to Section 139.42 of Title 62 of the Oklahoma  
18 Statutes, from any monies not otherwise appropriated from the  
19 General Revenue Fund of the State Treasury for the fiscal year  
20 ending June 30, 2021, the sum of Five Million Dollars  
21 (\$5,000,000.00), or so much thereof as may be necessary for matching  
22 federal disaster funds and for other disaster-related assistance.

23 SECTION 148. There is hereby appropriated to the Department of  
24 Public Safety from any monies not otherwise appropriated from the

1 General Revenue Fund of the State Treasury for the fiscal year  
2 ending June 30, 2021, the sum of Six Million Six Hundred Twenty-two  
3 Thousand Five Hundred Seven Dollars (\$6,622,507.00) for the purpose  
4 of expediting and facilitating the issuance of REAL ID compliant  
5 driver licenses and identifications.

6 SECTION 149. There is hereby appropriated to the Oklahoma  
7 Department of Commerce from any monies not otherwise appropriated  
8 from the General Revenue Fund of the State Treasury for the fiscal  
9 year ending June 30, 2021, the sum of Fifteen Million Dollars  
10 (\$15,000,000.00) for the purpose of funding and implementing a  
11 business incubator program.

12 SECTION 150. Sections 1 through 131 of this act shall become  
13 effective July 1, 2021.
