10	An Act relating to the Department of Corrections; requiring the expenditure of certain funds in certain
11	amounts for certain purposes; providing lapse dates; and requiring and prohibiting certain budget
12	procedures.

14	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
15	SECTION 1. From the funds appropriated to the Department of
16	Corrections in Enrolled Senate Bill No. 1040 of the 2nd Session of
17	the 58th Oklahoma Legislature, the Department of Corrections shall
18	expend Four Million Eight Hundred Ninety-four Thousand Six Hundred
19	Fifty Dollars (\$4,894,650.00) for the purpose of funding a
20	contractual per diem increase at the Lawton Correctional and
21	Rehabilitation Facility.
22	SECTION 2. From the funds appropriated to the Department of
23	Corrections in Enrolled Senate Bill No. 1040 of the 2nd Session of
24	the 58th Oklahoma Legislature, the Department of Corrections shall

expend Two Million Nine Hundred Twenty Thousand Dollars
(\$2,920,000.00) for the purpose of funding a contractual per diem
increase at the Davis Correctional Facility.

SECTION 3. Appropriations made by this act, not including 4 5 appropriations made for capital outlay purposes, may be budgeted for the fiscal year ending June 30, 2023 (hereafter FY-23), or may be 6 budgeted for the fiscal year ending June 30, 2024 (hereafter FY-24). 7 Funds budgeted for FY-23 may be encumbered only through June 30, 8 9 2023, and must be expended by November 15, 2023. Any funds remaining after November 15, 2023, and not budgeted for FY-24, shall 10 lapse to the credit of the proper fund for the then current fiscal 11 year. Funds budgeted for FY-24 may be encumbered only through June 12 30, 2024. Any funds remaining after November 15, 2024, shall lapse 13 to the credit of the proper fund for the then current fiscal year. 14 These appropriations may not be budgeted in both fiscal years 15 simultaneously. Funds budgeted in FY-23, and not required to pay 16 17 obligations for that fiscal year, may be budgeted for FY-24, after the agency to which the funds have been appropriated has prepared 18 and submitted a budget work program revision removing these funds 19 from the FY-23 budget work program and after such revision has been 20 approved by the Office of Management and Enterprise Services. 21
