



1 Oklahoma Motor Vehicle Commission, upon a new motor vehicle, travel  
2 trailer or commercial trailer when a transaction is completed for  
3 the sale of ~~said~~ the vehicle or trailer. Except for cab and chassis  
4 trucks, the temporary license plate under this section shall be  
5 placed at the location provided for the permanent motor vehicle  
6 license plate. The purchaser of a new cab and chassis truck may  
7 place the temporary license plate under this section in the rear  
8 window. ~~Said~~ The temporary license plate shall show the dealer's  
9 license number which is issued to him or her each year by the  
10 Oklahoma Tax Commission, the date the new motor vehicle, travel  
11 trailer or commercial trailer was purchased and the company name of  
12 the selling dealer. The Oklahoma Motor Vehicle Commission is hereby  
13 directed to develop a temporary license plate design to incorporate  
14 these requirements in a manner that will permit law enforcement  
15 personnel to readily identify the dealer license number and date of  
16 the vehicle purchase. The Motor Vehicle Commission is further  
17 authorized to develop additional requirements and parameters  
18 designed to discourage or prevent illegal duplication and use of the  
19 temporary license plate. On or before sixty (60) days from the date  
20 of purchase for purchases made on or after the effective date of  
21 this act and before July 1, 2023, and thirty (30) days from the date  
22 of purchase of a new motor vehicle, travel trailer or commercial  
23 trailer, for purchases made before the effective date of this act,  
24 ~~said~~ the temporary license plate shall be removed and replaced with

1 a permanent, current Oklahoma license plate. Use of ~~said~~ the  
2 temporary license plate by a licensed dealer for other than the  
3 purpose of normally doing business shall constitute grounds for  
4 revocation of the dealer's license.

5 It shall be unlawful for any licensed dealer of new motor  
6 vehicles, travel trailers or commercial trailers to procure the  
7 registration and licensing of any new motor vehicle, travel trailer  
8 or commercial trailer sold by such licensed dealer or to act as the  
9 agent for such purchaser in the procurement of ~~said~~ the registration  
10 and licensing. The license of any licensed dealer of new motor  
11 vehicles, travel trailers or commercial trailers violating the  
12 provisions of this section shall be revoked.

13 SECTION 2. It being immediately necessary for the preservation  
14 of the public peace, health or safety, an emergency is hereby  
15 declared to exist, by reason whereof this act shall take effect and  
16 be in full force from and after its passage and approval.
