8 An Act relating to state government; amending 74 O.S.
9 2021, Section 291.2, which relates to the Board on
10 Legislative Compensation; specifying ex officio
11 members; providing for Executive Director of the
12 Legislative Office of Fiscal Transparency to provide
13 certain services; providing an effective date; and
14 declaring an emergency.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. AMENDATORY 74 O.S. 2021, Section 291.2, is
17 amended to read as follows:

18 Section 291.2 A. The Board on Legislative Compensation created
19 by Section 21 of Article V of the Oklahoma Constitution shall meet
20 on the third Tuesday of October in every odd-numbered year at nine
21 o'clock a.m. in the State Capitol Building, at which meeting the
22 Board shall review the compensation paid to members of the State
23 Legislature and, if necessary, change the compensation.

24 B. The Board may, at the call of its chairman or upon a
majority vote of its membership, hold such additional meetings as
are necessary to carry out its official duties.

1 C. Any change in legislative compensation shall be made by the
2 Board no later than the third Tuesday of November in said odd-
3 numbered year.

4 D. Five members of the Board shall constitute a quorum and a
5 majority vote of such quorum shall be necessary for the Board to
6 act. The appointed members of said Board shall serve terms which
7 run concurrently with the terms of the respective appointing
8 authorities and shall serve at their pleasure. The Director of the
9 Office of Management and Enterprise Services and the Chair of the
10 Oklahoma Tax Commission shall serve as ~~Secretary to the Board~~ ex
11 officio members of the Board as required by Section 21 of Article V
12 of the Oklahoma Constitution.

13 E. The Executive Director of the Legislative Office of Fiscal
14 Transparency shall serve as secretary to the Board and provide staff
15 support to the Board.

16 F. The Board shall elect such other officers as they deem
17 needed from their membership.

18 G. No member of the Board shall be a lobbyist as required to be
19 registered pursuant to the Oklahoma Campaign Compliance and Ethical
20 Standards Act.

21 SECTION 2. This act shall become effective July 1, 2022.

22 SECTION 3. It being immediately necessary for the preservation
23 of the public peace, health or safety, an emergency is hereby
24

1 declared to exist, by reason whereof this act shall take effect and
2 be in full force from and after its passage and approval.
