12	SECTION 1. AMENDATORY 22 O.S. 2021, Section 60.1, is
13	amended to read as follows:
14	Section 60.1. As used in the Protection from Domestic Abuse Act
15	and in the Domestic Abuse Reporting Act, Sections 40.5 through 40.7
16	of this title, and Section 150.12B of Title 74 of the Oklahoma
17	Statutes:
18	1. <u>"Coercive control" means unreasonably engaging in any of the</u>
19	following:
20	a. <u>intentionally isolating a family or household member</u>
21	from friends, relatives, or other sources of support,
22	b. depriving a family or household member of basic
23	<u>necessities,</u>

1	<u>C.</u>	controlling, regulating, or monitoring a family or
2		household member's movements, communications, daily
3		behavior, finances, economic resources, or access to
4		services, which includes stalking or cyberstalking,

7		threats based on actual or suspected immigration

6	household member or coercive control as defined by this section;
7	3. <u>4.</u> "Family or household members" means:
8	a. parents, including grandparents, stepparents, adoptive
9	parents and foster parents,
10	b. children, including grandchildren, stepchildren,
11	adopted children and foster children,
12	c. persons otherwise related by blood or marriage living
13	in the same household, and
14	d. persons otherwise related by blood or marriage;
15	4. 5. "Foreign protective order" means any valid order of
16	protection issued by a court of another state or a tribal court;
17	5. 6. "Harassment" means a knowing and willful course or
18	pattern of conduct by a family or household member or an individual
19	who is or has been involved in a dating relationship with the
20	person, directed at a specific person which seriously alarms or
21	annoys the person, and which serves no legitimate purpose. The
22	course of conduct must be such as would cause a reasonable person to
23	suffer substantial emotional distress and must actually cause

"Intimate partner" means: 4 5 a. current or former spouses, persons who are or were in a dating relationship, b. 6 persons who are the biological parents of the same 7 с. child, regardless of their marital status or whether 8 9 they have lived together at any time, and persons who currently or formerly lived together in an d. 10 intimate way, primarily characterized by affectionate 11 or sexual involvement. A sexual relationship may be 12 an indicator that a person is an intimate partner, but 13 is never a necessary condition; 14

"Mutual protective order" means a final protective order 15 or orders issued to both a plaintiff who has filed a petition for a 16 protective order and a defendant included as the defendant in the 17 plaintiff's petition restraining the parties from committing 18 domestic violence, stalking, harassment or rape against each other. 19 If both parties allege domestic abuse, violence, stalking, 20 harassment or rape against each other, the parties shall do so by 21 separate petition pursuant to Section 60.4 of this title; 22

8. 9. "Rape" means rape and rape by instrumentation in
 violation of Sections 1111 and 1111.1 of Title 21 of the Oklahoma
 Statutes;

9. 10. "Stalking" means the willful, malicious, and repeated 4 5 following or harassment of a person by an adult, emancipated minor, or minor thirteen (13) years of age or older, in a manner that would 6 cause a reasonable person to feel frightened, intimidated, 7 threatened, harassed, or molested and actually causes the person 8 9 being followed or harassed to feel terrorized, frightened, intimidated, threatened, harassed or molested. Stalking also means 10 a course of conduct composed of a series of two or more separate 11 12 acts over a period of time, however short, evidencing a continuity of purpose or unconsented contact with a person that is initiated or 13 continued without the consent of the individual or in disregard of 14 the expressed desire of the individual that the contact be avoided 15 or discontinued. Unconsented contact or course of conduct includes, 16 but is not limited to: 17

18 a. following or appearing within the sight of that19 individual,

- 20 b. approaching or confronting that individual in a public
  21 place or on private property,
- c. appearing at the workplace or residence of thatindividual,
