10	Officer; deleting appointment authority of the Governor; providing hiring authority to the Director
11	of the Office of Management and Enterprise Services;
12	modifying certain duties of the Chief Information Officer and the Director of the Office of Management
13	and Enterprise Services; deleting salary range; eliminating statutory eligibility requirements;
14	making certain initial assessment and report an annual requirement; modifying contents of certain
15	report; modifying duties of the Information Services  Division of the Office of Management and Enterprise
16	Services; and providing an effective date.

18	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
19	SECTION 1. AMENDATORY 62 O.S. 2011, Section 34.11.1, as
20	last amended by Section 2, Chapter 384, O.S.L. 2017 (62 O.S. Supp.
21	2020, Section 34.11.1), is amended to read as follows:
22	Section 34.11.1. A. There is hereby created the position of
23	Chief Information Officer who shall be <del>appointed by the Governor</del>
24	hired by the Director of the Office of Management and Enterprise

2 3 4	having authority over the Information Services Division of the  Office of Management and Enterprise Services, shall also serve as  Secretary of Information Technology and Telecommunications or  successor cabinet position and shall have jurisdictional areas of

6	responsibility related to information technology and
7	telecommunications systems of all state agencies as provided for in
8	state law. The salary of the Chief Information Officer shall not be

11	B. Any person appointed to the position of Chief Information
12	Officer shall meet the following eligibility requirements:
13	1. A baccalaureate degree in Computer Information Systems,
14	Information Systems or Technology Management, Business
15	Administration, Finance, or other similar degree;
16	2. A minimum of ten (10) years of professional experience with
17	responsibilities for management and support of information systems
18	and information technology, including seven (7) years of direct
19	management of a major information technology operation;
20	3. Familiarity with local and wide-area network design,
21	implementation, and operation;
22	4. Experience with data and voice convergence service
23	offerings;

5. Experience in developing technology budgets;

1	6. Experience in developing requests for proposal and
2	administering the bid process;
3	7. Experience managing professional staff, teams, and
4	consultants;
5	8. Knowledge of telecommunications operations;
6	9. Ability to develop and set strategic direction for
7	information technology and telecommunications and to manage daily
8	development and operations functions;
9	10. An effective communicator who is able to build consensus;
10	11. Ability to analyze and resolve complex issues, both logical
11	and interpersonal;
12	12. Effective verbal and written communications skills and
13	effective presentation skills, geared toward coordination and
14	education;
15	13. Ability to negotiate and defuse conflict; and
16	14. A self-motivator, independent, cooperative, flexible and
17	<del>creative.</del>
18	$rac{ extsf{C-}}{ extsf{B}_{ullet}}$ The salary and any other expenses for the Chief
19	Information Officer shall be budgeted as a separate line item
20	through the Office of Management and Enterprise Services. The
21	operating expenses of the Information Services Division shall be set
22	by the Chief Information Officer and shall be budgeted as a separate
23	line item through the Office of Management and Enterprise Services.
24	The Office of Management and Enterprise Services shall provide

adequate office space, equipment and support necessary to enable the
Chief Information Officer to carry out the information technology
and telecommunications duties and responsibilities of the Chief
Information Officer and the Information Services Division.

D. C. 1. Within twelve (12) months of appointment, the first Chief Information Officer shall complete an assessment, which shall be modified annually The Chief Information Officer shall complete an annual assessment, pursuant to Section 35.5 of this title, of the implementation of the transfer, coordination, and modernization of all information technology and telecommunication systems of all state agencies in the state as provided for in the Oklahoma Information Services Act. The assessment shall include the information technology and telecommunications systems of all institutions within The Oklahoma State System of Higher Education, the Oklahoma State Regents for Higher Education and the telecommunications network known as OneNet as assembled and submitted by the Oklahoma Higher Education Chief Information Officer, as designated by the Oklahoma State Regents for Higher Education.

2. Within twelve (12) months of appointment, the first The
Chief Information Officer shall issue a an annual report setting out

  - Formulate and implement the information technology strategy for all state agencies;
  - 2. Define, design, and implement a shared services statewide infrastructure and application environment for information technology and telecommunications for all state agencies;
  - 3. Direct the development and operation of a scalable telecommunications infrastructure that supports data and voice communications reliability, integrity, and security;
  - 4. Supervise the applications development process for those applications that are utilized across multiple agencies;
  - 5. Provide direction for the professional development of information technology staff of state agencies and oversee the professional development of the staff of the Information Services Division of the Office of Management and Enterprise Services;
  - 6. Evaluate all technology and telecommunication investment choices for all state agencies;

- 7. Create a plan to ensure alignment of current systems, tools, and processes with the strategic information technology plan for all state agencies;
- 8. Set direction and provide oversight for the support and continuous upgrading of the current information technology and telecommunication infrastructure in the state in support of enhanced reliability, user service levels, and security;
- 9. Direct the development, implementation, and management of appropriate standards, policies and procedures to ensure the success of state information technology and telecommunication initiatives;
- 10. Recruit, hire and transfer the required technical staff in the Information Services Division of the Office of Management and Enterprise Services to support the services provided by the Division and the execution of the strategic information technology plan;
- 11. Establish, maintain, and enforce information technology and telecommunication standards;
- 12. Delegate, coordinate, and review all work to ensure quality and efficient operation of the Information Services Division of the Office of Management and Enterprise Services;
- 13. Create and implement a communication plan that disseminates pertinent information to state agencies on standards, policies, procedures, service levels, project status, and other important information to customers of the Information Services Division of the

Office of Management and Enterprise Services and provide for agency feedback and performance evaluation by customers of the Division;

- 14. Develop and implement training programs for state agencies using the shared services of the Information Services Division of the Office of Management and Enterprise Services and recommend training programs to state agencies on information technology and telecommunication systems, products and procedures;
- 15. Provide counseling, performance evaluation, training, motivation, discipline, and assign duties for employees of the Information Services Division of the Office of Management and Enterprise Services;
- of OMES the purchasing of all information technology and telecommunication services and approve the purchase of any information technology and telecommunication product except the following:
  - a. a purchase less than or equal to Five Thousand Dollars (\$5,000.00) if such product is purchased using a state purchase card and the product is listed on either the Approved Hardware or Approved Software list located on the Office of Management and Enterprise Services website, or
  - b. a purchase over Five Thousand Dollars (\$5,000.00) and less than or equal to Twenty-five Thousand Dollars

1 (\$25,000.00) if such product is purchased using a
2 state purchase card, the product is listed on an
3 information technology or telecommunications statewide
4 contract, and the product is listed on either the
5 Approved Hardware or Approved Software list located on
6 the Office of Management and Enterprise Services

website;

- 17. Develop and enforce an overall infrastructure architecture strategy and associated roadmaps for desktop, network, server, storage, and statewide management systems for state agencies;
- 18. Effectively manage the design, implementation and support of complex, highly available infrastructure to ensure optimal performance, on-time delivery of features, and new products, and scalable growth; and
- 19. Define and implement a governance model for requesting services and monitoring service level metrics for all shared services: and
- 20. Create the budget for the Information Services Division of the Office of Management and Enterprise Services to be submitted to the Legislature each year.
- G. F. The State Governmental Technology Applications Review Board shall provide ongoing oversight of the implementation of the plan of action required in subsection  $\frac{1}{2}$  of this section. Any

proposed amendments to the plan of action shall be approved by the Board prior to adoption.

- H. G. 1. The Chief Information Officer, at the direction of the Director of OMES, shall act as the Information Technology and Telecommunications Purchasing Director for all state agencies and shall be responsible for the procurement of all information technology and telecommunication software, hardware, equipment, peripheral devices, maintenance, consulting services, high technology systems, and other related information technology, data processing, telecommunication and related peripherals and services for all state agencies. The Chief Information Officer shall establish, implement, and enforce policies and procedures for the procurement of information technology and telecommunication software, hardware, equipment, peripheral devices, maintenance, consulting services, high technology systems, and other related information technology, data processing, telecommunication and related peripherals and services by purchase, lease-purchase, lease with option to purchase, lease and rental for all state agencies. The procurement policies and procedures established by the Chief Information Officer shall be consistent with The Oklahoma Central Purchasing Act.
- 2. The Chief Information Officer, or any employee or agent of the Chief Information Officer acting within the scope of delegated authority at the direction of the Director of OMES, shall have the

same power and authority regarding the procurement of all information technology and telecommunication products and services as outlined in paragraph 1 of this subsection for all state agencies as the State Purchasing Director has for all acquisitions used or consumed by state agencies as established in The Oklahoma Central Purchasing Act. Such authority shall, consistent with the authority granted to the State Purchasing Director pursuant to Section 85.10 of Title 74 of the Oklahoma Statutes, include the power to designate financial or proprietary information submitted by a bidder confidential and reject all requests to disclose the information so designated, if the Chief Information Officer requires the bidder to submit the financial or proprietary information with a bid, proposal, or quotation.

H. The Information Services Division of the Office of
Management and Enterprise Services and the Chief Information Officer
shall be subject to The Oklahoma Central Purchasing Act for the
approval and purchase of equipment and products not related to
information and telecommunications technology, equipment, software,
products and related peripherals and services and shall also be
subject to the requirements of the Public Competitive Bidding Act of
1974, the Oklahoma Lighting Energy Conservation Act and the Public
Building Construction and Planning Act when procuring data
processing, information technology, telecommunication, and related
peripherals and services and when constructing information

1 technology and telecommunication facilities, telecommunication 2 networks and supporting infrastructure. The Chief Information 3 Officer shall be authorized to delegate all or some of the procurement of information technology and telecommunication products 5 and services and construction of facilities and telecommunication networks to another state entity if the Chief Information Officer 6 determines it to be cost-effective and in the best interest of the 7 state. The Chief Information Officer, at the direction of the 8 9 Director of OMES, shall have authority to designate information 10 technology and telecommunication contracts as statewide contracts and mandatory statewide contracts pursuant to Section 85.5 of Title 11 12 74 of the Oklahoma Statutes and to negotiate consolidation contracts, enterprise agreements and high technology systems 13 contracts in accordance with the procedures outlined in Section 14 15 85.9D of Title 74 of the Oklahoma Statutes. Any contract entered 16 into by a state agency for which the Chief Information Officer has not acted as the Information Technology and Telecommunications 17 Purchasing Director as required in this subsection or subsection H G 18 of this section, shall be deemed to be unenforceable and the Office 19 of Management and Enterprise Services shall not process any claim 20 associated with the provisions thereof. 21

J. I. The Chief Information Officer shall establish, implement, and enforce policies and procedure for the development and procurement of an interoperable radio communications system for

- state agencies. The Chief Information Officer shall work with local governmental entities in developing the interoperable radio communications system.
  - K. J. The Chief Information Officer shall develop and implement a plan to utilize open source technology and products for the information technology and telecommunication systems of all state agencies.
  - En K. All state agencies and authorities of this state and all officers and employees of those entities shall work and cooperate with and lend assistance to the Chief Information Officer and the Information Services Division of the Office of Management and Enterprise Services and provide any and all information requested by the Chief Information Officer.
  - M. L. The Chief Information Officer, at the direction of the

    Director of OMES, shall prepare an annual report detailing the

  - N. M. For purposes of the Oklahoma Information Services Act, unless otherwise provided for, "state agencies" shall include any office, officer, bureau, board, commission, counsel, unit, division, body, authority or institution of the executive branch of state

1 government, whether elected or appointed; provided, except with respect to the provisions of subsection  $\frac{1}{2}$  C of this section, the 2 term "state agencies" shall not include institutions within The 3 Oklahoma State System of Higher Education, the Oklahoma State 4 5 Regents for Higher Education and the telecommunications network known as OneNet. 6 7 O. N. As used in this section: 1. "High technology system" means advanced technological 8 9 equipment, software, communication lines, and services for the 10 processing, storing, and retrieval of information by a state agency; 2. "Consolidation contract" means a contract for several state 11 12 or public agencies for the purpose of purchasing information technology and telecommunication goods and services; and 13 3. "Enterprise agreement" means an agreement for information 14 15 technology or telecommunication goods and services with a supplier who manufactures, develops and designs products and provides 16 services that are used by one or more state agencies. 17 SECTION 2.
