9 An Act relating to law enforcement officers;  
10 prohibiting certain disclosure of personal  
information of law enforcement officers; providing  
11 penalties; providing definitions; providing for  
codification; and providing an effective date.

14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. NEW LAW A new section of law to be codified  
16 in the Oklahoma Statutes as Section 1176 of Title 21, unless there  
17 is created a duplication in numbering, reads as follows:

18 A. It shall be unlawful for a person, who by telephonic or  
19 electronic communication, as defined in Section 1172 of Title 21 of  
20 the Oklahoma Statutes, to willfully publish on a public online site  
21 or forum, attempt to publish or conspire to publish personally  
22 identifiable information of a law enforcement officer with the  
23 intent to threaten, intimidate, harass or stalk, or as a result,  
24 causes, attempts to cause or would be reasonably expected to cause

1 substantial emotional distress or financial loss to that person, or  
2 to that officer's family or household member or intimate partner.

3 B. Except as provided in subsection C of this act, any person  
4 convicted of the provisions of subsection A of this section shall be  
5 guilty of a misdemeanor.

6 C. Any person who is convicted of a second or subsequent  
7 offense pursuant to this section shall be guilty of a felony.

8 D. As used in subsection A of this act:

9 1. "Personally identifiable information" shall include, but not  
10 be limited to:

11 a. name,

12 b. birth date,

13 c. address,

14 d. telephone number,

15 e. driver license number,

16 f. Social Security number,

17 g. place of employment,

18 h. mother's maiden name, or

19 i. a photograph or any other realistic likeness;

20 2. "Family or household member" shall mean parents including  
21 grandparents, stepparents, adoptive parents and foster parents;  
22 children including grandchildren, stepchildren, adopted children and  
23 foster children; and persons otherwise related by blood or marriage  
24 living in the same household; and

1       3. "Law enforcement officer" shall mean any officer, agent or  
2 employee of a state, unit of local government, or an Indian tribe  
3 authorized by law or by a government agency to engage in or  
4 supervise the prevention, detection or investigation of any  
5 violation of criminal law.

6       SECTION 2. This act shall become effective November 1, 2021.
