11 An Act relating to the Supreme Court; making an  
12 appropriation; providing amount; providing purpose;  
13 and declaring an emergency.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. There is hereby appropriated to the Supreme Court  
17 from any monies not otherwise appropriated from the General Revenue  
18 Cash-flow Reserve Fund (Fund 090) of the State Treasury the sum of  
19 Seven Million Five Hundred Thousand Dollars (\$7,500,000.00) or so  
20 much thereof as may be necessary to perform the duties imposed upon  
21 the district courts by law.

22 SECTION 2. It being immediately necessary for the preservation  
23 of the public peace, health or safety, an emergency is hereby  
24

1 declared to exist, by reason whereof this act shall take effect and  
2 be in full force from and after its passage and approval.
