There is hereby appropriated to the Health Care SECTION 1. Workforce Development Revolving Fund, created in Enrolled House Bill No. 4453 of the 2nd Session of the 58th Oklahoma Legislature, from any monies not otherwise appropriated from the Statewide Recovery Fund of the State Treasury created in Enrolled House Bill No. 3349 of the 2nd Session of the 58th Oklahoma Legislature, the sum of Ten Million Dollars (\$10,000,000.00) or so much thereof as may be necessary to establish a grant program with Southwestern Oklahoma State University for the purpose of recruiting, educating, and stabilizing Oklahoma's health care workforce.

There is hereby appropriated to the Health Care Workforce Development Revolving Fund, created in Enrolled House Bill No. 4453 of the 2nd Session of the 58th Oklahoma Legislature, from any monies not otherwise appropriated from the Statewide Recovery Fund of the State Treasury created in Enrolled House Bill No. 3349 of the 2nd Session of the 58th Oklahoma Legislature, the sum of Three Hundred Thousand Dollars (\$300,000.00) or so much thereof as may be necessary to establish a grant program with Western Oklahoma State College for the purpose of recruiting, educating, and stabilizing Oklahoma's health care workforce.

SECTION 22. The Commission may reserve not more than two percent (2%) from each grant program authorized in this act for purposes of administering the program.

SECTION 23. The Health Care Workforce Training Commission shall promulgate rules and establish procedures for evaluating and
