7	An Act relating to medical marijuana; amending 63
8	O.S. 2021, Section 427.6, as last amended by Section 11, Chapter 553, O.S.L. 2021, which relates to
9	monitoring and disciplinary actions for license holders; expanding scope of penalties; decreasing
10	period for assessment of penalties; increasing fine amount; removing penalties for inaccurate or
11	fraudulent reporting; authorizing the revocation of license upon a second violation by the business, or
12	any employee or agent thereof; and providing an effective date.

15	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
16	SECTION 1. AMENDATORY 63 O.S. 2021, Section 427.6, as
17	last amended by Section 11, Chapter 553, O.S.L. 2021, is amended to
18	read as follows:
19	Section 427.6. A. The State Department of Health shall address
20	issues related to the medical marijuana program in Oklahoma
21	including, but not limited to, monitoring and disciplinary actions
22	as they relate to the medical marijuana program.
23	B. 1. The Department or its designee may perform on-site
24	inspections or investigations of a licensee or applicant for any

<sup>1</sup> medical marijuana business license, research facility, education <sup>2</sup> facility or waste disposal facility to determine compliance with <sup>3</sup> applicable laws, rules and regulations or submissions made pursuant <sup>4</sup> to this section. The Department may enter the licensed premises of <sup>5</sup> a medical marijuana business, research facility, education facility <sup>6</sup> or waste disposal facility licensee or applicant to assess or <sup>7</sup> monitor compliance or ensure qualifications for licensure.

8 2. Post-licensure inspections shall be limited to twice per 9 calendar year. However, investigations and additional inspections 10 may occur when the Department believes an investigation or 11 additional inspection is necessary due to a possible violation of 12 applicable laws, rules or regulations. The State Commissioner of 13 Health may adopt rules imposing penalties including, but not limited 14 to, monetary fines and suspension or revocation of licensure for 15 failure to allow the Authority reasonable access to the licensed 16 premises for purposes of conducting an inspection.

17 3. The Department may review relevant records of a licensed 18 medical marijuana business, licensed medical marijuana research 19 facility, licensed medical marijuana education facility or licensed 20 medical marijuana waste disposal facility, and may require and 21 conduct interviews with such persons or entities and persons 22 affiliated with such entities, for the purpose of determining 23 compliance with Department requirements and applicable laws, rules 24 and regulations. \_ \_

4. The Department may refer complaints alleging criminal
 activity that are made against a licensee to appropriate Oklahoma
 state or local law enforcement authorities.

C. Disciplinary action may be taken against an applicant or
licensee for not adhering to applicable laws pursuant to the terms,
conditions and guidelines set forth in the Oklahoma Medical
Marijuana and Patient Protection Act.

D. Disciplinary actions may include revocation, suspension or
 denial of an application, license or final authorization and other
 action deemed appropriate by the Department.

E. Disciplinary actions may be imposed upon a medical marijuana business licensee for:

13 1. Failure to comply with or satisfy any provision of 14 applicable laws, rules or regulations;

15 2. Falsification or misrepresentation of any material or 16 information submitted to the Department or other licensees;

17 3. Failing to allow or impeding entry by authorized 18 representatives of the Department;

<sup>19</sup> 4. Failure to adhere to any acknowledgement, verification or <sup>20</sup> other representation made to the Department;

5. Failure to submit or disclose information required by applicable laws, rules or regulations or otherwise requested by the Department;

1 6. Failure to correct any violation of this section cited as a 2 result of a review or audit of financial records or other materials; 3 7. Failure to comply with requested access by the Department to 4 the licensed premises or materials; 5 Failure to pay a required monetary penalty; 8. 6 9. Diversion of medical marijuana or any medical marijuana 7 product, as determined by the Department; 8 10. Threatening or harming a medical marijuana patient 9 licensee, caregiver licensee, a medical practitioner or an employee 10 of the Department; and 11 11. Any other basis indicating a violation of the applicable 12 laws and regulations as identified by the Department. 13 F. Disciplinary actions against a licensee may include the 14 imposition of monetary penalties, which may be assessed by the 15 Department. The Department may suspend or revoke a license for 16 failure to pay any monetary penalty lawfully assessed by the 17 Department against a licensee. 18 G. Penalties for sales <del>or</del>, purchases or transfers of medical 19 marijuana by a medical marijuana business or employees or agents of 20 the medical marijuana business to persons other than those allowed 21 by law occurring within any two-year one-year time period may 22 include an initial fine of One Five Thousand Dollars (\$1,000.00) 23 (\$5,000.00) for a first violation and a fine of Five Fifteen 24 Thousand Dollars (\$5,000.00) (\$15,000.00) for any subsequent \_ \_

1 violation. Penalties for grossly inaccurate or fraudulent reporting 2 occurring within any two-year time period may include an initial 3 fine of Five Thousand Dollars (\$5,000.00) for a first violation and 4 a fine of Ten Thousand Dollars (\$10,000.00) for any subsequent 5 violation. The medical marijuana business may shall be subject to a 6 revocation of any license granted pursuant to the Oklahoma Medical 7 Marijuana and Patient Protection Act upon a showing that the 8 violation was willful or grossly negligent second violation of the 9 business or any employee or agent thereof.

H. 1. First offense for intentional and impermissible diversion of medical marijuana, concentrate, or products by a patient or caregiver to an unauthorized person shall not be punished under a criminal statute but may be subject to a fine of Two Hundred Dollars (\$200.00).

15 2. The second offense for impermissible diversion of medical 16 marijuana, concentrate, or products by a patient or caregiver to an 17 unauthorized person shall not be punished under a criminal statute 18 but may be subject to a fine of not to exceed Five Hundred Dollars 19 (\$500.00) and may result in revocation of the license upon a showing 20 that the violation was willful or grossly negligent.

I. The intentional diversion of medical marijuana, medical marijuana concentrate or medical marijuana products by a licensed medical marijuana patient or caregiver, medical marijuana business or employee of a medical marijuana business to an unauthorized minor

1 person who the licensed medical marijuana patient or caregiver, 2 medical marijuana business or employee of a medical marijuana 3 business knew or reasonably should have known to be a minor person 4 shall be subject to a cite and release citation and, upon a finding 5 of guilt or a plea of no contest, a fine of Two Thousand Five 6 Hundred Dollars (\$2,500.00). For a second or subsequent offense, 7 the licensed medical marijuana patient or caregiver, medical 8 marijuana business or employee of a medical marijuana business shall 9 be subject to a cite and release citation and, upon a finding of 10 guilt or a plea of no contest, a fine of Five Thousand Dollars 11 (\$5,000.00) and automatic termination of the medical marijuana 12 license.

13 J. Nothing in this section shall be construed to prevent the 14 criminal prosecution, after the presentation of evidence and a 15 finding beyond a reasonable doubt, of a licensed medical marijuana 16 patient or caregiver, medical marijuana business or employee of a 17 medical marijuana business who has diverted medical marijuana, 18 medical marijuana concentrate or medical marijuana products to an 19 unauthorized person with the intent or knowledge that the 20 unauthorized person was to engage in the distribution or trafficking 21 of medical marijuana, medical marijuana concentrate or medical 22 marijuana products.

K. In addition to any other remedies provided for by law, the Department, pursuant to its rules and regulations, may issue a

<sup>1</sup> written order to any licensee the Department has reason to believe <sup>2</sup> has violated Sections 420 through 426.1 of this title, the Oklahoma <sup>3</sup> Medical Marijuana and Patient Protection Act, the Oklahoma Medical <sup>4</sup> Marijuana Waste Management Act, or any rules promulgated by the <sup>5</sup> State Commissioner of Health and to whom the Department has served, <sup>6</sup> not less than thirty (30) days previously, a written notice of <sup>7</sup> violation of such statutes or rules.

8 1. The written order shall state with specificity the nature of 9 the violation. The Department may impose any disciplinary action 10 authorized under the provisions of this section including, but not 11 limited to, the assessment of monetary penalties.

12 2. Any order issued pursuant to the provisions of this section 13 shall become a final order unless, not more than thirty (30) days 14 after the order is served to the licensee, the licensee requests an 15 administrative hearing in accordance with the rules and regulations 16 of the Department. Upon such request, the Department shall promptly 17 initiate administrative proceedings.

18 Whenever the Department finds that an emergency exists L. 19 requiring immediate action in order to protect the health or welfare 20 of the public, the Department may issue an order, without providing 21 notice or hearing, stating the existence of said emergency and 22 requiring that action be taken as the Department deems necessary to 23 meet the emergency. Such action may include, but is not limited to, 24 ordering the licensee to immediately cease and desist operations by \_ \_

1	the licensee. The order shall be effective immediately upon
2	issuance. Any person to whom the order is directed shall comply
3	immediately with the provisions of the order. The Department may
4	assess a penalty not to exceed Ten Thousand Dollars (\$10,000.00) per
5	day of noncompliance with the order. In assessing such a penalty,
6	the Department shall consider the seriousness of the violation and
7	any efforts to comply with applicable requirements. Upon
8	application to the Department, the licensee shall be offered a
9	hearing within ten (10) days of the issuance of the order.
10	M. All hearings held pursuant to this section shall be in
11	accordance with the Oklahoma Administrative Procedures Act.
12	SECTION 2. This act shall become effective November 1, 2022.
