22 pregnant, with an intention other than:

- 23 (1) after viability of the unborn child, to produce a
24 live birth and preserve the life and health of
the child born alive, or
(2) to remove a dead unborn child;

25 2. "Unborn child" means an individual organism of the species
Homo sapiens from fertilization until birth; and

1 3. "Grant-supervising entity" means a private entity which
2 approves all grants made under the Choosing Childbirth Act that are
3 not directly made to private organizations by the State Department
4 of Health for reimbursement of services provided under the Choosing
5 Childbirth Act and which:

6 a. is organized as a not-for-profit corporation in
7 Oklahoma and as a 501(c)3 entity under the federal
8 Internal Revenue Code, and

9 b. does not encourage or counsel any woman to have an
10 abortion not necessary to prevent her death, to
11 provide her such an abortion or to refer her for such
12 an abortion, and does not accept funds or services
13 knowingly from any entity which performs abortions or
14 receives money for abortions.

15 SECTION 2. AMENDATORY 63 O.S. 2021, Section 1-740.17, is
16 amended to read as follows:

17 Section 1-740.17 A. The State Department of Health shall make
18 grants, as directed in subsection B of this section, from funds
19 appropriated by the Legislature ~~specifically for this purpose, to a~~

22 B. The purpose of the grants shall be to reimburse private

8 paragraph 3 of subsection ~~A~~ C of this section; and

9 5. Assure that none of the funds provided pursuant to the
10 Choosing Childbirth Act, nor any other funds or services provided by
11 the organization, are used to encourage or counsel a woman to have
12 an abortion not necessary to prevent her death, to provide her such
13 an abortion or to refer her for such an abortion.
