8 Substance Abuse Services, the Oklahoma State
9 University Medical Authority, the University
10 Hospitals Authority, the Oklahoma Department of
11 Veterans Affairs, the Oklahoma Commission on Children
12 and Youth, the Office of Disability Concerns, the
13 Department of Human Services, the Office of Juvenile
14 Affairs, the State Department of Rehabilitation
15 Services, the Oklahoma Department of Agriculture,
16 Food, and Forestry, Oklahoma State University
17 Veterinary Medicine Authority, the Oklahoma
18 Department of Commerce, the Oklahoma Conservation
19 Commission, the Rural Economic Action Plan Fund, the
20 Corporation Commission, the Department of
21 Environmental Quality, the Oklahoma Historical
22 Society, the J.M. Davis Memorial Commission, the
23 Department of Labor, the Department of Mines, the
24 Oklahoma Tourism and Recreation Department, the
Oklahoma Water Resources Board, the Alcoholic
Beverage Laws Enforcement Commission, the Department
of Corrections, the Oklahoma State Bureau of
Investigation, the Council on Law Enforcement
Education and Training, the Board of Medicolegal
Investigations, the Oklahoma State Bureau of
Narcotics and Dangerous Drugs Control, the Department
of Public Safety, the Office of the Attorney General,
the Court of Criminal Appeals, district attorneys and
the District Attorneys Council, the Supreme Court,
the Oklahoma Indigent Defense System, and the Pardon
and Parole Board; establishing amounts; identifying
sources; providing purposes and restrictions;
authorizing certain deposits and uses; clarifying
timeline for certain executions of the measure; and
providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

EDUCATION

1 SECTION 1. There is hereby appropriated to the State Board of
2 Education from any monies not otherwise appropriated from the
3 General Revenue Fund of the State Treasury for the fiscal year
4 ending June 30, 2024, the sum of One Billion Three Hundred Twelve
5 Million One Hundred Thirty-nine Thousand One Hundred Fifty-seven
6 Dollars (\$1,312,139,157.00) or so much thereof as may be necessary
7 for the financial support of public schools.

8 SECTION 2. There is hereby appropriated to the State Board of
9 Education from any monies not otherwise appropriated from the
10 Education Reform Revolving Fund created by Section 34.89 of Title 62
11 of the Oklahoma Statutes, the sum of One Billion Thirty-six Million
12 Seven Hundred One Thousand Three Hundred Sixty-six Dollars
13 (\$1,036,701,366.00) or so much thereof as may be necessary for the
14 financial support of public schools.

15 SECTION 3. There is hereby appropriated to the State Board of
16 Education from any monies not otherwise appropriated from the Common
17 Education Technology Revolving Fund, the sum of Forty-seven Million
18 Twenty-five Thousand Seven Hundred One Dollars (\$47,025,701.00) or
19 so much thereof as may be necessary for the financial support of
20 public schools.

21 SECTION 4. There is hereby appropriated to the State Board of
22 Education from any monies not otherwise appropriated from the
23 Oklahoma Education Lottery Trust Fund of the State Treasury for the
24 fiscal year ending June 30, 2024, the sum of Twenty-seven Million

1 Seven Hundred Eighty-seven Thousand Five Hundred Dollars
2 (\$27,787,500.00) or so much thereof as may be necessary for the
3 financial support of public schools.

4 SECTION 5. There is hereby appropriated to the State Board of
5 Education from any monies not otherwise appropriated from the
6 Oklahoma Education Lottery Trust Fund of the State Treasury for the
7 fiscal year ending June 30, 2022, the sum of Nine Million Two
8 Hundred Eighty-six Thousand Eight Hundred Twenty Dollars
9 (\$9,286,820.00) or so much thereof as may be necessary for the
10 financial support of public schools.

11 SECTION 6. There is hereby appropriated to the State Board of
12 Education from any monies not otherwise appropriated from the
13 Mineral Leasing Fund of the State Treasury for the fiscal year
14 ending June 30 2024, the sum of Four Million Seven Hundred Seventy-
15 one Thousand Fifteen Dollars (\$4,771,015.00) or so much thereof as
16 may be necessary for the financial support of public schools.

17 SECTION 7. There is hereby appropriated to the State Board of
18 Education from any monies not otherwise appropriated from the
19 General Revenue Fund of the State Treasury for the fiscal year
20 ending June 30, 2024, the sum of One Hundred Twenty-one Million
21 Three Hundred Nineteen Thousand Twenty-six Dollars (\$121,319,026.00)
22 or so much thereof as may be necessary for the support of public
23 school activities.

1 SECTION 8. There is hereby appropriated to the State Board of
2 Education from any monies not otherwise appropriated from the
3 General Revenue Fund of the State Treasury for the fiscal year
4 ending June 30, 2024, the sum of Three Hundred Fifty-nine Million
5 One Hundred Ninety-three Thousand Four Hundred Seventy Dollars
6 (\$359,193,470.00) or so much thereof as may be necessary for the
7 Certified Employee Health Benefit Allowance.

8 SECTION 9. There is hereby appropriated to the State Board of
9 Education from any monies not otherwise appropriated from the
10 General Revenue Fund of the State Treasury for the fiscal year
11 ending June 30, 2024, the sum of One Hundred Ninety-four Million Two
12 Hundred Eleven Thousand Three Hundred Fifty-nine Dollars
13 (\$194,211,359.00) or so much thereof as may be necessary for the
14 Support Personnel Health Benefit Allowance.

15 SECTION 10. There is hereby appropriated to the State Board of
16 Education from any monies not otherwise appropriated from the
17 General Revenue Fund of the State Treasury for the fiscal year
18 ending June 30, 2024, the sum of Nineteen Million One Hundred Forty-
19 five Thousand Three Hundred Sixty-six Dollars (\$19,145,366.00) or so
20 much thereof as may be necessary for administrative and support
21 functions of the State Department of Education.

22 SECTION 11. There is hereby appropriated to the State Board of
23 Education from any monies not otherwise appropriated from the
24 General Revenue Fund of the State Treasury for the fiscal year

1 ending June 30, 2022, the sum of Forty-five Million One Hundred
2 Ninety Thousand Dollars (\$45,190,000.00) or so much thereof as may
3 be necessary for the purchase of textbooks and instructional
4 materials.

5 SECTION 12. There is hereby appropriated to the State Board of
6 Education from any monies not otherwise appropriated from the
7 Oklahoma Education Lottery Trust Fund of the State Treasury for the
8 fiscal year ending June 30, 2024, the sum of Three Million Eighty-
9 seven Thousand Five Hundred Dollars (\$3,087,500.00) or so much
10 thereof as may be necessary for transfer to the School Consolidation
11 Assistance Fund.

12 SECTION 13. There is hereby appropriated to the State Board of
13 Education from any monies not otherwise appropriated from the
14 Oklahoma Education Lottery Trust Fund of the State Treasury for the
15 fiscal year ending June 30, 2022, the sum of One Million Thirty-one
16 Thousand Eight Hundred Sixty-nine Dollars (\$1,031,869.00) or so much
17 thereof as may be necessary for transfer to the School Consolidation
18 Assistance Fund.

19 SECTION 14. There is hereby appropriated to the State Board of
20 Education from any monies not otherwise appropriated from the
21 Oklahoma Education Lottery Fund of the State Treasury for the fiscal
22 year ending June 30, 2024, the sum of Three Million Eighty-seven
23 Thousand Five Hundred Dollars (\$3,087,500.00) or so much thereof as
24

1 may be necessary for transfer to the Teachers' Retirement System
2 Dedicated Revenue Revolving Fund.

3 SECTION 15. There is hereby appropriated to the State Board of
4 Education from any monies not otherwise appropriated from the
5 Oklahoma Education Lottery Trust Fund of the State Treasury for the
6 fiscal year ending June 30, 2022, the sum of One Million Thirty-one
7 Thousand Eight Hundred Sixty-nine Dollars (\$1,031,869.00) or so much
8 thereof as may be necessary for transfer to the Teachers' Retirement
9 System Dedicated Revenue Revolving Fund.

10 SECTION 16. There is hereby appropriated to the State Board of
11 Education from any monies not otherwise appropriated from the
12 General Revenue Fund of the State Treasury for the fiscal year
13 ending June 30, 2021, the sum of Eighty-seven Million Seven Hundred
14 Thousand Dollars (\$87,700,000.00) to be transferred to the Ad
15 Valorem Reimbursement Fund, created pursuant to Section 193 of Title
16 62 of the Oklahoma Statutes, for the purpose of reimbursing counties
17 for school districts that claim a loss of revenue due to a tax
18 exemption granted pursuant to the provisions of Section 6B of
19 Article X of the Oklahoma Constitution.

20 SECTION 17. There is hereby appropriated to the State Board of
21 Education for deposit in the State Public Common School Building
22 Equalization Fund created by Section 32 of Article X of the Oklahoma
23 Constitution, from any monies not otherwise appropriated from the
24 General Revenue Fund of the State Treasury for the fiscal year

1 ending June 30, 2022, Forty-four Million Dollars (\$44,000,000.00) to
2 be distributed as redbud school grants as provided in Section 3-104
3 of Title 70 of the Oklahoma Statutes.

4 SECTION 18. For the fiscal year ending June 30, 2024, the State
5 Board of Education is hereby authorized to transfer from the
6 Teachers' Retirement System Dedicated Revenue Revolving Fund to the
7 Teachers' Retirement System of Oklahoma the sum of Four Hundred
8 Sixty Million One Hundred Fifty-two Thousand Two Hundred Ten Dollars
9 (\$460,152,210.00) and from appropriations provided in Sections 14
10 and 15 of this act, in the amounts provided in those sections for
11 the purposes prescribed in Section 34.93 of Title 62 of the Oklahoma
12 Statutes.

13 SECTION 19. There is hereby appropriated to the Oklahoma Arts
14 Council from any monies not otherwise appropriated from the General
15 Revenue Fund of the State Treasury for the fiscal year ending June
16 30, 2024, the sum of Three Million Seven Hundred Thirty Thousand
17 Thirty Dollars (\$3,730,030.00) or so much thereof as may be
18 necessary to perform the duties imposed upon the Council by law.

19 SECTION 20. There is hereby appropriated to the State Board of
20 Career and Technology Education from any monies not otherwise
21 appropriated from the General Revenue Fund of the State Treasury for
22 the fiscal year ending June 30, 2024, the sum of One Hundred Sixty
23 Million Two Hundred Six Thousand Five Hundred Sixty-eight Dollars
24

1 (\$160,206,568.00) or so much thereof as may be necessary to perform
2 the duties imposed upon the Board by law.

3 SECTION 21. There is hereby appropriated to the State Board of
4 Career and Technology Education from any monies not otherwise
5 appropriated from the Oklahoma Education Lottery Trust Fund of the
6 State Treasury for the fiscal year ending June 30, 2024, the sum of
7 Three Million Three Hundred Ninety-six Thousand Two Hundred Fifty
8 Dollars (\$3,396,250.00) pursuant to Section 713 of Title 3A of the
9 Oklahoma Statutes for allocation and general operating budgets of
10 the institutions and for other programs, construction, renovations,
11 or repairs administered by the State Board of Career and Technology
12 Education.

13 SECTION 22. There is hereby appropriated to the State Board of
14 Career and Technology Education from any monies not otherwise
15 appropriated from the Oklahoma Education Lottery Trust Fund of the
16 State Treasury for the fiscal year ending June 30, 2022, the sum of
17 One Million One Hundred Thirty-five Thousand Fifty-six Dollars
18 (\$1,135,056.00) pursuant to Section 713 of Title 3A of the Oklahoma
19 Statutes for allocation and general operating budgets of the
20 institutions and for other programs, construction, renovations, or
21 repairs administered by the State Board of Career and Technology
22 Education.

23 SECTION 23. There is hereby appropriated to the Office of
24 Educational Quality and Accountability from any monies not otherwise

1 appropriated from the General Revenue Fund of the State Treasury for
2 the fiscal year ending June 30, 2024, the sum of One Million Three
3 Hundred Sixty-seven Thousand Two Hundred Nine Dollars
4 (\$1,367,209.00) or so much thereof as may be necessary to perform
5 the duties imposed upon the Office by law. Of those funds
6 appropriated, the sum of Sixty Thousand Dollars (\$60,000.00) shall
7 be deposited in the Teacher Certification Scholarship Revolving Fund
8 created pursuant to Section 6-187C of Title 70 of the Oklahoma
9 Statutes. Of those funds appropriated, the sum of One Hundred
10 Eighty Thousand Dollars (\$180,000.00) shall be deposited in the
11 Education Leadership Oklahoma Revolving Fund created pursuant to
12 Section 6-204.3 of Title 70 of the Oklahoma Statutes.

13 SECTION 24. There is hereby appropriated to the Office of
14 Educational Quality and Accountability from any monies not otherwise
15 appropriated from the General Revenue Fund of the State Treasury for
16 the fiscal year ending June 30, 2022, the sum of Five Hundred
17 Thousand Dollars (\$500,000.00) or so much thereof as may be
18 necessary to perform the duties imposed upon the Office by law.

19 SECTION 25. There is hereby appropriated to the Oklahoma
20 Educational Television Authority from any monies not otherwise
21 appropriated from the General Revenue Fund of the State Treasury for
22 the fiscal year ending June 30, 2024, the sum of Two Million Eight
23 Hundred Seventy-nine Thousand Four Dollars (\$2,879,004.00) or so
24

1 much thereof as may be necessary to perform the duties imposed upon
2 the Authority by law.

3 SECTION 26. There is hereby appropriated to the Oklahoma State
4 Regents for Higher Education from any monies not otherwise
5 appropriated from the General Revenue Fund of the State Treasury for
6 the fiscal year ending June 30, 2024, the sum of Eight Hundred
7 Fifty-five Million One Hundred Twenty Thousand One Hundred Eighty-
8 eight Dollars (\$855,120,188.00) or so much thereof as may be
9 necessary for allocation by the Oklahoma State Regents for Higher
10 Education pursuant to the provisions of Article XVII-A of the
11 Oklahoma Constitution for the education and construction,
12 renovations, or repairs administered by the Oklahoma State Regents
13 for Higher Education. Of those funds appropriated, the sum of Three
14 Million One Hundred Forty-nine Thousand Eight Hundred Ninety-seven
15 Dollars (\$3,149,897.00) shall be transferred to the Oklahoma Tuition
16 Equalization Grant Trust Fund to implement the provisions of the
17 Oklahoma Tuition Equalization Grant Act.

18 SECTION 27. There is hereby appropriated to the Oklahoma State
19 Regents for Higher Education from any monies not otherwise
20 appropriated from the General Revenue Fund of the State Treasury for
21 the fiscal year ending June 30, 2024, the sum of Seventeen Million
22 Eight Hundred Forty-six Thousand Seven Hundred Ninety-seven Dollars
23 (\$17,846,797.00) or so much thereof as may be necessary for
24

1 expenditures for concurrent enrollment pursuant to Section 628.13 of
2 Title 70 of the Oklahoma Statutes.

3 SECTION 28. There is hereby appropriated to the Oklahoma State
4 Regents for Higher Education from any monies not otherwise
5 appropriated from the General Revenue Fund of the State Treasury for
6 the fiscal year ending June 30, 2024, the sum of Four Million Two
7 Hundred Thirty-two Thousand Nine Hundred Seventy-four Dollars
8 (\$4,232,974.00) or so much thereof as may be necessary for the
9 general operating budget of the administrative offices of the
10 Oklahoma State Regents for Higher Education.

11 SECTION 29. The Oklahoma State Regents for Higher Education are
12 hereby authorized to expend during the fiscal year ending June 30,
13 2024, the sum of Forty-seven Million Twenty-five Thousand Seven
14 Hundred One Dollars (\$47,025,701.00) from any monies not otherwise
15 appropriated from the Higher Education Capital Revolving Fund of the
16 State Treasury for allocation by the Oklahoma State Regents for
17 Higher Education pursuant to the provisions of Article XIII-A of the
18 Oklahoma Constitution for the education and general operating
19 budgets of the institutions and for other programs, construction,
20 renovations, or repairs administered by the Oklahoma State Regents
21 for Higher Education.

22 SECTION 30. The Oklahoma State Regents for Higher Education are
23 hereby authorized to expend during the fiscal year ending June 30,
24 2024, the sum of Forty-seven Million Twenty-five Thousand Seven

1 Hundred One Dollars (\$47,025,701.00) from any monies not otherwise
2 appropriated from the Oklahoma Student Aid Revolving Fund of the
3 State Treasury for allocation by the Oklahoma State Regents for
4 Higher Education pursuant to the provisions of Article XIII-A of the
5 Oklahoma Constitution for the education and general operating
6 budgets of the institutions and for other programs, construction,
7 renovations, or repairs administered by the Oklahoma State Regents
8 for Higher Education.

9 SECTION 31. There is hereby appropriated to the Oklahoma State
10 Regents for Higher Education from any monies not otherwise
11 appropriated from the Oklahoma Education Lottery Trust Fund of the
12 State Treasury for the fiscal year ending June 30, 2024, the sum of
13 Twenty-four Million Three Hundred Ninety-one Thousand Two Hundred
14 Fifty Dollars (\$24,391,250.00) pursuant to Section 713 of Title 3A
15 of the Oklahoma Statutes for allocation by the Oklahoma State
16 Regents for Higher Education pursuant to the provisions of Article
17 XIII-A of the Oklahoma Constitution for construction, renovations,
18 or repairs administered by the Oklahoma State Regents for Higher
19 Education or for any other purpose authorized by Section 713 of
20 Title 3A of the Oklahoma Statutes.

21 SECTION 32. There is hereby appropriated to the Oklahoma State
22 Regents for Higher Education from any monies not otherwise
23 appropriated from the Oklahoma Education Lottery Trust Fund of the
24 State Treasury for the fiscal year ending June 30, 2022, the sum of

1 Eight Million One Hundred Fifty-one Thousand Seven Hundred Sixty-
2 four Dollars (\$8,151,764.00) pursuant to Section 713 of Title 3A of
3 the Oklahoma Statutes for allocation by the Oklahoma State Regents
4 for Higher Education pursuant to the provisions of Article XIII-A of
5 the Oklahoma Constitution for construction, renovations, or repairs
6 administered by the Oklahoma State Regents for Higher Education or
7 for any other purpose authorized by Section 713 of Title 3A of the
8 Oklahoma Statutes.

9 SECTION 33. There is hereby appropriated to the Commissioners
10 of the Land Office from any monies not otherwise appropriated from
11 the Commissioners of the Land Office Fund of the State Treasury for
12 the fiscal year ending June 30, 2024, the sum of Six Million Seven
13 Hundred Three Thousand Four Hundred Twenty-one Dollars
14 (\$6,703,421.00) or so much thereof as may be necessary to perform
15 the duties imposed upon the Office by law.

16 SECTION 34. There is hereby appropriated to the Oklahoma
17 Department of Libraries from any monies not otherwise appropriated
18 from the General Revenue Fund of the State Treasury for the fiscal
19 year ending June 30, 2024, the sum of Five Million Nine Hundred
20 Sixteen Thousand Five Hundred Sixty-five Dollars (\$5,916,565.00) or
21 so much thereof as may be necessary to perform the duties imposed
22 upon the Department by law.

23 SECTION 35. There is hereby appropriated to the Health Care
24 Workforce Training Commission from any monies not otherwise

1 appropriated from the General Revenue Fund of the State Treasury for
2 the fiscal year ending June 30, 2024, the sum of Seven Million Two
3 Hundred Sixty-eight Thousand Six Hundred Twenty-nine Dollars
4 (\$7,268,629.00) or so much thereof as may be necessary to perform
5 the duties imposed upon the Commission by law.

6 SECTION 36. There is hereby appropriated to the Health Care
7 Workforce Training Commission from any monies not otherwise
8 appropriated from the General Revenue Fund of the State Treasury for
9 the fiscal year ending June 30, 2022, the sum of Four Hundred
10 Thousand Dollars (\$400,000.00) or so much thereof as may be
11 necessary to perform the duties imposed upon the Commission by law.

12 SECTION 37. There is hereby appropriated to the Oklahoma Board
13 of Private Vocational Schools from any monies not otherwise
14 appropriated from the General Revenue Fund of the State Treasury for
15 the fiscal year ending June 30, 2024, the sum of Three Hundred One
16 Thousand Dollars (\$301,000.00) or so much thereof as may be
17 necessary to perform the duties imposed upon the Board by law.

18 SECTION 38. There is hereby appropriated to the Board of
19 Trustees of the Oklahoma School of Science and Mathematics from any
20 monies not otherwise appropriated from the General Revenue Fund of
21 the State Treasury for the fiscal year ending June 30, 2024, the sum
22 of Seven Million Four Hundred Forty-six Thousand Three Hundred
23 Seventy-three Dollars (\$7,446,373.00) or so much thereof as may be
24 necessary to perform the duties imposed upon the Board by law.

1 SECTION 39. There is hereby appropriated to the Oklahoma Center
2 for the Advancement of Science and Technology from any monies not
3 otherwise appropriated from the General Revenue Fund of the State
4 Treasury for the fiscal year ending June 30, 2024, the sum of
5 Sixteen Million Eight Hundred Forty-six Thousand Five Hundred Forty-
6 two Dollars (\$16,846,542.00) or so much thereof as may be necessary
7 to perform the duties imposed upon the Oklahoma Center for the
8 Advancement of Science and Technology by law. Of those funds
9 appropriated, the sum of Seven Million Six Hundred Eighteen Thousand
10 Six Hundred Seventeen Dollars (\$7,618,617.00) shall be deposited in
11 the Research Support Revolving Fund, created pursuant to Section
12 5060.11 of Title 74 of the Oklahoma Statutes, provided Two Million
13 Two Hundred Fifty Thousand Dollars (\$2,250,000.00) shall be
14 dedicated to Applied Research and Development for Industry
15 Innovation. Of those funds appropriated, the sum of Two Million
16 Seven Hundred Fifty-nine Thousand Three Hundred Eight Dollars
17 (\$2,759,308.00) shall be deposited in the Seed-Capital Revolving
18 Fund, created pursuant to Section 5060.21 of Title 74 of the
19 Oklahoma Statutes.

20 SECTION 40. There is hereby appropriated to the Oklahoma
21 Accelerator Revolving Fund created by Enrolled House Bill No. 1030
22 of the 1st Extraordinary Session of the 59th Oklahoma Legislature,

24 Accelerator Program Fund at the Oklahoma Department of Commerce, the

1 sum of Thirteen Million Seven Hundred Fifty Thousand Dollars
2 (\$13,750,000.00) to be budgeted and expended in accordance with law.

3 FINANCE

4 SECTION 41. There is hereby appropriated to the Oklahoma Tax
5 Commission from any monies not otherwise appropriated from the
6 General Revenue Fund of the State Treasury for the fiscal year
7 ending June 30, 2024, the sum of Thirty-seven Million One Hundred

13 SECTION 149. Appropriations, authorizations, and distributions
14 directed in this act to or from a revolving fund of the State
15 Treasury enacted during the 1st Regular Session or 1st Extraordinary
16 Session of the 59th Oklahoma Legislature shall be executable upon
17 the later of the effective date for such applicable section of this
18 act or upon the date of such fund's creation.

19 SECTION 150. Sections 1 through 15, 18 through 49, 51 through
20 74, 76 through 104, and 106 through 141 of this act shall become
21 effective July 1, 2023.
