8 An Act relating to state government; amending 74 O.S.
9 2021, Section 250.4, which relates to the salaries of
10 statewide elected officers; increasing salaries to
11 certain amounts for certain officers; making
12 increases applicable to terms beginning after certain
13 date; and providing an effective date.

14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. AMENDATORY 74 O.S. 2021, Section 250.4, is
16 amended to read as follows:

17 Section 250.4 Pursuant to provisions of the Constitution of the
18 State of Oklahoma from and after the beginning date of a term of
19 office which commences in, or after, January ~~2016~~ 2024, the
20 following officers of the State of Oklahoma shall be annually
21 compensated for their services, payable monthly, as follows:

22 1. The Governor shall receive a salary of ~~One Hundred Forty-~~
23 ~~seven Thousand Dollars (\$147,000.00)~~ One Hundred Ninety-nine
24 Thousand Dollars (\$199,000.00);

7 4. The State Superintendent of Public Instruction shall receive

10 (\$155,000.00);

11 5. Each member of the Corporation Commission shall receive a

13 ~~Dollars (\$114,713.00)~~ One Hundred Fifty-five Thousand Dollars
14 (\$155,000.00);

15 6. The State Treasurer shall receive a salary of ~~One Hundred~~

18 7. The State Auditor and Inspector shall receive a salary of

9. The Commissioner of Labor shall receive a salary of ~~One Hundred Five Thousand Fifty three Dollars (\$105,053.00)~~ One Hundred Fifty-five Thousand Dollars (\$155,000.00).

SECTION 2. This act shall become effective January 1, 2024.
