7 PROPOSED COMMITTEE SUBSTITUTE

8 An Act relating to prisons and reformatories;  
9 creating the Oklahoma Department of Corrections  
10 Prison Rodeo Revolving Fund; making revolving fund  
11 continuing and not subject to fiscal year  
12 limitations; stating purpose of revolving fund;  
13 making expenditures subject to warrants; providing  
14 for codification; and declaring an emergency.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. NEW LAW A new section of law to be codified  
17 in the Oklahoma Statutes as Section 559.1 of Title 57, unless there  
18 is created a duplication in numbering, reads as follows:

19 There is hereby created in the State Treasury a revolving fund  
20 for the Oklahoma Department of Corrections to be designated the  
21 "Oklahoma Department of Corrections Prison Rodeo Revolving Fund".  
22 The fund shall be a continuing fund, not subject to fiscal year  
23 limitations, and shall consist of all monies directed for deposit by  
24 law. All monies accruing to the credit of said fund are hereby  
appropriated and may be used for the purpose of restoring,

1 rehabilitating, and expanding the prison rodeo arena of the Oklahoma  
2 Department of Corrections. Expenditures from said fund shall be  
3 made upon warrants issued by the Oklahoma Department of Corrections  
4 and approved by the Office of Management and Enterprise Services.

5 SECTION 2. It being immediately necessary for the preservation  
6 of the public peace, health or safety, an emergency is hereby  
7 declared to exist, by reason whereof this act shall take effect and  
8 be in full force from and after its passage and approval.
