From the funds appropriated to the Oklahoma State 3 Regents for Higher Education in Enrolled House Bill No. 1004 of the 4 5 1st Extraordinary Session of the 59th Oklahoma Legislature, the Oklahoma State Regents for Higher Education are authorized to expend 6 during the fiscal year ending June 30, 2024, the sum of Twelve 7 Million Five Hundred Thousand Dollars (\$12,500,000.00) for the 8 9 purpose of establishing the National Guard Educational Assistance 10 Fund.

SECTION 3. From the funds appropriated to the Oklahoma State Regents for Higher Education in Enrolled House Bill No. 1004 of the 13 1st Extraordinary Session of the 59th Oklahoma Legislature, the Oklahoma State Regents for Higher Education are authorized to expend during the fiscal year ending June 30, 2024, the sum of Forty-eight Million Nine Hundred Eight Thousand Two Hundred Sixteen Dollars (\$48,908,216.00) for the purpose of faculty pay raises.

SECTION 4. From the funds appropriated to the Oklahoma State Regents for Higher Education in Enrolled House Bill No. 1004 of the 1st Extraordinary Session of the 59th Oklahoma Legislature, the Oklahoma State Regents for Higher Education are authorized to expend during the fiscal year ending June 30, 2024, the sum of Twenty Million Dollars (\$20,000,000.00) for the purpose of expanding
