12 An Act relating to Service Oklahoma; amending 47 O.S.
13 2021, Section 2-147, which relates to the State
14 Public Safety Fund; modifying inclusions; amending
15 Sections 1, 3, and 6, Chapter 282, O.S.L. 2022 (47
16 O.S. Supp. 2022, Sections 3-101, 3-103 and 3-106),
17 which relate to the creation of Service Oklahoma, the
18 Director of Service Oklahoma and the Service Oklahoma
19 Revolving Fund; modifying references; creating a
20 separate agency; providing responsibilities for
21 agency; requiring coordination; directing certain
22 compensation; creating the Licensed Operator
23 Performance Fund; amending 47 O.S. 2021, Section 6-
24 101, as last amended by Section 37, Chapter 282,
O.S.L. 2022 (47 O.S. Supp. 2022, Section 6-101),
which relates to class requirements for driver
licenses; modifying certain fee retention by licensed
operators; amending 47 O.S. 2021, Section 6-105.3, as
last amended by Section 1, Chapter 65, O.S.L. 2022
(47 O.S. Supp. 2022, Section 6-105.3), which relates
to issuance of identification card; modifying certain

4 2021, Section 1103, which relates to legislative
5 intent; authorizing certain fee retention; amending
6 47 O.S. 2021, Section 1104, as last amended by
7 Section 1, Chapter 363, O.S.L. 2022 (47 O.S. Supp.
8 2022, Section 1104), which relates to apportionment
9 of fees; requiring certain monthly reporting;
10 directing certain apportionment; amending 47 O.S.
11 2021, Section 1135.5, as last amended by Section 23
12 of Enrolled Senate Bill No. 782 of the 1st Session of
13 the 59th Oklahoma Legislature (47 O.S. Supp. 2022,
14 Section 1135.5), which relates to special license
15 plates; modifying certain fee retention by licensed
16 operators; amending 47 O.S. 2021, Section 1140, as
17 amended by Section 174, Chapter 282, O.S.L. 2022 (47
18 O.S. Supp. 2022, Section 1140), which relates to
19 qualifications for licensed operators; prescribing
20 certain method of payment for licensed operators;
21 amending 47 O.S. 2021, Section 1141.1, as last
22 amended by Section 177, Chapter 282, O.S.L. 2022 (47
23 O.S. Supp. 2022, Section 1141.1), which relates to
24 retention of taxes and fees; modifying certain fee
retention by licensed operators; repealing 47 O.S.
2021, Section 1132.5, which relates to additional
registration fees; providing an effective date; and
declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 47 O.S. 2021, Section 2-147, is
amended to read as follows:

Section 2-147. A. There is hereby created in the State
Treasury a fund to be designated as the "State Public Safety Fund".
The fund shall be subject to legislative appropriation and shall
consist of revenues deposited to such fund by Section 1113.2 of

1 Title 47 of the Oklahoma Statutes and of such other revenues as may
2 be provided by law.

3 B. The State Public Safety Fund shall be utilized by the
4 Legislature through appropriations to support public safety ~~in~~
5 ~~Oklahoma~~ and the services offered by Service Oklahoma.

6 SECTION 2. AMENDATORY Section 1, Chapter 282, O.S.L.
7 2022 (47 O.S. Supp. 2022, Section 3-101), is amended to read as
8 follows:

9 Section 3-101. A. ~~Service Oklahoma, a division of the Office~~
10 ~~of Management and Enterprise Services,~~ is hereby created, which
11 shall consist of the Executive Director of Service Oklahoma and such
12 divisions, sections, committees, offices, boards, and positions as
13 may be established by the Executive Director of Service Oklahoma or
14 by law.

15 The applicable powers, duties, and responsibilities exercised by
16 the Driver License Services Division of the Department of Public
17 Safety shall be fully transferred to Service Oklahoma on November 1,
18 2022. All employees of the Department of Public Safety whose duties
19 are transferred under this act shall be transferred to Service
20 Oklahoma.

21 The applicable powers, duties, and responsibilities exercised by
22 the Motor Services Division of the Oklahoma Tax Commission shall be
23 fully transferred to Service Oklahoma on January 1, 2023. All
24

1 employees of the Oklahoma Tax Commission whose duties are
2 transferred under this act shall be transferred to Service Oklahoma.

3 B. 1. Beginning November 1, 2023, Service Oklahoma shall cease
4 to be part of or a division of the Office of Management and
5 Enterprise Services and shall be deemed to be a separate and
6 distinct agency, to be known as Service Oklahoma. Service Oklahoma
7 and the Director of Service Oklahoma shall continue to exercise
8 their statutory powers, duties, and contractual responsibilities.
9 All records, property, equipment, assets, monies, financial
10 interests, liabilities, matters pending, and funds of the division
11 shall be transferred to Service Oklahoma.

12 2. Service Oklahoma shall succeed to any contractual rights or
13 responsibilities incurred by the Office of Management and Enterprise
14 Services pertaining to licensed operators.

15 3. Rules promulgated by the Office of Management and Enterprise
16 Services pertaining to Service Oklahoma that are in effect on the
17 effective date of this act shall be immediately adopted and enforced
18 by the Executive Director of Service Oklahoma. The Executive
19 Director maintains the authority to further promulgate and enforce
20 rules.

21 4. The Office of Management and Enterprise Services and Service
22 Oklahoma may enter into an agreement for the transfer of personnel
23 from the Office of Management and Enterprise Services to Service
24 Oklahoma. No employee shall be transferred to Service Oklahoma

1 except on the freely given written consent of the employee. All
2 employees who are transferred to Service Oklahoma shall not be
3 required to accept a lesser grade or salary than presently received.
4 All employees shall retain leave, sick, and annual time earned, and
5 any retirement and longevity benefits which have accrued during
6 their tenure with the Office of Management and Enterprise Services.
7 The transfer of personnel between the state agencies shall be
8 coordinated with the Office of Management and Enterprise Services.

9 5. The expenses incurred by Service Oklahoma as a result of the
10 transfer required by this subsection shall be paid by Service
11 Oklahoma.

12 6. The division within the Department known as Service Oklahoma
13 shall be abolished by the Office of Management and Enterprise
14 Services after the transfer has been completed.

15 7. The Office of Management and Enterprise Services shall
16 coordinate the transfer of records, property, equipment, assets,
17 funds, allotments, purchase orders, liabilities, outstanding
18 financial obligations, or encumbrances provided for in this
19 subsection.

20 SECTION 3. AMENDATORY Section 3, Chapter 282, O.S.L.
21 2022 (47 O.S. Supp. 2022, Section 3-103), is amended to read as
22 follows:

23 Section 3-103. A. The Executive Director of Service Oklahoma
24 shall be appointed by the Governor with the advice and consent of

1 the Senate. The Executive Director shall serve at the pleasure of
2 the Governor and may be removed or replaced without cause.
3 Compensation for the Executive Director shall be determined pursuant
4 to Section 3601.2 of Title 74 of the Oklahoma Statutes. The
5 Executive Director may be removed from office by a two-thirds (2/3)
6 vote of the members elected to and constituting each chamber of the
7 Oklahoma Legislature.

8 B. The Executive Director of Service Oklahoma shall be the
9 chief executive officer of Service Oklahoma and shall act for
10 Service Oklahoma in all matters except as may be otherwise provided
11 by law. The powers and duties of the Executive Director shall
12 include, but not be limited to:

13 1. Organize Service Oklahoma in a manner to efficiently achieve
14 the objectives of Service Oklahoma;

15 2. Supervise all activities of Service Oklahoma;

16 3. Administer programs and policies of Service Oklahoma;

17 4. Employ, discharge, appoint, contract, and fix duties and
18 compensation of employees at the discretion of the Executive
19 Director;

20 5. Appoint assistants, deputies, officers, investigators,
21 attorneys, and other employees as may be necessary to carry out
22 functions of Service Oklahoma;

23 6. Prescribe rules and regulations for the operation of Service
24 Oklahoma;

1 7. Provide input and recommendations to the Service Oklahoma
2 Operator Board on all matters including branding and physical
3 standardization requirements, customer service metrics, analysis,
4 and improvement processes for licensed operators, and processes for
5 termination of licensed operators for failure to comply with the
6 customer service metrics;

7 8. Establish internal policies and procedures;

8 9. Prescribe and provide suitable forms deemed necessary to
9 carry out the functions of Service Oklahoma and any other laws the
10 enforcement and administration of which are vested in Service
11 Oklahoma;

12 10. Establish such divisions, sections, committees, advisory
13 committees, offices, and positions in Service Oklahoma as the
14 Executive Director deems necessary to carry out the functions of
15 Service Oklahoma;

16 11. Accept and disburse grants, allotments, gifts, devises,
17 bequests, funds, appropriations, and other property made or offered
18 to Service Oklahoma; and

19 12. Create the budget for Service Oklahoma to be submitted to
20 the Legislature each year.

21 C. The salary and other expenses for the Executive Director
22 shall be budgeted as a separate line item through ~~the Office of~~
23 ~~Management and Enterprise Services~~ Service Oklahoma. The operating
24 expenses of Service Oklahoma shall be set by the Executive Director

1 and shall be budgeted as a separate line item through ~~the Office of~~
2 ~~Management and Enterprise Services~~ Service Oklahoma.

3 D. 1. The Executive Director of Service Oklahoma shall direct
4 all purchases, hiring, procurement, and budget for Service Oklahoma
5 ~~of the Office of Management and Enterprise Services~~ and establish,
6 implement, and enforce policies and procedures related thereto,
7 consistent with the Oklahoma Central Purchasing Act. Service
8 Oklahoma and the Executive Director shall be subject to the
9 requirements of the Public Competitive Bidding Act of 1974, the
10 Oklahoma Lighting Energy Conservation Act, and the Public ~~Building~~
11 ~~Construction and Planning~~ Facilities Act.

12 2. The Executive Director of Service Oklahoma, or any employee
13 or agent of the Executive Director of Service Oklahoma acting within
14 the scope of delegated authority, shall have the same power and
15 authority related to purchases, hiring, procurement, and budget for
16 Service Oklahoma as outlined in paragraph 1 of this subsection for
17 Service Oklahoma as the State Purchasing Director has for all
18 acquisitions used or consumed by state agencies as established in
19 the Oklahoma Central Purchasing Act. Such authority shall,
20 consistent with the authority granted to the State Purchasing
21 Director ~~pursuant to Section 85.10 of Title 74 of the Oklahoma~~
22 ~~Statutes~~, include the power to designate financial or proprietary
23 information submitted by a bidder confidential and reject all
24 requests to disclose the information so designated, if the Executive

1 Director of Service Oklahoma requires the bidder to submit the
2 financial or proprietary information with a bid, proposal, or
3 quotation.

4 E. Service Oklahoma shall determine the compensation to be
5 retained by licensed operators.

6 1. Before the last day in September in every even-numbered
7 year, Service Oklahoma shall review the compensation paid to
8 licensed operators and, if necessary, change the compensation.
9 Service Oklahoma shall engage an independent third party to evaluate
10 the compensation paid to licensed operators who shall provide any
11 recommendations no later than November 1 in the even-numbered year.
12 Any recommended change in licensed operator compensation shall be
13 finalized by Service Oklahoma no later than the third Tuesday of
14 November in the even-numbered year. Notice of such recommendation
15 shall be provided to the Governor, the President Pro Tempore and the
16 Chair of the Appropriations Committee of the Senate, and the Speaker
17 and the Chair of the Appropriations and Budget Committee of the
18 House of Representatives.

19 2. Any change in licensed operator compensation, unless
20 rejected or amended as provided by this subsection, shall become
21 effective on July 1 of the following calendar year. Any amendment
22 passed by a majority vote of each house of the Legislature shall
23 become effective as provided by the amendment unless vetoed by the
24 Governor.

1 SECTION 4. AMENDATORY Section 6, Chapter 282, O.S.L.
2 2022 (47 O.S. Supp. 2022, Section 3-106), is amended to read as
3 follows:

4 Section 3-106. A. There is hereby created in the State
5 Treasury a revolving fund for Service Oklahoma to be designated the
6 "Service Oklahoma Revolving Fund". The fund shall be a continuing
7 fund, not subject to fiscal year limitations. All monies accruing
8 to the credit of ~~said~~ the fund are hereby appropriated and shall be
9 budgeted and expended by Service Oklahoma for the restricted
10 purposes of the monies as prescribed by law. Expenditures from ~~said~~
11 the fund shall be made upon warrants issued by the State Treasurer
12 against claims filed as prescribed by law with the Director of the
13 Office of Management and Enterprise Services for approval and
14 payment.

15 B. There is hereby created in the State Treasury a revolving
16 fund for Service Oklahoma to be designated the "Service Oklahoma
17 Reimbursement Fund". The fund shall be a continuing fund, not
18 subject to fiscal year limitations. All monies accruing to the
19 credit of ~~said~~ the fund are hereby appropriated and shall be
20 budgeted and expended by Service Oklahoma for the restricted
21 purposes of the monies as prescribed by law. Expenditures from ~~said~~
22 the fund shall be made upon warrants issued by the State Treasurer
23 against claims filed as prescribed by law with the Director of the
24

1 Office of Management and Enterprise Services for approval and
2 payment.

3 C. There is hereby created in the State Treasury a revolving
4 fund for Service Oklahoma, to be designated the "Service Oklahoma
5 Computer Imaging System Revolving Fund". The fund shall be a
6 continuing fund not subject to fiscal year limitations. All monies
7 accruing to the credit of ~~said~~ the fund are hereby appropriated and
8 shall be budgeted and expended by Service Oklahoma for the purpose
9 of implementing, developing, administering, and maintaining the
10 computer imaging system of Service Oklahoma. Expenditures from ~~said~~
11 the fund shall be made upon warrants issued by the State Treasurer
12 against claims filed as prescribed by law with the Director of the
13 Office of Management and Enterprise Services for approval and
14 payment.

15 D. There is hereby created in the State Treasury a revolving
16 fund for Service Oklahoma to be designated the "Licensed Operator
17 Performance Fund". This fund shall be a continuing fund not subject
18 to fiscal year limitations. All monies accruing to the credit of
19 the fund are hereby appropriated and shall be budgeted and expended
20 by Service Oklahoma for the restricted purposes of the monies as
21 prescribed by law. Expenditures from the fund shall be made upon
22 warrants issued by the State Treasurer against claims filed as
23 prescribed by law with the Director of the Office of Management and
24 Enterprise Services for approval and payment.

1 1. The Licensed Operator Performance Fund shall be distributed
2 to licensed operators in accordance with the applicable metrics
3 determined by Service Oklahoma.

4 2. In the event that excess funds exist in the Licensed
5 Operator Performance Fund after distribution to licensed operators
6 pursuant to this subsection, the remaining funds are authorized to
7 be expended for the purpose of purchasing back a licensed operator
8 license from a licensed operator, pursuant to Section 1140 of this
9 title.

10 SECTION 5. AMENDATORY 47 O.S. 2021, Section 6-101, as
11 last amended by Section 37, Chapter 282, O.S.L. 2022 (47 O.S. Supp.
12 2022, Section 6-101), is amended to read as follows:

13 Section 6-101. A. No person, except those hereinafter
14 expressly exempted in Sections 6-102 and 6-102.1 of this title,
15 shall operate any motor vehicle upon a highway in this state unless
16 the person has a valid Oklahoma driver license for the class of
17 vehicle being operated under the provisions of this title. No
18 person shall be permitted to possess more than one valid license at
19 any time, except as provided in paragraph 4 of subsection F of this
20 section.

21 B. 1. No person shall operate a Class A commercial motor
22 vehicle unless the person is eighteen (18) years of age or older and
23 holds a valid Class A commercial license, except as provided in
24 paragraph 5 of this subsection and subsection F of this section.

1 Any person holding a valid Class A commercial license shall be
2 permitted to operate motor vehicles in Classes A, B, C and D, except
3 as provided for in paragraph 4 of this subsection.

4 2. No person shall operate a Class B commercial motor vehicle
5 unless the person is eighteen (18) years of age or older and holds a
6 valid Class B commercial license, except as provided in paragraph 5
7 of subsection F of this section. Any person holding a valid Class B
8 commercial license shall be permitted to operate motor vehicles in
9 Classes B, C and D, except as provided for in paragraph 4 of this
10 subsection.

11 3. No person shall operate a Class C commercial motor vehicle
12 unless the person is eighteen (18) years of age or older and holds a
13 valid Class C commercial license, except as provided in subsection F
14 of this section. Any person holding a valid Class C commercial
15 license shall be permitted to operate motor vehicles in Classes C
16 and D, except as provided for in paragraph 4 of this subsection.

17 4. No person under twenty-one (21) years of age shall be
18 licensed to operate any motor vehicle which is required to be
19 placarded for hazardous materials pursuant to 49 C.F.R., Part 172,
20 subpart F, except as provided in subsection F of this section;
21 provided, a person eighteen (18) years of age or older may be
22 licensed to operate a farm vehicle which is required to be placarded
23 for hazardous materials pursuant to 49 C.F.R., Part 172, subpart F,
24 except as provided in subsection F of this section.

1 5. A person at least seventeen (17) years of age who
2 successfully completes all examinations required by law may be
3 issued by Service Oklahoma:

4 a. a restricted Class A commercial license which shall
5 grant to the licensee the privilege to operate a Class
6 A or Class B commercial motor vehicle for harvest
7 purposes or a Class D motor vehicle, or

8 b. a restricted Class B commercial license which shall
9 grant to the licensee the privilege to operate a Class
10 B commercial motor vehicle for harvest purposes or a
11 Class D motor vehicle.

12 6. No person shall operate a Class D motor vehicle unless the
13 person is sixteen (16) years of age or older and holds a valid Class
14 D license, except as provided for in Section 6-102 or 6-105 of this
15 title. Any person holding a valid Class D license shall be
16 permitted to operate motor vehicles in Class D only.

17 C. Any person issued a driver license pursuant to this section
18 may exercise the privilege thereby granted upon all streets and
19 highways in this state.

20 D. No person shall operate a motorcycle or motor-driven cycle
21 without having a valid Class A, B, C or D license with a motorcycle
22 endorsement. Except as otherwise provided by law, any new applicant
23 for an original driver license shall be required to successfully
24 complete a written examination, vision examination and driving

1 examination for a motorcycle as prescribed by the Department of
2 Public Safety, in conjunction with Service Oklahoma, and a certified
3 state-approved motorcycle basic rider course approved by the
4 Department, in conjunction with Service Oklahoma, if the applicant
5 is seventeen (17) years of age or younger to be eligible for a
6 motorcycle endorsement thereon. The written examination and driving
7 examination for a motorcycle shall be waived by Service Oklahoma
8 upon verification that the person has successfully completed a
9 certified Motorcycle Safety Foundation rider course approved by the
10 Department, in conjunction with Service Oklahoma.

11 E. Except as otherwise provided by law, any person who lawfully
12 possesses a valid Oklahoma driver license which is eligible for
13 renewal shall be required to successfully complete a written
14 examination, vision examination and driving examination for a
15 motorcycle as prescribed by the Department, in conjunction with
16 Service Oklahoma, and a certified state-approved motorcycle basic
17 rider course approved by the Department, in conjunction with Service
18 Oklahoma, if the person is seventeen (17) years of age or younger to
19 be eligible for a motorcycle endorsement. The written examination
20 and driving examination for a motorcycle shall be waived by Service
21 Oklahoma upon verification that the person has successfully
22 completed a certified Motorcycle Safety Foundation rider course
23 approved by the Department, in conjunction with Service Oklahoma.

24

1 F. 1. Any person eighteen (18) years of age or older may apply
2 for a restricted Class A, B or C commercial learner permit. Service
3 Oklahoma, after the applicant has passed all parts of the
4 examination for a Class D license and has successfully passed all
5 parts of the examination for a Class A, B or C commercial license
6 other than the driving examination, may issue to the applicant a
7 commercial learner permit which shall entitle the person having
8 immediate lawful possession of the commercial learner permit and a
9 valid Oklahoma driver license or provisional driver license pursuant
10 to Section 6-212 of this title to operate a Class A, B or C
11 commercial motor vehicle upon the public highways solely for the
12 purpose of behind-the-wheel training in accordance with rules
13 promulgated by the Department.

14 2. This commercial learner permit shall be issued for a period
15 as provided in Section 6-115 of this title of one hundred eighty
16 (180) days, which may be renewed one time for an additional one
17 hundred eighty (180) days; provided, such commercial learner permit
18 may be suspended, revoked, canceled, denied or disqualified at the
19 discretion of the Department, with notice to Service Oklahoma, for
20 violation of the restrictions, for failing to give the required or
21 correct information on the application or for violation of any
22 traffic laws of this state pertaining to the operation of a motor
23 vehicle. Except as otherwise provided, the lawful possessor of a
24 commercial learner permit who has been issued a commercial learner

1 permit for a minimum of fourteen (14) days may have the restriction
2 requiring an accompanying driver removed by satisfactorily
3 completing a driver's examination; provided, the removal of a
4 restriction shall not authorize the operation of a Class A, B or C
5 commercial motor vehicle if such operation is otherwise prohibited
6 by law.

7 3. No person shall apply for and Service Oklahoma shall not
8 issue an original Class A, B or C driver license until the person
9 has been issued a commercial learner permit and held the permit for
10 at least fourteen (14) days. Any person who currently holds a Class
11 B or C license and who wishes to apply for another class of
12 commercial driver license shall be required to apply for a
13 commercial learner permit and to hold the permit for at least
14 fourteen (14) days before applying for the Class A or B license, as
15 applicable. Any person who currently holds a Class A, B or C
16 license and who wishes to add an endorsement or remove a restriction
17 for which a skills examination is required shall be required to
18 apply for a commercial learner permit and to hold the permit for at
19 least fourteen (14) days before applying for the endorsement.

20 4. A commercial learner permit shall be issued by Service
21 Oklahoma as a separate and unique document which shall be valid only
22 in conjunction with a valid Oklahoma driver license or provisional
23 driver license pursuant to Section 6-212 of this title, both of
24 which shall be in the possession of the person to whom they have

1 | been issued whenever that person is operating a commercial motor
2 | vehicle as provided in this subsection.

3 | 5. After one renewal of a commercial learner permit, as
4 | provided in paragraph 2 of this subsection, a commercial permit
5 | shall not be renewed again. Any person who has held a commercial
6 | learner permit for the initial issuance period and one renewal
7 | period shall not be eligible for and Service Oklahoma shall not
8 | issue another renewal of the permit; provided, the person may
9 | reapply for a new commercial learner permit, as provided for in this
10 | subsection.

11 | G. 1. For purposes of this title:

12 | a. "REAL ID Compliant Driver License" or "Identification
13 | Card" means a driver license or identification card
14 | issued by ~~the State of Oklahoma~~ this state that has
15 | been certified by the United States Department of
16 | Homeland Security (USDHS) as compliant with the
17 | requirements of the REAL ID Act of 2005, Public Law
18 | No. 109-13. A REAL ID Compliant Driver License or
19 | Identification Card and the process through which it
20 | is issued incorporate a variety of security measures
21 | designed to protect the integrity and trustworthiness
22 | of the license or card. A REAL ID Compliant Driver
23 | License or Identification Card will be clearly marked

24 |

1 on the face indicating that it is a compliant
2 document, and

- 3 b. "REAL ID Noncompliant Driver License" or
4 "Identification Card" means a driver license or
5 identification card issued by ~~the State of Oklahoma~~
6 this state that has not been certified by the United
7 States Department of Homeland Security (USDHS) as
8 being compliant with the requirements of the REAL ID
9 Act of 2005. A REAL ID Noncompliant Driver License or
10 Identification Card will be clearly marked on the face
11 indicating that it is not compliant with the federal
12 REAL ID Act of 2005 and is not acceptable for official
13 federal purposes. The driver license or
14 identification card will have a unique design or color
15 indicator that clearly distinguishes it from a

17 6-101 of this title. The Department shall not issue a REAL ID
18 Compliant Identification Card to any applicant who has been
19 previously issued a REAL ID Compliant Driver License or REAL ID

14 Section 6-114. A. 1. In the event that a driver license is
15 lost, destroyed, or requires the updating of any information,
16 restriction or endorsement displayed thereon, the person to whom
17 such license was issued may obtain a replacement thereof pursuant to
18 the provisions of subsection G of Section 6-101 of this title, and
19 upon payment of the required fee. If the person is an alien, the
20 person shall appear before Service Oklahoma or a licensed operator
21 and, after furnishing primary and secondary proofs of identity as
22 required in this section, shall be issued a replacement driver
23 license for a period which does not exceed the lesser of:

24 a. the expiration date of the license being replaced, or

1 b. the expiration date on the valid documentation
2 authorizing the presence of the person in the United
3 States, as required by paragraph 9 of subsection A of
4 Section 6-103 of this title.

5 2. The cost of a replacement license shall be Twenty-five
6 Dollars (\$25.00), of which:

7 a. Two Dollars (\$2.00) shall be apportioned as provided
8 in Section 1104 of this title,

9 b. Three Dollars (\$3.00) shall be remitted to the State
10 Treasurer to be credited to the General Revenue Fund,

11 c. Five Dollars (\$5.00) shall be credited to the
12 Department of Public Safety Computer Imaging System
13 Revolving Fund to be used solely for the purpose of
14 administering and maintaining the computer imaging
15 system of the Department through October 31, 2022.

16 Beginning November 1, 2022, Five Dollars (\$5.00) shall
17 be credited to the Service Oklahoma Computer Imaging
18 System Revolving Fund to be used solely for the
19 purpose of administering and maintaining the computer
20 imaging system of Service Oklahoma,

21 d. Ten Dollars (\$10.00) shall be credited to the
22 Revolving Fund of the Department of Public Safety
23 through October 31, 2022. Beginning November 1, 2022,
24

1 the Ten Dollars (\$10.00) shall be credited to the
2 Service Oklahoma Revolving Fund,

3 e. Three Dollars (\$3.00) shall be deposited to the State
4 Public Safety Fund created in Section 2-147 of this
5 title, and

6 f. (1) Two Dollars (\$2.00) of the fee authorized by this
7 paragraph related to the replacement of a driver
8 license by a licensed operator that does not
9 process approved applications or renewals for
10 REAL ID Compliant Driver Licenses or
11 Identification Cards shall be deposited, in
12 addition to the amount authorized by subparagraph
13 e of this paragraph, to the State Public Safety
14 Fund created in Section 2-147 of this title, or

15 (2) Two Dollars (\$2.00) of the fee authorized by this
16 paragraph related to the replacement of a driver
17 license by a licensed operator that does process
18 approved applications or renewals for REAL ID
19 Compliant Driver Licenses or Identification Cards
20 shall be retained by the licensed operator
21 through June 30, 2023. Beginning July 1, 2023,
22 these monies shall be retained by the licensed
23 operator pursuant to subsection E of Section
24 1141.1 of this title.

1 3. Service Oklahoma shall promulgate rules prescribing forms of
2 primary and secondary identification acceptable for replacement of
3 an Oklahoma driver license; provided, however, a valid and unexpired
4 U.S. passport shall be acceptable as both primary and secondary
5 identification.

6 B. Any person desiring to add or remove an endorsement or
7 endorsements or a restriction or restrictions to any existing driver
8 license, when authorized by Service Oklahoma, shall obtain a
9 replacement license with the endorsement or endorsements or the
10 restriction or restrictions change thereon and shall be charged the
11 fee for a replacement license as provided in subsection A of this
12 section.

13 SECTION 8. AMENDATORY 47 O.S. 2021, Section 6-117, as
14 amended by Section 57, Chapter 282, O.S.L. 2022 (47 O.S. Supp. 2022,
15 Section 6-117), is amended to read as follows:

16 Section 6-117. A. Service Oklahoma shall file every
17 application for a driver license or identification card received by
18 Service Oklahoma and shall maintain suitable indexes containing:

19 1. All applications denied and on each thereof note the reasons
20 for the denial;

21 2. All applications granted;

22 3. The name of every person whose driving privilege has been
23 suspended, revoked, canceled, or disqualified by Service Oklahoma
24 and after each such name note the reasons for the action. Any

1 notation of suspension of the driving privilege of a person for
2 reason of nonpayment of a fine shall be removed from the driving
3 record after the person has paid the fine and the driving privilege
4 of the person is reinstated as provided for by law;

5 4. The county of residence, the name, date of birth, and
6 mailing address of each person residing in that county who is
7 eighteen (18) years of age or older, and who is the holder of a
8 current driver license or a current identification card issued by
9 Service Oklahoma for the purpose of ascertaining names of all
10 persons qualified for jury service as required by Section 18 of
11 Title 38 of the Oklahoma Statutes; and

12 5. The name, driver license number, and mailing address of
13 every person for the purpose of giving notice, if necessary, as
14 required by Section 2-116 of this title.

15 B. Service Oklahoma shall file all collision reports and
16 abstracts of court records of convictions received by it pursuant to
17 the laws of this state and maintain convenient records of the
18 records and reports or make suitable notations in order that an
19 individual record of a person showing the convictions of the person
20 and the traffic collisions in which the person has been involved
21 shall be readily ascertainable and available for the consideration
22 of Service Oklahoma upon any application for a driver license or
23 renewal of a driver license and at other suitable times. Any
24 abstract, index or other entry relating to a driving record

1 according to the licensing authority in another state or a province
2 of Canada may be posted upon the driving record of any resident of
3 this state when notice thereof is received by documentation or by
4 electronic transmission. The individual record of a person shall
5 not include any collision reports and abstracts of court records
6 involving a collision in which the person was not issued a citation
7 or if a citation is issued and the person was not convicted.

8 C. 1. Service Oklahoma may designate and is hereby authorized
9 to prepare under the seal of Service Oklahoma and deliver upon
10 request a copy of any collision report on file with the Department,
11 charging a fee of:

12 a. beginning on July 1, 2011, through June 30, 2013,
13 Fifteen Dollars (\$15.00), of which Eight Dollars
14 (\$8.00) shall be deposited by the Commissioner to the
15 credit of the Department of Public Safety Revolving
16 Fund and, in addition to other purposes authorized by
17 law, the expenditures from that fund of monies derived
18 from the Eight Dollars (\$8.00) pursuant to this
19 subparagraph shall be used to fund any Oklahoma
20 Highway Patrol Trooper Academy provided by the
21 Department of Public Safety. Any remaining funds
22 shall be deposited in an account to be utilized
23 exclusively for future expenses directly related to
24

1 the operation of an Oklahoma Highway Patrol Academy,
2 and

3 b. beginning on July 1, 2013, and any year thereafter,
4 Seven Dollars (\$7.00).

5 However, Service Oklahoma shall not be required to furnish
6 personal information from the collision report which is contrary to
7 the provisions of the Driver's Privacy Protection Act, 18 United
8 States Code, Sections 2721 through 2725.

9 2. Notwithstanding the provisions of paragraph 1 of this
10 subsection, Service Oklahoma is authorized to enter into contracts
11 to supply information regarding vehicles reported to be involved in
12 collisions. For each vehicle, the information shall be limited to
13 that which only describes the vehicle and the collision. Service
14 Oklahoma shall not be required to provide any information regarding
15 the owner or operator of the vehicle or any information which would
16 conflict with Section 2-110 or Section 1109 of this title.

17 D. Service Oklahoma or any licensed operator upon request shall
18 prepare and furnish to any authorized person a Motor Vehicle Report
19 of any person subject to the provisions of the motor vehicle laws of
20 this state. However, Service Oklahoma shall not be required to
21 furnish personal information from a driving record contrary to the
22 provisions of the Driver's Privacy Protection Act, 18 United States
23 Code, Sections 2721 through 2725. The Motor Vehicle Report shall be
24 a summary of the driving record of the person and shall include the

1 enumeration of any motor vehicle collisions, reference to
2 convictions for violations of motor vehicle laws, and any action
3 taken against the privilege of the person to operate a motor
4 vehicle, as shown by the files of Service Oklahoma for the three (3)
5 years preceding the date of the request. The Motor Vehicle Report,
6 to include any record or information associated with the Motor
7 Vehicle Report, shall not be deemed a "public civil record" as
8 defined in Section 18 of Title 22 of the Oklahoma Statutes, and
9 shall not be subject to expungement. Service Oklahoma shall not be
10 required to release to any person, in whole or in part and in any
11 format, a driving index, as described in subsection A of this
12 section, except as otherwise provided for by law. For each Motor
13 Vehicle Report furnished by Service Oklahoma, Service Oklahoma shall
14 collect the sum of Twenty-five Dollars (\$25.00), Twenty Dollars
15 (\$20.00) of which shall be deposited in the General Revenue Fund and
16 Five Dollars (\$5.00) shall be deposited in the Department of Public
17 Safety Revolving Fund through October 31, 2022. Beginning November
18 1, 2022, the Five Dollars (\$5.00) shall be deposited in the Service
19 Oklahoma Revolving Fund. For each Motor Vehicle Report furnished by
20 a licensed operator, the licensed operator shall collect the sum of
21 Twenty-five Dollars (\$25.00), Eighteen Dollars (\$18.00) of which
22 shall be paid to the Oklahoma Tax Commission for deposit in the
23 General Revenue Fund in the State Treasury, Five Dollars (\$5.00)
24 shall be deposited in the Department of Public Safety Revolving Fund

1 and Two Dollars (\$2.00) of which shall be retained by the licensed
2 operator through October 31, 2022. Beginning November 1, 2022, for
3 each Motor Vehicle Report furnished by a licensed operator, the
4 licensed operator shall collect the sum of Twenty-five Dollars
5 (\$25.00), Eighteen Dollars (\$18.00) of which shall be paid to the
6 Oklahoma Tax Commission for deposit in the General Revenue Fund in
7 the State Treasury, Five Dollars (\$5.00) shall be deposited in the
8 Service Oklahoma Revolving Fund, and Two Dollars (\$2.00) shall be
9 retained by the licensed operator through June 30, 2025. Beginning
10 July 1, 2025, Eighteen Dollars (\$18.00) of the fee shall be paid to
11 the Oklahoma Tax Commission for deposit in the General Revenue Fund
12 in the State Treasury, Five Dollars (\$5.00) shall be deposited in
13 the Service Oklahoma Revolving Fund, and Two Dollars (\$2.00) shall
14 be retained by the licensed operator pursuant to subsection E of
15 Section 1141.1 of this title. Persons sixty-five (65) years of age
16 or older shall not be required to pay a fee for their own Motor
17 Vehicle Report furnished by Service Oklahoma or a licensed operator.
18 For purposes of this subsection, a Motor Vehicle Report shall
19 include a report which indicates that no driving record is on file
20 with Service Oklahoma for the information received by Service
21 Oklahoma in the request for the Motor Vehicle Report.

22 E. Service Oklahoma may develop procedures whereby an acting
23 agent of an employer or an employer of a person:

24 1. Who has a Class A, B, C or D driver license; and

1 2. Who operates a commercial, company-owned or personal motor
2 vehicle during the course of business in the course of his or her
3 employment with the employer, may automatically be notified,
4 pursuant to a fee schedule established by Service Oklahoma, should
5 the driving record of a person reflect a traffic conviction in any
6 court or an administrative action by Service Oklahoma which alters
7 the status of the commercial driving privileges of the person, or
8 any other change to the driving status. The notification system
9 shall include electronic delivery of a Motor Vehicle Report at least
10 annually for any employee who is a commercial driver licensee or who
11 operates a commercial motor vehicle, as required by 49 C.F.R.,
12 Section 391.25, or who operates a company-owned or personal motor
13 vehicle during the course of business. All monies received by the
14 Commissioner of Public Safety and the officers and employees of the
15 Department pursuant to this subsection shall be deposited in the
16 Department of Public Safety Restricted Revolving Fund through
17 October 31, 2022. Beginning November 1, 2022, all monies received
18 by the Director of Service Oklahoma and the officers and employees
19 of Service Oklahoma pursuant to this subsection shall be deposited
20 in the Service Oklahoma Revolving Fund. For each Motor Vehicle
21 Report furnished by Service Oklahoma, through the electronic
22 notification system, Service Oklahoma shall collect the sum of
23 Twenty-five Dollars (\$25.00), Eighteen Dollars (\$18.00) of which
24 shall be deposited in the General Revenue Fund in the State

1 Treasury. Five Dollars (\$5.00) shall be deposited in the Department
2 of Public Safety Revolving Fund through October 31, 2022. Beginning
3 November 1, 2022, for each Motor Vehicle Report furnished by Service
4 Oklahoma, through the electronic notification system, Service
5 Oklahoma shall collect the sum of Twenty-five Dollars (\$25.00),
6 Eighteen Dollars (\$18.00) of which shall be deposited in the General
7 Revenue Fund in the State Treasury, Five Dollars (\$5.00) shall be
8 deposited in the Service Oklahoma Revolving Fund. Two Dollars
9 (\$2.00) shall be retained by Service Oklahoma or its authorized
10 agent for the purpose of development and maintenance of the
11 electronic notification system.

12 F. Service Oklahoma is authorized to establish a procedure for
13 reviewing the driving records of state residents who are existing
14 policyholders of any insurance company licensed to operate in this
15 state during specified periods of time and producing a report which
16 identifies the policyholders which have had violation and/or status
17 changes to their driving records during such time period. Service
18 Oklahoma may sell such report to the insurance company or its agent
19 at a fee to be set by Service Oklahoma. Any such report sold by
20 Service Oklahoma shall only consist of information otherwise
21 lawfully obtainable by the insurance company or its agent. The fee
22 shall be sufficient to recover all costs incurred by Service
23 Oklahoma and ensure that there will be no net revenue loss to the
24 state. Such fee shall be deposited in the Department of Public

1 Safety Revolving Fund through October 31, 2022. Beginning November
2 1, 2022, such fee shall be deposited in the Service Oklahoma
3 Revolving Fund.

4 G. All monies received by the Commissioner of Public Safety or
5 Service Oklahoma and the officers and employees of the Department
6 shall be remitted to the State Treasurer to be credited to the
7 General Revenue Fund in the State Treasury except as otherwise
8 provided for by law.

9 SECTION 9. AMENDATORY 47 O.S. 2021, Section 1103, is
10 amended to read as follows:

11 Section 1103. A. It is the intent of the Legislature that the
12 owner or owners of every vehicle in this state shall possess a
13 certificate of title as proof of ownership and that every vehicle
14 shall be registered in the name of the owner or owners thereof. All
15 registration and license fees and mileage taxes imposed by ~~this act~~
16 the Oklahoma Vehicle License and Registration Act shall be for the
17 purpose of providing funds for the general governmental functions of
18 the state, counties, municipalities and schools and for the
19 maintenance and upkeep of the avenues of public access of this
20 state. Such registration and license fees shall apply to every
21 vehicle operated upon, over, along or across any avenue of public
22 access within this state and when paid in full, shall be in lieu of
23 all other taxes, general and local, unless otherwise specifically
24 provided.

1 B. Unless otherwise provided, all fees to be retained by the
2 licensed operator pursuant to the Oklahoma Vehicle License and
3 Registration Act, shall be retained by the licensed operator
4 pursuant to subsection E of Section 1141.1 of this title.

5 1. This section shall apply to subsection H of Section 1105,
6 Section 1115, 1132, 1132.1, 1132.4, 1135.1, 1135.2, 1135.3,
7 subsection H of Section 1140, and Section 1151 of this title, and
8 Section 2103 of Title 68 of the Oklahoma Statutes, beginning July 1,
9 2023.

10 2. This section shall apply to subsections G, L, M, N, and R of
11 Section 1105, Sections 1107.4, 1110, 1116, 1126, 1135.4, 1135.7,
12 1135.9, and 1143 of this title, and Section 4021 of Title 63 of the
13 Oklahoma Statutes, beginning July 1, 2025.

14 SECTION 10. AMENDATORY 47 O.S. 2021, Section 1104, as
15 last amended by Section 1, Chapter 363, O.S.L. 2022 (47 O.S. Supp.
16 2022, Section 1104), is amended to read as follows:

17 Section 1104. A. Unless otherwise provided by law, all fees,
18 taxes and penalties collected or received pursuant to the Oklahoma
19 Vehicle License and Registration Act or Section 1-101 et seq. of
20 this title shall be apportioned and distributed monthly by the
21 Oklahoma Tax Commission in accordance with this section. Service
22 Oklahoma shall provide to the Oklahoma Tax Commission monthly
23 reports of motor vehicle collection information, including, but not
24 limited to, motor vehicle monthly apportionment information,

1 refunds, canceled vouchers, waste tire collections, organ donor
2 program amounts, driver license records, prorate amounts, and sales
3 tax amounts. The reports shall be delivered electronically pursuant
4 to the current calendar year apportionment disbursement schedule
5 provided to Service Oklahoma by the Oklahoma Tax Commission on or
6 before December 1st annually.

7 One percent (1%) of fees collected shall be apportioned to the
8 Licensed Operator Performance Fund created in Section 3-106 of this
9 title, in accordance with the applicable metrics determined by
10 Service Oklahoma.

11 B. 1. The following percentages of the monies referred to in
12 subsection A of this section shall be apportioned to the various
13 school districts in accordance with paragraph 2 of this subsection:

- 14 a. from October 1, 2000, until June 30, 2001, thirty-five
15 and forty-six one-hundredths percent (35.46%),
- 16 b. for the year beginning July 1, 2001, and ending June
17 30, 2002, thirty-five and ninety-one one-hundredths
18 percent (35.91%),
- 19 c. for the year beginning July 1, 2002, through the year
20 ending on June 30, 2015, thirty-six and twenty one-
21 hundredths percent (36.20%),
- 22 d. for the year beginning July 1, 2015, through the year
23 ending on June 30, 2019, thirty-six and twenty one-
24 hundredths percent (36.20%), but in no event shall the

1 amount apportioned in any fiscal year pursuant to this
2 subparagraph exceed the total amount apportioned for
3 the fiscal year ending on June 30, 2015. Any amounts
4 in excess of such limitation shall be placed to the
5 credit of the General Revenue Fund, and

6 e. for the year beginning July 1, 2019, and all
7 subsequent years, thirty-six and twenty one-hundredths
8 percent (36.20%), but in no event shall the amount
9 apportioned in any fiscal year pursuant to this
10 subparagraph exceed the total amount apportioned for
11 the fiscal year ending on June 30, 2015. Any amounts
12 in excess of such limitation shall be placed to the
13 credit of the Rebuilding Oklahoma Access and Driver
14 Safety Fund created in Section 1521 of Title 69 of the
15 Oklahoma Statutes.

16 2. The monies apportioned pursuant to subparagraphs a through e
17 of paragraph 1 of this subsection shall be apportioned to the
18 various school districts so that each district shall receive an
19 amount based upon the proportion that each district's average daily
20 attendance bears to the total average daily attendance of those
21 districts entitled to receive funds pursuant to this section as
22 certified by the State Department of Education.

1 Each district's allocation of funds shall be remitted to the
2 county treasurer of the county wherein the administrative
3 headquarters of the district are located.

4 No district shall be eligible for the funds herein provided
5 unless the district makes an ad valorem tax levy of fifteen (15)
6 mills and maintains nine (9) years of instruction and pursuant to
7 the rules of the State Board of Education, is authorized to maintain
8 ten (10) years of instruction.

9 C. The following percentages of the monies referred to in
10 subsection A of this section shall be remitted to the State
11 Treasurer to be credited to the General Revenue Fund of the State
12 Treasury:

13 1. From October 1, 2000, until June 30, 2001, forty-five and
14 ninety-seven one-hundredths percent (45.97%);

15 2. For the year beginning July 1, 2001, and ending June 30,
16 2002, forty-five and twenty-nine one-hundredths percent (45.29%);

17 3. For the year beginning July 1, 2002, and for the subsequent
18 fiscal years ending June 30, 2007, forty-four and eighty-four one-
19 hundredths percent (44.84%);

20 4. For the year beginning July 1, 2007, and ending June 30,
21 2008, thirty-nine and eighty-four one-hundredths percent (39.84%);

22 5. For the year beginning July 1, 2008, and ending June 30,
23 2009, thirty-four and eighty-four one-hundredths percent (34.84%);
24

1 6. For the period beginning July 1, 2009, and ending December
2 31, 2012, twenty-nine and eighty-four one-hundredths percent
3 (29.84%);

4 7. For the period beginning January 1, 2013, and ending June
5 30, 2013, twenty-nine and thirty-four one-hundredths percent
6 (29.34%);

7 8. For the year beginning July 1, 2013, and ending June 30,
8 2014, twenty-six and eighty-four one-hundredths percent (26.84%);
9 and

10 9. For the year beginning July 1, 2014, through the year ending
11 June 30, 2019, twenty-four and eighty-four one-hundredths percent
12 (24.84%).

13 D. The following percentages of the monies referred to in
14 subsection A of this section shall be remitted to the State
15 Treasurer to be credited to the State Transportation Fund:

16 1. From October 1, 2000, until June 30, 2001, thirty one-
17 hundredths percent (0.30%);

18 2. For the year beginning July 1, 2001, through the year ending
19 on June 30, 2015, thirty-one one-hundredths percent (0.31%);

20 3. For the year beginning July 1, 2015, through the year ending
21 on June 30, 2019, thirty-one one-hundredths percent (0.31%), but in
22 no event shall the amount apportioned in any fiscal year pursuant to
23 this paragraph exceed the total amount apportioned for the fiscal
24 year ending on June 30, 2015. Any amounts in excess of such

1 limitation shall be placed to the credit of the General Revenue
2 Fund; and

3 4. For the year beginning July 1, 2019, and all subsequent
4 years, thirty-one one-hundredths percent (0.31%), but in no event
5 shall the amount apportioned in any fiscal year pursuant to this
6 paragraph exceed the total amount apportioned for the fiscal year
7 ending on June 30, 2015. Any amounts in excess of such limitation
8 shall be placed to the credit of the Rebuilding Oklahoma Access and
9 Driver Safety Fund created in Section 1521 of Title 69 of the
10 Oklahoma Statutes.

11 E. 1. The following percentages of the monies referred to in
12 subsection A of this section shall be apportioned to the various
13 counties as set forth in paragraph 2 of this subsection:

14 a. from October 1, 2000, until June 30, 2001, seven and
15 nine one-hundredths percent (7.09%),

16 b. for the year beginning July 1, 2001, and ending June
17 30, 2002, seven and eighteen one-hundredths percent
18 (7.18%),

19 c. for the year beginning July 1, 2002, through the year
20 ending on June 30, 2015, seven and twenty-four one-
21 hundredths percent (7.24%),

22 d. for the year beginning July 1, 2015, through the year
23 ending on June 30, 2019, seven and twenty-four one-
24 hundredths percent (7.24%), but in no event shall the

1 amount apportioned in any fiscal year pursuant to this
2 subparagraph exceed the total amount apportioned for
3 the fiscal year ending on June 30, 2015. Any amounts
4 in excess of such limitation shall be placed to the
5 credit of the General Revenue Fund, and

6 e. for the year beginning July 1, 2019, and all
7 subsequent years, seven and twenty-four one-hundredths
8 percent (7.24%), but in no event shall the amount
9 apportioned in any fiscal year pursuant to this
10 subparagraph exceed the total amount apportioned for
11 the fiscal year ending on June 30, 2015. Any amounts
12 in excess of such limitation shall be placed to the
13 credit of the Rebuilding Oklahoma Access and Driver
14 Safety Fund created in Section 1521 of Title 69 of the
15 Oklahoma Statutes.

16 2. The monies apportioned pursuant to subparagraphs a through e
17 of paragraph 1 of this subsection shall be apportioned as follows:
18 forty percent (40%) of such sum shall be distributed to the various
19 counties in that proportion which the county road mileage of each
20 county bears to the entire state road mileage as certified by the
21 Transportation Commission and the remaining sixty percent (60%) of
22 such sum shall be distributed to the various counties on the basis
23 which the population and area of each county bears to the total
24 population and area of the state. The population shall be as shown

1 by the last Federal Decennial Census or the most recent annual
2 estimate provided by the United States Bureau of the Census. The
3 funds shall be used for the purpose of constructing and maintaining
4 county highways; provided, however, the county treasurer may deposit
5 so much of the funds in the sinking fund as may be necessary for the
6 retirement of interest and annual accrual of indebtedness created by
7 the issuance of county or township bonds for road purposes. Such
8 deposits to the sinking fund shall not exceed forty percent (40%) of
9 the funds allocated to a county pursuant to this paragraph.

10 F. 1. The following percentages of the monies referred to in
11 subsection A of this section shall be remitted to the county
12 treasurers of the respective counties and by them deposited in a
13 separate special revenue fund to be used by the county commissioners
14 in accordance with paragraph 2 of this subsection:

15 a. from October 1, 2000, until June 30, 2001, two and
16 fifty-three one-hundredths percent (2.53%),

7 e. for the year beginning July 1, 2019, and all

24 to this paragraph shall be limited as follows:

15 Title 69 of the Oklahoma Statutes.

16 N. Monies allocated to counties by this section may be
17 estimated by the county excise board in the budget for the county as
18 anticipated revenue to the extent of ninety percent (90%) of the
19 previous year's income from such source; provided, not more than
20 fifteen percent (15%) can be encumbered during any month.

21 O. Notwithstanding any other provisions of this section, for
22 the fiscal year beginning July 1, 2003, the first One Hundred

3 SECTION 11. AMENDATORY 47 O.S. 2021, Section 1135.5, as
4 last amended by Section 23 of Enrolled Senate Bill No. 782 of the

6 Section 1135.5), is amended to read as follows:

7 Section 1135.5. A. Service Oklahoma is hereby authorized to
8 design and issue appropriate official special license plates to
9 persons wishing to demonstrate support and provide financial
10 assistance as provided by this section.

11 Special license plates shall not be transferred to any other
12 person but shall be removed from the vehicle upon transfer of
13 ownership and retained. The special license plate may then be used
14 on another vehicle but only after such other vehicle has been
15 registered for the current year with a licensed operator.

16 Special license plates shall be renewed each year by Service
17 Oklahoma or a licensed operator, unless authorized by Service
18 Oklahoma to be renewed for a period greater than one (1) year.
19 Service Oklahoma shall notify by mail all persons issued special
20 license plates. The notice shall contain all necessary information
21 and shall contain instructions for the renewal procedure upon
22 presentation to a licensed operator or Service Oklahoma. The
23 license plates shall be issued on a staggered system.

24

1 Service Oklahoma is hereby directed to develop and implement a
2 system whereby licensed operators are permitted to accept
3 applications for special license plates authorized under this
4 section. The licensed operator shall confirm the applicant's
5 eligibility, if applicable, collect and deposit any amount
6 specifically authorized by law, accept and process the necessary
7 information directly into such system and generate a receipt
8 accordingly. For performance of these duties, licensed operators
9 shall retain the fee provided in Section 1141.1 of this title for
10 registration of a motor vehicle through June 30, 2025. ~~The licensed~~
11 ~~operator fees for acceptance of applications and renewals shall be~~
12 ~~paid out of the Tax Commission Reimbursement Fund. Beginning~~
13 ~~January 1, 2023, Through June 30, 2025,~~ the licensed operator fees
14 for acceptance of applications and renewals shall be paid out of the
15 Service Oklahoma Reimbursement Fund. Beginning July 1, 2023, fees
16 shall be retained by the licensed operator pursuant to subsection E
17 of Section 1141.1 of this title.

18 If fewer than one hundred of any type of special license plates
19 authorized prior to January 1, 2004, are issued prior to January 1,
20 2006, Service Oklahoma shall discontinue issuance and renewal of
21 that type of special license plate. Any such authorized special
22 license plate registrant shall be allowed to display the license
23 plate upon the designated vehicle until the registration expiration
24

1 date. After such time the expired special license plate shall be
2 removed from the vehicle.

3 For special license plates authorized on or after July 1, 2004,
4 no special license plates shall be developed or issued by Service
5 Oklahoma until Service Oklahoma receives one hundred prepaid
6 applications therefor. The prepaid applications must be received by
7 Service Oklahoma within one hundred eighty (180) days of the
8 effective date of the authorization or the authority to issue shall
9 be null and void. In the event one hundred prepaid applications are
10 not received by Service Oklahoma within such prescribed time period
11 any payment so received shall be refunded accordingly.

12 B. The special license plates provided by this section are as
13 follows:

14 1. University or College Supporter License Plate - such plates
15 shall be designed and issued to any person wishing to demonstrate
16 support to any state-supported or private university or college. As
17 provided in this section, an amount of the fee collected shall be
18 apportioned as provided in Section 1104.1 of this title;

19 2. Environmental Awareness License Plate - such plates shall be
20 designed, subject to the criteria to be presented to Service
21 Oklahoma by the Department of Environmental Quality in consultation
22 with the Oklahoma Arts Council, and issued to any person wishing to
23 demonstrate support to implement the statewide general public
24 Environmental Education Program created pursuant to the provisions

1 of the Oklahoma Environmental Quality Code. Such plates shall be
2 designed and issued to any person in any combination of numbers and
3 letters from one to a maximum of seven, as for personalized license
4 plates. A dealer's license plate issued pursuant to Section 1116.1
5 or 1128 of this title may be designated an Environmental Awareness
6 License Plate upon payment of the fee imposed by this section and
7 any other registration fees required by the Oklahoma Vehicle License
8 and Registration Act. As provided in this section, an amount of the
9 fee collected shall be apportioned pursuant to Section 1104.2 of
10 this title;

11 3. Firefighter License Plate - such plates shall be designed
12 for any career or retired firefighter, volunteer or paid.
13 Firefighters may apply for firefighter plates for up to four
14 vehicles with a rated capacity of one (1) ton or less or for a
15 motorcycle upon proof of a fire department membership by either an
16 identification card or letter from the chief of the fire department.
17 Retirees who are eligible for such plates shall provide proof of
18 eligibility upon initial application, but shall not be required to
19 provide proof of eligibility annually. The surviving spouse of any
20 deceased firefighter, if the spouse has not since remarried, may
21 apply for a firefighter license plate for one vehicle with a rated
22 carrying capacity of one (1) ton or less or for a motorcycle upon
23 proof that the deceased firefighter was a member of a fire
24 department by either an identification card or letter from the chief

1 of the fire department. The license plate shall be designed in
2 consultation with the Oklahoma State Firefighters Association.

3 As provided in this section, an amount of the fee collected
4 shall be deposited to the Oklahoma State Firemen's Museum Building &
5 Memorial Fund for support of the Oklahoma State Firefighters Museum
6 and the Oklahoma Fallen and Living Firefighters Memorial;

7 4. Wildlife Conservation License Plate - such plates shall be
8 designed, subject to the criteria to be presented to Service
9 Oklahoma by the Department of Wildlife Conservation in consultation
10 with the Oklahoma Arts Council, and issued to any person wishing to
11 demonstrate support for wildlife conservation in this state through
12 the Wildlife Diversity Fund, provided for in Section 3-310 of Title
13 29 of the Oklahoma Statutes. Such plates may be designed and issued
14 to any person as for personalized license plates.

15 As provided in this section, an amount of the fee collected
16 shall be apportioned pursuant to subsection D of Section 3-310 of
17 Title 29 of the Oklahoma Statutes;

18 5. Child Abuse Prevention License Plate - such plates shall be
19 designed, subject to the criteria to be presented to Service
20 Oklahoma by the Office of Child Abuse Prevention in the State
21 Department of Health and the Child Abuse Prevention Action
22 Committee, and issued to any person wishing to demonstrate support
23 for the prevention of child abuse.

24

1 As provided in this section, an amount of the fee collected
2 shall be deposited in the Child Abuse Prevention Fund;

3 6. United States Olympic and Paralympic Committee Supporter
4 License Plate - such plates shall be designed and issued to any
5 person wishing to demonstrate support for the United States Olympic
6 and Paralympic Committee. The plates shall be issued to any person
7 in any combination of numbers and letters from one to a maximum of
8 seven, as for personalized license plates. The plate shall contain
9 the official United States Olympic and Paralympic Committee logo.
10 Service Oklahoma shall be authorized, if necessary, to enter into a
11 licensing agreement with the United States Olympic and Paralympic
12 Committee for any licensing fees which may be required in order to
13 use the United States Olympic and Paralympic Committee logo or
14 design. The licensing agreement shall provide for a payment of not
15 more than Twenty-five Dollars (\$25.00) for each license plate
16 issued;

17 7. Oklahoma History License Plate - such plates shall be
18 designed and issued to any person wishing to demonstrate interest in
19 Oklahoma history. As provided in this section, an amount of the fee
20 collected shall be deposited to the Oklahoma Historical Society
21 Revolving Fund to be used for educational purposes;

22 8. Historic Route 66 License Plate - such:

- 23 a. vehicle plates shall be designed to honor historic
24 Route 66, also known as the "Mother Road". As

1 provided in this section, an amount of the fee
2 collected for each vehicle license plate shall be
3 apportioned to the Oklahoma Historical Society
4 Revolving Fund to be distributed to the Oklahoma Route
5 66 Museum located in Clinton, Oklahoma, and

6 b. motorcycle plates shall be designed in consultation
7 with the Oklahoma Route 66 Association, Inc. Service
8 Oklahoma shall be authorized to enter into a licensing
9 agreement with the Oklahoma Route 66 Association,
10 Inc., for any licensing fees which may be required in
11 order to use the Oklahoma Route 66 Association, Inc.,
12 logo or design. The licensing agreement shall provide
13 for a payment to the Oklahoma Route 66 Association,
14 Inc., of not more than Twenty Dollars (\$20.00) for
15 each motorcycle license plate issued;

16 9. Heart of the Heartland License Plate - such plates shall be
17 designed and issued to any person wishing to honor the victims of
18 the terrorist bombing attack on the Alfred P. Murrah Federal
19 Building in downtown Oklahoma City on April 19, 1995. As provided
20 in this section, an amount of the fee collected shall be deposited
21 in the Heart of the Heartland Scholarship Fund, as established in
22 Section 2282 of Title 70 of the Oklahoma Statutes;

23 10. Emergency Medical Technician License Plate - such plates
24 shall be designed and issued to any person who is an emergency

1 medical technician. Such persons may apply for an emergency medical
2 technician license plate for each vehicle with a rated carrying
3 capacity of one (1) ton or less upon proof of an emergency medical
4 technician's license. The license plate shall be designed in
5 consultation with the Oklahoma Emergency Medical Technicians
6 Association. As provided in this section, an amount of the fee
7 collected shall be apportioned to the Emergency Medical Personnel
8 Death Benefit Revolving Fund created in Section 1-2505.2 of Title 63
9 of the Oklahoma Statutes;

10 11. Fight Breast Cancer License Plate - such plates shall be
11 designed to demonstrate support for the prevention and treatment of
12 breast cancer in this state;

13 12. Crime Victims Awareness License Plate - such plates shall
14 be designed and issued to any person wishing to demonstrate
15 awareness of and support for victims of crimes. The license plates
16 shall be designed in consultation with the Crime Victims
17 Compensation Program. As provided in this section, an amount of the
18 fee collected shall be apportioned to the Attorney General's
19 Revolving Fund for the Office of the Attorney General, which is
20 hereby directed to use such funds to contract with a statewide
21 nonprofit organization to provide services to crime victims;

22 13. Safe Kids Oklahoma License Plate - such plates shall be
23 designed and issued to any person wishing to demonstrate support and
24 awareness of the Safe Kids Oklahoma. The license plate shall be

1 designed in consultation with the Oklahoma Safe Kids Association.
2 As provided in this section, an amount of the fee collected shall be
3 deposited in the Children's Hospital - Oklahoma Safe Kids
4 Association Revolving Fund to be distributed to the Safe Kids
5 Oklahoma program;

6 14. Oklahoma Four-H Club License Plate - such plates shall be
7 designed, subject to criteria to be presented to Service Oklahoma by
8 the Four-H Foundation, and issued to any person wishing to
9 demonstrate support of the Oklahoma Four-H Club. Such plates may be
10 designed and issued to any person as for personalized license
11 plates. As provided in this section, an amount of the fee collected
12 shall be apportioned to the OSU Extension Service License Plate
13 Revolving Fund created in Section 1104.4 of this title;

14 15. Agricultural Awareness License Plate - such plates shall be
15 designed, subject to criteria to be presented to Service Oklahoma,
16 by the Oklahoma Department of Agriculture, Food, and Forestry in
17 consultation with the Oklahoma Arts Council, and issued to any
18 person wishing to demonstrate support of the Department's Ag in the
19 Classroom Education Program. As provided in this section, an amount
20 of the fee collected shall be apportioned as provided in Section
21 1104.3 of this title;

22 16. Oklahoma Statehood Centennial License Plate - such plates
23 shall be designed and issued to any person wishing to commemorate
24 the centennial of Oklahoma's admission to statehood in 1907. The

1 license plates shall be designed in consultation with the Oklahoma
2 Capitol Complex and Centennial Commemoration Commission. As
3 provided in this section, an amount of the fee collected shall be
4 deposited in the Oklahoma Department of Commerce Revolving Fund
5 created in Section 5012 of Title 74 of the Oklahoma Statutes;

6 17. Support Education License Plate - such plates shall be
7 designed, subject to criteria to be presented to Service Oklahoma by
8 the State Department of Education in consultation with the Oklahoma
9 Arts Council, and issued to any person wishing to demonstrate
10 support for education in this state. All licensed operators shall
11 display a sample of the Support Education License plate in the area
12 of the business accessed by the public. Twenty-three Dollars
13 (\$23.00) of the fee collected shall be apportioned as follows:

- 14 a. five percent (5%) shall be deposited to the Education
15 Reform Revolving Fund,
- 16 b. five percent (5%) shall be deposited to the Oklahoma
17 State Regents for Higher Education Revolving Fund,
- 18 c. five percent (5%) shall be deposited to the State
19 Career-Technology Fund, and
- 20 d. eighty-five percent (85%) shall be deposited to the
21 Teachers' Retirement Benefit Fund as set forth in
22 Section 17-108 of Title 70 of the Oklahoma Statutes.

23 However, when the Teachers' Retirement Benefit Fund attains a
24 seventy percent (70%) funded ratio based on an annual actuarial

1 valuation as required by law, the amount of the fee shall be
2 apportioned equally pursuant to subparagraphs a, b and c of this
3 paragraph;

4 18. Retired Oklahoma Highway Patrol Officers License Plate -
5 such plates shall be designed and issued to any retired officer of
6 the Oklahoma Highway Patrol. The license plate shall have the
7 legend "Oklahoma" and shall contain, in the center of the plate, the
8 Highway Patrol Officers patch using the same colors and pattern as
9 used in the patch. Centered on the bottom of the license plate
10 shall be the word "Retired". The letters "TRP" shall be used in
11 combination with three numbers on either side of the insignia or
12 emblem. The color of the letters and numbers shall be brown.
13 Retirees who are eligible for such plates shall provide proof of
14 eligibility upon initial application, but shall not be required to
15 provide proof of eligibility annually. The surviving spouse of any
16 deceased retired officer of the Oklahoma Highway Patrol, if the
17 spouse has not since remarried, or if remarried, the remarriage is
18 terminated by death, divorce, or annulment, may apply for a Retired
19 Oklahoma Highway Patrol Officers license plate. As provided in this
20 section, an amount of the fee collected shall be deposited into the
21 Oklahoma Law Enforcement Retirement Fund;

22 19. Boy Scouts of America Supporter License Plate - such plates
23 shall be designed and issued to any person wishing to demonstrate
24 support for the Boy Scouts of America. The plates shall be issued

1 to any person in any combination of numbers and letters from one to
2 a maximum of seven, as for personalized license plates. The plate
3 shall contain the official Boy Scouts of America logo. Service
4 Oklahoma shall be authorized, if necessary, to enter into a
5 licensing agreement with the Boy Scouts of America for any licensing
6 fees which may be required in order to use the Boy Scouts of America
7 logo or design. The licensing agreement shall provide for a payment
8 to the Boy Scouts of America of not more than Twenty Dollars
9 (\$20.00) for each license plate issued;

10 20. Urban Forestry and Beautification License Plate - such
11 plates shall be designed, subject to criteria to be presented to
12 Service Oklahoma, by the Oklahoma Department of Agriculture, Food,
13 and Forestry in consultation with nonprofit organizations in this
14 state that develop and operate programs to encourage urban forestry
15 and beautification, and issued to any person wishing to demonstrate
16 support of such programs. As provided in this section, an amount of
17 the fee collected shall be apportioned as provided in Section 1104.5
18 of this title;

19 21. Oklahoma State Parks Supporter License Plate - such plates
20 shall be designed, subject to criteria to be presented to Serve
21 Oklahoma by the Oklahoma Tourism and Recreation Department, and
22 issued to any person wishing to demonstrate support for the Oklahoma
23 state parks system. Twenty-three Dollars (\$23.00) of the fee
24 collected shall be deposited in the Oklahoma Tourism and Recreation

1 Department Revolving Fund. Such money shall be designated for and
2 may only be expended for the support of Oklahoma state parks;

3 22. Adoption Creates Families License Plate - such plates shall
4 be issued to any person wishing to demonstrate support of pregnant
5 women who are committed to placing their children for adoption and
6 wishing to provide assistance to guardians, adoptive parents and
7 other created families to assist in the adoption and placement of
8 children in permanent, safe homes. The license plates shall be
9 designed and final terminology delivered in consultation with the
10 Oklahoma Adoption Coalition and the Department of Human Services.
11 Twenty-five Dollars (\$25.00) of the fee collected shall be deposited
12 in a revolving fund established in the State Treasury for and to be
13 used by the Department of Human Services for the implementation of
14 the Investing in Stronger Oklahoma Families Act specifically for
15 created families;

16 23. Choose Life License Plate - such plates shall be designed,
17 subject to criteria presented to Service Oklahoma, by Choose Life
18 America, Inc., and issued to any person who wishes to demonstrate
19 support of organizations that encourage adoption as a positive
20 choice for women with unplanned pregnancies. As provided in this
21 section, an amount of the fee collected shall be deposited in the
22 Choose Life Assistance Program Revolving Fund established in Section
23 1104.6 of this title;

24

1 24. Future Farmers of America License Plate - such plates shall
2 be designed and issued to persons wishing to demonstrate support for
3 the Oklahoma FFA Association (formerly known as Future Farmers of
4 America). The license plates shall be designed in consultation with
5 the Oklahoma FFA Association Board of Directors. As provided in
6 this section, an amount of the fee collected shall be apportioned as
7 provided in Section 1104.7 of this title;

8 25. Lions Club License Plate - such plates shall be designed
9 and issued to persons wishing to demonstrate support for the Lions
10 Clubs of Oklahoma. The plates shall be issued to any person in any
11 combination of numbers and letters from one to a maximum of seven,
12 as for personalized license plates. The license plates shall be
13 designed in consultation with the Oklahoma Lions Service Foundation
14 and shall contain the official logo of the International Association
15 of Lions Clubs. Service Oklahoma shall be authorized to enter into
16 a licensing agreement with the Oklahoma Lions Service Foundation.
17 The licensing agreement shall provide for a payment to the Oklahoma
18 Lions Service Foundation of not more than Ten Dollars (\$10.00) for
19 each license plate issued;

20 26. Color Oklahoma License Plate - such plates shall be
21 designed, subject to criteria to be presented to Service Oklahoma by
22 the Oklahoma Native Plant Society, and issued to any person wishing
23 to demonstrate support for preserving and planting wildflowers and
24 native plants in this state and to promote Oklahoma's wildflower

1 heritage through education. As provided in this section, an amount
2 of the fee collected shall be apportioned as provided in Section
3 1104.8 of this title;

4 27. Girl Scouts of the United States of America Supporter
5 License Plate - such plates shall be designed and issued to any
6 person wishing to demonstrate support for the Girl Scouts of the
7 United States of America. The plates shall be issued to any person
8 in any combination of numbers and letters from one to a maximum of
9 seven, as for personalized license plates. The plate shall contain
10 the official Girl Scouts of the United States of America logo.
11 Service Oklahoma shall be authorized, if necessary, to enter into a
12 licensing agreement with the Girl Scouts of the United States of
13 America for any licensing fees which may be required in order to use
14 the Girl Scouts of the United States of America logo or design. The
15 licensing agreement shall provide for a payment to the Magic Empire
16 Council of Girl Scouts, acting on behalf of all Oklahoma Girl Scout
17 councils, of not more than Twenty Dollars (\$20.00) for each license
18 plate issued;

19 28. Oklahoma City Memorial Marathon License Plate - such plates
20 shall be designed and issued to any person wishing to demonstrate
21 support for the Oklahoma City Memorial Marathon. The plate shall be
22 designed in consultation with the Oklahoma City Memorial Marathon.
23 Service Oklahoma shall be authorized to enter into a licensing
24 agreement with the Oklahoma City Memorial Marathon for any licensing

1 fees which may be required in order to use the Oklahoma City
2 Memorial Marathon logo or design. The licensing agreement shall
3 provide for a payment to the Oklahoma City Memorial Marathon of not
4 more than Twenty Dollars (\$20.00) for each license plate issued;

5 29. Oklahoma Scenic Rivers License Plate - such plates shall be
6 designed to demonstrate support for the Grand River Dam Authority.
7 The plates shall be designed in consultation with the Grand River
8 Dam Authority. Twenty-five Dollars (\$25.00) of the fee shall be
9 apportioned to the Grand River Dam Authority;

10 30. Fight Cancer License Plate - such plates shall be designed
11 to demonstrate support for the Oklahoma Central Cancer Registry.
12 The plate shall contain the American Cancer Society logo. The
13 American Cancer Society logo shall be used in accordance with the
14 American Cancer Society's branding guidelines and shall only be
15 utilized to support the Oklahoma Central Cancer Registry. Twenty
16 Dollars (\$20.00) of the fee shall be apportioned to the Oklahoma
17 Central Cancer Registry Revolving Fund;

18 31. Animal Friendly License Plate - such plates shall be
19 designed and issued to any person wishing to demonstrate support for
20 controlling the overpopulation of dogs and cats through educational
21 and sterilization efforts. The plates shall be designed in
22 consultation with the Veterinary Medical Association. Twenty
23 Dollars (\$20.00) of the fee collected shall be designated by the
24 purchaser of the plate to be deposited in the Oklahoma Pet

1 Overpopulation Fund created in Section 2368.13 of Title 68 of the
2 Oklahoma Statutes or the Animal Friendly Revolving Fund created in
3 Section 1104.10 of this title;

4 32. Patriot License Plate - such plates shall be designed in
5 consultation with the Military Department of the State of Oklahoma
6 and issued to any person wishing to demonstrate support for Oklahoma
7 residents who are members of the Oklahoma National Guard and
8 deployed on active duty. The plates shall be issued to any person
9 in any combination of numbers and letters from one to a maximum of
10 seven, as for personalized license plates. As provided in this
11 section, a portion of the fee collected shall be deposited in the
12 Patriot License Plate Revolving Fund created in Section 1104.11 of
13 this title;

14 33. Global War on Terrorism License Plate - such plate shall be
15 designed in consultation with the Military Department of the State
16 of Oklahoma and issued to any person wishing to demonstrate support
17 for Oklahoma residents who are members of the Armed Forces of the
18 United States or Oklahoma National Guard that have served in the
19 Global War on Terrorism. The plate shall be issued to any person in
20 any combination of numbers and letters from one to a maximum of six.
21 As provided in this section, a portion of the fee collected shall be
22 deposited in the Oklahoma National Guard Museum Fund created in
23 Section 235.1 of Title 44 of the Oklahoma Statutes;

24

1 34. Boys and Girls Clubs of America Supporter License Plate -
2 such plates shall be designed and issued to any person wishing to
3 demonstrate support for the Boys and Girls Clubs of America. The
4 plates shall be issued to any person in any combination of numbers
5 and letters from one to a maximum of seven, as for personalized
6 license plates. The plate shall contain the official Boys and Girls
7 Clubs of America logo. Service Oklahoma, if necessary, may enter
8 into a licensing agreement with the Boys and Girls Clubs of America
9 for any licensing fees which may be required in order to use the
10 Boys and Girls Clubs of America logo or design. The licensing
11 agreement shall provide for a payment to the Boys and Girls Clubs of
12 America of not more than Twenty Dollars (\$20.00) for each license
13 plate issued;

14 35. Oklahoma Quarter Horse License Plate - such plates shall be
15 designed and issued to any person wishing to demonstrate support for
16 the American Quarter Horse in this state. The plate shall be
17 designed in consultation with the Oklahoma Quarter Horse
18 Association. As provided in this section, a portion of the fee
19 collected shall be deposited in the Oklahoma Quarter Horse Revolving
20 Fund created in Section 1104.12 of this title;

21 36. Oklahoma Association for the Deaf License Plate - such
22 plates shall be designed in consultation with the Oklahoma
23 Association for the Deaf and issued to any person wishing to
24 demonstrate support for Oklahoma residents who are deaf. The plates

1 shall be issued to any person in any combination of numbers and
2 letters from one to a maximum of seven, as for personalized license
3 plates. As provided in this section, a portion of the fee collected
4 shall be deposited in the Oklahoma Association for the Deaf License
5 Plate Revolving Fund created in Section 1104.15 of this title;

6 37. Oklahoma City Zoo License Plate - such plates shall be
7 issued to any person wishing to demonstrate support for the Oklahoma
8 City Zoo. The license plates shall be designed in consultation with
9 the Oklahoma Zoological Society, Inc. As provided in this section,
10 an amount of the fee collected shall be deposited in the Oklahoma
11 Zoological Society Revolving Fund created in Section 1104.13 of this
12 title;

13 38. March of Dimes License Plate - such plates shall be issued
14 to persons wishing to demonstrate support for the March of Dimes
15 mission to improve the health of babies by preventing birth defects,
16 premature birth and infant mortality. The license plates shall be
17 designed in consultation with the Oklahoma Chapter March of Dimes.
18 As provided in this section, an amount of the fee collected shall be
19 deposited in the Oklahoma Prevent Birth Defects, Premature Birth and
20 Infant Mortality Fund established in Section 1104.14 of this title;

21 39. Support Our Troops Supporter License Plate - such plates
22 shall be designed and issued to any person wishing to demonstrate
23 support for Support Our Troops Incorporated. The plates shall be
24 issued to any person in any combination of numbers and letters from

1 one to a maximum of six. The plate shall contain the official
2 Support Our Troops Incorporated logo which includes the mark
3 "Support Our Troops" across the bottom of the plate. Service
4 Oklahoma, if necessary, may enter into a licensing agreement with
5 Support Our Troops Incorporated for any licensing fees which may be
6 required in order to use the Support Our Troops Incorporated logo or
7 design. The licensing agreement shall provide for a payment to
8 Support Our Troops Incorporated of Twenty-five Dollars (\$25.00) for
9 each license plate issued;

10 40. Folds of Honor Supporter License Plate - such plates shall
11 be authorized to be designed and issued to any person wishing to
12 demonstrate support for the Oklahoma City Chapter of Folds of Honor
13 Incorporated, a nonprofit charitable organization exempt from
14 taxation pursuant to the provisions of the Internal Revenue Code, 26
15 U.S.C., Section 501(c)(3), providing educational scholarships to
16 spouses and children of America's fallen and disabled military
17 service members. The plates shall be issued to any person in any
18 combination of numbers and letters from one to a maximum of six.
19 Such person may apply for a Folds of Honor Supporter license plate
20 for a motorcycle; provided, the license plate for motorcycles may be
21 of similar design to the license plate for motor vehicles or may be
22 a new design in order to meet space requirements for a motorcycle
23 license plate. The plate shall be designed in consultation with the
24 Oklahoma City Chapter of Folds of Honor Incorporated and shall

1 contain the official Folds of Honor Incorporated logo which includes
2 the mark "Folds of Honor" across the bottom of the plate. Service

5 required in order to use the Folds of Honor Incorporated logo or
6 design. The licensing agreement shall provide for a payment to
7 Folds of Honor Incorporated of Twenty-five Dollars (\$25.00) for each
8 license plate issued. Subject to the provisions of subsection A of
9 this section, the Folds of Honor Supporter License Plate is hereby
10 reauthorized effective November 1, 2019;

11 41. Armed Forces Veterans Motorcycle License Plate - such
12 plates shall be designed for use on a motorcycle in consultation
13 with A Brotherhood Aiming Toward Education of Oklahoma, Inc.
14 (ABATE), and issued to any honorably discharged former member of the
15 United States Armed Forces wishing to demonstrate support for the
16 Oklahoma National Guard Museum. Persons applying for such license
17 plate must show proof of past military service. As provided in this
18 section, a portion of the fee collected shall be deposited in the
19 Oklahoma National Guard Museum Fund created in Section 235.1 of
20 Title 44 of the Oklahoma Statutes;

21 42. Buffalo Soldier License Plate - such plates shall be issued
22 to any person wishing to honor and celebrate the history and
23 contribution of the Buffalo Soldiers. The license plates shall be
24 designed in consultation with the Lawton-Fort Sill Chapter of the

1 Buffalo Soldiers 9th and 10th (Horse) Cavalry National Association.
2 As provided in this section, an amount of the fee collected shall be
3 deposited in the Buffalo Soldier License Plate Revolving Fund
4 created in Section 1104.16 of this title;

5 43. Prevent Blindness Oklahoma License Plate - such plates
6 shall be issued to any person wishing to provide financial support
7 for vision screening of school age children in this state. The
8 license plates shall be designed in consultation with Prevent
9 Blindness Oklahoma. As provided in this section, an amount of the
10 fee collected shall be deposited in the Prevent Blindness Oklahoma
11 License Plate Revolving Fund created in Section 1104.17 of this
12 title;

13 44. Oklahoma State Capitol Restoration License Plate - such
14 plates shall be designed and issued to any person wishing to
15 demonstrate support for restoration of the Oklahoma State Capitol
16 building. The license plates shall be designed in consultation with
17 the Friends of the Capitol corporation, created pursuant to Section
18 15.4 of Title 73 of the Oklahoma Statutes and the State Capitol
19 Preservation Commission created pursuant to Section 4102 of Title 74
20 of the Oklahoma Statutes. As provided in this section, an amount of
21 the fee collected shall be deposited in the Oklahoma Friends of the

1 45. Eastern Red Cedar Tree License Plate - such plates shall be
2 designed, subject to criteria to be presented to Service Oklahoma
3 and issued to any person wishing to demonstrate support for the
4 removal of Eastern Redcedar trees from lands in the state and to
5 develop marketable uses for the harvested trees. The license plate
6 shall be designed in consultation with the Oklahoma Department of
7 Agriculture, Food, and Forestry. Twenty-three Dollars (\$23.00) of
8 the fee collected shall be deposited in the Eastern Redcedar

17 combination of numbers and letters from one to a maximum of six.
18 The license plates shall be designed in consultation with the
19 University of Oklahoma Foundation, Pancreatic Cancer Research Fund.
20 As provided in this section, an amount of the fee collected shall be
21 deposited in the Pancreatic Cancer Research License Plate Revolving
22 Fund created in Section 1104.19 of this title;

23 47. Alzheimer's Research License Plate - such plates shall be
24 issued to any person wishing to provide financial support for the

1 Oklahoma Chapter of the Alzheimer's Association. The license plates
2 shall be designed in consultation with the Oklahoma Chapter of the
3 Alzheimer's Association. As provided in this section, an amount of
4 the fee collected shall be deposited in the Alzheimer's Research
5 License Plate Revolving Fund created in Section 1104.20 of this
6 title;

7 48. Hospice and Palliative Care License Plate - such plates
8 shall be issued to any person wishing to provide financial support
9 for the Oklahoma Hospice and Palliative Care Association. The
10 license plates shall be designed in consultation with the Oklahoma
11 Hospice and Palliative Care Association. As provided in this
12 section, an amount of the fee collected shall be deposited in the
13 Hospice and Palliative Care License Plate Revolving Fund created in
14 Section 1104.21 of this title;

15 49. Juvenile Diabetes Research License Plate - such plates
16 shall be issued to any person wishing to provide financial support
17 for the Oklahoma Chapters of the Juvenile Diabetes Research
18 Foundation. The license plates shall be designed in consultation
19 with the Oklahoma Chapters of the Juvenile Diabetes Research
20 Foundation. As provided in this section, an amount of the fee
21 collected shall be deposited in the Juvenile Diabetes Research

1 50. Deer Creek Schools Foundation License Plate - such plates
2 shall be issued to any person wishing to provide financial support
3 for the Deer Creek Schools Foundation. The license plates shall be
4 designed in consultation with the Deer Creek Schools Foundation.
5 The plates shall be issued to any person in any combination of
6 numbers and letters from one to a maximum of seven, as for
7 personalized license plates. As provided in this section, an amount

11 51. Lupus Awareness and Education License Plate - such plates
12 shall be issued to any person wishing to provide financial support

15 Chapter of the Lupus Foundation of America. As provided in this
16 section, an amount of the fee collected shall be deposited in the

18 1104.24 of this title. Subject to the provisions of subsection A of
19 this section, the Lupus Awareness and Education License Plate is
20 hereby reauthorized effective November 1, 2018;

21 52. Chiefs of Police License Plate - such plates shall be
22 issued to any person wishing to provide financial support for the
23 Oklahoma Association of Chiefs of Police for a vehicle or motorcycle
24 in any combination of numbers and letters from one to a maximum of

1 seven, as for personalized license plates. The license plates shall
2 be designed in consultation with the Oklahoma Association of Chiefs
3 of Police. The license plate for a motorcycle may be of similar
4 design as space permits or a new design in order to meet the space
5 requirements of a motorcycle license plate. Service Oklahoma shall
6 be authorized to enter into a licensing agreement with the Oklahoma
7 Association of Chiefs of Police for any licensing fees which may be
8 required in order to use the association's logo or design. The

21 94. Oklahoma Women Veterans Organization License Plate - such
22 plates shall be designed and issued to any female veteran of any
23 branch of the United States Armed Forces wishing to demonstrate
24 support for the Oklahoma Women Veterans Organization. The license

1 plates shall be designed in consultation with the Oklahoma Women
2 Veterans Organization. Service Oklahoma shall be authorized to
3 enter into a licensing agreement with the Oklahoma Women Veterans
4 Organization for any licensing fees which may be required in order
5 to use the organization's logo or design. The licensing agreement
6 shall provide for a payment to the Oklahoma Women Veterans
7 Organization of not more than Twenty Dollars (\$20.00) for each
8 license plate issued;

9 95. FIRST (For Inspiration and Recognition of Science and
10 Technology) in Oklahoma License Plate - such plates shall be issued
11 to any person wishing to demonstrate support for FIRST in Oklahoma
12 Robotics programs. The license plates shall be designed in
13 consultation with the administration of FIRST in Oklahoma. Service
14 Oklahoma shall be authorized to enter into a licensing agreement
15 with FIRST in Oklahoma for any licensing fees which may be required
16 in order to use the FIRST in Oklahoma logo or design. The licensing
17 agreement shall provide for a payment to FIRST in Oklahoma of not
18 more than Twenty Dollars (\$20.00) for each license plate issued;

19 96. Pittsburg State University License Plate - such plates
20 shall be designed and issued to any person wishing to demonstrate
21 support for the Pittsburg State University. The license plates
22 shall be designed in consultation with Pittsburg State University.
23 Service Oklahoma shall be authorized to enter into a licensing
24 agreement with Pittsburg State University for any licensing fees

1 which may be required in order to use the school foundation's logo
2 or design. The licensing agreement shall provide for a payment to
3 the Pittsburg State University of not more than Twenty Dollars
4 (\$20.00) for each license plate issued;

5 97. Greenwood Historical District License Plate - such plates
6 shall be issued to persons wishing to demonstrate support for the
7 Tulsa Juneteenth Festival held in the Greenwood Historical District
8 in Tulsa, Oklahoma. The plates shall be issued to any person in any
9 combination of numbers and letters from one to a maximum of seven,
10 as for personalized license plates. The license plates shall be
11 designed in consultation with the Black Wall Street Chamber of
12 Commerce. Service Oklahoma shall be authorized to enter into a
13 licensing agreement with the Tulsa Juneteenth Festival for any
14 licensing fees which may be required in order to use the Festival's
15 logo or design. For each license plate issued, the licensing
16 agreement shall provide for a payment of Twenty-five Dollars
17 (\$25.00) of the fee collected to the Tulsa Juneteenth Festival and
18 an additional Two Dollars (\$2.00) of the fee collected shall be
19 deposited in the Public School Classroom Support Revolving Fund, for
20 expenditure as provided in Section 1-123 of Title 70 of the Oklahoma
21 Statutes;

22 98. Oklahoma Veterans of Foreign Wars Auxiliary Chapters
23 License Plate - such plates shall be designed to honor the Oklahoma
24 Veterans of Foreign Wars Auxiliary Chapters and issued to any

1 resident of this state upon proof of membership in the Oklahoma
2 Veterans of Foreign Wars Auxiliary organization in this state. The
3 license plates shall be designed in consultation with the Oklahoma
4 Veterans of Foreign Wars Auxiliary organization. Service Oklahoma
5 shall be authorized to enter into a licensing agreement with the
6 Oklahoma Veterans of Foreign Wars Auxiliary organization for any
7 licensing fees which may be required in order to use the
8 organization's logo or design. The licensing agreement shall
9 provide for a payment to the Oklahoma Veterans of Foreign Wars
10 Auxiliary organization of not more than Twenty Dollars (\$20.00) for
11 each license plate issued;

12 99. Transportation to Transportation License Plate - such
13 plates shall be designed and issued to persons wishing to support
14 county roads and bridges. The license plates shall be designed in
15 consultation with the Association of County Commissioners of
16 Oklahoma. Twenty Dollars (\$20.00) of the fee collected shall be
17 paid to the county treasurer for the county in which the license
18 plate was purchased to be credited to the county highway fund
19 created pursuant to Section 1503 of Title 69 of the Oklahoma
20 Statutes;

21 100. Blue Star Mothers License Plate - such plates shall be
22 designed and issued to any person showing proof of membership in an
23 Oklahoma Chapter of Blue Star Mothers of America, Inc. The license
24 plates shall be designed in consultation with Blue Star Mothers of

1 America, Inc., Oklahoma Chapter One. Service Oklahoma shall be
2 authorized to enter into a licensing agreement with Blue Star
3 Mothers of America, Inc., Oklahoma Chapter One for any licensing
4 fees which may be required in order to use the Blue Star Mothers of
5 America logo or design. The licensing agreement shall provide for a
6 payment to Blue Star Mothers of America, Inc., Oklahoma Chapter One
7 of not more than Twenty Dollars (\$20.00) for each license plate
8 issued;

9 101. Oklahoma Golf License Plate - such plates shall be
10 designed and issued to any person wishing to demonstrate support for
11 the sport of golf in this state. The license plates shall be
12 designed in consultation with the South Central Section of the
13 Professional Golfers' Association of America and issued to any
14 person wishing to demonstrate support for the sport of golf in this
15 state. Service Oklahoma shall be authorized to enter into a
16 licensing agreement with the South Central Section of the
17 Professional Golfers' Association of America for any licensing fees
18 which may be required in order to use the organization's logo or
19 design. The licensing agreement shall provide for a payment to the
20 South Central Section of the Professional Golfers' Association of
21 America of not more than Twenty Dollars (\$20.00) for each license
22 plate issued;

23 102. Paramedic License Plate - such plates shall be designed
24 and issued to any person who is a paramedic. Such persons may apply

1 for a paramedic license plate for each vehicle with a rated carrying
2 capacity of one (1) ton or less or a motorcycle upon proof of a
3 paramedic license. The license plates shall be designed in
4 consultation with the Oklahoma State University-Oklahoma City
5 Paramedicine program and the Oklahoma Emergency Medical Technicians
6 Association. The letters "PM" shall be placed on the plate followed
7 by four random numbers, or such numbers as requested by such persons
8 applying for the plate. Twenty Dollars (\$20.00) of the fees
9 collected shall be deposited in the Emergency Medical Personnel
10 Death Benefit Revolving Fund created in Section 1-2505.2 of Title 63
11 of the Oklahoma Statutes. Subject to the provisions of subsection A
12 of this section, the Paramedic License Plate is hereby reauthorized
13 effective November 1, 2022;

14 103. National Defense Service Medal License Plate - such plates
15 shall be designed and issued to those persons who have received the
16 National Defense Service Medal and wish to demonstrate support for
17 the Oklahoma Department of Veterans Affairs. The license plates
18 shall be designed in consultation with the Oklahoma Department of
19 Veterans Affairs. Service Oklahoma shall be authorized to enter
20 into a licensing agreement with the Oklahoma Department of Veterans
21 Affairs for any licensing fees which may be required in order to use
22 the Department's logo or design. The licensing agreement shall
23 provide for a payment to the Oklahoma Department of Veterans Affairs
24

1 of not more than Twenty Dollars (\$20.00) for each license plate
2 issued;

3 104. University of Oklahoma RUF/NEKS License Plate - such
4 plates shall be designed and issued to any past or present member of
5 the University of Oklahoma RUF/NEKS upon providing proof of
6 membership in the organization as may be required by Service
7 Oklahoma. The license plates shall be designed in consultation with
8 the University of Oklahoma RUF/NEKS. Service Oklahoma shall be
9 authorized to enter into a licensing agreement with the University
10 of Oklahoma RUF/NEKS for any licensing fees which may be required in
11 order to use the organization's logo or design. The licensing
12 agreement shall provide for a payment to the Mike James RUF/NEKS
13 Memorial Scholarship of not more than Twenty Dollars (\$20.00) for
14 each license plate issued;

15 105. Tulsa Community College License Plate - such plates shall
16 be issued to persons wishing to support Tulsa Community College.
17 The plates shall be designed in consultation with Tulsa Community
18 College. Service Oklahoma shall be authorized to enter into a
19 licensing agreement with Tulsa Community College for any licensing
20 fees which may be required in order to use the organization's logo
21 or design. The licensing agreement shall provide for a payment to
22 Tulsa Community College of not more than Twenty Dollars (\$20.00) for
23 each license plate issued;

24

1 106. Street Kings Car Club License Plate - such plates shall be
2 designed and issued to any person wishing to demonstrate support for
3 the Street Kings Car Club in Guthrie. The license plates shall be
4 designed in consultation with the Street Kings Car Club. Service
5 Oklahoma shall be authorized to enter into a licensing agreement
6 with the Street Kings Car Club for any licensing fees which may be
7 required in order to use the organization's logo or design. The
8 licensing agreement shall provide for a payment to the Street Kings
9 Car Club of not more than Twenty Dollars (\$20.00) for each license
10 plate issued;

11 107. Epilepsy Foundation License Plate - such plates shall be
12 designed and issued to any person wishing to demonstrate support for
13 the Epilepsy Foundation. The license plates shall be designed in
14 consultation with the Epilepsy Foundation of Oklahoma. Service
15 Oklahoma shall be authorized to enter into licensing agreements with
16 the Epilepsy Foundation for any licensing fees which may be required
17 in order to use the organization's logo or design. The licensing
18 agreement shall provide for a payment to the Epilepsy Foundation of
19 not more than Twenty Dollars (\$20.00) for each license plate issued;

20 108. America First License Plate - such plates shall be
21 designed and issued to any person wishing to demonstrate support for
22 the proclamation of "America First". The license plates shall be
23 designed in consultation with Warriors for Freedom and the Honoring
24 America's Warriors Foundations. Service Oklahoma shall be

1 authorized to enter into licensing agreements with the Warriors for
2 Freedom and Honoring America's Warriors Foundations for any
3 licensing fees which may be required in order to use the
4 Foundations' logos or designs. The licensing agreements shall
5 provide for a payment to the Honoring America's Warriors Foundation
6 of not more than Ten Dollars (\$10.00) and a payment to the Warriors
7 for Freedom Foundation of not more than Ten Dollars (\$10.00) for
8 each license plate issued;

9 109. Diabetes Awareness License Plate - such plates shall be
10 designed and issued to any person wishing to provide financial
11 support for Diabetes Solutions of Oklahoma. The license plates
12 shall be designed in consultation with Diabetes Solutions of
13 Oklahoma. Service Oklahoma shall be authorized to enter into
14 licensing agreements with Diabetes Solutions of Oklahoma for any
15 licensing fees which may be required in order to use the Diabetes
16 Solutions of Oklahoma logos or designs. The licensing agreements
17 shall provide for a deposit to the Diabetes Awareness License Plate
18 Revolving Fund established in Section 1104.33 of this title;

19 110. Alliance of Mental Health Providers of Oklahoma License
20 Plate - such plates shall be designed and issued to any person
21 wishing to demonstrate support for the Alliance of Mental Health
22 Providers of Oklahoma. The license plates shall be designed in
23 consultation with the Alliance of Mental Health Providers of
24 Oklahoma. Service Oklahoma shall be authorized to enter into

1 licensing agreements with the Alliance of Mental Health Providers of
2 Oklahoma for any licensing fees which may be required in order to
3 use the organization's logo or design. The licensing agreement
4 shall provide for a payment to the Alliance of Mental Health
5 Providers of Oklahoma of not more than Twenty Dollars (\$20.00) for
6 each license plate issued; and

7 111. Stillwater Public Schools License Plate - such plates
8 shall be designed and issued to any person wishing to demonstrate
9 support for the Stillwater School District. The license plates
10 shall be designed in consultation with the administration of the
11 Stillwater School District. Service Oklahoma shall be authorized to
12 enter into a licensing agreement with the Stillwater School District
13 for any licensing fees which may be required in order to use the
14 school district's logo or design. The licensing agreement shall
15 provide for a payment to the Stillwater School District of not more
16 than Twenty Dollars (\$20.00) for each license plate issued.

17 C. The fee for such plates shall be Thirty-five Dollars
18 (\$35.00) per year of renewal and shall be in addition to all other
19 registration fees provided by the Oklahoma Vehicle License and
20 Registration Act. The fee shall be apportioned as follows through
21 June 30, 2023:

22 1. Twenty Dollars (\$20.00) per year of renewal or any other
23 amount as provided in this title of the fee shall be apportioned as
24

1 provided or deposited in a fund as specified within the paragraph
2 authorizing the special license plate;

3 2. Eight Dollars (\$8.00) per year of renewal of the fee shall
4 be deposited in the Tax Commission Reimbursement Fund to be used for
5 the administration of the Oklahoma Vehicle License and Registration
6 Act. Beginning January 1, 2023, Eight Dollars (\$8.00) per year of
7 renewal of the fee shall be deposited in the Service Oklahoma
8 Reimbursement Fund to be used for the administration of the Oklahoma
9 Vehicle License and Registration Act; and

10 3. Any remaining amounts of the fee shall be apportioned as
11 provided in Section 1104 of this title.

12 SECTION 12. AMENDATORY 47 O.S. 2021, Section 1140, as
13 amended by Section 174, Chapter 282, O.S.L. 2022 (47 O.S. Supp.
14 2022, Section 1140), is amended to read as follows:

15 Section 1140. A. The Service Oklahoma Operator Board shall
16 adopt rules prescribing minimum qualifications and requirements for
17 locating Service Oklahoma locations and for persons applying for a
18 license to operate a designated Service Oklahoma location. Such
19 qualifications and requirements shall include, but not be limited
20 to, the following:

- 21 1. Necessary job skills and experience;
- 22 2. Minimum office hours;

23

24

- 1 3. Provision for sufficient staffing, equipment, office space
2 and parking to provide maximum efficiency and maximum convenience to
3 the public;
- 4 4. Obtainment of a faithful performance surety bond as provided
5 for by law;
- 6 5. That the applicant has not been convicted of a felony and
7 that no felony charges are pending against the applicant;
- 8 6. That the location specified in the individual's application
9 for a license to operate a designated Service Oklahoma location not
10 be owned by a member of Service Oklahoma or an employee of Service
11 Oklahoma or any person related to a member of Service Oklahoma or an
12 employee of Service Oklahoma within the third degree by
13 consanguinity, marriage, or adoption and that the location not be
14 within a three-mile radius of an existing licensed operator unless
15 the applicant is assuming the location of an operating licensed
16 operator;
- 17 7. That a single website, designated by Service Oklahoma, will
18 be used for the distribution of services provided by Service
19 Oklahoma with motor vehicle services to be fulfilled by licensed
20 operators;
- 21 8. That licensed operators will attend all required training
22 provided by Service Oklahoma; and
- 23 9. That there should be at least one Service Oklahoma location
24 in each county.

1 B. 1. Any person making application to the Service Oklahoma
2 Operator Board for the purpose of obtaining a license to operate a
3 designated Service Oklahoma location shall pay, when submitting the
4 application, a nonrefundable application fee of One Hundred Dollars
5 (\$100.00). All such application fees shall be deposited in the
6 Oklahoma Tax Commission ~~Revolving~~ Fund. Beginning January 1, 2023,
7 all such application fees shall be deposited in the Service Oklahoma
8 Revolving Fund.

9 2. Any person making application to the Service Oklahoma
10 Operator Board for the purpose of obtaining a license to operate a
11 designated Service Oklahoma location must meet standardization and
12 branding requirements established by the Service Oklahoma Operator
13 Board, upon recommendations from Service Oklahoma. Upon approval,
14 the person must either pay a fee to Service Oklahoma for all costs
15 related to meeting the standardization and branding requirements or
16 obtain approval from the Service Oklahoma Operator Board that the
17 location meets all standardization and branding requirements. All
18 such fees shall be deposited in the Service Oklahoma Revolving Fund.
19 The amount of the license fee will be determined by the Service
20 Oklahoma Operator Board. This provision shall not apply to any
21 existing Service Oklahoma location.

22 C. Upon application by a person to serve as a licensed
23 operator, the Service Oklahoma Operator Board is authorized to make
24 a determination whether such person and such location meets the

1 criteria and guidelines established by the Service Oklahoma Operator
2 Board and, if such be the case, may issue a license to operate a
3 designated Service Oklahoma location.

4 D. 1. A licensed operator may be permitted, upon application,
5 to sell or transfer an existing license to operate a designated
6 Service Oklahoma location. Any sale or transfer of a license is
7 subject to approval of the Service Oklahoma Operator Board. In
8 order to sell or transfer an existing licensed operator license, the
9 licensed operator shall meet the following guidelines and
10 requirements:

- 11 a. the licensed operator shall be in good standing with
12 the Service Oklahoma Operator Board,
- 13 b. the licensed operator shall have held a licensed
14 operator license, issued by the Service Oklahoma
15 Operator Board, for a minimum of five (5) years, and
- 16 c. the licensed operator shall provide the Service
17 Oklahoma Operator Board evidence that the proposed
18 buyer or transferee of the licensed operator licensee
19 meets the qualifications and requirements set forth in
20 subsection A of this section, has the ability to meet
21 all financial requirements and terms of any current
22 existing contract between the licensed operator and
23 Service Oklahoma, and agrees to the onboarding and
24 training requirements of Service Oklahoma, as

1 established by Service Oklahoma and the Service
2 Oklahoma Operator Board.

3 2. The purchase price of a licensed operator license shall be
4 agreed upon by the licensed operator and the individual purchasing
5 the license to operate a designated Service Oklahoma location.
6 However, the purchaser or transferee agrees to pay a transfer fee to
7 Service Oklahoma in the amount of three percent (3%) of the last
8 annual gross revenue from fees retained at the Service Oklahoma
9 location to be purchased, not to exceed Fifteen Thousand Dollars
10 (\$15,000.00). The transfer fee shall be deposited in the Service
11 Oklahoma Revolving Fund.

12 3. Upon receipt of the application to sell or transfer an
13 existing licensed operator license, the Service Oklahoma Operator
14 Board will determine whether the licensed operator license may be
15 sold or transferred on the condition that the existing location is
16 in good standing and the new licensee meets the requirements
17 outlined in Section 1140 et seq. of this title.

18 4. The Service Oklahoma Operator Board may, at its discretion,
19 buy back a licensed operator license from a licensed operator who
20 desires to sell or transfer its licensed operator license but has
21 held a licensed operator license issued by Service Oklahoma for less
22 than five (5) years. The purchase price for such a license will be
23 one-half (1/2) times the most recent annual gross revenue from fees
24 retained of that Service Oklahoma location, not to exceed Two

1 Hundred Thousand Dollars (\$200,000.00). The purchase price shall be
2 paid out of the excess funds available in the Licensed Operator
3 Performance Fund, created in Section 3-106 of this title, after
4 distribution to licensed operators, pursuant to Section 3-106 of
5 this title.

6 E. 1. Licensed operators shall be subject to all laws relating
7 to licensed operators and shall be subject to removal for cause by
8 the Service Oklahoma Operator Board. Any action taken by Service
9 Oklahoma to revoke a license shall be pursuant to and in accordance
10 with the provisions of the Administrative Procedures Act. For the
11 purposes of this section, "for cause" shall be defined as follows:

- 12 a. repeated violations of written contracts, rules,
13 regulations and statutes pertaining to licensed
14 operators after written warning by the Service
15 Oklahoma Operator Board and an opportunity to correct
16 such violations,
- 17 b. failure of the licensed operator to promptly remit
18 funds owed to Service Oklahoma upon written demand,
- 19 c. being charged with a felony crime involving dishonesty
20 or moral turpitude,
- 21 d. failure to timely file state and federal income tax
22 returns, or
- 23 e. any act of official misconduct as set forth in Section
24 93 of Title 51 of the Oklahoma Statutes.

1 In the event a license is revoked by the Service Oklahoma
2 Operator Board for cause, the Service Oklahoma location operated by
3 the licensed operator will be permanently closed and the licensed
4 operator shall not be entitled to any compensation.

5 Motor license agents and licensed operators in good standing as
6 of November 1, 2022, shall be exempt from the branding and physical
7 standardization requirements to be established by the Service
8 Oklahoma Operator Board, with the recommendation of the Director of
9 Service Oklahoma.

10 2. A license to operate a designated Service Oklahoma location
11 may be revoked by the Service Oklahoma Operator Board for failure to
12 meet the standards for customer satisfaction established by the
13 Service Oklahoma Operator Board. In the event of revocation, the
14 licensed operator shall sell his or her license to operate a Service
15 Oklahoma location to Service Oklahoma at a rate of one-half (1/2)
16 times the most recent annual gross revenue from fees retained of
17 that Service Oklahoma location, not to exceed Two Hundred Thousand
18 Dollars (\$200,000.00). The purchase price shall be paid out of the
19 excess funds available in the Licensed Operator Performance Fund,
20 created in Section 3-106 of this title, after distribution to
21 licensed operators, pursuant to Section 3-106 of this title.

22 F. All licensed operators shall be licensed by and under the
23 supervision of Service Oklahoma; provided, any agent authorized to
24 issue registrations pursuant to the International Registration Plan

1 shall also be under the supervision of the Corporation Commission,
2 subject to rules promulgated by the Corporation Commission pursuant
3 to the provisions of subsection E of Section 1166 of this title.
4 Service Oklahoma shall be the holder of all licenses and has the
5 right to approve and revoke such licenses. After obtaining a
6 license, any such licensed operator shall furnish and file with
7 Service Oklahoma a bond in such amount as may be fixed by Service
8 Oklahoma. Such licensed operator shall be removable at the will of
9 Service Oklahoma. Such licensed operator shall perform all duties
10 and do such things in the administration of the laws of this state
11 as shall be enjoined upon and required by the Service Oklahoma
12 Operator Board. Provided, Service Oklahoma may operate a Service
13 Oklahoma location in any county where a vacancy occurs, as
14 determined by Service Oklahoma.

15 G. In the event of a vacancy due to the death of a licensed
16 operator, the licensed operator's designee or a licensed operator
17 location employee shall immediately notify Service Oklahoma. A
18 licensed operator may designate an individual to continue to operate
19 the Service Oklahoma location upon the death of the licensed
20 operator. The designee shall apply to obtain a license to operate
21 the vacant licensed operator location with the Service Oklahoma
22 Operator Board within thirty (30) days of the licensed operator's
23 death. In the event that no designee is designated or that the
24 designee fails to apply to be a licensed operator with Service

1 Oklahoma within thirty (30) days, Service Oklahoma may take any and
2 all action it deems appropriate in order to provide for the orderly
3 transition and the maintenance of operations of the Service Oklahoma
4 location, as permitted by law.

5 H. When an application for registration is made with Service
6 Oklahoma, the Corporation Commission or a licensed operator, a
7 registration fee of One Dollar and seventy-five cents (\$1.75) shall
8 be collected for each license plate or decal issued. Such fees
9 shall be in addition to the registration fees on motor vehicles and
10 when an application for registration is made to the licensed
11 operator, such licensed operator shall retain a fee as provided in
12 Section 1141.1 of this title through June 30, 2023. Beginning July
13 1, 2023, the fee shall be retained by the licensed operator pursuant
14 to subsection E of Section 1141.1 of this title. When the fee is
15 paid by a person making application directly with Service Oklahoma
16 or the Corporation Commission, as applicable, the registration fees
17 shall be in the same amount as provided for licensed operators and
18 the fee provided by Section 1141.1 of this title shall be deposited
19 in the Oklahoma Tax Commission ~~Revolving~~ Fund or as provided in
20 Section 1167 of this title, as applicable. Beginning January 1,
21 2023, the fee provided by Section 1141.1 of this title shall be
22 deposited in the Service Oklahoma Revolving Fund or as provided in
23 Section 1167 of this title, as applicable. Service Oklahoma shall
24 prepare schedules of registration fees and charges for titles which

1 shall include the fees for such licensed operators and all fees and
2 charges paid by a person shall be listed separately on the
3 application and registration and totaled on the application and
4 registration. The licensed operators shall charge only such fees as
5 are specifically provided for by law, and all such authorized fees
6 shall be posted in such a manner that any person shall have notice
7 of all fees that are imposed by law.

8 I. Any licensed operator shall be responsible for all costs
9 incurred by Service Oklahoma when relocating an existing Service
10 Oklahoma location. The Service Oklahoma Operator Board may waive
11 payment of such costs in case of unforeseen business or emergency
12 conditions beyond the control of the licensed operator.

13 J. Any existing contracts by or between any motor license agent
14 and the Oklahoma Tax Commission shall be assigned to Service
15 Oklahoma. All existing motor license agents in good standing with
16 the Oklahoma Tax Commission will be offered a subsequent contract
17 from Service Oklahoma to become a licensed operator to take effect
18 on January 1, 2023. The contract between existing motor license
19 agents and Service Oklahoma shall be agreed to no later than
20 December 31, 2022. In the event an existing motor license agent
21 declines to enter into the subsequent contract with Service Oklahoma
22 to become a licensed operator, that motor license agent may continue
23 to conduct business pursuant to the existing contract through
24 December 31, 2025, so long as that motor license agent remains in

1 good standing with Service Oklahoma in accordance with the terms of
2 the existing contract.

3 SECTION 13. AMENDATORY 47 O.S. 2021, Section 1141.1, as
4 last amended by Section 177, Chapter 282, O.S.L. 2022 (47 O.S. Supp.
5 2022, Section 1141.1), is amended to read as follows:

7 retain the following amounts from the taxes and fees collected by

21 2025, Three Dollars and fifty-six cents (\$3.56) for each special
22 license plate issued pursuant to Sections 1135.1 through Section
23 1135.7 of this title;

2 certificate of title issued for boats and motors pursuant to the
3 Oklahoma Statutes;

4 4. For each certificate of registration issued for boats and
5 motors pursuant to the Oklahoma Statutes, an amount determined
6 pursuant to the provisions of subsection B of this section;

7 5. Two Dollars and twenty-five cents (\$2.25) for each
8 certificate of title issued pursuant to the Oklahoma Vehicle License
9 and Registration Act. Provided, the fee retention amount for
10 certificates of title issued pursuant to the provisions of
11 subsection H of Section 1105 of this title, in which an insurer pays
12 the optional twenty-two-dollar-fee amount, is Four Dollars and fifty
13 cents (\$4.50);

14 6. ~~Beginning October 1, 2000, three percent (3%) of the vehicle~~
15 ~~excise tax collected pursuant to Section 2103 of Title 68 of the~~

4 7. Four percent (4%) of the excise tax collected on the
5 transfer of boats and motors pursuant to the Oklahoma Statutes
6 through June 30, 2025;

7 8. Two Dollars (\$2.00) for each driver license, endorsement,
8 identification license, or renewal or duplicate issued pursuant to
9 Section 6-101 et seq. of this title through June 30, 2023;

10 9. Two Dollars (\$2.00) for the recording of security interests
11 as provided in Section 1110 of this title;

12 10. Two Dollars (\$2.00) for each inspection conducted pursuant
13 to subsection L of Section 1105 of this title;

14 11. Three Dollars (\$3.00) for each inspection conducted
15 pursuant to subsection M of Section 1105 of this title;

16 12. One Dollar (\$1.00) for each certificate of ownership filed
17 pursuant to subsection R of Section 1105 of this title;

18 13. One Dollar (\$1.00) for each temporary permit issued
19 pursuant to Section 1124 of this title;

20 14. One Dollar and fifty cents (\$1.50) for processing each
21 proof of financial responsibility, driver license information,
22 insurance verification information, and other additional information
23 as provided in Section 7-602 of this title;

1 15. The mailing fees and registration fees provided in Sections
2 1131 and 1140 of this title;

3 16. The notary fee provided in Section 1143 of this title;

4 17. Three Dollars (\$3.00) for each lien entry form completed
5 and recorded on a certificate of title pursuant to subsection G of
6 Section 1105 of this title;

7 18. Seven Dollars (\$7.00) for each notice of transfer as
8 provided by subsection B of Section 1107.4 of this title;

9 19. Seven Dollars (\$7.00) for each certificate of title or each
10 certificate of registration issued for repossessed vehicles pursuant
11 to Section 1126 of this title;

12 20. Any amount specifically authorized by law to be retained by
13 the licensed operator for the furnishing of a summary of a traffic
14 record;

15 21. Beginning July 1, 2009 and through June 30, 2023, each
16 licensed operator shall also be entitled to a portion of the
17 penalties for delinquent registration or payment of excise tax as
18 provided for in subsection C of Section 1115, subsection F of
19 Section 1132 and subsection C of Section 1151 of this title and of
20 subsection A of Section 2103 of Title 68 of the Oklahoma Statutes;

21 22. Beginning January 1, 2023, each licensed operator shall be
22 entitled to retain Three Dollars and fifty-six cents (\$3.56) for
23 each electric vehicle registered pursuant to the provisions of this
24 act and such amount shall be in addition to any other amount

1 otherwise authorized by this section to be retained with respect to
2 a vehicle through June 30, 2025; and

3 23. Beginning January 1, 2023 and through June 30, 2023, each
4 licensed operator shall be entitled to retain three and twenty-five
5 hundredths percent (3.25%) of the vehicle excise tax collected
6 pursuant to Section 2103 of Title 68 of the Oklahoma Statutes for
7 each electric vehicle but such amount shall not be in addition to
8 any other amount otherwise authorized by this section to be retained
9 with respect to a vehicle.

10 The balance of the funds collected shall be remitted to Service
11 Oklahoma as provided in Section 1142 of this title to be apportioned
12 pursuant to Section 1104 of this title.

13 B. ~~For~~ Through June 30, 2025, each certificate of registration
14 issued for boats and motors, each licensed operator shall be
15 entitled to retain the greater of One Dollar and twenty-five cents
16 (\$1.25) or an amount to be determined by Service Oklahoma according
17 to the provisions of this subsection. At the end of fiscal year
18 1997 and each fiscal year thereafter, Service Oklahoma shall compute
19 the average amount of registration fees for all boats and motors
20 registered in this state during the fiscal year and shall multiply

11 a. licensed operators shall be entitled to retain
12 nineteen percent (19%) of all fees collected related

15 of Section 1132 of this title, subsection A of Section
16 1132.1 of this title, subsection A of Section 1132.4
17 of this title, and subsection H of 1140 of this title,

19 b. licensed operators shall be entitled to retain forty
20 percent (40%) of all fees collected related to the
21 issuance of Class A, Class B, Class C, and Class D
22 driver licenses, permits, and identification cards,
23 including REAL ID Compliant and REAL ID Noncompliant

1 credentials, pursuant to Section 6-101 et seq. of this
2 title.

3 2. All other fees directed by this section shall default back
4 to the apportionment outlined in Section 1104 of this title.

5 SECTION 14. REPEALER 47 O.S. 2021, Section 1132.5, is
6 hereby repealed.

7 SECTION 15. This act shall become effective July 1, 2023.

8 SECTION 16. It being immediately necessary for the preservation
9 of the public peace, health or safety, an emergency is hereby
10 declared to exist, by reason whereof this act shall take effect and
11 be in full force from and after its passage and approval.
