8 An Act relating to the practice of nursing; providing
9 for independent prescriptive authority of Advanced
10 Practice Registered Nurses who meet certain
11 requirements; providing certain construction; stating
12 application criteria; specifying duration of
13 authority; authorizing supervision by Advanced
14 Practice Registered Nurse with independent
15 prescriptive authority who meets certain
16 requirements; authorizing Oklahoma Board of Nursing
17 to prescribe additional qualifications; providing for
18 application approval, denial, reapplication, fees,
19 and independent prescriptive authority revocation;
20 amending 59 O.S. 2021, Section 353.1, as amended by
21 Section 6, Chapter 288, O.S.L. 2022 (59 O.S. Supp.
22 2022, Section 353.1), which relates to definitions
23 used in the Oklahoma Pharmacy Act; modifying and
24 adding definitions; amending 59 O.S. 2021, Section
353.1a, which relates to prescriptive authority of
Advanced Practice Registered Nurses; modifying
prescriptive authority of certain Advanced Practice
Registered Nurses; amending 59 O.S. 2021, Section
567.3a, which relates to definitions used in the
Oklahoma Nursing Practice Act; modifying and adding
definitions; amending 59 O.S. 2021, Section 567.4a,
which relates to prescriptive authority; specifying
authority of the Board to grant prescriptive
authority; directing the Board to promulgate certain
rules; modifying references; conforming language;
clarifying certain educational requirement; amending
59 O.S. 2021, Section 567.5a, which relates to
Advanced Practice Registered Nurse license; providing
for independent prescriptive authority by
endorsement; amending 63 O.S. 2021, Section 2-312, as

1 amended by Section 2, Chapter 184, O.S.L. 2022 (63
2 O.S. Supp. 2022, Section 2-312), which relates to
3 controlled dangerous substances; conforming language
4 relating to supervision requirement; updating
5 statutory language; updating statutory references;
6 providing for codification; and providing an
7 effective date.

8 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

9 SECTION 1. NEW LAW A new section of law to be codified
10 in the Oklahoma Statutes as Section 567.4c of Title 59, unless there
11 is created a duplication in numbering, reads as follows:

12 A. 1. An Advanced Practice Registered Nurse recognized by the
13 Oklahoma Board of Nursing as a Certified Nurse Practitioner,
14 Clinical Nurse Specialist, or Certified Nurse-Midwife who has
15 completed a minimum of two thousand (2,000) hours of practice with
16 prescriptive authority supervised by a physician or a supervising
17 Advanced Practice Registered Nurse may apply to the Oklahoma Board
18 of Nursing for authority to prescribe and order independent of
19 supervision. This paragraph shall not be construed to exclude
20 practice hours with supervised prescriptive authority obtained prior
21 to the effective date of this act from being counted toward the two-
22 thousand-hour requirement of this paragraph.

23 2. The application for independent prescriptive authority shall
24 include proof that the Certified Nurse Practitioner, Clinical Nurse
Specialist, or Certified Nurse-Midwife:

- 1 a. holds a valid, current license in the appropriate
2 Advanced Practice Registered Nurse role issued by the
3 Board and is in good standing with the Board, and
4 b. has completed a minimum of two thousand (2,000) hours
5 of practice with prescriptive authority supervised by
6 a physician or supervising Advanced Practice
7 Registered Nurse.

8 3. Independent prescriptive authority granted under this
9 subsection shall be valid until the expiration of the current
10 license to practice and may be renewed upon application to the Board
11 at the same time and for the same period as the renewal of the
12 license to practice.

13 B. 1. A Certified Nurse Practitioner, Clinical Nurse
14 Specialist, or Certified Nurse-Midwife who has obtained independent
15 prescriptive authority under subsection A of this section and who
16 has completed a minimum of eight thousand (8,000) hours of practice
17 with independent prescriptive authority may serve as a supervising
18 Advanced Practice Registered Nurse.

19 2. Notwithstanding paragraph 1 of this subsection, an Advanced
20 Practice Registered Nurse who has been licensed and in practice for
21 a minimum of five (5) years as of the effective date of this act
22 without a lapse of work, upon obtainment of independent prescriptive
23 authority under subsection A of this section, may serve as a
24 supervising Advanced Practice Registered Nurse.

1 3. The Board may at its discretion prescribe by rule additional
2 qualifications for supervising Advanced Practice Registered Nurses
3 including, but not limited to, qualifications pertaining to the
4 Advanced Practice Registered Nurse role or specialty.

5 C. The Board shall review any application submitted under this
6 section and shall approve or deny the application, stating the
7 reason or reasons for denial, if denied. If denied, the applicant
8 may reapply using the process prescribed by subsection A of this
9 section.

10 D. The Board may suspend or revoke independent prescriptive
11 authority granted under this section for good cause at any time.

12 E. The Board may establish a fee for the review of initial and
13 renewal applications under the provisions of this section.

14 SECTION 2. AMENDATORY 59 O.S. 2021, Section 353.1, as
15 amended by Section 6, Chapter 288, O.S.L. 2022 (59 O.S. Supp. 2022,
16 Section 353.1), is amended to read as follows:

17 Section 353.1. For the purposes of the Oklahoma Pharmacy Act:

18 1. "Accredited program" means those seminars, classes,
19 meetings, work projects, and other educational courses approved by
20 the ~~Board~~ State Board of Pharmacy for purposes of continuing
21 professional education;

22 2. "Act" means the Oklahoma Pharmacy Act;
23
24

1 3. "Administer" means the direct application of a drug, whether
2 by injection, inhalation, ingestion or any other means, to the body
3 of a patient;

4 4. "Assistant pharmacist" means any person presently licensed
5 as an assistant pharmacist in ~~the State of Oklahoma~~ this state by
6 the Board pursuant to Section 353.10 of this title and for the
7 purposes of the Oklahoma Pharmacy Act shall be considered the same
8 as a pharmacist, except where otherwise specified;

9 5. "Board" or "State Board" means the State Board of Pharmacy;

10 6. "Certify" or "certification of a prescription" means the
11 review of a filled prescription by a licensed pharmacist or a
12 licensed practitioner with dispensing authority to confirm that the
13 medication, labeling and packaging of the filled prescription are
14 accurate and meet all requirements prescribed by state and federal
15 law. For the purposes of this paragraph, "licensed practitioner"
16 shall not include optometrists with dispensing authority;

17 7. "Chemical" means any medicinal substance, whether simple or
18 compound or obtained through the process of the science and art of
19 chemistry, whether of organic or inorganic origin;

20 8. "Compounding" means the combining, admixing, mixing,
21 diluting, pooling, reconstituting or otherwise altering of a drug or
22 bulk drug substance to create a drug. Compounding includes the
23 preparation of drugs or devices in anticipation of prescription drug
24 orders based on routine, regularly observed prescribing patterns;

1 9. "Continuing professional education" means professional,
2 pharmaceutical education in the general areas of the socioeconomic
3 and legal aspects of health care; the properties and actions of
4 drugs and dosage forms; and the etiology, characteristics and
5 therapeutics of the diseased state;

6 10. "Dangerous drug", "legend drug", "prescription drug" or "Rx
7 Only" means a drug:

- 8 a. for human use subject to 21 U.S.C. 353(b)(1), or
- 9 b. is labeled "Prescription Only", or labeled with the
10 following statement: "Caution: Federal law restricts
11 this drug ~~except for~~ to use by or on the order of a
12 licensed veterinarian.";

13 11. "Director" means the Executive Director of the State Board
14 of Pharmacy unless context clearly indicates otherwise;

15 12. "Dispense" or "dispensing" means the interpretation,
16 evaluation, and implementation of a prescription drug order
17 including the preparation and delivery of a drug or device to a
18 patient or a patient's agent in a suitable container appropriately
19 labeled for subsequent administration to, or use by, a patient.
20 Dispense includes sell, distribute, leave with, give away, dispose
21 of, deliver or supply;

22 13. "Dispenser" means a retail pharmacy, hospital pharmacy, a
23 group of chain pharmacies under common ownership and control that do
24 not act as a wholesale distributor, or any other person authorized

1 by law to dispense or administer prescription drugs, and the
2 affiliated warehouses or distributions of such entities under common
3 ownership and control that do not act as a wholesale distributor.
4 For the purposes of this paragraph, ~~"dispenser"~~ dispenser does not
5 mean a person who dispenses only products to be used in animals in
6 accordance with 21 U.S.C. 360b(a) (5);

7 14. "Distribute" or "distribution" means the sale, purchase,
8 trade, delivery, handling, storage, or receipt of a product, and
9 does not include the dispensing of a product pursuant to a
10 prescription executed in accordance with 21 U.S.C. 353(b) (1) or the
11 dispensing of a product approved under 21 U.S.C. 360b(b); provided,
12 taking actual physical possession of a product or title shall not be
13 required;

14 15. "Doctor of Pharmacy" means a person licensed by the Board
15 to engage in the practice of pharmacy. The terms "pharmacist",
16 "D.Ph.", and "Doctor of Pharmacy" shall be interchangeable and shall
17 have the same meaning wherever they appear in the Oklahoma Statutes
18 and the rules promulgated by the Board;

19 16. "Drug outlet" means all manufacturers, repackagers,
20 outsourcing facilities, wholesale distributors, third-party
21 logistics providers, pharmacies, and all other facilities which are
22 engaged in dispensing, delivery, distribution or storage of
23 dangerous drugs;

24

1 17. "Drugs" means all medicinal substances and preparations
2 recognized by the United States ~~Pharmacopoeia~~ Pharmacopeia and
3 National Formulary, or any revision thereof, and all substances and
4 preparations intended for external and/or internal use in the cure,
5 diagnosis, mitigation, treatment or prevention of disease in humans
6 or animals and all substances and preparations, other than food,
7 intended to affect the structure or any function of the body of a
8 human or animals;

9 18. "Drug sample" means a unit of a prescription drug packaged
10 under the authority and responsibility of the manufacturer that is
11 not intended to be sold and is intended to promote the sale of the
12 drug;

13 19. "Durable medical equipment" has the same meaning as
14 provided by ~~Section 2 of this act~~ Section 375.2 of this title;

15 20. "Filled prescription" means a packaged prescription
16 medication to which a label has been affixed which contains such
17 information as is required by the Oklahoma Pharmacy Act;

18 21. "Hospital" means any institution licensed as a hospital by
19 this state for the care and treatment of patients, or a pharmacy
20 operated by the Oklahoma Department of Veterans Affairs;

21 22. "Licensed practitioner" means:

- 22 a. an allopathic physician,
- 23 b. an osteopathic physician,
- 24 c. a podiatric physician,

- 1 d. a dentist,
- 2 e. a veterinarian ~~or~~,
- 3 f. an optometrist, or
- 4 g. a Certified Nurse Practitioner, Clinical Nurse
- 5 Specialist, or Certified Nurse-Midwife who has
- 6 obtained independent prescriptive authority under
- 7 Section 1 of this act,

8 licensed to practice and authorized to prescribe dangerous drugs
9 within the scope of practice of such practitioner;

10 23. "Manufacturer" or "virtual manufacturer" means with respect
11 to a product:

- 12 a. a person that holds an application approved under 21
- 13 U.S.C. 355 or a license issued under 42 U.S.C. 262 for
- 14 such product, or if such product is not the subject of
- 15 an approved application or license, the person who
- 16 manufactured the product,
- 17 b. a co-licensed partner of the person described in
- 18 subparagraph a of this paragraph that obtains the
- 19 product directly from a person described in this
- 20 subparagraph or subparagraph a of this paragraph,
- 21 c. an affiliate of a person described in subparagraph a
- 22 or b of this paragraph who receives the product
- 23 directly from a person described in this subparagraph
- 24 or in subparagraph a or b of this paragraph, or

1 d. a person who contracts with another to manufacture a
2 product;

3 24. "Manufacturing" means the production, preparation,
4 propagation, compounding, conversion or processing of a device or a
5 drug, either directly or indirectly by extraction from substances of
6 natural origin or independently by means of chemical or biological
7 synthesis and includes any packaging or repackaging of the
8 substances or labeling or relabeling of its container, and the
9 promotion and marketing of such drugs or devices. The term
10 ~~"manufacturing"~~ manufacturing also includes the preparation and
11 promotion of commercially available products from bulk compounds for
12 resale by licensed pharmacies, licensed practitioners or other
13 persons;

14 25. "Medical gas" means those gases including those in liquid
15 state upon which the manufacturer or distributor has placed one of
16 several cautions, such as "Rx Only", in compliance with federal law;

17 26. "Medical gas order" means an order for medical gas issued
18 by a licensed prescriber;

19 27. "Medical gas distributor" means a person licensed to
20 distribute, transfer, wholesale, deliver or sell medical gases on
21 drug orders to suppliers or other entities licensed to use,
22 administer or distribute medical gas and may also include a patient
23 or ultimate user;

1 28. "Medical gas supplier" means a person who dispenses medical
2 gases on drug orders only to a patient or ultimate user;

3 29. "Medicine" means any drug or combination of drugs which has
4 the property of curing, preventing, treating, diagnosing or
5 mitigating diseases, or which is used for that purpose;

6 30. "Nonprescription drugs" means medicines or drugs which are
7 sold without a prescription and which are prepackaged for use by the
8 consumer and labeled in accordance with the requirements of the
9 statutes and regulations of this state and the federal government.
10 Such items shall also include medical and dental supplies and
11 bottled or nonbulk chemicals which are sold or offered for sale to
12 the general public if such articles or preparations meet the
13 requirements of the Federal Food, Drug, and Cosmetic Act, 21
14 U.S.C.A., Section 321 et seq.;

15 31. "Outsourcing facility" including "virtual outsourcing
16 facility" means a facility at one geographic location or address
17 that:

- 18 a. is engaged in the compounding of sterile drugs,
- 19 b. has elected to register as an outsourcing facility,
- 20 and
- 21 c. complies with all requirements of 21 U.S.C. 353b;

22 32. "Package" means the smallest individual saleable unit of
23 product for distribution by a manufacturer or repackager that is
24 intended by the manufacturer for ultimate sale to the dispenser of

1 such product. For the purposes of this paragraph, "individual
2 saleable unit" means the smallest container of a product introduced
3 into commerce by the manufacturer or repackager that is intended by
4 the manufacturer or repackager for individual sale to a dispenser;

5 33. "Person" means an individual, partnership, limited
6 liability company, corporation or association, unless the context
7 otherwise requires;

8 34. "Pharmacist-in-charge" or "PIC" means the pharmacist
9 licensed in this state responsible for the management control of a
10 pharmacy and all other aspects of the practice of pharmacy in a
11 licensed pharmacy as defined by Section 353.18 of this title;

12 35. "Pharmacy" means a place regularly licensed by the State
13 Board of Pharmacy in which prescriptions, drugs, medicines,
14 chemicals and poisons are compounded or dispensed or such place
15 where pharmacists practice the profession of pharmacy, or a pharmacy
16 operated by the Oklahoma Department of Veterans Affairs;

17 36. "Pharmacy technician", "technician", "Rx tech", or "tech"
18 means a person issued a Technician permit by the State Board of
19 Pharmacy to assist the pharmacist and perform nonjudgmental,
20 technical, manipulative, non-discretionary functions in the
21 prescription department under the immediate and direct supervision
22 of a pharmacist;

23 37. "Poison" means any substance which when introduced into the
24 body, either directly or by absorption, produces violent, morbid or

1 fatal changes, or which destroys living tissue with which such
2 substance comes into contact;

3 38. "Practice of pharmacy" means:

- 4 a. the interpretation and evaluation of prescription
5 orders,
- 6 b. the compounding, dispensing, administering and
7 labeling of drugs and devices, except labeling by a
8 manufacturer, repackager or distributor of
9 nonprescription drugs and commercially packaged legend
10 drugs and devices,
- 11 c. the participation in drug selection and drug
12 utilization reviews,
- 13 d. the proper and safe storage of drugs and devices and
14 the maintenance of proper records thereof,
- 15 e. the responsibility for advising by counseling and
16 providing information, where professionally necessary
17 or where regulated, of therapeutic values, content,
18 hazards and use of drugs and devices,
- 19 f. the offering or performing of those acts, services,
20 operations or transactions necessary in the conduct,
21 operation, management and control of a pharmacy, or
22 g. the provision of those acts or services that are
23 necessary to provide pharmaceutical care;

24

1 39. "Preparation" means an article which may or may not contain
2 sterile products compounded in a licensed pharmacy pursuant to the
3 order of a licensed prescriber;

4 40. "Prescriber" means a person licensed in this state who is
5 authorized to prescribe dangerous drugs within the scope of practice
6 of the person's profession;

7 41. "Prescription" means and includes any order for drug or
8 medical supplies written or signed, or transmitted by word of mouth,
9 telephone or other means of communication:

10 a. by a licensed prescriber,

11 b. under the supervision of ~~an Oklahoma licensed~~
12 ~~practitioner, an Oklahoma licensed advanced practice~~
13 ~~registered nurse or an Oklahoma licensed~~ a supervising
14 physician, by a physician assistant licensed in this
15 state, or

16 c. (1) under the supervision of a supervising physician
17 or supervising Advanced Practice Registered
18 Nurse, by a Certified Nurse Practitioner,
19 Clinical Nurse Specialist, or Certified Nurse-
20 Midwife licensed in this state who has not
21 obtained independent prescriptive authority under
22 Section 1 of this act, or
23 (2) by a Certified Nurse Practitioner, Clinical Nurse
24 Specialist, or Certified Nurse-Midwife licensed

1 in this state who has obtained independent
2 prescriptive authority under Section 1 of this
3 act, or

4 d. by an Oklahoma licensed wholesaler or distributor as
5 authorized in Section 353.29.1 of this title;

6 42. "Product" means a prescription drug in a finished dosage
7 form for administration to a patient without substantial further
8 manufacturing, such as capsules, tablets, and lyophilized products
9 before reconstitution. "Product" does not include blood components
10 intended for transfusion, radioactive drugs or biologics and medical
11 gas;

12 43. "Repackager", including "virtual repackager", means a
13 person who owns or operates an establishment that repacks and
14 relabels a product or package for further sale or distribution
15 without further transaction;

16 44. "Sterile drug" means a drug that is intended for parenteral
17 administration, an ophthalmic or oral inhalation drug in aqueous
18 format, or a drug that is required to be sterile under state and
19 federal law;

20 45. "Supervising Advanced Practice Registered Nurse" has the
21 same meaning as provided by Section 567.3a of this title;

22 46. "Supervising physician" means an individual holding a
23 current license to practice as a physician from the State Board of
24 Medical Licensure and Supervision, pursuant to the provisions of the

1 Oklahoma Allopathic Medical and Surgical Licensure and Supervision
2 Act, or the State Board of Osteopathic Examiners, pursuant to the
3 provisions of the Oklahoma Osteopathic Medicine Act, who supervises
4 ~~an advanced practice registered nurse~~ a Certified Nurse
5 Practitioner, Clinical Nurse Specialist, or Certified Nurse-Midwife
6 as defined in Section 567.3a of this title who has not obtained
7 independent prescriptive authority under Section 1 of this act,
8 and who is not in training as an intern, resident, or fellow. ~~To be~~
9 ~~eligible to supervise an advanced practice registered nurse, such~~
10 The supervising physician shall remain in compliance with the rules
11 promulgated by the State Board of Medical Licensure and Supervision
12 or the State Board of Osteopathic Examiners;

13 ~~46.~~ 47. "Supportive personnel" means technicians and auxiliary
14 supportive persons who are regularly paid employees of a pharmacy
15 who work and perform tasks in the pharmacy as authorized by Section
16 353.18A of this title;

17 ~~47.~~ 48. "Third-party logistics provider" including "virtual
18 third-party logistics provider" means an entity that provides or
19 coordinates warehousing, or other logistics services of a product in
20 interstate commerce on behalf of a manufacturer, wholesale
21 distributor, or dispenser of a product but does not take ownership
22 of the product, nor have responsibility to direct the sale or
23 disposition of the product. For the purposes of this paragraph,

24

1 "third-party logistics provider" does not include shippers and the
2 United States Postal Service;

3 ~~48.~~ 49. "Wholesale distributor" including "virtual wholesale
4 distributor" means a person other than a manufacturer, a
5 manufacturer's co-licensed partner, a third-party logistics
6 provider, or repackager engaged in wholesale distribution as defined
7 by 21 U.S.C. 353(e) (4) as amended by the Drug Supply Chain Security
8 Act;

9 ~~49.~~ 50. "County jail" means a facility operated by a county for
10 the physical detention and correction of persons charged with, or
11 convicted of, criminal offenses or ordinance violations or persons
12 found guilty of civil or criminal contempt;

13 ~~50.~~ 51. "State correctional facility" means a facility or
14 institution that houses a prisoner population under the jurisdiction
15 of the Department of Corrections;

16 ~~51.~~ 52. "Unit dose package" means a package that contains a
17 single dose drug with the name, strength, control number, and
18 expiration date of that drug on the label; and

19 ~~52.~~ 53. "Unit of issue package" means a package that provides
20 multiple doses of the same drug, but each drug is individually
21 separated and includes the name, lot number, and expiration date.

22 SECTION 3. AMENDATORY 59 O.S. 2021, Section 353.1a, is
23 amended to read as follows:

24

1 Section 353.1a. A. ~~Prescribing~~ 1. Prescriptive authority
2 shall be allowed, under the medical direction of a supervising
3 physician or supervising Advanced Practice Registered Nurse, for ~~an~~
4 ~~advanced practice nurse~~ a licensed Advanced Practice Registered
5 Nurse recognized by the Oklahoma Board of Nursing ~~in one of the~~
6 ~~following categories: advanced registered nurse practitioners,~~
7 ~~clinical nurse specialists, or certified nurse midwives~~ as a
8 Certified Nurse Practitioner, Clinical Nurse Specialist, or
9 Certified Nurse-Midwife who has not obtained independent
10 prescriptive authority under Section 1 of this act.

11 2. Prescriptive authority shall be allowed, independent of the
12 medical direction of a supervising physician or supervising Advanced
13 Practice Registered Nurse, for a licensed Advanced Practice
14 Registered Nurse recognized by the Oklahoma Board of Nursing as a
15 Certified Nurse Practitioner, Clinical Nurse Specialist, or
16 Certified Nurse-Midwife who has obtained independent prescriptive
17 authority under Section 1 of this act.

18 B. The ~~advanced practice nurse~~ Advanced Practice Registered
19 Nurse may write or sign, or transmit by word of mouth, telephone or
20 other means of communication an order for drugs or medical supplies
21 that is intended to be filled, compounded, or dispensed by a
22 pharmacist. The supervising physician or supervising Advanced
23 Practice Registered Nurse, if applicable, and the ~~advanced practice~~
24 ~~nurse~~ prescribing Advanced Practice Registered Nurse shall be

1 identified at the time of origination of the prescription and the
2 name of the ~~advanced practice nurse~~ prescribing Advanced Practice
3 Registered Nurse shall be printed on the prescription label.

4 ~~B.~~ C. Pharmacists may dispense prescriptions for non-controlled
5 prescription drugs authorized by an ~~advanced practice nurse~~ Advanced
6 Practice Registered Nurse or physician assistant, not located in
7 ~~Oklahoma~~ this state, provided that they are licensed in the state in
8 which they are actively prescribing.

9 ~~C.~~ D. 1. Pharmacists may only dispense prescriptions for
10 controlled dangerous substances prescribed by an ~~advanced practice~~
11 ~~nurse or physician assistant~~ Advanced Practice Registered Nurse
12 ~~licensed in the State of Oklahoma and supervised by an Oklahoma-~~
13 ~~licensed practitioner~~ this state who meets the criteria in paragraph
14 1 or 2 of subsection A of this section.

15 2. Pharmacists may only dispense prescriptions for controlled
16 dangerous substances prescribed by a physician assistant licensed in
17 this state and supervised by a supervising physician licensed in
18 this state.

19 SECTION 4. AMENDATORY 59 O.S. 2021, Section 567.3a, is
20 amended to read as follows:

21 Section 567.3a. As used in the Oklahoma Nursing Practice Act:

22 1. "Board" means the Oklahoma Board of Nursing;

23 2. "The practice of nursing" means the performance of services
24 provided for purposes of nursing diagnosis and treatment of human

1 responses to actual or potential health problems consistent with
2 educational preparation. Knowledge and skill are the basis for
3 assessment, analysis, planning, intervention, and evaluation used in
4 the promotion and maintenance of health and nursing management of
5 illness, injury, infirmity, restoration or optimal function, or
6 death with dignity. Practice is based on understanding the human

- i. delegating those nursing tasks as defined in the rules of the Board that may be performed by an advanced unlicensed assistive person;

5. "Advanced Practice Registered Nurse" means a licensed Registered Nurse:

- a. who has completed an advanced practice registered nursing education program in preparation for one of

1 four recognized ~~advanced practice registered nurse~~
2 Advanced Practice Registered Nurse roles,

3 b. who has passed a national certification examination
4 recognized by the Board that measures the ~~advanced~~
5 ~~practice registered nurse~~ Advanced Practice Registered

7 maintains recertification in the role and specialty
8 through a national certification program,

9 c. who has acquired advanced clinical knowledge and
10 skills in preparation for providing both direct and

1 6. Provide any and all other evidence as required by the Board
2 in its rules.

3 C. The Board may issue a license by endorsement to an Advanced
4 Practice Registered Nurse licensed under the laws of another state
5 if the applicant meets the qualifications for licensure in this
6 state. An applicant by endorsement shall:

7 1. Submit a completed written application and appropriate fees
8 as established by the Board;

9 2. Hold a current Registered Nurse license in this state;

10 3. Hold recognition as an Advanced Practice Registered Nurse in
11 a state or territory;

12 4. Have completed an advanced practice registered nursing
13 education program in one of the four roles and a specialty area
14 recognized by the Board. Effective January 1, 2016, the applicant
15 shall have completed an accredited graduate level advanced practice
16 registered nursing education program in at least one of the
17 following population foci: family/individual across the lifespan,
18 adult-gerontology, neonatal, pediatrics, women's health/gender-
19 related, or psychiatric/mental health;

20 5. Be currently certified in an advanced practice specialty
21 certification consistent with educational preparation and by a
22 national certifying body recognized by the Board;

23 6. Meet continued competency requirements as set forth in Board
24 rules; and

1 7. Provide any and all other evidence as required by the Board
2 in its rules.

3 D. The Board may issue prescriptive authority recognition by
4 endorsement to an Advanced Practice Registered Nurse licensed as an
5 APRN-CNP, APRN-CNS, or APRN-CNM under the laws of another state if
6 the applicant meets the requirements set forth in this section. An
7 applicant for prescriptive authority recognition by endorsement
8 shall:

9 1. Submit a completed written application and appropriate fees
10 as established by the Board;

11 2. Hold current Registered Nurse and Advanced Practice
12 Registered Nurse licenses (APRN-CNP, APRN-CNS, or APRN-CNM) in the
13 state;

14 3. Hold current licensure or recognition as an Advanced
15 Practice Registered Nurse in the same role and specialty with
16 prescribing privileges in another state or territory;

17 4. Submit documentation verifying successful completion of a
18 graduate level advanced practice registered nursing education
19 program that included an academic course in pharmacotherapeutic
20 management, and didactic and clinical preparation for prescribing
21 incorporated throughout the program;

22 5. Submit a written statement from an Oklahoma licensed
23 physician or supervising Advanced Practice Registered Nurse
24 supervising prescriptive authority as required by the Board in its

1 rules, or submit documentation that the applicant meets the
2 requirements for independent prescriptive authority under Section 1
3 of this act;

4 6. Meet continued competency requirements as set forth in Board
5 rules; and

6 7. Provide any and all other evidence as required by the Board
7 in its rules.

8 E. An Advanced Practice Registered Nurse license issued under
9 this section shall be renewed concurrently with the registered nurse
10 license, provided that qualifying criteria continue to be met.

11 F. The Board may reinstate a license as set forth in Board
12 rules.

13 SECTION 7. AMENDATORY 63 O.S. 2021, Section 2-312, as
14 amended by Section 2, Chapter 184, O.S.L. 2022 (63 O.S. Supp. 2022,
15 Section 2-312), is amended to read as follows:

16 Section 2-312. A. A physician, podiatrist, optometrist or a
17 dentist who has complied with the registration requirements of the
18 Uniform Controlled Dangerous Substances Act, in good faith and in
19 the course of such person's professional practice only, may
20 prescribe and administer controlled dangerous substances, or may
21 cause the same to be administered by medical or paramedical
22 personnel acting under the direction and supervision of the
23 physician, podiatrist, optometrist or dentist, and only may dispense
24

1 controlled dangerous substances pursuant to the provisions of
2 Sections 355.1 and 355.2 of Title 59 of the Oklahoma Statutes.

3 B. A veterinarian who has complied with the registration
4 requirements of the Uniform Controlled Dangerous Substances Act, in
5 good faith and in the course of the professional practice of the
6 veterinarian only, and not for use by a human being, may prescribe,
7 administer, and dispense controlled dangerous substances and may
8 cause them to be administered by an assistant or orderly under the
9 direction and supervision of the veterinarian.

10 C. 1. ~~An advanced practice nurse~~ Advanced Practice Registered
11 Nurse who is recognized to prescribe by the Oklahoma Board of
12 Nursing as ~~an advanced registered nurse practitioner, clinical nurse~~
13 ~~specialist or certified nurse-midwife,~~ a Certified Nurse
14 Practitioner, Clinical Nurse Specialist, or Certified Nurse-Midwife
15 but who has not obtained independent prescriptive authority under
16 Section 1 of this act and therefore is subject to medical direction
17 by a supervising physician, or supervising Advanced Practice
18 Registered Nurse pursuant to Section 567.3a of Title 59 of the
19 Oklahoma Statutes, and who has complied with the registration
20 requirements of the Uniform Controlled Dangerous Substances Act, in
21 good faith and in the course of professional practice only, may
22 prescribe and administer Schedule III, IV and V controlled dangerous
23 substances.

1 2. An Advanced Practice Registered Nurse who is recognized to
2 prescribe by the Oklahoma Board of Nursing as a Certified Nurse
3 Practitioner, Clinical Nurse Specialist, or Certified Nurse-Midwife
4 who has obtained independent prescriptive authority under Section 1
5 of this act, and who has complied with the registration requirements
6 of the Uniform Controlled Dangerous Substances Act, in good faith
7 and in the course of professional practice only, may prescribe and
8 administer Schedule III, IV, and V controlled dangerous substances.

9 D. An ~~advanced practice nurse~~ Advanced Practice Registered
10 Nurse who is recognized to order, select, obtain and administer
11 drugs by the Oklahoma Board of Nursing as a ~~certified registered~~
12 ~~nurse-anesthetist~~ Certified Registered Nurse Anesthetist pursuant to
13 Section 353.1b of Title 59 of the Oklahoma Statutes and who has
14 complied with the registration requirements of the Uniform
15 Controlled Dangerous Substances Act, in good faith and in the course
16 of such practitioner's professional practice only, may order,
17 select, obtain and administer Schedules II through V controlled
18 dangerous substances in a preanesthetic preparation or evaluation;
19 anesthesia induction, maintenance or emergence; or postanesthesia
20 care setting only. A ~~certified registered nurse-anesthetist~~
21 Certified Registered Nurse Anesthetist may order, select, obtain and
22 administer such drugs only during the perioperative or
23 periobstetrical period.

1 E. A physician assistant who is recognized to prescribe by the
2 State Board of Medical Licensure and Supervision under the medical
3 direction of a supervising physician, pursuant to Section 519.6 of
4 Title 59 of the Oklahoma Statutes, and who has complied with the
5 registration requirements of the Uniform Controlled Dangerous
6 Substances Act, in good faith and in the course of professional
7 practice only, may prescribe and administer Schedule II through V
8 controlled dangerous substances.

9 SECTION 8. This act shall become effective November 1, 2023.
