9 COMMITTEE SUBSTITUTE

10 An Act relating to substance abuse services; defining
11 terms; directing the Commissioner of Mental Health
12 and Substance Abuse Services to designate certain
13 physician to issue specified statewide standing
14 order; requiring designated physician to issue
15 certain standing order for emergency opioid
16 antagonists; specifying duration of effect of
17 standing order; providing for codification; and
18 declaring an emergency.

19 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

20 SECTION 1. NEW LAW A new section of law to be codified
21 in the Oklahoma Statutes as Section 2-225 of Title 43A, unless there
22 is created a duplication in numbering, reads as follows:

23 A. As used in this section:

24 1. "Dispenser" and "prescriber" have the same meaning as
provided by Section 353.1 of Title 59 of the Oklahoma Statutes; and

1 2. "Emergency opioid antagonist" means a drug including but not
2 limited to naloxone that blocks the effects of opioids and that is
3 approved by the United States Food and Drug Administration for the
4 treatment of an opioid overdose.

5 B. Within thirty (30) days of the effective date of this act,
6 the Commissioner of Mental Health and Substance Abuse Services shall
7 designate a physician, licensed in this state and in good standing,
8 to issue a statewide standing order for emergency opioid antagonists
9 under the provisions of this section.

10 C. Within thirty (30) days of being designated under subsection
11 B of this section, the physician shall issue a standing order that:

12 1. Authorizes any prescriber or dispenser to prescribe or
13 dispense emergency opioid antagonists to any person or entity within
14 this state upon request; and

15 2. Allows for the possession, storage, distribution, and
16 administration of emergency opioid antagonists by any individual or
17 entity within this state.

18 D. The standing order issued under this section shall remain in
19 effect until the United States Food and Drug Administration
20 classifies at least one emergency opioid antagonist as an over-the-
21 counter (OTC) drug.

22 SECTION 2. It being immediately necessary for the preservation
23 of the public peace, health or safety, an emergency is hereby
24

1 declared to exist, by reason whereof this act shall take effect and
2 be in full force from and after its passage and approval.
