

10 CONFERENCE COMMITTEE SUBSTITUTE

11 An Act relating to state government; defining terms;  
12 authorizing certain assignment of claims to the  
13 Attorney General; providing scope of authority;  
14 providing for limitations; providing for  
15 codification; and declaring an emergency.

16 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

17 SECTION 1. NEW LAW A new section of law to be codified  
18 in the Oklahoma Statutes as Section 20m of Title 74, unless there is  
19 created a duplication in numbering, reads as follows:

20 A. As used in this section:

21 1. "Person" means a natural person, corporation, partnership,  
22 limited liability company, proprietorship, association, municipal  
23 corporation, including any public trust which has a municipal  
24 corporation as its beneficiary, or other political subdivision of

1 this state, including any public trust which has a political  
2 subdivision as its beneficiary, or any other legal entity; and

3 2. "Assignment" means the transfer of any claims, causes of  
4 actions or rights held by a person against another party to the  
5 State of Oklahoma by the Attorney General. Assignment completely  
6 transfers the person's legal rights to the Attorney General and  
7 creates privity between the Attorney General and the party against  
8 whom the claims are instituted, authorizing the Attorney General to  
9 stand in the shoes of the person. Assignment only includes  
10 affirmative claims and not liabilities of the person as defined in  
11 subsection D of Section 2013 of Title 12 of the Oklahoma Statutes.

12 B. 1. The State of Oklahoma, through the Oklahoma Attorney  
13 General, is hereby explicitly authorized to accept assignments from  
14 any person, as defined subsection A of this section, for the purpose  
15 of representing said claims in legal matters or proceedings within  
16 the jurisdiction of the State of Oklahoma.

17 2. Assignments to the State of Oklahoma shall be made in  
18 accordance with applicable law.

19 C. 1. The Oklahoma Attorney General, upon accepting an  
20 assignment pursuant to this statute, shall have the authority to  
21 represent the assigned claims in all legal matters or proceedings.

22 2. The Attorney General shall exercise the same duties and  
23 responsibilities towards the assigned claims as towards any other  
24

1 claims managed by the Office of the Attorney General, subject to the  
2 terms and conditions of an assignment agreement.

3 D. 1. Nothing in this statute shall be construed to require  
4 the Oklahoma Attorney General to accept any assignment, nor shall it  
5 limit the Attorney General's discretion to decline an assignment for  
6 any reason deemed appropriate by the Attorney General or his or her  
7 designee.

8 2. Assigned claims are not subject to Section 20i of Title 74  
9 of the Oklahoma Statutes.

10 3. All legal rights and benefits given to the Attorney General  
11 shall remain in full force and effect for the assigned claims.

12 E. 1. In carrying out the provisions of this section, the  
13 Office of the Attorney General shall only accept assignment when it  
14 determines it is in the best interest of the public.

15 2. In determining the best interest of the public, the Attorney  
16 General shall consider factors such as:

- 17 a. protection of public health, safety, and welfare,
- 18 b. economic vitality and job creation,
- 19 c. environmental sustainability, and
- 20 d. equity and fair treatment for all citizens.

21 SECTION 2. It being immediately necessary for the preservation  
22 of the public peace, health or safety, an emergency is hereby  
23

1 declared to exist, by reason whereof this act shall take effect and  
2 be in full force from and after its passage and approval.
