13 5, Chapter 47, 1st Extraordinary Session, O.S.L. 2023
14 (47 O.S. Supp. 2023, Section 6-101), which relates to
15 class requirements for driver licenses; removing
16 certain requirement for driver license renewal;
17 disallowing renewal of commercial learner permit;
18 deleting now defunct statutory directives; amending
19 47 O.S. 2021, Section 6-105, as last amended by
20 Section 14, Chapter 310, O.S.L. 2023 (47 O.S. Supp.
21 2023, Section 6-105), which relates to graduated
22 class D licenses; modifying qualifying age for
23 learner permit; modifying qualifying age for certain
24 license; amending 47 O.S. 2021, Section 6-105.3, as
last amended by Section 6, Chapter 47, 1st
Extraordinary Session, O.S.L. 2023 (47 O.S. Supp.
2023, Section 6-105.3, which relates to
identification cards; modifying description of

individuals eligible to apply to be a designated

2 2023, Section 6-114), which relates to replacement
3 licenses; modifying required proof of identity;

6 2023, Section 6-122), which relates to renewal by
7 mail; modifying requirements for renewal of license;
8 amending Section 1, Chapter 409, O.S.L. 2022 (47 O.S.
9 Supp. 2023, Section 6-201.2), which relates to
10 recognition of Indian tribal court conviction;
11 modifying responsible agency; amending 47 O.S. 2021,
12 Section 6-205, which relates to mandatory revocation
13 of license by Department; modifying responsible
14 agency; amending 47 O.S. 2021, Section 6-208.1, which
15 relates to processing requests for suspension or
16 revocation; modifying responsible agency; amending 47
17 O.S. 2021, Section 6-209, which relates to surrender
18 or return of license; modifying responsible agency;

21 2023, Section 1102), which relates to definitions;
22 modifying definitions; amending 51 O.S. 2021, Section
23 24A.5, as amended by Section 5, Chapter 332, O.S.L.
24 2023 (51 O.S. Supp. 2023, Section 24A.5), which
relates to open and confidential records; modifying
responsible agency; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY Section 2, Chapter 282, O.S.L.
2022 (47 O.S. Supp. 2023, Section 3-102), is amended to read as
follows:

Section 3-102. As used in this act:

1. "Board" shall mean the Service Oklahoma Operator Board;

2. "Committee" shall mean the Licensed Operator Advisory

Committee;

1 3. "Director" shall mean the chief executive officer of Service
2 Oklahoma;

3 4. "Good standing" shall mean a licensed operator is current on
4 all required reporting and remittances and whose license is not
5 under review for revocation by the Service Oklahoma Operator Board;

6 5. "License" shall mean the authority granted by the Service
7 Oklahoma Operator Board to an individual for purposes of operating a
8 Service Oklahoma location;

9 6. "Licensed operator" shall mean ~~an individual who obtains a~~
10 ~~license from the Service Oklahoma Operator Board to operate a~~
11 ~~designated Service Oklahoma location and offers third-party~~
12 ~~fulfillment of designated services to be rendered by Service~~
13 ~~Oklahoma, as set forth in Section 1140 et seq. of Title 47 of the~~
14 ~~Oklahoma Statutes~~ any person licensed by the Service Oklahoma
15 Operator Board or designated or authorized to collect the fees and
16 enforce the provisions related to the fulfillment of designated
17 services to be rendered by Service Oklahoma. Any reference to motor
18 license agent in the Oklahoma Statutes shall mean licensed operator;
19 and

20 7. "Person" shall mean any individual, copartner, joint
21 venture, association, corporation, limited liability company,
22 estate, trust, business trust, syndicate, the State of Oklahoma,
23 Service Oklahoma, or any county, city, municipality, school district
24 or other political subdivision thereof, or any group or combination

1 acting as a unit, or any receiver appointed by the state or federal
2 court; and

3 8. "Service Oklahoma location" shall mean any location where
4 services offered by Service Oklahoma are provided including
5 locations operated by either Service Oklahoma or pursuant to a
6 license issued by Service Oklahoma.

7 SECTION 2. AMENDATORY 47 O.S. 2021, Section 6-101, as
8 last amended by Section 5, Chapter 47, 1st Extraordinary Session,
9 O.S.L. 2023 (47 O.S. Supp. 2023, Section 6-101), is amended to read
10 as follows:

11 Section 6-101. A. No person, except those hereinafter
12 expressly exempted in Sections 6-102 and 6-102.1 of this title,
13 shall operate any motor vehicle upon a highway in this state unless
14 the person has a valid Oklahoma driver license for the class of
15 vehicle being operated under the provisions of this title. No
16 person shall be permitted to possess more than one valid license at
17 any time, except as provided in paragraph 4 of subsection F of this
18 section.

19 B. 1. No person shall operate a Class A commercial motor
20 vehicle unless the person is eighteen (18) years of age or older and
21 holds a valid Class A commercial license, except as provided in
22 paragraph 5 of this subsection and subsection F of this section.
23 Any person holding a valid Class A commercial license shall be
24

1 permitted to operate motor vehicles in Classes A, B, C and D, except
2 as provided for in paragraph 4 of this subsection.

3 2. No person shall operate a Class B commercial motor vehicle
4 unless the person is eighteen (18) years of age or older and holds a
5 valid Class B commercial license, except as provided in paragraph 5
6 of subsection F of this section. Any person holding a valid Class B
7 commercial license shall be permitted to operate motor vehicles in
8 Classes B, C and D, except as provided for in paragraph 4 of this
9 subsection.

10 3. No person shall operate a Class C commercial motor vehicle
11 unless the person is eighteen (18) years of age or older and holds a
12 valid Class C commercial license, except as provided in subsection F
13 of this section. Any person holding a valid Class C commercial
14 license shall be permitted to operate motor vehicles in Classes C
15 and D, except as provided for in paragraph 4 of this subsection.

16 4. No person under twenty-one (21) years of age shall be
17 licensed to operate any motor vehicle which is required to be
18 placarded for hazardous materials pursuant to 49 C.F.R., Part 172,
19 subpart F, except as provided in subsection F of this section;
20 provided, a person eighteen (18) years of age or older may be
21 licensed to operate a farm vehicle which is required to be placarded
22 for hazardous materials pursuant to 49 C.F.R., Part 172, subpart F,
23 except as provided in subsection F of this section.

24

1 5. A person at least seventeen (17) years of age who
2 successfully completes all examinations required by law may be
3 issued by Service Oklahoma:

4 a. a restricted Class A commercial license which shall
5 grant to the licensee the privilege to operate a Class
6 A or Class B commercial motor vehicle for harvest
7 purposes or a Class D motor vehicle, or

8 b. a restricted Class B commercial license which shall
9 grant to the licensee the privilege to operate a Class
10 B commercial motor vehicle for harvest purposes or a
11 Class D motor vehicle.

12 6. No person shall operate a Class D motor vehicle unless the
13 person is sixteen (16) years of age or older and holds a valid Class
14 D license, except as provided for in Section 6-102 or 6-105 of this
15 title. Any person holding a valid Class D license shall be
16 permitted to operate motor vehicles in Class D only.

17 C. Any person issued a driver license pursuant to this section
18 may exercise the privilege thereby granted upon all streets and
19 highways in this state.

20 D. No person shall operate a motorcycle or motor-driven cycle
21 without having a valid Class A, B, C or D license with a motorcycle
22 endorsement. Except as otherwise provided by law, any new applicant
23 for an original driver license shall be required to successfully
24 complete a written examination, vision examination and driving

1 examination for a motorcycle as prescribed by the Department of
2 Public Safety, in conjunction with Service Oklahoma, and a certified
3 state-approved motorcycle basic rider course approved by the
4 Department, in conjunction with Service Oklahoma, if the applicant
5 is seventeen (17) years of age or younger to be eligible for a
6 motorcycle endorsement thereon. The written examination and driving
7 examination for a motorcycle shall be waived by Service Oklahoma
8 upon verification that the person has successfully completed a
9 certified Motorcycle Safety Foundation rider course approved by the
10 Department, in conjunction with Service Oklahoma.

11 E. Except as otherwise provided by law, any person who lawfully
12 possesses a valid Oklahoma driver license which is eligible for
13 renewal shall be required to successfully complete a written
14 examination, ~~vision examination~~ and driving examination for a
15 motorcycle as prescribed by the Department, in conjunction with
16 Service Oklahoma, and a certified state-approved motorcycle basic
17 rider course approved by the Department, in conjunction with Service
18 Oklahoma, if the person is seventeen (17) years of age or younger to
19 be eligible for a motorcycle endorsement. The written examination
20 and driving examination for a motorcycle shall be waived by Service
21 Oklahoma upon verification that the person has successfully
22 completed a certified Motorcycle Safety Foundation rider course
23 approved by the Department, in conjunction with Service Oklahoma.

24

1 F. 1. Any person eighteen (18) years of age or older may apply
2 for a restricted Class A, B or C commercial learner permit. Service
3 Oklahoma, after the applicant has passed all parts of the
4 examination for a Class D license and has successfully passed all
5 parts of the examination for a Class A, B or C commercial license
6 other than the driving examination, may issue to the applicant a
7 commercial learner permit which shall entitle the person having
8 immediate lawful possession of the commercial learner permit and a
9 valid Oklahoma driver license or provisional driver license pursuant
10 to Section 6-212 of this title to operate a Class A, B or C
11 commercial motor vehicle upon the public highways solely for the
12 purpose of behind-the-wheel training in accordance with rules
13 promulgated by the Department.

14 2. This commercial learner permit shall be issued for a period
15 as provided in Section 6-115 of this title of one hundred eighty
16 (180) days, which may be renewed one time for an additional one
17 hundred eighty (180) days; provided, such commercial learner permit
18 may be suspended, revoked, canceled, denied or disqualified at the
19 discretion of the Department, with notice to Service Oklahoma, for
20 violation of the restrictions, for failing to give the required or
21 correct information on the application or for violation of any
22 traffic laws of this state pertaining to the operation of a motor
23 vehicle. Except as otherwise provided, the lawful possessor of a
24 commercial learner permit who has been issued a commercial learner

1 permit for a minimum of fourteen (14) days may have the restriction
2 requiring an accompanying driver removed by satisfactorily
3 completing a driver's examination; provided, the removal of a
4 restriction shall not authorize the operation of a Class A, B or C
5 commercial motor vehicle if such operation is otherwise prohibited
6 by law.

7 3. No person shall apply for and Service Oklahoma shall not
8 issue an original Class A, B or C driver license until the person
9 has been issued a commercial learner permit and held the permit for
10 at least fourteen (14) days. Any person who currently holds a Class
11 B or C license and who wishes to apply for another class of
12 commercial driver license shall be required to apply for a
13 commercial learner permit and to hold the permit for at least
14 fourteen (14) days before applying for the Class A or B license, as
15 applicable. Any person who currently holds a Class A, B or C
16 license and who wishes to add an endorsement or remove a restriction
17 for which a skills examination is required shall be required to
18 apply for a commercial learner permit and to hold the permit for at
19 least fourteen (14) days before applying for the endorsement.

20 4. A commercial learner permit shall be issued by Service
21 Oklahoma as a separate and unique document which shall be valid only
22 in conjunction with a valid Oklahoma driver license or provisional
23 driver license pursuant to Section 6-212 of this title, both of
24 which shall be in the possession of the person to whom they have

1 | been issued whenever that person is operating a commercial motor
2 | vehicle as provided in this subsection.

3 | 5. ~~After one renewal of a commercial learner permit, as~~
4 | ~~provided in paragraph 2 of this subsection, a commercial permit~~
5 | ~~shall not be renewed again.~~ Any person who has held a commercial
6 | learner permit for the initial issuance period ~~and one renewal~~
7 | ~~period~~ shall not be eligible for and Service Oklahoma shall not
8 | issue ~~another~~ a renewal of the permit; provided, the person may
9 | reapply for a new commercial learner permit, as provided for in this
10 | subsection.

11 | G. 1. For purposes of this title:

12 | a. "REAL ID Compliant Driver License" or "Identification
13 | Card" means a driver license or identification card
14 | issued by this state that has been certified by the
15 | United States Department of Homeland Security (USDHS)
16 | as compliant with the requirements of the REAL ID Act
17 | of 2005, Public Law No. 109-13. A REAL ID Compliant
18 | Driver License or Identification Card and the process
19 | through which it is issued incorporate a variety of
20 | security measures designed to protect the integrity
21 | and trustworthiness of the license or card. A REAL ID
22 | Compliant Driver License or Identification Card will
23 | be clearly marked on the face indicating that it is a
24 | compliant document, and

1 b. "REAL ID Noncompliant Driver License" or
2 "Identification Card" means a driver license or
3 identification card issued by this state that has not
4 been certified by the United States Department of
5 Homeland Security (USDHS) as being compliant with the
6 requirements of the REAL ID Act of 2005. A REAL ID
7 Noncompliant Driver License or Identification Card
8 will be clearly marked on the face indicating that it
9 is not compliant with the federal REAL ID Act of 2005
10 and is not acceptable for official federal purposes.
11 The driver license or identification card will have a
12 unique design or color indicator that clearly
13 distinguishes it from a compliant license or card.

14 2. Original Driver License and Identification Card Issuance:

- 15 a. Application for an original REAL ID Compliant or REAL
16 ID Noncompliant Driver License or Identification Card
17 shall be made to Service Oklahoma.
- 18 b. Service Oklahoma employees shall perform all document
19 recognition and other requirements needed for approval
20 of an original REAL ID Compliant or REAL ID
21 Noncompliant Driver License or Identification Card
22 application.
- 23 c. Upon approval of an original REAL ID Compliant or REAL
24 ID Noncompliant Driver License or Identification Card

1 application, the applicant may take the approved
2 application document to a licensed operator to receive
3 a temporary driver license or identification card.

4 d. The licensed operator shall process the approved REAL
5 ID Compliant or REAL ID Noncompliant Driver License or
6 Identification Card application and upon payment shall
7 provide the applicant a temporary driver license or
8 identification card. A temporary driver license or
9 identification card shall afford the holder the
10 privileges otherwise granted by the specific class of
11 driver license or identification card for the period
12 of time listed on the temporary driver license or
13 identification card or the period of time prior to the
14 applicant receiving a REAL ID Compliant or REAL ID
15 Noncompliant Driver License or Identification Card,
16 whichever time period is shorter.

17 3. REAL ID Compliant Driver License and Identification Card

18 Renewal and Replacement:

19 a. Application for renewal or replacement of a REAL ID
20 Compliant Driver License or Identification Card may be
21 made to Service Oklahoma or to a licensed operator;
22 provided, such licensed operator is authorized to
23 process application for REAL ID Compliant Driver
24 Licenses and Identification Cards. A licensed

1 operator may process the voluntary downgrade of a REAL
2 ID Compliant Commercial Driver License to any lower
3 class license upon request of the licensee; provided,
4 no additional endorsements or restrictions are placed
5 on the license.

6 b. Service Oklahoma employees or authorized licensed
7 operators shall perform all document recognition and
8 other requirements needed for approval of a renewal or
9 replacement REAL ID Compliant Driver License or
10 Identification Card application.

11 c. Upon approval of a renewal or replacement REAL ID
12 Compliant Driver License or Identification Card
13 application, the applicant may receive a temporary
14 driver license or identification card from Service
15 Oklahoma or an authorized licensed operator.

16 d. A temporary driver license or identification card
17 acquired under the provisions of this paragraph shall
18 afford the holder the privileges otherwise granted by
19 the specific class of driver license or identification
20 card being renewed or replaced for the period of time
21 listed on the temporary driver license or
22 identification card or the period of time prior to the
23 applicant receiving a REAL ID Compliant Driver License
24

1 or Identification Card, whichever time period is
2 shorter.

- 3 e. For purposes of this title, an application for a REAL
4 ID Compliant Driver License or Identification Card by
5 an individual with a valid Oklahoma-issued driver
6 license or identification card shall be considered a
7 renewal of a REAL ID Compliant Driver License or
8 Identification Card.

9 4. REAL ID Noncompliant Driver License and Identification Card

10 Renewal and Replacement:

- 11 a. Application for renewal or replacement of a REAL ID
12 Noncompliant Driver License or Identification Card may
13 be made to Service Oklahoma or to a licensed operator.
14 A licensed operator may process the voluntary
15 downgrade of a REAL ID Noncompliant Commercial Driver
16 License to any lower class license upon request of the
17 licensee; provided, no additional endorsements or
18 restrictions are added to the license.
- 19 b. Service Oklahoma employees or licensed operators shall
20 perform all document recognition and other
21 requirements needed for approval of a renewal or
22 replacement REAL ID Noncompliant Driver License or
23 Identification Card application.

1 c. Upon approval of a renewal or replacement REAL ID
2 Noncompliant Driver License or Identification Card
3 application, the applicant may receive a temporary
4 driver license or identification card from Service
5 Oklahoma or a licensed operator.

6 d. A temporary driver license or identification card
7 acquired under the provisions of this paragraph shall
8 afford the holder the privileges otherwise granted by
9 the specific class of driver license or identification
10 card being renewed or replaced for the period of time
11 listed on the temporary driver license or
12 identification card or the period of time prior to the
13 applicant receiving a REAL ID Noncompliant Driver
14 License or Identification Card, whichever time period
15 is shorter.

16 H. 1. The fee charged for an approved application for an
17 original Oklahoma REAL ID Compliant or REAL ID Noncompliant Driver
18 License or an approved application for the addition of an
19 endorsement to a current valid Oklahoma REAL ID Compliant or REAL ID
20 Noncompliant Driver License shall be assessed in accordance with the
21 following schedule:

9 2. Notwithstanding the provisions of Section 1104 of this
10 title, all monies collected from the fees charged for Class A, B and
11 C commercial licenses pursuant to the provisions of this subsection
12 shall be deposited in the General Revenue Fund of this state.

13 I. The fee charged for any failed examination shall be Four
14 Dollars (\$4.00) for any license classification. Notwithstanding the
15 provisions of Section 1104 of this title, all monies collected from
16 such examination fees pursuant to the provisions of this subsection
17 shall be deposited in the General Revenue Fund of this state.

18 J. In addition to any fee charged pursuant to the provisions of
19 subsection H of this section, the fee charged for the issuance or
20 renewal of a REAL ID Noncompliant Driver License shall be in
21 accordance with the following schedule; provided, that any applicant
22 who has a CDL Learner Permit shall be charged only the replacement
23 fee for the issuance of the license:

16 issuance of the license:

9 L. A commercial learner permit may not be renewed ~~one time for~~
10 ~~a period of one hundred eighty (180) days. The cost for the renewed~~
11 ~~permit shall be the same as for the original permit.~~

12 M. Notwithstanding the provisions of Section 1104 of this
13 title, of each fee charged pursuant to the provisions of subsections
14 J, K and L of this section:

15 1. Five Dollars and fifty cents (\$5.50) of a 4-year license or
16 Eleven Dollars (\$11.00) of an 8-year license shall be deposited to
17 the Trauma Care Assistance Revolving Fund created in Section 1-
18 2530.9 of Title 63 of the Oklahoma Statutes;

19 2. Six Dollars and seventy-five cents (\$6.75) of a 4-year
20 license or Thirteen Dollars and fifty cents (\$13.50) of an 8-year
21 license shall be deposited to the Department of Public Safety
22 Computer Imaging System Revolving Fund to be used solely for the
23 purpose of administration and maintenance of the computerized
24 imaging system of the Department through October 31, 2022.

1 Beginning November 1, 2022, Six Dollars and seventy-five cents
2 (\$6.75) of a 4-year license or Thirteen Dollars and fifty cents
3 (\$13.50) of an 8-year license shall be deposited to the Service
4 Oklahoma Computer Imaging System Revolving Fund to be used solely
5 for the purpose of administration and maintenance of the
6 computerized imaging system of Service Oklahoma;

7 3. Ten Dollars (\$10.00) of a 4-year license or Twenty Dollars
8 (\$20.00) of an 8-year license shall be deposited to the Department
9 of Public Safety Revolving Fund for all original or renewal
10 issuances of licenses through October 31, 2022. Beginning November
11 1, 2022, Ten Dollars (\$10.00) of a 4-year license or Twenty Dollars
12 (\$20.00) of an 8-year license shall be deposited to the Service
13 Oklahoma Revolving Fund for all original or renewal issuances of
14 licenses; and

15 4. Five Dollars (\$5.00) of a 4-year license or Six Dollars
16 (\$6.00) of an 8-year license shall be deposited to the State Public
17 Safety Fund created in Section 2-147 of this title.

18 N. All original and renewal driver licenses shall expire as

10 G. Notwithstanding any other provision of law, when a person
11 makes application for a new identification card, or makes
12 application to renew an identification card, and the person has been
13 convicted of, or received a deferred judgment for, any offense
14 required to register pursuant to the Sex Offenders Registration Act,
15 the identification card shall be valid for a period of one (1) year
16 from the month of issuance, but may be renewed yearly during the
17 time the person is subject to registration on the Sex Offender
18 Registry. The cost for such identification card shall be the same
19 as for other identification cards and renewals.

20 H. Nothing in this section requires or authorizes the
21 Department of Public Safety to issue a REAL ID Noncompliant
22 Identification Card without the documentation required by the
23 provisions of paragraph 9 of subsection A of Section 6-103 of this
24 title.

1 SECTION 5. AMENDATORY 47 O.S. 2021, Section 6-106, as
2 amended by Section 45, Chapter 282, O.S.L. 2022 (47 O.S. Supp. 2023,
3 Section 6-106), is amended to read as follows:

4 Section 6-106. A. 1. Every application for a driver license
5 or identification card shall be made by the applicant upon a form
6 furnished by Service Oklahoma.

7 2. Every original, renewal, or replacement application for a
8 driver license or identification card made by a male applicant who
9 is at least sixteen (16) but less than twenty-six (26) years of age
10 shall include a statement that by submitting the application, the
11 applicant is consenting to registration with the Selective Service
12 System. The pertinent information from the application shall be
13 forwarded by Service Oklahoma to the Data Management Center of the
14 Selective Service System in order to register the applicant as
15 required by law with the Selective Service System. Any applicant
16 refusing to sign the consent statement shall be denied a driver
17 license or identification card.

18 3. Except as provided for in subsections G and H of this
19 section, every applicant for a driver license or identification card
20 shall provide to Service Oklahoma at the time of application a
21 document showing proof of identity. Service Oklahoma shall
22 promulgate rules prescribing forms of ~~primary and secondary~~
23 identification acceptable for an original Oklahoma driver license.
24

1 B. Every applicant for a driver license shall provide the
2 following information:

3 1. Full name;

4 2. Date of birth;

5 3. Sex;

6 4. Address of principal residence and county of such residence
7 which shall be referenced on the REAL ID Compliant Driver License or
8 Identification Card; proof of principal residency, as prescribed by
9 rules promulgated by Service Oklahoma, documenting provided address;

10 5. Current and complete mailing address to be maintained by
11 Service Oklahoma for the purpose of giving notice, if necessary, as
12 required by Section 2-116 of this title;

13 6. Medical information, as determined by the Department, which
14 shall assure Service Oklahoma that the person is not prohibited from
15 being licensed as provided by paragraph 7 of subsection A of Section
16 6-103 of this title;

17 7. Whether the applicant is deaf or hard-of-hearing;

18 8. A brief description of the applicant, as determined by the
19 Department;

20 9. Whether the applicant has previously been licensed, and, if
21 so, when and by what state or country, and whether any license has
22 ever been suspended or revoked, or whether an application has ever
23 been refused, and, if so, the date of and reason for the suspension,
24 revocation or refusal;

1 10. Whether the applicant is an alien eligible to be considered
2 for licensure and is not prohibited from licensure pursuant to
3 paragraph 9 of subsection A of Section 6-103 of this title;

4 11. Whether the applicant has:

5 a. previously been licensed and, if so, when and by what
6 state or country, and

7 b. held more than one license at the same time during the
8 immediately preceding ten (10) years; and

9 12. Social Security number.

10 No person shall request Service Oklahoma to use the Social Security
11 number of that person as the driver license number. Upon renewal or
12 replacement of any driver license issued after the effective date of
13 this act, the licensee shall advise Service Oklahoma or the licensed
14 operator if the present driver license number of the licensee is the
15 Social Security number of the licensee. If the driver license
16 number is the Social Security number, Service Oklahoma or the
17 licensed operator shall change the driver license number to a
18 computer-generated alphanumeric identification.

19 C. 1. In addition to the requirements of subsections A and B
20 of this section, every applicant for a commercial driver license who
21 is subject to the requirements of 49 C.F.R., Part 391, and is
22 applying for an original, renewal, or replacement license, and every
23 person who, upon or after May 8, 2012, is currently the holder of a
24 commercial driver license and is subject to the requirements of 49

1 C.F.R., Part 391, and who does not apply for a renewal or
2 replacement license prior to January 30, 2014, shall submit to
3 Service Oklahoma and maintain with Service Oklahoma a current
4 approved medical examination certificate signed by a licensed
5 physician authorized to perform and approve medical examination
6 certifications. Service Oklahoma shall adopt rules for maintaining
7 medical examination certificates pursuant to the requirements in 49
8 C.F.R., Parts 383 and 384. Any commercial driver licensee subject
9 to the requirements of this paragraph who fails to maintain on file
10 with Service Oklahoma a current, approved medical examination
11 certificate shall have the driving privileges of the person
12 downgraded to a Class D driver license by Service Oklahoma.

13 2. If the applicant is applying for an original commercial
14 driver license in Oklahoma or is transferring a commercial driver
15 license from another state to Oklahoma, Service Oklahoma shall
16 review the driving record of the applicant in other states for the
17 immediately preceding ten (10) years, unless the record review has
18 already been performed by Service Oklahoma. As a result of the
19 review, if it is determined by Service Oklahoma that the applicant
20 is subject to a period of disqualification as prescribed by Section
21 6-205.2 of this title which has not yet been imposed, Service
22 Oklahoma shall impose the period of disqualification and the
23 applicant shall serve the period of disqualification before a
24 commercial driver license is issued to the applicant; provided,

1 nothing in this paragraph shall be construed to prevent the issuance
2 of a Class D driver license to the applicant.

3 3. If the applicant has or is applying for a hazardous material
4 endorsement, the applicant shall submit to a security threat
5 assessment performed by the Transportation Security Administration
6 of the Department of Homeland Security as required by and pursuant
7 to 49 C.F.R., Part 1572, which shall be used to determine whether
8 the applicant is eligible for the endorsement pursuant to federal
9 law and regulation.

10 4. Service Oklahoma shall notify each commercial driving school
11 of the passage of this section, and each commercial driving school
12 shall notify prospective students of its school of the hazardous
13 material endorsement requirement.

14 D. In addition to the requirements of subsections A and B of
15 this section, every applicant shall be given an option on the
16 application for issuance of a driver license or identification card
17 or renewal pursuant to Section 6-115 of this title to provide an
18 emergency contact person. The emergency contact information
19 requested may include full name, address, and phone number. The
20 emergency contact information shall be maintained by Service
21 Oklahoma and shall be used by Service Oklahoma and law enforcement
22 for emergency purposes only. A person listed as an emergency
23 contact may request to be removed at any time. Any update to a
24 change of name, address, or phone number may be made by the

1 applicant listing the emergency contact person or by the person
2 listed as the emergency contact.

3 E. Whenever application is received from a person previously
4 licensed in another jurisdiction, Service Oklahoma shall request a
5 copy of the driving record from the other jurisdiction and,
6 effective September 1, 2005, from all other jurisdictions in which
7 the person was licensed within the immediately previous ten (10)
8 years. When received, the driving record shall become a part of the
9 driving record of the person in this state with the same force and
10 effect as though entered on the driver's record in this state in the
11 original instance.

12 F. Whenever Service Oklahoma receives a request for a driving
13 record from another licensing jurisdiction, the record shall be
14 forwarded without charge.

15 G. A person shall not apply for or possess more than one state-
16 issued or territory-issued REAL ID Compliant Driver License or
17 Identification Card pursuant to the provisions of Section 6-101 of
18 this title. A valid and unexpired Oklahoma driver license shall
19 serve as both primary and secondary proofs of identity whenever
20 application for a REAL ID Noncompliant Identification Card is
21 submitted to Service Oklahoma. The provisions of subsection B of
22 Section 1550.42 of Title 21 of the Oklahoma Statutes shall not apply
23 when issuing an identification card pursuant to the provisions of
24

1 this subsection. Service Oklahoma shall promulgate rules necessary
2 to implement and administer the provisions of this subsection.

3 H. A valid and unexpired U.S. passport shall serve as both
4 primary and secondary proofs of identity whenever application for a
5 driver license or identification card is submitted to the
6 Department. Service Oklahoma shall promulgate rules necessary to
7 implement and administer the provisions of this subsection.

8 SECTION 6. AMENDATORY 47 O.S. 2021, Section 6-110, as
9 last amended by Section 15, Chapter 310, O.S.L. 2023 (47 O.S. Supp.
10 2023, Section 6-110), is amended to read as follows:

11 Section 6-110. A. 1. Service Oklahoma shall establish
12 procedures to ensure every applicant for an original Class A, B, C
13 or D license and for any endorsements thereon is examined by Service
14 Oklahoma, or an approved written examination proctor, except as
15 otherwise provided in Section 6-101 et seq. of this title or as
16 provided in paragraph 2 of this subsection or in subsections D and E
17 of this section. Service Oklahoma is authorized to approve and
18 enter into agreements with local school districts, the Oklahoma
19 Department of Career and Technology Education, or institutions of
20 higher education to act as approved written examination proctors
21 with regard to any written examination required by this section.
22 The examination shall include a test of the applicant's:

23 a. eyesight,
24

- 1 b. ability to read and understand highway signs
2 regulating, warning and directing traffic,
3 c. knowledge of the traffic laws of this state including
4 a portion on bicycle and motorcycle safety, and
5 d. ability, by actual demonstration, to exercise ordinary
6 and reasonable control in the operation of a motor
7 vehicle. The actual demonstration shall be conducted
8 in the type of motor vehicle for the class of driver
9 license being applied for.

10 The Department of Public Safety, in conjunction with Service
11 Oklahoma, may create a knowledge test that may be taken on the
12 Internet by an applicant applying for a Class D license.

13 Any licensee seeking to apply for a driver license of another class
14 which is not covered by the licensee's current driver license shall
15 be considered an applicant for an original license for that class.

16 2. Service Oklahoma shall have the authority to waive the
17 requirement of any part of the examination required in paragraph 1
18 of this subsection for those applicants whose driving record meets
19 the standards set by the Department of Public Safety and surrender
20 either of the following:

- 21 a. a valid unexpired driver license issued by any state
22 or country for the same type or types of vehicles, or
23 b. an expired driver license that:
24

- 1 (1) is not expired more than six (6) months past the
2 expiration date listed on the driver license, and
3 (2) is not a Class A, B or C commercial driver
4 license or commercial driver license permit.

5 3. Service Oklahoma shall accept skills test results from
6 another state for Class A, B or C license applicants who have
7 successfully completed commercial motor vehicle driver training in
8 that state and successfully passed the skills test in that state;
9 provided, Service Oklahoma shall not accept skills test results from
10 another state when the applicant has not successfully completed
11 commercial motor vehicle driver training in that state. Nothing in
12 this section shall be construed to prohibit Service Oklahoma from
13 administering the skills test to any applicant who has successfully
14 completed commercial vehicle driver training in another state.

15 4. All applicants requiring a hazardous materials endorsement
16 shall be required, for the renewal of the endorsement, to
17 successfully complete the examination and to submit to a security
18 threat assessment performed by the Transportation Security
19 Administration of the Department of Homeland Security as required by
20 and pursuant to 49 C.F.R., Part 1572, which shall be used to
21 determine whether the applicant is eligible for renewal of the
22 endorsement pursuant to federal law and regulation.

23 5. Service Oklahoma, or an approved written examination
24 proctor, shall give the complete examination as provided for in this

1 section within thirty (30) days from the date the application is
2 received, and the examination shall be given at a location within
3 one hundred (100) miles of the residence of the applicant. Service
4 Oklahoma shall make every effort to make the examination locations
5 and times convenient for applicants. Service Oklahoma shall
6 consider giving the examination at various school sites if the
7 district board of education for the district in which the site is
8 located agrees and if economically feasible and practicable.

9 B. Any person holding a valid Oklahoma Class D license or
10 provisional driver license pursuant to Section 6-212 of this title
11 and applying for a Class A, B or C commercial license shall be
12 required to successfully complete all examinations as required for
13 the specified class. Failure to submit to Service Oklahoma
14 federally required medical certification information pursuant to 49
15 C.F.R., Part 391.41 et seq. shall result in an automatic downgrade
16 of a commercial license to a Class D license. Provided, however,
17 once the required medical certification information has been
18 received by Service Oklahoma, the license shall be reinstated to the
19 classification of the commercial license prior to the downgrade and
20 the holder of such a license shall not be required to reapply.

21 C. Except as provided in subsection E of Section 6-101 of this
22 title, any person holding a valid Oklahoma Class A, B or C
23 commercial license shall, upon time for renewal thereof, be entitled
24 to a Class D license without any type of testing or examination,

1 except for any endorsements thereon as otherwise provided for by
2 Section 6-110.1 of this title.

3 D. 1. Any certified driver education instructor who is
4 currently an operator or an employee of a commercial driver training
5 school in this state, ~~or~~ any driver education instructor employed by
6 any school district in this state, or any licensed operator or an
7 employee of a licensed operator shall be eligible to apply to be a
8 designated examiner of Service Oklahoma for the purposes of
9 administering the Class D driving skills portion of the Oklahoma
10 driving examination to any person who has been issued a learner
11 permit.

12 2. The Department of Public Safety, in conjunction with Service
13 Oklahoma, shall adopt a curriculum of required courses and training
14 to be offered to applicants who are qualified to apply to be a
15 designated examiner. The courses and training for certification
16 shall meet the same standards as required for driver examiners of
17 Service Oklahoma.

18 3. Each person applying to be a designated examiner shall be
19 required to pay an initial designated examiner certification fee of
20 One Thousand Dollars (\$1,000.00). Upon successful completion of
21 training prescribed by paragraph 2 of this subsection, the person
22 shall be required to pay an annual designated examiner certification
23 fee of Five Hundred Dollars (\$500.00). If an applicant for the
24 designated examiner program is employed by an Oklahoma public school

1 system that offers driver education, and he or she administers the
2 skills test only to students enrolled in a public school driver
3 education program, the certification fee may be waived by Service
4 Oklahoma. Each designated examiner certification shall expire on
5 the last day of the calendar year and may be renewed upon
6 application to Service Oklahoma. The designated examiner
7 certification fees collected by Service Oklahoma pursuant to this
8 subsection shall be deposited to the credit of the Department of
9 Public Safety Restricted Revolving Fund to be used for the purposes
10 of this subsection, through October 31, 2022. Beginning November 1,
11 2022, the designated examiner certification fees collected by
12 Service Oklahoma pursuant to this subsection shall be deposited to
13 the credit of the Service Oklahoma Revolving Fund. No designated
14 examiner certification fee shall be refunded in the event that
15 certification is denied, suspended or revoked.

16 4. A designated examiner may charge a fee for each Class D
17 driving skills examination given, whether the person being examined
18 passes or fails the examination.

19 5. Service Oklahoma shall require each designated examiner and
20 driver education instructor applicant to submit to an electronic
21 national criminal history record check pursuant to Section 150.9 of
22 Title 74 of the Oklahoma Statutes. The fees for the record check
23 shall be borne by the designated examiner, designated examiner
24

1 applicant, driver education instructor, or driver education
2 instructor applicant.

3 6. The Department of Public Safety, in conjunction with Service
4 Oklahoma, shall promulgate rules to implement and administer the
5 provisions of this subsection.

6 E. 1. Upon application and approval of Service Oklahoma, any
7 public or private commercial truck driving school that has or
8 maintains a program instructing students for a Class A, B or C
9 license, public transit agency or state, county or municipal
10 government agency in this state shall be authorized to hire or
11 employ designated examiners approved by Service Oklahoma to be
12 third-party examiners of the Class A, B or C driving skills portion
13 of the Oklahoma driving examination. All designated examiners must
14 successfully have completed the courses and training as outlined in
15 paragraph 2 of this subsection. Service Oklahoma shall be required
16 to approve at least one public transit agency that has or maintains
17 a program instructing students for a Class A, B or C license to hire
18 or employ third-party examiners pursuant to this section. It shall
19 be permissible for any public transit agency operating in the State
20 of Oklahoma to utilize the third-party examiners hired or employed
21 by a public transit agency approved by Service Oklahoma.

22 2. The Department of Public Safety, in conjunction with Service
23 Oklahoma, shall adopt a curriculum of required courses and training
24 to be offered to third-party examiners. The courses and training

1 for certification shall meet the same standards as required for
2 commercial driver examiners of Service Oklahoma.

3 3. Service Oklahoma shall require each third-party examiner
4 applicant and commercial school driver education instructor
5 applicant to submit to an electronic national criminal history
6 record check pursuant to Section 150.9 of Title 74 of the Oklahoma
7 Statutes. On or before December 1, 2022, Service Oklahoma shall
8 require each third-party examiner or commercial school driver
9 education instructor to submit to an electronic national criminal
10 history record check pursuant to Section 150.9 of Title 74 of the
11 Oklahoma Statutes. The fees for the background check shall be borne
12 by the third-party examiner, third-party examiner applicant,
13 commercial school driver education instructor or commercial school
14 driver education instructor applicant.

15 F. Service Oklahoma shall promulgate rules to:

16 1. Implement and administer the provisions of this section
17 based on requirements set forth in Section 383.75 of Title 49 of the
18 Code of Federal Regulations;

19 2. Establish a process to inform any school, public transit
20 agency, examiner, or state, county or municipal government agency,
21 who has been denied, within forty-five (45) days from the denial;

22 3. Create an appeal process for any school, public transit
23 agency, examiner, or state, county or municipal government agency
24 denied; and

1 4. If the initial application for approval was denied, limit
2 the number of times an individual school, public transit agency,
3 individual examiner applicant, or state, county or municipal
4 government agency may reapply in a calendar year to two
5 reapplications.

6 SECTION 7. AMENDATORY 47 O.S. 2021, Section 6-114, as
7 last amended by Section 7, Chapter 47, 1st Extraordinary Session,
8 O.S.L. 2023 (47 O.S. Supp. 2023, Section 6-114), is amended to read
9 as follows:

10 Section 6-114. A. 1. In the event that a driver license is
11 lost, destroyed, or requires the updating of any information,
12 restriction or endorsement displayed thereon, the person to whom
13 such license was issued may obtain a replacement thereof pursuant to
14 the provisions of subsection G of Section 6-101 of this title, and
15 upon payment of the required fee. If the person is an alien, the
16 person shall appear before Service Oklahoma or a licensed operator
17 and, after furnishing ~~primary and secondary proofs~~ proof of identity
18 as required in this section, shall be issued a replacement driver
19 license for a period which does not exceed the lesser of:

- 20 a. the expiration date of the license being replaced, or
- 21 b. the expiration date on the valid documentation
22 authorizing the presence of the person in the United
23 States, as required by paragraph 9 of subsection A of
24 Section 6-103 of this title.

1 2. The cost of a replacement license shall be Twenty-five
2 Dollars (\$25.00), of which:

3 a. Two Dollars (\$2.00) shall be apportioned as provided
4 in Section 1104 of this title,

5 b. Three Dollars (\$3.00) shall be remitted to the State
6 Treasurer to be credited to the General Revenue Fund,

7 c. Five Dollars (\$5.00) shall be credited to the
8 Department of Public Safety Computer Imaging System
9 Revolving Fund to be used solely for the purpose of
10 administering and maintaining the computer imaging
11 system of the Department through October 31, 2022.
12 Beginning November 1, 2022, Five Dollars (\$5.00) shall
13 be credited to the Service Oklahoma Computer Imaging
14 System Revolving Fund to be used solely for the
15 purpose of administering and maintaining the computer
16 imaging system of Service Oklahoma,

17 d. Ten Dollars (\$10.00) shall be credited to the
18 Revolving Fund of the Department of Public Safety
19 through October 31, 2022. Beginning November 1, 2022,
20 the Ten Dollars (\$10.00) shall be credited to the
21 Service Oklahoma Revolving Fund,

22 e. Three Dollars (\$3.00) shall be deposited to the State
23 Public Safety Fund created in Section 2-147 of this
24 title, and

1 f. (1) Two Dollars (\$2.00) of the fee authorized by this
2 paragraph related to the replacement of a driver
3 license by a licensed operator that does not
4 process approved applications or renewals for
5 REAL ID Compliant Driver Licenses or
6 Identification Cards shall be deposited, in
7 addition to the amount authorized by subparagraph
8 e of this paragraph, to the State Public Safety
9 Fund created in Section 2-147 of this title, or

10 (2) Two Dollars (\$2.00) of the fee authorized by this
11 paragraph related to the replacement of a driver
12 license by a licensed operator that does process
13 approved applications or renewals for REAL ID
14 Compliant Driver Licenses or Identification Cards
15 shall be retained by the licensed operator
16 through June 30, 2023. Beginning July 1, 2023,
17 these monies shall be retained by the licensed
18 operator pursuant to subsection E of Section
19 1141.1 of this title.

20 3. Service Oklahoma shall promulgate rules prescribing forms of
21 primary and secondary identification acceptable for replacement of
22 an Oklahoma driver license; provided, however, a valid and unexpired
23 U.S. passport shall be acceptable as both primary and secondary
24 identification.

1 B. Any person desiring to add or remove an endorsement or
2 endorsements or a restriction or restrictions to any existing driver
3 license, when authorized by Service Oklahoma, shall obtain a
4 replacement license with the endorsement or endorsements or the
5 restriction or restrictions change thereon and shall be charged the
6 fee for a replacement license as provided in subsection A of this
7 section.

8 SECTION 8. AMENDATORY 47 O.S. 2021, Section 6-122, as
9 amended by Section 62, Chapter 282, O.S.L. 2022 (47 O.S. Supp. 2023,
10 Section 6-122), is amended to read as follows:

11 Section 6-122. Service Oklahoma may develop procedures whereby
12 driver licenses issued under the provisions of Section 6-101 et seq.
13 of this title may be renewed or replaced by the applicant by mail or
14 online except for licenses to be renewed or replaced by aliens as
15 prescribed by subsection E of Section 6-115 of this title. Any
16 license issued pursuant to this section shall be valid for a period
17 as prescribed in Section 6-115 of this title. Service Oklahoma
18 shall not renew or replace a license by mail or online unless ~~the~~
19 ~~immediately preceding~~ there has been an issuance, renewal or
20 replacement ~~was~~ driver license done in person by the applicant
21 within the last sixteen (16) years.

22 Provided, any person or the spouse or dependent of a person:

23 1. Who is on active duty with the Armed Forces of the United
24 States; or

1 2. Who is currently employed as a civilian contractor with the
2 Armed Forces of the United States,
3 living outside of Oklahoma and having a valid Class D driver license
4 issued by the State of Oklahoma, requiring no material change, may
5 apply for no more than three consecutive renewals or replacement of
6 such license by mail or online, in accordance with Service Oklahoma
7 rules. A fourth consecutive renewal or replacement must be done in
8 person.

9 SECTION 9. AMENDATORY Section 1, Chapter 409, O.S.L.
10 2022 (47 O.S. Supp. 2023, Section 6-201.2), is amended to read as
11 follows:

12 Section 6-201.2 For purposes of Section 6-101 et seq. of Title
13 47 of the Oklahoma Statutes, ~~the Department of Public Safety~~ Service
14 Oklahoma shall recognize and act upon a report of conviction in a
15 qualified court of any federally recognized Indian tribe within the
16 geographical boundaries of this state or a court of the United
17 States in the same manner it acts upon any report of conviction from
18 an Oklahoma state or municipal court. Any report of conviction
19 submitted to ~~the Department~~ Service Oklahoma shall be submitted
20 using a format approved by ~~the Department~~ Service Oklahoma and shall
21 include the full name of the offender as it appears on the driver
22 license, the number of the driver license, and the penalty imposed.

14 Section 11-906.4 of this title. However, ~~the Department Service~~
15 Oklahoma shall not additionally revoke the driving privileges of the
16 person pursuant to this subsection if the driving privilege of the
17 person has been revoked because of a test result or test refusal
18 pursuant to Section 753 or 754 of this title arising from the same
19 circumstances which resulted in the conviction unless the revocation
20 because of a test result or test refusal is set aside;

21 3. Driving a motor vehicle during the commission of a felony;

22 4. Failure to stop and render aid as required under the laws of
23 this state in the event of a motor vehicle accident resulting in the
24 death or personal injury of another;

1 5. Perjury or the making of a false affidavit or statement
2 under oath to ~~the Department~~ Service Oklahoma under the Uniform
3 Vehicle Code or under any other law relating to the ownership or
4 operation of motor vehicles;

5 6. A felony conviction for unlawfully distributing, dispensing,
6 manufacturing, trafficking, attempting or conspiring to distribute,
7 dispense, manufacture, or traffic a controlled dangerous substance
8 as defined in the Uniform Controlled Dangerous Substances Act while
9 driving a motor vehicle;

10 7. A misdemeanor conviction for a violation of Section 1-229.34
11 of Title 63 of the Oklahoma Statutes;

12 8. Failure to obey a traffic control device as provided in
13 Section 11-202 of this title or a stop sign when such failure
14 results in great bodily injury to any other person; or

15 9. Failure to stop or to remain stopped for school bus loading
16 or unloading of children pursuant to Section 11-705 or 11-705.1 of
17 this title.

18 B. The first license revocation under any provision of this
19 section, except for paragraph 2, 3, 6, 7, or 9 of subsection A of
20 this section, shall be for a period of one (1) year. Such period
21 shall not be modified.

22 C. A license revocation under any provision of this section,
23 except for paragraph 2, 3, 6, or 7 of subsection A of this section,
24 shall be for a period of three (3) years if a prior revocation under

1 this section commenced within the preceding five-year period as
2 shown by the records of ~~the Department~~ Service Oklahoma. Such
3 period shall not be modified.

4 D. The period of license revocation under paragraph 2, 3 or 6
5 of subsection A of this section shall be governed by the provisions
6 of Section 6-205.1 of this title.

7 E. The first license revocation under paragraph 7 of subsection
8 A of this section shall be for a period of six (6) months. Such
9 periods shall not be modified.

10 F. The first license revocation under paragraph 9 of subsection
11 A of this section shall be for a period of one (1) year. Such
12 period may be modified. Any appeal of the revocation of driving
13 privilege under paragraph 9 of subsection A of this section shall be
14 governed by Section 6-211 of this title; provided, any modification
15 under this subsection shall apply to Class D motor vehicles only.

16 G. As used in this section, "great bodily injury" means bodily
17 injury which creates a substantial risk of death or which causes
18 serious, permanent disfigurement or protracted loss or impairment of
19 the function of any bodily member or organ.

20 H. Any person whose driving privileges are or have been
21 canceled or denied pursuant to this section, except for paragraph 1,
22 2 or 8 of subsection A of this section, may file a petition for
23 relief based upon error or hardship.

24

1 1. The petition shall be filed in the district court which
2 notified ~~the Department~~ Service Oklahoma. If the Notification
3 originated in a municipal court, the petition shall be filed in the
4 district court of the county in which the municipal court is
5 located. A copy of the Notification and a copy of ~~the Department's~~
6 Service Oklahoma's action canceling or denying driving privileges
7 pursuant to this section shall be attached to the petition.

8 2. The district court shall conduct a hearing on the petition
9 and may determine the matter de novo, without notice to ~~the~~
10 ~~Department~~ Service Oklahoma and, if applicable, without notice to
11 the municipal court; provided, the district court shall not consider
12 a collateral attack upon the merits of any conviction or
13 determination which has become final.

14 3. The district court may deny the petition or, in its
15 discretion, issue a written Order to ~~the Department~~ Service Oklahoma
16 to decrease the period of cancellation or denial to any period or
17 issue a written Order to vacate ~~the Department's~~ Service Oklahoma's
18 action taken pursuant to this section, in its entirety. The content
19 of the Order shall not grant or purport to grant any driving
20 privileges to the person; however, such Order may direct ~~the~~
21 ~~Department of Public Safety~~ Service Oklahoma to do so if the person
22 is otherwise eligible therefor. The petitioner is responsible for
23 his or her own attorney fees. However, if the petitioner is granted
24 relief for error, then the party that committed the error may be

1 ordered to pay attorney fees and costs. Unless all persons or
2 agencies the court had reason to believe may have had relevant
3 information related to the court record and departmental action have
4 been given notice of the petition, attorney fees and costs shall not
5 be awarded against any party. In no event shall ~~the Department of~~
6 ~~Public Safety~~ Service Oklahoma be liable for attorney fees and costs
7 for suspending, revoking, canceling or denying a driver license
8 based upon reasonable reliance on a notice from a court requiring
9 the revocation, suspension, cancellation or denial of the driver
10 license according to law.

11 SECTION 11. AMENDATORY 47 O.S. 2021, Section 6-208.1, is
12 amended to read as follows:

13 Section 6-208.1 If action by ~~the Department of Public Safety~~
14 Service Oklahoma to suspend, revoke, cancel or deny the ~~driver's~~
15 driver license of any person is based in whole or in part upon the
16 receipt of a record of conviction, report, affidavit or other
17 written instrument from any court, court clerk, law enforcement
18 officer, public agency, public officer or public employee and such
19 documentation is not received by ~~the Department~~ Service Oklahoma
20 within six (6) months from the date which in the judgment of ~~the~~
21 ~~Department~~ Service Oklahoma it should have been received, then ~~the~~
22 ~~Department~~ Service Oklahoma may decline to process such
23 documentation and may decline to take action to suspend, revoke,

1 cancel or deny the driver's license of such person, notwithstanding
2 any other provision of law.

3 SECTION 12. AMENDATORY 47 O.S. 2021, Section 6-209, is
4 amended to read as follows:

5 Section 6-209. A. ~~The Department~~ Service Oklahoma upon
6 canceling or denying the driver license of a person or upon
7 suspending or revoking the driving privilege of a person shall
8 require that the driver license of the person be surrendered to ~~the~~
9 ~~Department~~ Service Oklahoma. When the statutory requirements for
10 reinstatement are met in accordance with Oklahoma Statutes, the
11 person shall apply for a new driver license from ~~the Department~~
12 Service Oklahoma; provided ~~the Department~~ Service Oklahoma has
13 determined that the licensee is a person not prohibited from holding
14 a driver license under Section 6-103 of this title, and has
15 successfully completed the customary written, physical and driving
16 tests, if such tests are required. Identification of the person
17 shall be verified through the driver license digital file of ~~the~~
18 ~~Department~~ Service Oklahoma.

19 B. ~~The Department~~ Service Oklahoma, upon entering an order
20 canceling or denying a driver license or suspending or revoking the
21 driving privilege of a person, shall forward a copy of the order to
22 the licensee pursuant to the provisions of Section 2-116 of this
23 title and request the immediate return of the driver license to ~~the~~
24 ~~Department of Public Safety, Oklahoma City, Oklahoma, or the order~~

1 ~~may be served upon the licensee by an authorized member of the~~
2 ~~Department~~ Service Oklahoma. Failure to comply with the order of
3 ~~the Department~~ Service Oklahoma shall constitute a misdemeanor and,
4 upon conviction, the person shall be punished by a fine of not less
5 than Fifty Dollars (\$50.00) nor more than One Hundred Dollars
6 (\$100.00).

7 C. Any peace officer of this state may seize the license of any
8 person who, according to ~~Department~~ Service Oklahoma records, is
9 under suspension, cancellation, revocation or denial under the
10 provisions of this title. The officer shall immediately forward the
11 license to ~~the Department of Public Safety, Oklahoma City,~~ Service
12 Oklahoma.

13 D. No person shall have a property interest in the physical
14 driver license issued pursuant to the laws of this state. It shall
15 be the duty of every person whose driving privilege has been
16 suspended, canceled or revoked to immediately surrender his or her
17 driver license upon the request of any peace officer or
18 representative of ~~the Department~~ Service Oklahoma.

19 SECTION 13. AMENDATORY 47 O.S. 2021, Section 1102, as
20 amended by Section 106, Chapter 282, O.S.L. 2022 (47 O.S. Supp.
21 2023, Section 1102), is amended to read as follows:

22 Section 1102. As used in the Oklahoma Vehicle License and
23 Registration Act:

24

1 1. "All-terrain vehicle" means a vehicle manufactured and used
2 exclusively for off-highway use traveling on four or more non-
3 highway tires, and being fifty (50) inches or less in width;

4 2. "Carrying capacity" means the carrying capacity of a vehicle
5 as determined or declared in tons of cargo or payload by the owner;
6 provided, that such declared capacity shall not be less than the
7 minimum tonnage capacity fixed, listed or advertised by the
8 manufacturer of any vehicle;

9 3. "Certificate of title" means a document which is proof of
10 legal ownership of a motor vehicle as described and provided for in
11 Section 1105 of this title;

12 4. "Chips and oil" or the term "road oil and crushed rock"
13 means, with respect to materials authorized for use in the surfacing
14 of roads or highways as provided for in this title or in any
15 equivalent statute pertaining to road or highway surfacing in the
16 State of Oklahoma, any asphaltic materials. Wherever chips and oil
17 or road oil and crushed rock are authorized for use in the surfacing
18 of roads or highways in this state, whether by the Department of
19 Transportation, or by the county commissioners, or other road
20 building authority subject to the Oklahoma Vehicle License and
21 Registration Act, asphaltic materials are also authorized for use in
22 such surfacing and construction;

23 5. "Combined laden weight" means the weight of a truck or
24 station wagon and its cargo or payload transported thereon, or the

1 weight of a truck or truck-tractor plus the weight of any trailers
2 or semitrailers together with the cargo or payload transported
3 thereon;

4 6. "Commercial trailer" means any trailer, as defined in
5 Section 1-180 of this title, or semitrailer, as defined in Section
6 1-162 of this title, when such trailer or semitrailer is used
7 primarily for business or commercial purposes;

8 7. "Commercial trailer dealer" means any person, firm or
9 corporation engaged in the business of selling any new and unused,
10 or used, or both new and used commercial trailers;

11 8. "Commercial vehicle" means any vehicle over eight thousand
12 (8,000) pounds combined laden weight used primarily for business or
13 commercial purposes. Each motor vehicle being registered pursuant
14 to the provisions of this section shall have the name of the
15 commercial establishment or the words "Commercial Vehicle"
16 permanently and prominently displayed upon the outside of the
17 vehicle in letters not less than two (2) inches high. Such letters
18 shall be in sharp contrast to the background and shall be of
19 sufficient shape and color as to be readily legible during daylight
20 hours, from a distance of fifty (50) feet while the vehicle is not
21 in motion;

22 9. "Commission" or "Tax Commission" means the Oklahoma Tax
23 Commission;

24

1 10. "Construction machinery" means machines or devices drawn as
2 trailers which are designed and used for construction, tree trimming
3 and waste maintenance projects, which derive no revenue from the
4 transportation of persons or property, whose use of the highway is
5 only incidental and which are not mounted or affixed to another
6 vehicle; provided, construction machinery shall not include
7 implements of husbandry as defined in Section 1-125 of this title;

8 11. "Dealer" means any person, firm, association, corporation
9 or trust who sells, solicits or advertises the sale of new and
10 unused motor vehicles and holds a bona fide contract or franchise in
11 effect with a manufacturer or distributor of a particular make of
12 new or unused motor vehicle or vehicles for the sale of same;

13 12. "Mini-truck" means a foreign-manufactured import or
14 domestic-manufactured vehicle powered by an internal combustion
15 engine with a piston or rotor displacement of one thousand cubic
16 centimeters (1,000 cc) or less, which is sixty-seven (67) inches or
17 less in width, with an unladen dry weight of three thousand four
18 hundred (3,400) pounds or less, traveling on four or more tires,
19 having a top speed of approximately fifty-five (55) miles per hour,
20 equipped with a bed or compartment for hauling, and having an
21 enclosed passenger cab;

22 13. "Interstate commerce" means any commerce moving between any
23 place in a state and any place in another state or between places in
24 the same state through another state;

1 14. "Laden weight" means the combined weight of a vehicle when
2 fully equipped for use and the cargo or payload transported thereon;
3 provided, that in no event shall the laden weight be less than the
4 unladen weight of the vehicle fully equipped for use, plus the
5 manufacturer's rated carrying capacity;

6 15. "Local authorities" means every county, municipality or
7 local board or body having authority to adopt police regulations
8 under the Constitution and laws of this state;

9 16. "Low-speed electrical vehicle" means any four-wheeled
10 electrical vehicle that is powered by an electric motor that draws
11 current from rechargeable storage batteries or other sources of
12 electrical current and whose top speed is greater than twenty (20)
13 miles per hour but not greater than twenty-five (25) miles per hour
14 and is manufactured in compliance with the National Highway Traffic
15 Safety Administration standards for low-speed vehicles in 49 C.F.R.
16 571.500;

17 17. "Manufactured home" means a residential dwelling built in
18 accordance with the National Manufactured Housing Construction and
19 Safety Standards Act of 1974, 42 U.S.C., Section 5401 et seq., and
20 rules promulgated pursuant thereto and the rules promulgated by the
21 Oklahoma Used Motor Vehicle and Parts Commission pursuant to Section
22 582 of this title. Manufactured home shall not mean a park model
23 recreational vehicle as defined in this section;

1 18. "Manufactured home dealer" means any person, firm or
2 corporation engaged in the business of selling any new and unused,
3 or used, or both new and used manufactured homes. Such information
4 and a valid franchise letter as proof of authorization to sell any
5 such new manufactured home product line or lines shall be attached
6 to the application for a dealer license to sell manufactured homes.
7 "Manufactured home dealer" shall not include any person, firm or
8 corporation who sells or contracts for the sale of the dealer's own
9 personally titled manufactured home or homes. No person, firm or
10 corporation shall be considered a manufactured home dealer as to any
11 manufactured home purchased or acquired by such person, firm or
12 corporation for purposes other than resale; provided, that the
13 restriction set forth in this sentence shall not prevent an
14 otherwise qualified person, firm or corporation from utilizing a
15 single manufactured home as a sales office;

16 19. "Medium-speed electrical vehicle" means any self-propelled,
17 electrically powered four-wheeled motor vehicle, equipped with a
18 roll cage or crush-proof body design, whose speed attainable in one
19 (1) mile is more than thirty (30) miles per hour but not greater
20 than thirty-five (35) miles per hour;

21 20. "Licensed operator" means any person ~~appointed, designated~~
22 ~~or authorized by Service Oklahoma to collect the fees and to enforce~~
23 ~~the provisions provided for in the Oklahoma Vehicle License and~~
24 ~~Registration Act~~ licensed by the Service Oklahoma Operator Board or

1 designated or authorized to collect the fees and enforce the
2 provisions related to the fulfillment of designated services to be
3 rendered by Service Oklahoma;

4 21. "New vehicle" or "unused vehicle" means a vehicle which has
5 been in the possession of the manufacturer, distributor or
6 wholesaler or has been sold only by the manufacturer, distributor or
7 wholesaler to a dealer;

8 22. "Nonresident" means any person who is not a resident of
9 this state;

10 23. "Off-road motorcycle" means any motorcycle, as defined in
11 Section 1-135 of this title, when such motorcycle has been
12 manufactured for and used exclusively off roads, highways and any
13 other paved surfaces;

14 24. "Owner" means any person owning, operating or possessing
15 any vehicle herein defined;

16 25. "Park model recreational vehicle" means a vehicle that is:
17 a. designed and marketed as temporary living quarters for
18 camping, recreational, seasonal or travel use,
19 b. not permanently affixed to real property for use as a
20 permanent dwelling,
21 c. built on a single chassis mounted on wheels with a
22 gross trailer area not exceeding four hundred (400)
23 square feet in the setup mode, and
24

1 d. certified by the manufacturer as complying with
2 standard A119.5 of the American National Standards
3 Institute, Inc.;

4 26. "Person" means any individual, copartner, joint venture,
5 association, corporation, limited liability company, estate, trust,
6 business trust, syndicate, the State of Oklahoma, Service Oklahoma,
7 or any county, city, municipality, school district or other
8 political subdivision thereof, or any group or combination acting as
9 a unit, or any receiver appointed by the state or federal court;

10 27. "Rebodied vehicle" means a vehicle:

11 a. which has been assembled using a new body or new major
12 component which is of the identical type as the
13 original vehicle and is licensed by the manufacturer
14 of the original vehicle and other original, new or
15 reconditioned parts. For purposes of this paragraph,
16 "new body or new major component" means a new body,
17 cab, frame, front end clip or rear end clip,

18 b. which is not a salvage, rebuilt, or junked vehicle as
19 defined by paragraph 1, 2, or 6 of subsection A of
20 Section 1105 of this title, and

21 c. for which Service Oklahoma has assigned or will assign
22 a new identifying number;

23 28. "Recreational off-highway vehicle" means a vehicle
24 manufactured and used exclusively for off-highway use, traveling on

1 four or more non-highway tires, and being sixty-five (65) inches or
2 less in width;

3 29. "Recreational vehicle" means every vehicle which is built
4 on or permanently attached to a self-propelled motor chassis or
5 chassis cab which becomes an integral part of the completed vehicle
6 and is capable of being operated on the highways. In order to
7 qualify as a recreational vehicle pursuant to this paragraph such
8 vehicle shall be permanently constructed and equipped for human
9 habitation, having its own sleeping and kitchen facilities,
10 including permanently affixed cooking facilities, water tanks and
11 holding tank with permanent toilet facilities. Recreational vehicle
12 shall not include manufactured homes or any vehicle with portable
13 sleeping, toilet and kitchen facilities which are designed to be
14 removed from such vehicle. Recreational vehicle shall include park
15 model recreational vehicles as defined in this section;

16 30. "Remanufactured vehicle" means a vehicle which has been
17 assembled by a vehicle remanufacturer using a new body and which may
18 include original, reconditioned, or remanufactured parts, and which
19 is not a salvage, rebuilt, or junked vehicle as defined by
20 paragraphs 1, 2, and 6, respectively, of subsection A of Section
21 1105 of this title;

22 31. "Rental trailer" means all small or utility trailers or
23 semitrailers constructed and suitable for towing by a passenger
24 automobile and designed only for carrying property, when the

1 trailers or semitrailers are owned by, or are in the possession of,
2 any person engaged in renting or leasing such trailers or
3 semitrailers for intrastate or interstate use or combined intrastate
4 and interstate use;

5 32. "Special mobilized machinery" means special purpose
6 machines or devices, either self-propelled or drawn as trailers or
7 semitrailers, which derive no revenue from the transportation of
8 persons or property, whose use of the highway is only incidental,
9 and whose useful revenue producing service is performed at
10 destinations in an area away from the traveled surface of an
11 established open highway;

12 33. "State" means the State of Oklahoma;

13 34. "Station wagon" means any passenger vehicle which does not
14 have a separate luggage compartment or trunk and which does not have
15 open beds, and has one or more rear seats readily lifted out or
16 folded, whether same is called a station wagon or ranch wagon;

17 35. "Street-legal utility vehicle" means a vehicle meeting the
18 description and specifications of Section 1-171.1 of this title;

19 36. "Travel trailer" means any vehicular portable structure
20 built on a chassis, used as a temporary dwelling for travel,
21 recreational or vacation use, and, when factory-equipped for the
22 road, it shall have a body width not exceeding eight (8) feet and an
23 overall length not exceeding forty (40) feet, including the hitch or
24 coupling;

1 37. "Travel trailer dealer" means any person, firm or
2 corporation engaged in the business of selling any new and unused,
3 or used, or both new and used travel trailers. Such information and
4 a valid franchise letter as proof of authorization to sell any such
5 new travel trailer product line or lines shall be attached to the
6 application for a dealer license to sell travel trailers. "Travel
7 trailer dealer" shall not include any person, firm or corporation
8 who sells or contracts for the sale of his or her own personally
9 titled travel trailer or trailers. No person, firm or corporation
10 shall be considered as a travel trailer dealer as to any travel
11 trailer purchased or acquired by such person, firm or corporation
12 for purposes other than resale;

13 38. "Used motor vehicle dealer" means "used motor vehicle
14 dealer" as defined in Section 581 of this title;

15 39. "Used vehicle" means any vehicle which has been sold,
16 bargained, exchanged or given away, or used to the extent that it
17 has become what is commonly known, and generally recognized, as a
18 "secondhand" vehicle. This shall also include any vehicle other
19 than a remanufactured vehicle, regardless of age, owned by any
20 person who is not a dealer;

21 40. "Utility vehicle" means a vehicle powered by an internal
22 combustion engine, manufactured and used exclusively for off-highway
23 use, equipped with seating for two or more people and a steering
24 wheel, traveling on four or more wheels;

1 41. "Vehicle" means any type of conveyance or device in, upon
2 or by which a person or property is or may be transported from one
3 location to another upon the avenues of public access within the
4 state. "Vehicle" does not include bicycles, trailers except travel
5 trailers and rental trailers, or implements of husbandry as defined
6 in Section 1-125 of this title. All implements of husbandry used as
7 conveyances shall be required to display the owner's driver license
8 number or license plate number of any vehicle owned by the owner of
9 the implement of husbandry on the rear of the implement in numbers
10 not less than two (2) inches in height. The use of the owner's
11 Social Security number on the rear of the implement of husbandry
12 shall not be required; and

13 42. "Vehicle remanufacturer" means a commercial entity which
14 assembles remanufactured vehicles.

15 SECTION 14. AMENDATORY 51 O.S. 2021, Section 24A.5, as
16 amended by Section 5, Chapter 332, O.S.L. 2023 (51 O.S. Supp. 2023,
17 Section 24A.5), is amended to read as follows:

18 Section 24A.5 All records of public bodies and public officials
19 shall be open to any person for inspection, copying, or mechanical
20 reproduction during regular business hours; provided:

21 1. The Oklahoma Open Records Act, Sections 24A.1 through 24A.30
22 of this title, does not apply to records specifically required by
23 law to be kept confidential including:

24

- 1 a. records protected by a state evidentiary privilege
2 such as the attorney-client privilege, the work
3 product immunity from discovery and the identity of
4 informer privileges,
- 5 b. records of what transpired during meetings of a public
6 body lawfully closed to the public such as executive
7 sessions authorized under the Oklahoma Open Meeting
8 Act,
- 9 c. personal information within driver records as defined
10 by the Driver's Privacy Protection Act, 18 United
11 States Code, Sections 2721 through 2725,
- 12 d. information in the files of the Board of Medicolegal
13 Investigations obtained pursuant to Sections 940 and
14 941 of Title 63 of the Oklahoma Statutes that may be
15 hearsay, preliminary unsubstantiated investigation-
16 related findings, or confidential medical information,
- 17 e. any test forms, question banks and answer keys
18 developed for state licensure examinations, but
19 specifically excluding test preparation materials or
20 study guides, or
- 21 f. last names, addresses, social security numbers or tax
22 identification numbers, and proof of identification
23 submitted to the Oklahoma Lottery Commission by
24 persons claiming a lottery prize;

1 2. All Social Security numbers included in a record may be
2 confidential regardless of the person's status as a public employee
3 or private individual and may be redacted or deleted prior to
4 release of the record by the public body;

5 3. Any reasonably segregable portion of a record containing
6 exempt material shall be provided after deletion of the exempt
7 portions; provided however, ~~the Department of Public Safety Service~~
8 Oklahoma shall not be required to assemble for the requesting person
9 specific information, in any format, from driving records relating
10 to any person whose name and date of birth or whose driver license
11 number is not furnished by the requesting person.

12 The Oklahoma State Bureau of Investigation shall not be required
13 to assemble for the requesting person any criminal history records
14 relating to persons whose names, dates of birth, and other
15 identifying information required by the Oklahoma State Bureau of
16 Investigation pursuant to administrative rule are not furnished by
17 the requesting person;

18 4. Any request for a record which contains individual records
19 of persons, and the cost of copying, reproducing or certifying each
20 individual record is otherwise prescribed by state law, the cost may
21 be assessed for each individual record, or portion thereof requested
22 as prescribed by state law. Otherwise, a public body may charge a
23 fee only for recovery of the reasonable, direct costs of record
24 copying, or mechanical reproduction. Notwithstanding any state or

1 local provision to the contrary, in no instance shall the record
2 copying fee exceed twenty-five cents (\$0.25) per page for records
3 having the dimensions of eight and one-half (8 1/2) by fourteen (14)
4 inches or smaller, or a maximum of One Dollar (\$1.00) per copied
5 page for a certified copy. However, if the request:

- 6 a. is solely for commercial purpose, or
- 7 b. would clearly cause excessive disruption of the
8 essential functions of the public body,

9 then the public body may charge a reasonable fee to recover the
10 direct cost of record search and copying; however, publication in a
11 newspaper or broadcast by news media for news purposes shall not
12 constitute a resale or use of a record for trade or commercial
13 purpose and charges for providing copies of electronic data to the
14 news media for a news purpose shall not exceed the direct cost of
15 making the copy. The fee charged by the Department of Public Safety
16 for a copy in a computerized format of a record of the Department
17 shall not exceed the direct cost of making the copy unless the fee
18 for the record is otherwise set by law.

19 Any public body establishing fees under this act shall post a
20 written schedule of the fees at its principal office and with the
21 county clerk.

22 In no case shall a search fee be charged when the release of
23 records is in the public interest, including, but not limited to,
24 release to the news media, scholars, authors and taxpayers seeking

1 to determine whether those entrusted with the affairs of the
2 government are honestly, faithfully, and competently performing
3 their duties as public servants.

4 The fees shall not be used for the purpose of discouraging
5 requests for information or as obstacles to disclosure of requested
6 information;

7 5. The land description tract index of all recorded instruments
8 concerning real property required to be kept by the county clerk of
9 any county shall be available for inspection or copying in
10 accordance with the provisions of the Oklahoma Open Records Act;
11 provided, however, the index shall not be copied or mechanically
12 reproduced for the purpose of sale of the information;

13 6. A public body must provide prompt, reasonable access to its
14 records but may establish reasonable procedures which protect the
15 integrity and organization of its records and to prevent excessive
16 disruptions of its essential functions. A delay in providing access
17 to records shall be limited solely to the time required for
18 preparing the requested documents and the avoidance of excessive
19 disruptions of the public body's essential functions. In no event
20 may production of a current request for records be unreasonably
21 delayed until after completion of a prior records request that will
22 take substantially longer than the current request. Any public body
23 which makes the requested records available on the Internet shall

24

1 meet the obligation of providing prompt, reasonable access to its
2 records as required by this paragraph; and

3 7. A public body shall designate certain persons who are
4 authorized to release records of the public body for inspection,
5 copying, or mechanical reproduction. At least one person shall be
6 available at all times to release records during the regular
7 business hours of the public body.

8 SECTION 15. It being immediately necessary for the preservation
9 of the public peace, health or safety, an emergency is hereby
10 declared to exist, by reason whereof this act shall take effect and
11 be in full force from and after its passage and approval.
