7 An Act relating to the Oklahoma Department of
8 Agriculture, Food, and Forestry; creating the
9 Oklahoma City National Memorial Education Revolving
10 Fund; making an appropriation; providing for
11 expenditures; providing purpose of fund; providing
12 for codification; providing an effective date; and
13 declaring an emergency.

14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. NEW LAW A new section of law to be codified
16 in the Oklahoma Statutes as Section 2-34 of Title 2, unless there is
17 created a duplication in numbering, reads as follows:

18 There is hereby created in the State Treasury a revolving fund
19 for the Oklahoma Department of Agriculture, Food, and Forestry to be
20 designated the "Oklahoma City National Memorial Education Revolving
21 Fund". The fund shall be a continuing fund, not subject to fiscal
22 year limitations, and shall consist of all monies received by the
23 Oklahoma Department of Agriculture, Food, and Forestry from
24 legislative appropriations for the purpose of providing curriculum
materials and instruction on the April 19, 1995, Alfred P. Murrah

1 Federal Building bombing to students in this state. All monies
2 accruing to the credit of the fund are hereby appropriated and may
3 be expended by the Oklahoma Department of Agriculture, Food, and
4 Forestry for the purpose provided for in this section.

5 Expenditures from the fund shall be made upon warrants issued by
6 the State Treasurer against claims filed as prescribed by law with
7 the Director of the Office of Management and Enterprise Services for
8 approval and payment.

9 SECTION 2. There is hereby appropriated to the Oklahoma City
10 National Memorial Education Revolving Fund from any monies not
11 otherwise appropriated from the General Revenue Fund of the State
12 Treasury for the fiscal year ending June 30, 2025, the sum of One
13 Million Five Hundred Thousand Dollars (\$1,500,000.00) or so much
14 thereof as necessary for the purpose of providing curriculum
15 materials and instruction on the April 19, 1995, Alfred P. Murrah
16 Federal Building bombing to Oklahoma students.

17 SECTION 3. This act shall become effective July 1, 2024.

18 SECTION 4. It being immediately necessary for the preservation
19 of the public peace, health or safety, an emergency is hereby
20 declared to exist, by reason whereof this act shall take effect and
21 be in full force from and after its passage and approval.
