11	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
12	SECTION 1. NEW LAW A new section of law to be codified
13	in the Oklahoma Statutes as Section 1096 of Title 64, unless there
14	is created a duplication in numbering, reads as follows:
15	The Commissioners of the Land Office and the Office of
16	Management and Enterprise Services shall contract with the
17	Department of Public Safety for security and law enforcement
18	services in all facilities under the jurisdiction of the Offices or
19	Department within "State Capitol Park" in Oklahoma City and the
20	Executive Center at 201 West 5th Street and appurtenances thereto in
21	Tulsa.
22	SECTION 2. AMENDATORY 73 O.S. 2021, Section 173, is
23	amended to read as follows:

Section 173. A. The Oklahoma Capitol Improvement Authority may
contract with the Office of Management and Enterprise Services to
maintain grounds and for housekeeping, maintenance and repair of
properties under the jurisdiction of the Authority.

5 B. The Oklahoma Capitol Improvement Authority and the Office of 6 Management and Enterprise Services shall contract with the 7 Department of Public Safety for security and law enforcement 8 services in all facilities under the jurisdiction of the Authority 9 or Department within "State Capitol Park" in Oklahoma City and the 10 J. Howard Edmondson Office Building, Robert S. Kerr Office Building 11 and appurtenances thereto in Tulsa.

12 C. The Oklahoma Capitol Improvement Authority shall provide 13 office and operations space for Office of Management and Enterprise 14 Services' functions.

The Office of Management and Enterprise Services shall 15 D. establish accounts for the Office of Management and Enterprise 16 Services, by building or other improvement, as the Director of the 17 Office of Management and Enterprise Services considers necessary to 18 properly account and identify receipts and expenditures related to 19 construction, repair, maintenance, insurance and other operating 20 expenses of buildings and improvements owned, used or occupied by or 21 on behalf of the Oklahoma Capitol Improvement Authority, where the 22 services are carried out by contract with the Authority. 23

24 SECTION 3. This act shall become effective November 1, 2024.
