6 An Act relating to motor vehicles; amending 47 O.S.
7 2021, Section 2-124, which relates to the Oklahoma
8 Law Enforcement Telecommunication Systems Division;
9 updating statutory language; providing certain
10 vehicle registration information; and providing an
11 effective date.

12 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

13 SECTION 1. AMENDATORY 47 O.S. 2021, Section 2-124, is
14 amended to read as follows:

15 Section 2-124. A. There is hereby created within the
16 Department of Public Safety an Oklahoma Law Enforcement
17 Telecommunication Systems Division.

18 B. The Division shall:

19 1. Operate and maintain an ~~on-line~~ online, realtime computer
20 system and a statewide law enforcement data communication network;

21 2. Utilize and distribute information on vehicle registration,
22 driver records, criminals and the commission of crimes;

23 3. Be responsible for the coordination of user agencies with
24 the National Crime Information Center in Washington, D.C., and the
National Law Enforcement Telecommunication System, or its successor;

1 4. Be the central access and control point for ~~Oklahoma's~~ the
2 state's input, retrieval, and exchange of law enforcement
3 information in the National Crime Information Center and the
4 National Law Enforcement Telecommunication System; and

5 5. Provide user agencies a data communication network, in order
6 to exchange and distribute law enforcement data rapidly, and
7 training in the use of the Oklahoma Law Enforcement
8 Telecommunication Systems.

9 C. The statewide law enforcement data communications network
10 shall be a part of the Oklahoma Government Telecommunications
11 Network (OGTN) created in Section 34.23 of Title 62 of the Oklahoma
12 Statutes; provided, however, the Department of Public Safety may
13 continue to operate, maintain, and enhance the statewide law
14 enforcement data communications network; provided, however, the
15 Department of Public Safety shall submit all plans for the
16 enhancement of the statewide law enforcement communications network
17 to the Office of Management and Enterprise Services for review and
18 approval. The Department of Public Safety shall participate with
19 the Office of Management and Enterprise Services in joint efforts to
20 provide services for the OGTN.

21 D. All criminal justice agencies disseminating criminal history
22 information derived from the National Crime Information Center's
23 criminal history file shall maintain a record of dissemination in
24 accordance with federal law as well as rules promulgated by the

1 National Crime Information Center and the Commissioner of Public
2 Safety.

3 E. The Oklahoma Law Enforcement Telecommunication Systems
4 Division shall have the authority to audit state and local law
5 enforcement and criminal justice agencies to ensure compliance with
6 federal laws as well as rules of the Department of Public Safety
7 which pertain to the Oklahoma Law Enforcement Telecommunication
8 Systems.

9 F. The Department of Public Safety may provide the Oklahoma
10 Turnpike Authority vehicle registration information within this
11 state that is available through the Oklahoma Law Enforcement
12 Telecommunication Systems network for purposes of the operation of
13 toll transportation facilities.

14 SECTION 2. This act shall become effective November 1, 2024.
