18	incentive scholarship program and teacher employment incentive
19	program, pursuant to Section 698.3 of Title 70 of the Oklahoma
20	Statutes. Such funds shall be used to supplement rather than
21	replace existing resources and programs.
22	SECTION 2. From the funds appropriated to the Oklahoma State
23	Regents for Higher Education in Enrolled House Bill No. 1004 of the
24	1st Extraordinary Session of the 59th Oklahoma Legislature, the

Oklahoma State Regents for Higher Education are authorized to expend
 during the fiscal year ending June 30, 2024, the sum of Twelve
 Million Five Hundred Thousand Dollars (\$12,500,000.00) for the
 purpose of establishing the National Guard Educational Assistance
 Fund.

From the funds appropriated to the Oklahoma State 7 Regents for Higher Education in Enrolled House Bill No. 1004 of the 8 1st Extraordinary Session of the 59th Oklahoma Legislature, the 9 Oklahoma State Regents for Higher Education are authorized to expend 10 during the fiscal year ending June 30, 2024, the sum of Forty-eight 11 Million Nine Hundred Eight Thousand Two Hundred Sixteen Dollars 12 (\$48,908,216.00) for the purpose of faculty pay raises.

SECTION 4. From the funds appropriated to the Oklahoma State 13 Regents for Higher Education in Enrolled House Bill No. 1004 of the 14 1st Extraordinary Session of the 59th Oklahoma Legislature, the 15 Oklahoma State Regents for Higher Education are authorized to expend 16 17 during the fiscal year ending June 30, 2024, the sum of Twenty Million Dollars (\$20,000,000.00) for the purpose of expanding 18 engineering programs. Such funds shall be used to supplement rather 19 than replace existing resources and programs. 20

21 SECTION 5. From the funds appropriated to the Oklahoma State 22 Regents for Higher Education in Enrolled House Bill No. 1004 of the 23 1st Extraordinary Session of the 59th Oklahoma Legislature, the 24 Oklahoma State Regents for Higher Education are authorized to expend

From the funds appropriated to the Oklahoma State 18 Regents for Higher Education in Enrolled House Bill No. 1004 of the 19 1st Extraordinary Session of the 59th Oklahoma Legislature, the 20 Oklahoma State Regents for Higher Education are authorized to expend 21 during the fiscal year ending June 30, 2024, the sum of Two Hundred 22 Thousand Dollars (\$200,000.00) for the purpose of establishing a 23 food pantry. 24
