6 An Act relating to state government; amending 3 O.S.
7 2021, Sections 81, 82, 84, 84.2, 85, 85.1, 87, 90,
8 91, 92, 93, 102.1, 116, 121, 251, 256, 401, and 421,
9 which relate to the Oklahoma Aeronautics Commission
10 Act, Airport Zoning Act, Aircraft Pilot and Passenger
11 Protection Act, anemometer towers, registration of
12 aircraft, airport and air navigation facilities, and
13 unmanned aircraft development; changing name of
14 certain commission; amending Sections 3 and 4,
15 Chapter 203, O.S.L. 2022 (3 O.S. Supp. 2022, Sections
16 413 and 414), which relate to the Oklahoma Air
17 Service Development Grant Program and Oklahoma Air
18 Service Development Grant Program Revolving Fund;
19 changing name of certain commission; amending 17 O.S.
20 2021, Sections 160.20 and 160.21, as amended by
21 Section 2, Chapter 310, O.S.L. 2019, which relate to
22 the Oklahoma Wind Energy Development Act; changing
23 name of certain commission; amending 47 O.S. 2021,
24 Section 1135.5, as last amended by Section 3, Chapter
397, O.S.L. 2022 (47 O.S. Supp. 2022, Section
1135.5), which relates to special license plates;
changing name of certain commission; amending 68 O.S.
2021, Section 500.6a, which relates to the Motor Fuel
Tax Code; changing name of certain commission;
amending 68 O.S. 2021, Section 6005, as amended by
Section 1, Chapter 148, O.S.L. 2022 (68 O.S. Supp.
2022, Section 6005), which relates to Aircraft Excise
Tax; changing name of certain commission; amending 74
O.S. 2021, Section 5003.12, which relates to the
Aerospace Commerce Economic Services Act; changing
name of certain commission; updating statutory
language; updating statutory references; and
providing an effective date.

1 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

2 SECTION 1. AMENDATORY 3 O.S. 2021, Section 81, is
3 amended to read as follows:

4 Section 81. This act shall be known and may be cited as the
5 "Oklahoma ~~Aeronautics Commission~~ Department of Aerospace and
6 Aeronautics Act."

7 SECTION 2. AMENDATORY 3 O.S. 2021, Section 82, is
8 amended to read as follows:

9 Section 82. As used in the Oklahoma ~~Aeronautics Commission~~
10 Department of Aerospace and Aeronautics Act, unless the context
11 otherwise requires:

12 1. "Aeronautics" means the science, art and practice of flight
13 including, but not limited to, transportation by aircraft and
14 matters relating to air commerce; the operation, construction,
15 repair or maintenance of aircraft, aircraft power plants and
16 accessories including the repair, packing and maintenance of
17 parachutes; the design, establishment, construction, extension,
18 operation, improvement, repair or maintenance of airports,
19 restricted landing areas or other air navigation facilities; and
20 instruction in flying or ground subjects pertaining thereto;

21 2. "Aeronautical hazard" means any structure, object of natural
22 growth or use of land, which obstructs the airspace required for the
23 flight of aircraft in landing or taking off at an airport that is
24 otherwise hazardous to the operation and navigation of aircraft;

1 3. "Air navigation facility" means any facility used in,
2 available for use in, or designed for use in, aid of air navigation
3 including landing areas, any structures, mechanisms, lights,
4 beacons, markers, communicating systems or other instrumentalities
5 or devices used or useful as an aid, or constituting an advantage or
6 convenience, to the safe taking off, navigation and landing of
7 aircraft, or the safe and efficient operation or maintenance of an
8 airport and any combination of any or all of such facilities;

9 4. "Aircraft" means any contraption now known, or hereafter
10 invented, used or designed for navigation of or flight in the air or
11 airspace;

12 5. "Airman" means any individual who engages, as the person in
13 command, or as a pilot, mechanic or member of the crew, in the
14 navigation of aircraft while under way, and any individual who is
15 directly in charge of the inspection, maintenance, overhauling or
16 repair of aircraft, aircraft engines, propellers and appliances;

17 6. "Airport" means an area of land or water that is used, or
18 intended to be used, for the landing and takeoff of aircraft, and
19 buildings and facilities, if any;

20 7. "Airspace" means that portion of the atmosphere overlying a
21 designated geographical area considered as subject to territorial
22 jurisdiction or international law in respect to its use by aircraft,
23 guided missiles, and rockets;

1 8. "Commercial service airport" means an airport meeting the
2 current Federal Aviation Administration definition for commercial
3 service airport;

4 9. "Commission" means the seven members of the Oklahoma
5 Aerospace and Aeronautics Commission as appointed by the Governor;

6 10. "Department" means the Oklahoma Department of Aerospace and
7 Aeronautics;

8 ~~10.~~ 11. "Director" means the Director of the Oklahoma
9 Department of Aerospace and Aeronautics ~~of Oklahoma;~~

10 ~~11.~~ 12. "General aviation airport" means an airport not meeting
11 the criteria for definition as a commercial service or reliever
12 airport;

13 ~~12.~~ 13. "Helipad" means a small, designated area, usually with
14 a prepared surface, on a heliport, airport, landing or takeoff area,
15 apron or ramp, or movement area used for takeoff, landing or parking
16 of helicopters;

17 ~~13.~~ 14. "Heliport" means an area of land, water or structure
18 used or intended to be used for the landing and takeoff of
19 helicopters and includes its buildings and facilities, if any;

20 ~~14.~~ 15. "Manned aircraft" means an aircraft, as defined in this
21 section, that is operated with a person in or on the aircraft;

22 ~~15.~~ 16. "Model aircraft" means an aircraft as defined in this
23 section that is mechanically driven or launched into flight and that
24 meets all of the following requirements:

1 a. is flown solely for hobby or recreational purposes,
2 and

3 b. is not used for payment, consideration, gratuity or
4 benefit, directly or indirectly charged, demanded,
5 received or collected by any person for the use of the
6 aircraft or any photographic or video image produced
7 by the aircraft;

8 ~~16.~~ 17. "Municipality" means any incorporated city, village, or
9 town of this state and any county or political subdivision or
10 district in this state, or any public trust thereof, which is, or
11 may be, authorized by law to acquire, establish, construct,
12 maintain, improve, and operate airports, airstrips, and aeronautical
13 navigation facilities;

14 ~~17.~~ 18. "Operation of aircraft" or "operate aircraft" means the
15 use, navigation or piloting of aircraft in the airspace over this
16 state or upon any airport within this state;

17 ~~18.~~ 19. "Person" means any individual, firm, partnership,
18 corporation, company, association, joint stock association or body
19 politic and includes any trustee, receiver, assignee or other
20 similar representative thereof;

21 ~~19.~~ 20. "Primary commercial service airport" means an airport
22 meeting the current Federal Aviation Administration definition for
23 primary commercial service airport;

1 ~~20.~~ 21. "Reliever airport" means an airport designated by the
2 Federal Aviation Administration as a reliever airport and which
3 provides substantial capacity or instrument training relief to a
4 primary commercial service airport;

5 ~~21.~~ 22. "Resources" means services, facilities, funds,
6 equipment, property, personnel and such other activities as are
7 customarily included within the term;

8 ~~22.~~ 23. "State" or "this state" means the State of Oklahoma;

9 ~~23.~~ 24. "Unmanned aircraft" means an aircraft, as defined in
10 this section, that is operated without the possibility of human
11 intervention from within or on the aircraft; and

12 ~~24.~~ 25. "Unmanned aircraft system" means an unmanned aircraft
13 and associated elements including communication links and components
14 that control the unmanned aircraft that are required for the pilot
15 in command to operate safely and efficiently in the National
16 Airspace System.

17 SECTION 3. AMENDATORY 3 O.S. 2021, Section 84, is
18 amended to read as follows:

19 Section 84. A. There is hereby created the Oklahoma Aerospace
20 and Aeronautics Commission, which shall be the successor to the
21 Oklahoma Aviation Commission created by Section 81 et seq. of this
22 title. The Oklahoma Aerospace and Aeronautics Commission shall
23 consist of seven (7) members, who shall be appointed by the Governor
24 and who shall continue in office, as designated by the Governor at

1 the time of appointment, through the last day of the second, third,
2 fourth, fifth, sixth, and seventh calendar years, respectively,
3 following the passage of ~~this act~~ Section 81 et seq. of this title,
4 with the initial seventh member remaining in office until the end of
5 the calendar year 1979. The successors of the members initially
6 appointed shall be appointed for terms of six (6) years in the same
7 manner as the members originally appointed under ~~this act~~ Section 81
8 et seq. of this title, except that any person appointed to fill a
9 vacancy shall be appointed only for the remainder of such term.
10 Each member shall serve until the appointment and qualification of a
11 successor. One member shall be appointed from each congressional
12 district and any remaining members shall be appointed from the state
13 at large. However, when congressional districts are redrawn each
14 member appointed prior to July 1 of the year in which such
15 modification becomes effective shall complete the current term of
16 office and appointments made after July 1 of the year in which such
17 modification becomes effective shall be based on the redrawn
18 districts. Appointments made after July 1 of the year in which such
19 modification becomes effective shall be from any redrawn districts
20 which are not represented by a board member until such time as each
21 of the modified congressional districts are represented by a board
22 member. No appointments may be made after July 1 of the year in
23 which such modification becomes effective if such appointment would
24 result in more than two members serving from the same modified

1 district. To qualify for appointment to the Commission, an
2 appointee shall have the following minimum qualifications:

3 1. A citizen and bona fide resident of the state; and

4 2. Three (3) years' experience in aeronautical activities, such
5 as general aviation, agricultural aviation, airport management, or
6 air carrier operation.

7 Members of the Commission shall receive no salary but shall be
8 entitled to be reimbursed for necessary travel expenses pursuant to
9 the State Travel Reimbursement Act. The members of the Commission
10 may be removed by the Governor for inefficiency, neglect of duty, or
11 malfeasance in office in the manner provided by law for the removal
12 of officers not subject to impeachment.

13 B. 1. A The Director of the Oklahoma Department of Aerospace
14 and Aeronautics shall be appointed by the Commission, ~~who~~ and shall
15 serve at the pleasure of the Commission. The Director shall be
16 appointed with due regard to such person's fitness, by aeronautical
17 education and by knowledge of and recent practical experience in
18 aeronautics for the efficient dispatch of the powers and duties duly
19 vested in and imposed upon the Director. The Director shall devote
20 full time to the duties of the office and shall not be actively
21 engaged or employed in any other business, vocation, or employment,
22 nor shall the Director have any pecuniary interest in or any stock
23 in or bonds of any civil aeronautics enterprise. The Director shall
24 be reimbursed for all traveling and other expenses incurred in the

1 discharge of the official duties of the Director, subject to general
2 statutory limitations on such expenses as contained in the State
3 Travel Reimbursement Act.

4 2. The Director shall be the executive officer of the
5 ~~Commission~~ Department and under its supervision shall administer the
6 provisions of ~~this act~~ Section 81 et seq. of this title and rules,
7 regulations, and orders established thereunder and all other laws of
8 the state relative to aeronautics. The Director shall attend all
9 meetings of the Commission, but shall have no vote. The Director
10 shall be in charge of the offices of the ~~Commission~~ Department and
11 responsible ~~to the Commission~~ for the preparation of reports and the
12 collection and dissemination of data and other public information
13 relating to aerospace and aeronautics. The Director is hereby
14 empowered to execute all contracts entered into by the Commission.

15 3. The Commission may, by written order filed in its office,
16 delegate to the Director any of the powers or duties vested in or
17 imposed upon it by ~~this act~~ Section 81 et seq. of this title. Such
18 delegated powers and duties may be exercised by the Director in the
19 name of the Commission.

20 4. The Director shall appoint, subject to the approval of the
21 Commission, such experts, field and office assistants, clerks, and
22 other employees as may be required and authorized for the proper
23 discharge of the functions of the ~~Commission~~ Department.

1 C. The Commission shall, within thirty (30) days after its
2 appointment, organize, adopt a seal, and make such rules and
3 regulations for its administration, not inconsistent herewith, nor
4 inconsistent with, or contrary to, any act of the Congress of the
5 United States or regulations promulgated or standards established
6 pursuant thereto, as it may deem expedient and from time to time
7 amend such rules and regulations. At such organizational meeting it
8 shall elect from among its members a chair, a vice chair, and a
9 secretary, to serve for one (1) year, and annually thereafter shall
10 elect such officers, all to serve until their successors are
11 appointed and qualified. The Commission shall schedule meetings at
12 a convenient time and place as they become necessary. Four (4)
13 members shall constitute a quorum, and no action shall be taken by
14 less than a majority of the Commission. Special meetings may be
15 called as provided by the rules and regulations of the Commission.
16 Regular meetings shall be held at the established offices of the
17 ~~Commission~~ Department, but, whenever the convenience of the public
18 or of the parties may be promoted, or delay or expense may be
19 prevented, the Commission may hold meetings, hearings, or
20 proceedings at any other place designated by it. The ~~Commission~~
21 Department shall report in writing to the Governor on or about
22 January 31 of each year. The report shall contain a summary of the
23 proceedings of the ~~Commission~~ Department during the preceding fiscal
24 year, a detailed and itemized statement of all revenue and of all

1 expenditures made by or ~~in~~ on behalf of the ~~Commission~~ Department,
2 such other information as it may deem necessary or useful, and any
3 additional information which may be requested by the Governor.

4 D. Suitable office space shall be provided by the Office of
5 Management and Enterprise Services for the ~~Commission~~ Department in
6 the City of Oklahoma City, and the ~~Commission~~ Department may incur
7 the necessary expense for office rent, furniture, stationery,
8 printing, incidental expenses, and other necessary expenses needed
9 for the administration of ~~this act~~ Section 81 et seq. of this title.

10 SECTION 4. AMENDATORY 3 O.S. 2021, Section 84.2, is
11 amended to read as follows:

12 Section 84.2. A. Beginning July 1, 2002, the Oklahoma
13 ~~Aeronautics Commission~~ Department of Aerospace and Aeronautics shall
14 cease to be part of or a division of the Department of
15 Transportation and shall be deemed to be a separate and distinct
16 agency, to be known as the Oklahoma ~~Aeronautics Commission~~
17 Department of Aerospace and Aeronautics, and not under the Merit
18 System of Personnel Administration. The Oklahoma ~~Aeronautics~~
19 ~~Commission~~ Department of Aerospace and Aeronautics and the Director
20 of the Oklahoma Department of Aerospace and Aeronautics shall
21 continue to exercise their statutory powers, duties, and
22 responsibilities. All records, property, equipment, assets, monies,
23 matters pending, and funds of the division shall be transferred to
24

1 the Oklahoma ~~Aeronautics Commission~~ Department of Aerospace and
2 Aeronautics.

3 B. 1. The number of full-time-equivalent employees for the
4 Oklahoma ~~Aeronautics Commission~~ Department of Aerospace and
5 Aeronautics shall not be less than ten, nor more than the number of
6 employees currently allowed by law for the Oklahoma Aeronautics
7 Commission division of the Department of Transportation and who
8 transfer to the Oklahoma ~~Aeronautics Commission~~ Department of
9 Aerospace and Aeronautics pursuant to this section. In no event
10 shall the total full-time-equivalent employees of the Oklahoma
11 ~~Aeronautics Commission~~ Department of Aerospace and Aeronautics
12 transferring or electing to remain with the Department of
13 Transportation exceed eighteen full-time-equivalent positions.

14 2. All full-time-equivalent employee positions for the Oklahoma
15 ~~Aeronautics Commission~~ Department of Aerospace and Aeronautics shall
16 not be under the Merit System of Personnel Administration and shall
17 be considered unclassified service. All employees shall serve at
18 the pleasure of the Director of the Oklahoma ~~Aeronautics Commission~~
19 Department of Aerospace and Aeronautics.

20 3. The Oklahoma ~~Aeronautics Commission~~ Department of Aerospace
21 and Aeronautics and the Department of Transportation may enter into
22 an agreement for the transfer of personnel from the Department of
23 Transportation to the Oklahoma ~~Aeronautics Commission~~ Department of
24 Aerospace and Aeronautics. No employee shall be transferred to the

1 Oklahoma ~~Aeronautics Commission~~ Department of Aerospace and
2 Aeronautics except on the freely given written consent of the
3 employee. All classified employees under the Merit System of
4 Personnel Administration who are not transferred to the Oklahoma
5 ~~Aeronautics Commission~~ Department of Aerospace and Aeronautics shall
6 retain the status in the class to which the position occupied by the
7 employee on July 1, 2002, is allocated by the Office of Personnel
8 Management. The salary of such an employee shall not be reduced as
9 a result of such position allocation. All employees who are
10 transferred to the Oklahoma ~~Aeronautics Commission~~ Department of
11 Aerospace and Aeronautics shall not be required to accept a lesser
12 grade or salary than presently received. All employees shall retain
13 leave, sick and annual time earned, and any retirement and longevity
14 benefits which have accrued during their tenure with the Department
15 of Transportation. The transfer of personnel between the state
16 agencies shall be coordinated with the Office of Personnel
17 Management.

18 C. The Oklahoma ~~Aeronautics Commission~~ Department of Aerospace
19 and Aeronautics shall be authorized to rent, lease, or own the
20 appropriate office space and property in order to conduct its
21 business. The Oklahoma ~~Aeronautics Commission~~ Department of
22 Aerospace and Aeronautics is authorized to accept gifts, bequests,
23 devises, contributions, and grants, public or private, including
24 federal funds or funds from any other source for use in furthering

1 the purpose of the Oklahoma ~~Aeronautics Commission~~ Department of
2 Aerospace and Aeronautics.

3 D. Funding for the Oklahoma ~~Aeronautics Commission~~ Department
4 of Aerospace and Aeronautics shall be provided for in the
5 appropriation process of the Legislature, in addition to any other
6 funding provided by law. The expenses incurred by the Oklahoma
7 ~~Aeronautics Commission~~ Department of Aerospace and Aeronautics as a
8 result of the transfer required by this section shall be paid by the
9 Oklahoma ~~Aeronautics Commission~~ Department of Aerospace and
10 Aeronautics.

11 E. The division within the Department of Transportation known
12 as the Oklahoma Aeronautics Commission shall be abolished by the
13 Transportation Commission after the transfer has been completed.

14 F. The Director of State Finance is directed to coordinate the
15 transfer of assets, funds, allotments, purchase orders, liabilities,
16 outstanding financial obligations or encumbrances provided for in
17 this section. The Department of Central Services shall coordinate
18 the transfer of property and records provided for in this section.

19 SECTION 5. AMENDATORY 3 O.S. 2021, Section 85, is
20 amended to read as follows:

21 Section 85. A. The Oklahoma ~~Aeronautics Commission~~ Department
22 of Aerospace and Aeronautics and its Director acting under its
23 authority is empowered and directed to encourage, foster, and assist
24 in the development of aerospace and aeronautics in this state and to

1 encourage the establishment of airports and air navigation
2 facilities. It shall cooperate with and assist the federal
3 government, the municipalities of this state, and other persons in
4 the development of aerospace and aeronautics, and shall seek to
5 coordinate the aeronautical activities of these bodies and persons.
6 Municipalities are authorized to cooperate with the ~~Commission~~
7 Department in the development of aeronautics and aeronautical
8 facilities in this state.

9 B. The ~~Commission~~ Department may organize and administer a
10 voluntary program of air-age education in cooperation with the
11 schools, colleges, and for the general public, and may prepare and
12 conduct voluntary flight clinics for airmen and issue such bulletins
13 and publications as may be required.

14 C. The ~~Commission~~ Department shall assist in all aeronautical
15 matters related to emergency management actions in conformance with
16 federal directions and with the Emergency Operations Plan of the
17 state.

18 D. The ~~Commission~~ Department may establish air markers
19 throughout the state.

20 E. The ~~Commission~~ Department may purchase and install roadside
21 signs directing highway traffic to airports, subject to approval of
22 the State Transportation Commission.

23 F. The ~~Commission~~ Department shall:
24

1 1. Draft and recommend necessary legislation to advance the
2 interests of the state in aerospace and aeronautics;

3 2. Represent the state in aeronautical matters before federal
4 agencies and other state agencies; and

5 3. Participate as party plaintiff or defendant or as intervener
6 on behalf of the state or any municipality or citizen thereof in any
7 proceeding which involves the interest of the state in aerospace or
8 aeronautics.

9 G. 1. The ~~Commission~~ Department may, insofar as is reasonably
10 possible, make available its engineering and other technical
11 services to any municipality or person desiring them in connection
12 with the planning, acquisition, construction, improvement,
13 maintenance, or operation of airports or navigation facilities.

14 2. The ~~Commission~~ Department may render financial assistance by
15 grant or loan or both to any municipality or municipalities acting
16 jointly in the planning, acquisition, construction, improvement,
17 maintenance, or operation of an airport owned or controlled, or to
18 be owned or controlled, by such municipality or municipalities, out
19 of appropriations or other monies made available by the Legislature
20 for such purposes. Such financial assistance may be furnished in
21 connection with federal or other financial aid for the same
22 purposes.

23 3. The ~~Commission~~ Department shall be designated as the agent
24 of this state or political subdivision of this state for the purpose

1 of applying for, receiving, administering and disbursing federal
2 funds and other public monies for the benefit of general aviation
3 airports, except reliever airports, as may be available under
4 applicable federal law or other laws. If requested by a political
5 subdivision, the ~~Commission~~ Department may act as its or their agent
6 in contracting for and supervising such planning, acquisition,
7 construction, improvement, maintenance, or operation; and all
8 political subdivisions are authorized to designate the ~~Commission~~
9 Department as their agent for the foregoing purposes. The
10 ~~Commission~~ Department, as principal on behalf of the state, may
11 enter into any contracts with the United States or with any person,
12 which may be required in connection with a grant or loan of federal
13 monies for municipal airport or air navigation facility purposes.
14 All federal monies accepted under this section shall be accepted and
15 transferred or expended by the ~~Commission~~ Department upon such terms
16 and conditions as are prescribed by the United States. All monies
17 received by the ~~Commission~~ Department pursuant to this section shall
18 be deposited in the Oklahoma ~~Aeronautics Commission~~ Department of
19 Aerospace and Aeronautics Revolving Fund in the State Treasury and
20 shall be paid out by the ~~Commission~~ Department in accordance with
21 the terms and conditions of any agreement entered into under the
22 provisions of this section.

23 H. 1. The ~~Commission~~ Department is authorized on behalf of and
24 in the name of the state, out of appropriations and other monies

1 made available for such purposes, to plan, zone, establish,
2 construct, enlarge, improve, maintain, equip, operate, regulate,
3 protect, and police airports and air navigation facilities, either
4 within or without the state, including the construction,
5 installation, equipping, maintenance, and operation at such airports
6 of buildings and other facilities for the servicing of aircraft or
7 for the comfort and accommodation of air travelers. However, the
8 regulatory authority shall not extend to any airman employed by, nor
9 to any aeronautics facility or aircraft under the exclusive
10 possession, operation, or control of, a person holding a certificate
11 of public convenience and necessity issued by any agency of the
12 United States to operate as a common carrier by air of persons
13 and/or property in interstate commerce. For such purposes the
14 ~~Commission~~ Department may, by purchase, gift, devise, or lease,
15 acquire property, real or personal, or any interest therein
16 including easements in aeronautical hazards or land outside the
17 boundaries of an airport or airport site, as are necessary to permit
18 safe and efficient operation of the state airports or to permit the
19 removal, elimination, obstruction-marking or obstruction-lighting of
20 airport hazards, or to prevent the establishment of airport hazards.
21 In like manner the ~~Commission~~ Department may acquire existing
22 airports and air navigation facilities. However, the ~~Commission~~
23 Department shall not acquire or take over any airport or air
24 navigation facility owned or controlled by a municipality of this or

1 any other state without the consent of such municipality. The
2 ~~Commission~~ Department may, by sale, lease, or otherwise, dispose of
3 any such property, airport, air navigation facility, or portion
4 thereof or interest therein. The disposal, by sale, lease, or
5 otherwise, shall be in accordance with the laws of this state
6 governing the disposition of other property of the state, except
7 that, in the case of disposals to any municipality or state
8 government or the United States for aeronautical purposes incident
9 thereto, the sale, lease, or other disposal may be effected in such
10 manner and upon such terms as the ~~Commission~~ Department may deem in
11 the best interest of the state.

12 2. All airports owned by the state shall be within the primary
13 jurisdiction of the Oklahoma ~~Aeronautics Commission~~ Department of
14 Aerospace and Aeronautics for purposes of design, development, and
15 operation; provided, that airports owned and operated by the
16 Oklahoma Space Industry Development Authority shall be exempt from
17 such provisions, and during the time of a national emergency, the
18 Air National Guard shall be exempt from such provisions, and
19 provided further, that any airport owned by the state may be leased
20 by the ~~Commission~~ Department to a public or private agency, as it
21 may deem fit.

22 3. Nothing contained in the Oklahoma ~~Aeronautics Commission~~
23 Department of Aerospace and Aeronautics Act shall be construed to
24

1 limit any right, power, or authority of the state or a municipality
2 to regulate airport hazards by zoning.

3 4. The ~~Commission~~ Department may exercise any powers granted by
4 this section jointly with any municipalities or with the United
5 States.

6 5. a. In operating an airport or air navigation facility
7 owned or controlled by the state, the ~~Commission~~
8 Department may enter into contracts, leases, and other
9 arrangements for a term not exceeding twenty-five (25)
10 years with any persons granting the privilege of using
11 or improving such airport or air navigation facility
12 or any portion or facility thereof or space therein
13 for commercial purposes; conferring the privilege of
14 supplying goods, commodities, things, services, or
15 facilities at such airport or air navigation facility;
16 or making available services to be furnished by the
17 ~~Commission~~ Department or its agents at such airport or
18 air navigation facility.

19 In each such case the ~~Commission~~ Department may
20 establish the terms and conditions and fix the
21 charges, rentals, or fees for the privileges or
22 services, which shall be reasonable and uniform for
23 the same class of privileges or services and shall be
24 established with due regard to the property and

1 improvements used and the expenses of operation to the
2 state; provided, that in no case shall the public be
3 deprived of its rightful, equal, and uniform use of
4 the airport, air navigation facility or portion or
5 facility thereof.

6 b. The ~~Commission~~ Department may by contract, lease, or
7 other arrangement, upon a consideration fixed by it,
8 grant to any qualified person for a term not to exceed
9 twenty-five (25) years the privilege of operating, as
10 agent of the state or otherwise, any airport owned or
11 controlled by the state; provided, that no such person
12 shall be granted any authority to operate the airport
13 other than as a public airport or to enter into any
14 contracts, leases, or other arrangements in connection
15 with the operation of the airport which the ~~Commission~~
16 Department might not have undertaken under
17 subparagraph a of this paragraph.

18 c. To enforce the payment of any charges for repairs to,
19 or improvements, storage, or care of, any personal
20 property made or furnished by the ~~Commission~~
21 Department or its agents in connection with the
22 operation of an airport or air navigation facility
23 owned or operated by the state, the state shall have
24

1 liens on such property, which shall be enforceable by
2 the ~~Commission~~ Department as provided by law.

3 6. In accepting federal monies under this section, the
4 ~~Commission~~ Department shall have the same authority to enter into
5 contracts on behalf of the state as is granted to the ~~Commission~~
6 Department under paragraph 3 of subsection G of this section with
7 respect to federal monies accepted on behalf of municipalities. All
8 monies received by the ~~Commission~~ Department pursuant to this
9 section shall be deposited in the Oklahoma ~~Aeronautics Commission~~
10 Department of Aerospace and Aeronautics Revolving Fund in the State
11 Treasury and shall be paid out of the ~~Commission~~ Department Fund in
12 accordance with the terms and conditions of any agreement entered
13 into under the provisions of this section.

14 7. The ~~Commission~~ Department shall grant no exclusive right for
15 the use of any airport or air navigation facility under its
16 jurisdiction. This shall not be construed to prevent the making of
17 contracts, leases, and other arrangements pursuant to paragraph 5 of
18 this subsection.

19 I. The ~~Commission~~ Department may enter into any contracts
20 necessary to the execution of the powers granted it by the Oklahoma
21 ~~Aeronautics Commission~~ Department of Aerospace and Aeronautics Act.
22 All contracts made by the ~~Commission~~ Department, either as the agent
23 of the state or as the agent of any municipality, shall be made
24 pursuant to the laws of the state governing the making of like

1 contracts. When the planning, acquisition, construction,
2 improvement, maintenance, or operation of any airport or air
3 navigation facility is financed wholly or partially with federal
4 monies, the ~~Commission~~ Department as agent of the state or of any
5 municipality may let contracts in the manner prescribed by the
6 federal authorities acting under the laws of the United States and
7 any rules or regulations made thereunder.

8 J. 1. The Commission, the Director, or any officer or employee
9 of the ~~Commission~~ Department designated by it shall have the power
10 to hold investigations, inquiries, and hearings concerning matters
11 covered by the provisions of the Oklahoma ~~Aeronautics Commission~~
12 Department of Aerospace and Aeronautics Act and the rules,
13 regulations, and orders of the ~~Commission~~ Department. Hearings
14 shall be open to the public and shall be held upon such call or
15 notice as the Commission shall deem advisable. Each member of the
16 Commission, the Director, and every officer or employee of the
17 ~~Commission~~ Department designated by it to hold any inquiry,
18 investigation, or hearing shall have the power to administer oaths
19 and affirmations, certify to all official acts, issue subpoenas, and
20 order the attendance and testimony of witnesses and the production
21 of papers, books, and documents. In case of the failure of any
22 person to comply with any subpoena or order issued under the
23 authority of this subsection, or on the refusal of any witness to
24 testify to any matters regarding which he may be lawfully

1 interrogated, it shall be the duty of the district court of any
2 county or of the judge thereof, on application of the ~~Commission~~
3 Department or its authorized representative, to compel obedience by
4 proceedings for contempt, as in the case of disobedience of the
5 requirements of a subpoena issued from such court or a refusal to
6 testify therein.

7 2. In order to facilitate the making of investigations by the
8 ~~Commission~~ Department in the interest of public safety and promotion
9 of aeronautics the public interest requires, and it is therefore
10 provided, that the reports of investigations or hearings, or any
11 part thereof, shall not be admitted in evidence or used for any
12 purpose in any suit, action, or proceeding growing out of any matter
13 referred to in the investigation, hearing, or report thereof, except
14 in case of any suit, action, or proceeding, civil or criminal,
15 instituted by or in behalf of the ~~Commission~~ Department or in the
16 name of the state under the provisions of the Oklahoma ~~Aeronautics~~
17 ~~Commission~~ Department of Aerospace and Aeronautics Act or other laws
18 of the state relating to aeronautics; nor shall any member of the
19 Commission, or the Director, or any officer or employee of the
20 ~~Commission~~ Department be required to testify to any facts
21 ascertained in, or information gained by reason of, such person's
22 official capacity, or be required to testify as an expert witness in
23 any suit, action, or proceeding involving any aircraft. Subject to
24 the foregoing provisions, the ~~Commission~~ Department may in its

1 discretion make available to appropriate federal, state and
2 municipal agencies information and material developed in the course
3 of its investigations and hearings.

4 K. 1. The ~~Commission~~ Department is authorized to confer with
5 or to hold joint hearings with any agency of the United States in
6 connection with any matter arising under the Oklahoma ~~Aeronautics~~
7 ~~Commission~~ Department of Aerospace and Aeronautics Act or relating
8 to the sound development of aerospace and aeronautics.

9 2. The ~~Commission~~ Department is authorized to avail itself of
10 the cooperation, services, records, and facilities of the agencies
11 of the United States as fully as may be practicable in the
12 administration and enforcement of the Oklahoma ~~Aeronautics~~
13 ~~Commission~~ Department of Aerospace and Aeronautics Act. The
14 ~~Commission~~ Department shall furnish to the agencies of the United
15 States its cooperation, services, records, and facilities, insofar
16 as may be practicable.

17 3. The ~~Commission~~ Department shall report to the appropriate
18 agency of the United States all accidents in aeronautics in this
19 state of which it is informed and shall, insofar as is practicable,
20 preserve, protect, and prevent the removal of the component parts of
21 any aircraft involved in an accident being investigated by it until
22 the federal agency institutes an investigation.

23 L. The ~~Commission~~ Department may organize and administer an
24 aerospace education program in cooperation with universities,

1 colleges and schools for the general public. The ~~Commission~~
2 Department may also plan and act jointly in a cooperative aviation
3 research or high technology program. As part of these programs, the
4 ~~Commission~~ Department may issue aviation communication films and
5 publications.

6 M. The ~~Commission~~ Department shall administer an airport
7 inspection program for all public-use airports within ~~the State of~~
8 ~~Oklahoma~~ this state. The inspection program shall occur on a three-
9 year cycle and shall be administered by the Oklahoma ~~Aeronautics~~
10 ~~Commission~~ Department of Aerospace and Aeronautics. Airport owners,
11 including individuals and municipalities, shall provide access to
12 airport facilities for conducting the inspections. The ~~Commission~~
13 Department shall provide a written report to each public-use airport
14 detailing the findings of such inspections.

15 SECTION 6. AMENDATORY 3 O.S. 2021, Section 85.1, is
16 amended to read as follows:

17 Section 85.1. The Oklahoma ~~Aeronautics Commission~~ Department of
18 Aerospace and Aeronautics is hereby authorized on behalf of and in
19 the name of the state, to accept title to property, real or
20 personal, or any interest therein including easements from any
21 authority, county, municipality or political subdivision thereof.
22 The ~~Commission~~ Department is further authorized to construct,
23 enlarge, improve, maintain, equip, operate, regulate, protect, and
24 police such property, including the construction, installation,

1 equipping, maintenance, and operation of airports, buildings and
2 other facilities for the servicing of aircraft or for the comfort
3 and accommodation of air travelers. Any property accepted pursuant
4 to this section shall be in accordance with and subject to Section
5 ~~82~~ 81 et seq. of Title 3 of the Oklahoma Statutes this title.

6 SECTION 7. AMENDATORY 3 O.S. 2021, Section 87, is
7 amended to read as follows:

8 Section 87. In carrying out the provisions of ~~this act~~ Section
9 81 et seq. of this title the ~~Commission~~ Oklahoma Department of
10 Aerospace and Aeronautics may use the facilities, services, and
11 resources of other agencies of the state and of the municipalities
12 of the state, and all other such agencies of the state and
13 municipalities are hereby specifically authorized to cooperate with
14 the ~~Commission~~ Department by use of their respective equipment,
15 facilities, services, and resources in the furtherance of the
16 purposes of ~~this act~~ Section 81 et seq. of this title and in the
17 furtherance of the plans and programs of the ~~Commission~~ Department.

18 SECTION 8. AMENDATORY 3 O.S. 2021, Section 90, is
19 amended to read as follows:

20 Section 90. In order to assure a safe and adequate system of
21 airports within this state:

22 1. In every county wherein there is no active airport, the
23 Oklahoma ~~Aeronautics Commission~~ Department of Aerospace and
24 Aeronautics is authorized to construct within such county or a

1 municipality located therein or upon land owned by the federal
2 government but under the active control of the state, county or a
3 municipality located within such county a runway of not less than
4 two thousand six hundred (2,600) feet in length and to repair,
5 maintain and hardsurface such runway.

6 2. In each county wherein there already exists an active
7 airport owned by such county or a municipality located therein or
8 upon land owned by the federal government but under the active
9 control of the state, county or a municipality located within such
10 county, but there does not exist within such county a hardsurfaced
11 runway of at least two thousand six hundred (2,600) feet in length,
12 the Oklahoma ~~Aeronautics Commission~~ Department of Aerospace and
13 Aeronautics may construct upon such lands as those described in
14 paragraph 1 of this section a runway of not less than two thousand
15 six hundred (2,600) feet and may repair, maintain and hardsurface
16 such runway, or may, where sufficient land is available for such
17 purpose, expand such existing airport to a length of two thousand
18 six hundred (2,600) feet and may thereupon repair, maintain and
19 hardsurface the entire runway.

20 3. During the fiscal year in which federal funds are available
21 under the Federal Airport Program for development or improvement of
22 a state, county or city owned or controlled airport, the Oklahoma
23 ~~Aeronautics Commission~~ Department of Aerospace and Aeronautics shall
24 be prohibited from performing any construction or major repair work

1 upon such airstrip unless and until such federal funds have been
2 available for such purpose.

3 4. The Oklahoma ~~Aeronautics Commission~~ Department of Aerospace
4 and Aeronautics, in any county where no airport containing two
5 thousand six hundred (2,600) feet or more runway exists, is
6 authorized to accept gifts of land to be used for a county airport
7 and of money to be used to acquire an airport.

8 5. The Oklahoma ~~Aeronautics Commission~~ Department of Aerospace
9 and Aeronautics is further authorized to accept federal grants for
10 construction, repair, maintenance and other purposes not
11 inconsistent with the provisions of this section and to utilize
12 machinery and material for the purpose of matching available federal
13 funds and grants.

14 SECTION 9. AMENDATORY 3 O.S. 2021, Section 91, is
15 amended to read as follows:

16 Section 91. There is hereby created in the State Treasury a
17 revolving fund for the Oklahoma ~~Aeronautics Commission~~ Department of
18 Aerospace and Aeronautics to be designated as the Oklahoma
19 ~~Aeronautics Commission~~ Department of Aerospace and Aeronautics
20 Revolving Fund. The fund shall be a continuing fund, not subject to
21 fiscal year limitations, and shall consist of a monthly allocation
22 by the Oklahoma Tax Commission of Three Thousand Dollars (\$3,000.00)
23 from the motor fuel excise tax levied and collected pursuant to the
24 provisions of Title 68 of the Oklahoma Statutes, such amount being a

1 part of the estimated amount of tax paid on gasoline consumed by
2 engines to propel aircraft in ~~Oklahoma~~ this state, sale of surplus
3 property, fees and receipts collected pursuant to the Oklahoma Open
4 Records Act, donations, gifts, bequests, contribution, devices,
5 interagency reimbursements, federal funds unless otherwise provided
6 by federal law or regulation, sale of leases and aircraft
7 registration fees and taxes, fees authorized by Section 1135.5 of
8 Title 47 of the Oklahoma Statutes or any other source. All monies
9 accruing to the fund are hereby appropriated and may be budgeted and
10 expended by the Oklahoma ~~Aeronautics Commission~~ Department of
11 Aerospace and Aeronautics for airport construction and
12 rehabilitation programs, general operations of the agency, for
13 promoting the awareness of aviation and aerospace, and providing
14 financial support for aviation education programs to address the
15 need for a skilled and competent aviation workforce. Expenditures
16 from the fund shall be made upon warrants issued by the State
17 Treasurer against claims filed as prescribed by law with the
18 Director of the Office of Management and Enterprise Services for
19 approval and payment.

20 SECTION 10. AMENDATORY 3 O.S. 2021, Section 92, is
21 amended to read as follows:

22 Section 92. The Oklahoma ~~Aeronautics Commission~~ Department of
23 Aerospace and Aeronautics is hereby authorized and empowered to
24 offer for sale, sell and execute oil and gas leases, and other

1 mineral and mining leases, and agricultural leases on any of the
2 lands of ~~the State of Oklahoma~~ this state under the control and
3 supervision of ~~said Commission~~ the Department, provided, the
4 development of ~~said~~ land for the purpose leased will not unduly
5 interfere with the aeronautical purpose for which said land is being
6 used by the state. ~~Said Commission~~ The Department is hereby given
7 authority to adopt and promulgate such additional rules and
8 regulations, not inconsistent herewith, as it may deem necessary and
9 for the best interest of the state in facilitating the sale of said
10 leases. It shall be the duty of the Director of the Oklahoma
11 ~~Aeronautics Commission~~ Department of Aerospace and Aeronautics to
12 execute ~~said~~ such leases for and in behalf of ~~said Commission~~ the
13 Department, and ~~said~~ the Director shall be liable on his official
14 bond for failure to faithfully discharge his duties hereunder. The
15 sales of all oil, gas and mineral leases shall be made upon the
16 basis of a retained royalty of not less than one-eighth (1/8) of all
17 oil, gas, casinghead gas, and other minerals produced from the lands
18 covered by ~~said~~ such leases and such additional cash bonus as may be
19 procured. Provided, however, if the state owns less than one
20 hundred percent (100%) of the oil, gas, casinghead gas and other
21 minerals covered by any such lease, the royalty retained shall not
22 be less than one-eighth (1/8) of the mineral interest so owned. All
23 oil, gas, mineral and agricultural leases shall be sold only after
24 advertisement for a period of three (3) weeks in a legal newspaper

1 published and of general circulation in the county in which said
2 lands are located. ~~Said~~ The sale shall be made to the highest and
3 best bidder and all bids shall be in sealed envelopes and opened and
4 considered at the same time.

5 SECTION 11. AMENDATORY 3 O.S. 2021, Section 93, is
6 amended to read as follows:

7 Section 93. All money derived from the sale of ~~said~~ such
8 leases, and from any royalties subsequently accruing, shall be
9 deposited in the State Treasury and credited to the Oklahoma
10 ~~Aeronautics Commission~~ Department of Aerospace and Aeronautics
11 Revolving Fund, and ~~said~~ such money may be expended in the same
12 manner and for the purposes as other money in ~~said~~ the fund is
13 authorized to be expended.

14 SECTION 12. AMENDATORY 3 O.S. 2021, Section 102.1, is
15 amended to read as follows:

16 Section 102.1. A. In order to prevent the erection of
17 structures dangerous to air navigation, subject to the provisions of
18 subsections B, C and D of this section, each person shall secure
19 from the local airport zoning authority, or in the absence of a
20 local airport zoning authority, the Oklahoma ~~Aeronautics Commission~~
21 Department of Aerospace and Aeronautics, a permit for the erection,
22 alteration, or modification of any structure the result of which
23 would exceed the federal obstruction standards as contained in 14
24 CFR, Part 77. Permits from the local airport zoning authority will

1 be required only within an airport hazard area where federal
2 standards are exceeded and if the proposed construction is within:

3 1. A 10-nautical mile radius of the geographical center of a
4 publicly owned or operated airport, a military airport, or an
5 airport open for public use which has a published instrument
6 approach procedure;

7 2. A 6-nautical mile radius of the geographical center of a
8 publicly owned or operated airport, a military airport, or an
9 airport open for public use which has no published instrument
10 approach procedure and has runways in excess of three thousand two
11 hundred (3,200) feet in length; or

12 3. A 2.5-nautical mile radius of the geographical center of a
13 publicly owned or operated airport, a military airport, or an
14 airport open for public use which has no published instrument
15 approach and has runways three thousand two hundred (3,200) feet or
16 less in length.

17 B. Affected airports will be considered as having those
18 facilities which are programmed in the Federal Aviation
19 Administration's Regional Aviation System Plan and will be so
20 protected.

21 C. Permit requirements of subsection A of this section shall
22 not apply to projects which received construction permits from the
23 Federal Communications Commission for structures exceeding federal
24 obstruction standards prior to May 20, 1975; nor shall it apply to

1 previously approved structures now existing, or any necessary
2 replacement or repairs to such existing structures, so long as the
3 height and location is unchanged.

4 D. In determining whether to issue or deny a permit, the local
5 airport zoning authority shall consider:

6 1. The nature of the terrain and height of existing structures;
7 2. Public and private interests and investments;
8 3. The character of flying operations and planned developments
9 of airports;

10 4. Federal airways as designated by the Federal Aviation
11 Administration that lie within the radii described in paragraphs 1
12 through 3 of subsection A of this section;

13 5. Whether the construction of the proposed structure would
14 cause an increase in the minimum descent altitude or the decision
15 height at the affected airport;

16 6. Technological advances;

17 7. The safety of persons on the ground and in the air; and

18 8. Land use density.

19 E. In order to promote the health, safety and welfare of the
20 public and to protect persons and property by promoting safety in
21 aeronautics, the Oklahoma ~~Aeronautics Commission~~ Department of
22 Aerospace and Aeronautics may review any structure erected, altered,
23 or modified since January 1, 1996, in which no permit was secured
24 from the local airport zoning authority because of the absence of a

1 local airport authority. The Oklahoma ~~Aeronautics Commission~~
2 Department of Aerospace and Aeronautics shall determine whether such
3 structures meet the requirements set forth in this section. If the
4 structures do not meet the requirements as set forth in this
5 section, the Oklahoma ~~Aeronautics Commission~~ Department of Aerospace
6 and Aeronautics may request the owners of such structure to make any
7 necessary modifications to protect the health, safety and welfare of
8 the public, including, but not limited to, altering, marking,
9 mapping, or identifying such structure. The Oklahoma ~~Aeronautics~~
10 ~~Commission~~ Department of Aerospace and Aeronautics may assist the
11 owner of such structure in any manner deemed feasible by the
12 Oklahoma ~~Aeronautics Commission~~ Department of Aerospace and
13 Aeronautics.

14 SECTION 13. AMENDATORY 3 O.S. 2021, Section 116, is
15 amended to read as follows:

16 Section 116. The Oklahoma ~~Aeronautics Commission~~ Department of
17 Aerospace and Aeronautics may provide technical assistance to any
18 political subdivision requesting assistance in the preparation of an
19 airport zoning code. A copy of all local airport zoning codes,
20 rules, and regulations, and amendments and proposed and granted
21 variances thereto, shall be filed with the Oklahoma ~~Aeronautics~~
22 ~~Commission~~ Department of Aerospace and Aeronautics.

23 SECTION 14. AMENDATORY 3 O.S. 2021, Section 121, is
24 amended to read as follows:

1 Section 121. A. For purposes of this section:

2 1. "Anemometer" means an instrument for measuring and recording
3 wind speed;

4 2. "Anemometer tower" means a structure, including all guy
5 wires and accessory facilities, on which an anemometer is mounted,
6 that is fifty (50) feet in height above the ground or higher, is not
7 located within the boundaries of a municipality, and whose
8 appearance is not otherwise regulated by state or federal law; and

9 3. "Commission" means the seven members of the Oklahoma
10 Aerospace and Aeronautics Commission; and

11 4. "Department" means the Oklahoma Department of Aerospace and
12 Aeronautics.

13 B. In addition to any zoning requirements of the Airport Zoning
14 Act or the Aircraft Pilot and Passenger Protection Act, the
15 ~~Commission~~ Department shall promulgate rules regulating the
16 appearance of anemometer towers to ensure that anemometer towers are
17 clearly recognizable in clear air during daylight hours according to
18 the following guidelines:

19 1. The ~~Commission~~ Department shall consider the best method for
20 making anemometer towers visible, including but not limited to
21 painting, flagging, or marking the towers and guy wires; and

22 2. Any rule promulgated pursuant to this section may apply
23 immediately, upon adoption, to anemometer towers constructed after
24 the date of adoption; however, anemometer towers constructed prior

1 to the date of adoption of the rule shall be exempt from the rule
2 for one (1) year from the date of adoption.

3 C. The ~~Commission~~ Department shall establish and maintain a
4 database containing the location of all anemometer towers by
5 November 1, 2015. The ~~Commission~~ Department may contract with a
6 governmental entity or private entity to create and maintain the
7 database.

8 D. The ~~Commission~~ Department shall promulgate rules requiring
9 an owner of an anemometer tower to provide the ~~Commission~~ Department
10 with information specifying the location and height of the tower,
11 and any other information the ~~Commission~~ Department may require to
12 ensure aviation safety.

13 E. The ~~Commission~~ Department shall promulgate rules requiring
14 any person proposing to construct an anemometer tower to notify the
15 ~~Commission~~ Department of such proposal. The ~~Commission~~ Department
16 shall require the owner of the proposed tower to provide the
17 ~~Commission~~ Department with information specifying the location and
18 height of the tower, and any other information the ~~Commission~~
19 Department may require to ensure aviation safety.

20 F. The ~~Commission~~ Department shall promulgate rules by
21 requiring the owner of an anemometer tower to notify the ~~Commission~~
22 Department upon removal or destruction of an anemometer tower.
23
24

1 G. The ~~Commission~~ Department shall have the authority to
2 promulgate rules and implement administrative penalties to enforce
3 the provisions of this ~~act~~ section.

4 H. Violations of this act are prohibited.

5 SECTION 15. AMENDATORY 3 O.S. 2021, Section 251, is
6 amended to read as follows:

7 Section 251. A. It is hereby declared that it is the policy of
8 the Legislature to make registration procedures for aircraft similar
9 to those for automobiles, with the authority to accomplish the same
10 vested fully in the Oklahoma Tax Commission separately from the
11 Oklahoma ~~Aeronautics Commission~~ Department of Aerospace and
12 Aeronautics, the jurisdiction of the two ~~Commissions~~ agencies, their
13 directors and officers being separate.

14 B. It shall be the duty of the Oklahoma Tax Commission to
15 promulgate any additional rules and regulations and designate forms
16 and procedures for the implementation of ~~this act~~ Section 251 et
17 seq. of this title.

18 SECTION 16. AMENDATORY 3 O.S. 2021, Section 256, is
19 amended to read as follows:

20 Section 256. A. Registration fees and taxes on aircraft shall
21 be paid to and collected by the Oklahoma Tax Commission and its
22 agents in the same manner as registration fees and taxes are paid
23 and collected on automobiles.

1 The registration and reregistration of aircraft shall be subject
2 to the following schedule and rates:

3 1. Single-engine piston aircraft shall be taxed according to
4 the following Schedule "A":

1 2. Rotary-wing aircraft shall be taxed at two times the
2 Schedule "A" fee, based on the same weight classifications.

3 3. Multiengine piston aircraft shall be taxed at three times
4 the Schedule "A" fee, based on the same weight classifications.

5 4. Turbo-prop aircraft shall be taxed at six times the Schedule
6 "A" fee, based on the same weight classifications.

7 5. Turbo-jet aircraft shall be taxed at ten times the Schedule
8 "A" fee, based on the same weight classifications.

9 6. Antique aircraft as defined by the Federal Aviation
10 Administration, sailplanes, balloons, and home-built aircraft shall
11 be subject to a flat-rate fee of Ten Dollars (\$10.00).

12 7. The fees of this subsection, except those in paragraph 6 of
13 this subsection, shall be reduced at a rate of ten percent (10%)
14 each year following the date of manufacture until the fee is equal
15 to fifty percent (50%) of the original fee, which shall then be the
16 fee for each year thereafter.

17 8. Every aircraft owner shall have the right to appeal the
18 assessment of the fee as provided for in this subsection, and the
19 Oklahoma Tax Commission shall appraise the aircraft and its avionics
20 as personal property at the fair market value thereof, and shall
21 apply a twelve-percent assessment rate which shall be levied at the
22 appropriate county millage rate.

23 B. Aircraft purchased after January 1 of each year and subject
24 to registration as provided for in this section shall be registered

1 and taxed on a prorated basis. Registration fees and taxes shall be
2 in lieu of all aircraft ad valorem taxes. All such monies collected
3 shall be paid to the Oklahoma Tax Commission and disbursed as
4 follows:

5 1. Three percent (3%) of all such funds shall be paid to the
6 State Treasurer for deposit to the credit of the General Revenue
7 Fund of the State Treasury; and

8 2. Ninety-seven percent (97%) of ~~said~~ such registration fees
9 and taxes shall be deposited in the Oklahoma ~~Aeronautics Commission~~
10 Department of Aerospace and Aeronautics Revolving Fund.

11 SECTION 17. AMENDATORY 3 O.S. 2021, Section 401, is
12 amended to read as follows:

13 Section 401. Contracts entered into for projects and activities
14 of the Oklahoma ~~Aeronautics Commission~~ Department of Aerospace and
15 Aeronautics relating to airport and air navigation facility
16 construction, maintenance and repair shall be awarded using the
17 competitive bidding process set forth in the Public Competitive
18 Bidding Act of 1974. The ~~Commission~~ Department may administer the
19 competitive bidding process through the ~~Oklahoma~~ Department of
20 Transportation rather than the Office of Management and Enterprise
21 Services.

22 SECTION 18. AMENDATORY 3 O.S. 2021, Section 421, is
23 amended to read as follows:

1 Section 421. A. The Oklahoma ~~Aeronautics Commission~~ Department
2 of Aerospace and Aeronautics is hereby established as the
3 clearinghouse for unmanned aircraft systems (UAS) in ~~the State of~~
4 ~~Oklahoma~~ this state and shall be designated as the agency of this
5 state for the promotion, enhancement and development of UAS and to
6 ensure the safe integration and use of this new technology within
7 the state. The purpose of this clearinghouse is to create a
8 partnership between those entities that currently operate UAS, those
9 that desire to use this technology in the future and other entities
10 that can support the research and development of UAS to ensure that
11 ~~the State of Oklahoma~~ this state can more effectively respond to the
12 needs of this critical sector of the aviation and aerospace
13 industry. In the operation of this clearinghouse, the ~~Commission~~
14 Department shall cooperate, assist and coordinate with the federal
15 government, agencies of this state, tribal entities, municipalities
16 and other persons in the development of unmanned aircraft systems
17 throughout the state to ensure the acceptance of this technology and
18 the successful integration of UAS into the National Airspace System.
19 Contingent upon the availability of funds, the Oklahoma ~~Aeronautics~~
20 ~~Commission~~ Department of Aerospace and Aeronautics may use
21 established program processes or may contract with other qualified
22 entities to carry out the duties and responsibilities of ~~this act~~
23 the Unmanned Aircraft Systems Development Act of 2021.

1 B. The primary goal of the UAS clearinghouse within the
2 ~~Commission~~ Department is to establish a central point within state
3 government to develop the strategy for how ~~the State of Oklahoma~~
4 this state can become a leader in the UAS industry. It will focus
5 the collective resources, knowledge, information and assets within
6 state government to ensure coordinated efforts amongst all parties.
7 The clearinghouse will:

8 1. Conduct research on what other states and localities are
9 doing insofar as their UAS rules and regulations so that it can
10 provide recommendations to ensure ~~Oklahoma~~ this state is in the best
11 position within the industry;

12 2. Organize and coordinate the application for any UAS test
13 site, integration opportunity, pilot program or grant funding on
14 behalf of ~~the State of Oklahoma~~ this state;

15 3. Maintain a registry of UAS being operated by state agencies,
16 except those UAS that are part of a university-affiliated research
17 program; and

18 4. Maintain a registry of educational institutions that offer
19 training programs for users of UAS.

20 SECTION 19. AMENDATORY Section 3, Chapter 203, O.S.L.
21 2022 (3 O.S. Supp. 2022, Section 413), is amended to read as
22 follows:

23 Section 413. A. There is hereby created within the Oklahoma
24 ~~Aeronautics Commission~~ Department of Aerospace and Aeronautics, the

1 Oklahoma Air Service Development Grant Program. The Oklahoma Air
2 Service Development Grant Program (OASDGP) is designed to offer
3 financial assistance by grant to private or public entities for the
4 purpose of assisting commercial air service development. Grant
5 funding is administered based on merit and the potential for a
6 specific project to enhance the state's economy. Grants are one-
7 time awards.

8 B. Grant funding can be used for commercial air service
9 development projects and include minimum revenue guarantees for
10 specific new routes, marketing and advertising of service, market
11 study and research projects to develop data for a business case for
12 new service, start-up cost offsets to reduce the cost of an airline
13 beginning service, and other innovative risk sharing models to
14 support the introduction of new airline service in the state.
15 Grants must be used to recruit service in an airport-pair that has
16 no current, daily scheduled airline service. Grants may not be used
17 to support current routes or to recruit a second carrier to an
18 airport-pair.

19 C. Public, private and nonprofit entities within ~~Oklahoma~~ this
20 state that have sufficient financial and management capacity to
21 complete the requested project are eligible for funding under this
22 program. Eligible entities include:

- 23 1. Airport sponsors of publicly owned airports;
- 24 2. Oklahoma municipalities;

1 3. Chambers of commerce; or

2 4. Community organizations that promote economic development.

3 D. Each application must include a detailed business plan with
4 supporting data for the proposed project. The business plan should
5 include:

6 1. Available passengers for the route including local demand
7 and connecting demand;

8 2. Detail on available revenue;

9 3. Current and historical fare data relative to peers and how
10 the project will lower fares; and

11 4. Business demand for companies based in ~~Oklahoma~~ this state
12 or doing business in ~~Oklahoma~~ this state that may use the proposed
13 route.

14 E. Projects with airline support will be considered first for
15 funding under this program. Airline support can be evidenced by a
16 letter, dated, signed, and on airline letterhead, or other
17 communication directly from an airline stating its support for the
18 funding and its interest in the proposed route. An airline letter
19 of support is not required for funding to be allocated to a project
20 but will be used in prioritizing fund awards.

21 F. To be considered for state funding under this program,
22 applicants must demonstrate the ability to provide a minimum twenty
23 percent (20%) of all funding for the project through local sources.
24 Local funding should be dedicated to the project and evidenced by

1 letters of commitment before an application is submitted. Any
2 private enterprise or nonairport, nonmunicipal, nonprofit entity
3 must have a letter of credit to qualify for a grant without a public
4 partner.

5 G. Each application should include a narrative organized into
6 seven (7) sections:

- 7 1. A proposal summary;
- 8 2. Applicant organization description, history, and ability to
9 fund the project;
- 10 3. Air service background and history of the airport/market;
- 11 4. Project description, target route, and specific business
12 plan for service;
- 13 5. Timeline;
- 14 6. Budget including local funding; and
- 15 7. Letters of support.

16 H. Applications will first be vetted for completeness. Any
17 application which does not include the information listed in
18 subsection G will be eliminated from consideration. Any application
19 that does not include local funding for at least twenty percent
20 (20%) of the project cost will be eliminated from consideration.
21 Any applicant that cannot demonstrate he or she is working with an
22 airport sponsor on the project will be eliminated from
23 consideration.

1 I. Once applications have been deemed to meet minimum
2 requirements, they will be evaluated for funding against each other,
3 with special attention paid to the following criteria in this order:

- 4 1. The viability of the business case for service and the
5 opportunity for service to be sustainable;
- 6 2. The need for the service in the community and region;
- 7 3. The challenges with current air service that could be
8 rectified with grant funding;
- 9 4. Share of local funding versus grant funding;
- 10 5. Airline support for the project;
- 11 6. Broad-based stakeholder support for the project; and
- 12 7. The ability to use the funding in a timely manner.

13 The Oklahoma Department of Commerce shall be part of this review
14 process. The state may request additional information from the
15 applicant and may require a written response from the applicant for
16 any outstanding questions. The state reserves the right to require
17 formal presentations from each applicant to explain the proposed
18 project.

19 J. The state will enter into a grant agreement contract with
20 recipients prior to distributing program funds. The agreement shall
21 include:

- 22 1. The specific project receiving grant funding;
- 23 2. The maximum dollar amount of state funding;
- 24 3. Effective dates of the grant;

1 4. Rights to terminate the grant agreement;

2 5. Inspection and reporting requirements to verify project
3 status and expenditures; and

4 6. Conditions of disbursement of grant funds including
5 obligation to repay funds if the terms of the agreement are not met.

6 The grant agreement contract shall require the awardee to
7 provide ongoing quarterly reports stating progress and detailing any
8 activity related to the project.

9 SECTION 20. AMENDATORY Section 4, Chapter 203, O.S.L.
10 2022 (3 O.S. Supp. 2022, Section 414), is amended to read as
11 follows:

12 Section 414. There is hereby created in the State Treasury a
13 revolving fund for the Oklahoma ~~Aeronautics Commission~~ Department of
14 Aerospace and Aeronautics to be designated the "Oklahoma Air Service
15 Development Grant Program Revolving Fund". The fund shall be a
16 continuing fund, not subject to fiscal year limitations, and shall
17 consist of all monies received by the Tax Commission which are
18 specifically required by law to be deposited in the fund, any public
19 or private donations, contributions and gifts received for the
20 benefit of the fund, and any amounts appropriated by the
21 Legislature. All monies accruing to the credit of the fund are
22 hereby appropriated and may be budgeted and expended by the Oklahoma
23 ~~Aeronautics Commission~~ Department of Aerospace and Aeronautics for
24 the purpose of funding grants as provided in ~~this act~~ Section 411 et

1 seq. of this title. Expenditures from the fund shall be made upon
2 warrants issued by the State Treasurer against claims filed as
3 prescribed by law with the Director of the Office of Management and
4 Enterprise Services for approval and payment.

5 SECTION 21. AMENDATORY 17 O.S. 2021, Section 160.20, is
6 amended to read as follows:

7 Section 160.20. A. After August 21, 2015, no wind energy
8 facility may be constructed if the base of any tower is located at a
9 distance of less than:

10 1. One and one-half (1 1/2) nautical miles from the center line
11 of any runway located on:

12 a. a public-use airport as defined in Section 120.2 of
13 Title 3 of the Oklahoma Statutes, or

14 b. an airport owned by a municipality;

15 2. One and one-half (1 1/2) nautical miles from any public
16 school which is a part of a public school district; or

17 3. One and one-half (1 1/2) nautical miles from a hospital.

18 B. Attestation of compliance with the setback requirements in
19 this section shall be included in any reports required by the
20 Corporation Commission. Stakeholder and landowner disputes arising
21 under subsection A of this section shall fall under the exclusive
22 jurisdiction of the district courts. The Corporation Commission may
23 seek enforcement of the submission and attestation requirements of
24

1 this subsection and subsection C of this section through its
2 administrative court system.

3 C. After ~~the effective date of this act~~ April 3, 2018,
4 construction or operation of a proposed individual wind turbine or
5 any other individual structure requiring a Federal Aviation
6 Administration (FAA) Form 7460-1 that is part of a wind energy
7 facility shall not encroach upon or otherwise have a significant
8 adverse impact on the mission, training or operations of any
9 military installation or branch of military as determined by the
10 Military Aviation and Installation Assurance Siting Clearinghouse
11 (Clearinghouse) and the FAA. Areas of impact include, but are not
12 limited to, military training routes, drop zones, approaches to
13 runways and bombing ranges. No individual wind turbine or any other
14 individual structure that requires a FAA 7460-1 form that is part of
15 a wind energy facility may be constructed or expanded unless there
16 is an active Determination of No Hazard from the FAA and adverse
17 impacts to the United States Department of Defense, pursuant to
18 Title 32 of the Code of Federal Regulations, Section 211.6, have
19 been resolved as evidenced by documentation from the Clearinghouse
20 for the individual wind turbine or other individual structure. The
21 Mission Compatibility Certification Letter or successor form may
22 serve as such evidence of adverse impacts being resolved with the
23 Department of Defense or successor agency.

1 1. The Determination of No Hazard and documentation of the
2 resolution of adverse impacts to the Department of Defense shall be
3 filed with the Corporation Commission and the Oklahoma ~~Aeronautics~~
4 ~~Commission~~ Department of Aerospace and Aeronautics.

5 2. The requirements established by this subsection shall not
6 prohibit the construction of an individual wind turbine or any other
7 individual structure requiring a FAA 7460-1 form that is part of a
8 wind energy facility if that individual wind turbine or other
9 individual structure has received a Determination of No Hazard or
10 mitigation plan on or before ~~the effective date of this act~~ April 3,
11 2018.

12 3. The Corporation Commission is authorized to promulgate rules
13 and regulations for the implementation of the provisions of this
14 section and Section 160.21 of this title.

15 D. If an owner of a wind energy facility fails to submit an
16 active Determination of No Hazard and documentation that adverse
17 impacts to the Department of Defense have been resolved by the
18 Clearinghouse for the individual wind turbine or other individual
19 structure prior to the start of construction, the owner shall be
20 subject to an administrative penalty not to exceed One Thousand Five
21 Hundred Dollars (\$1,500.00) per day, per violation from the
22 Corporation Commission as provided by law. In addition,
23 stakeholders, including, but not limited to, the Corporation
24 Commission or the ~~Aeronautics Commission~~ Oklahoma Department of

1 Aerospace and Aeronautics may institute an action in any court of
2 general jurisdiction to prevent, restrain, correct or abate any
3 violation of subsection C of this section other than Corporation
4 Commission actions related to submissions or attestations.

5 SECTION 22. AMENDATORY 17 O.S. 2021, Section 160.21, as
6 amended by Section 2, Chapter 310, O.S.L. 2019, is amended to read
7 as follows:

8 Section 160.21. A. The owner of a wind energy facility shall
9 submit notification of intent to build a facility to the Corporation
10 Commission within six (6) months of the initial filing with the
11 Federal Aviation Administration (FAA) of a FAA 7460-1 form. The
12 Corporation Commission shall prescribe the form and submittal
13 requirements of the notification; provided, the information required
14 on the notification form shall include at least the same information
15 required on the FAA form and a map of the project boundary. The
16 owner of a wind energy facility shall submit to the Oklahoma
17 ~~Aeronautics Commission~~ Department of Aerospace and Aeronautics
18 copies of all initial FAA 7460-1 forms for all individual wind
19 turbines or any other individual structure that requires a FAA Form
20 7460-1 that is part of a wind energy facility within thirty (30)
21 days of the initial filing with the FAA. The ~~Aeronautics Commission~~
22 Oklahoma Department of Aerospace and Aeronautics shall prescribe the
23 submittal requirements for the 7460-1 form. The owner of the wind
24 energy facility shall send copies of the notification to the board

1 of county commissioners of every county in which all or a portion of
2 the wind energy facility is to be located within twenty-four (24)
3 hours of filing with the Corporation Commission. If all or a
4 portion of the wind energy facility is to be located within the
5 incorporated area of a municipality, copies of the notification
6 shall also be sent to the governing body of the municipality within
7 twenty-four (24) hours of filing with the Corporation Commission.
8 If the owner of a wind energy facility is required to file
9 subsequent 7460-1 forms with the FAA due to changing locations or
10 heights of individual structures from the locations or heights
11 originally proposed in the initial 7460-1 forms submitted to the
12 ~~Aeronautics Commission~~ Oklahoma Department of Aerospace and
13 Aeronautics, the owner shall, within ten (10) days of filing with
14 the FAA, submit such subsequent 7460-1 forms to the Corporation
15 Commission and ~~Aeronautics Commission~~ Oklahoma Department of
16 Aerospace and Aeronautics. A wind energy facility owner shall not
17 be required to start the notification processes over unless the
18 subsequent 7460-1 forms expand the project beyond its original
19 boundaries submitted to the Corporation Commission.

20 B. Within ten (10) days of receiving a FAA 7460-1 form, as
21 provided for in subsection A of this section, the ~~Aeronautics~~
22 ~~Commission~~ Oklahoma Department of Aerospace and Aeronautics shall
23 notify the Oklahoma Strategic Military Planning Commission. The
24 Oklahoma Strategic Military Planning Commission shall notify local

1 base commanders upon receipt of this notification. The Oklahoma
2 Strategic Military Planning Commission shall submit a letter to the
3 Military Aviation and Installation Assurance Siting Clearinghouse
4 outlining potential areas of impact, as provided in Section 160.20
5 of this title, within thirty (30) days of receipt of the
6 notification. The letter from the Oklahoma Strategic Military
7 Planning Commission shall be submitted to the Corporation
8 Commission, the ~~Aeronautics Commission~~ Oklahoma Department of
9 Aerospace and Aeronautics and the wind energy facility owner at the
10 same time the letter is submitted to the Clearinghouse.

11 C. Within six (6) months of submitting the notification with
12 the Corporation Commission as provided for in subsection A of this
13 section, the owner of the wind energy facility shall cause a copy of
14 the notification to be published in a newspaper of general
15 circulation in the county or counties in which all or a portion of
16 the wind energy facility is to be located. Proof of publication
17 shall be submitted to the Corporation Commission.

18 D. Within six (6) months of submitting the notification with
19 the Corporation Commission as provided in subsection A of this
20 section, the owner of the wind energy facility shall cause a copy of
21 the notification to be sent, by certified mail, to:

22 1. Any operator, as reflected in the records of the Corporation
23 Commission, who is conducting oil and gas operations upon all or any
24

1 part of the surface estate as to which the wind energy developer
2 intends the construction of the wind energy facility;

3 2. Any operator, as reflected in the records of the Corporation
4 Commission, of an unspaced unit, or a unit created by order of the
5 Corporation Commission, who is conducting oil and gas operations for
6 the unit where all or any part of the unit area is within the
7 geographical boundaries of the surface estate as to which the wind
8 energy developer intends the construction of the wind energy
9 facility; and

10 3. As to tracts of land not described in paragraphs 1 and 2 of
11 this subsection on which the wind energy developer intends to
12 construct a wind energy facility, all lessees of oil and gas leases
13 covering the mineral estate underlying any part of the tracts of
14 land that are filed of record with county clerk in the county where
15 the tracts are located and whose primary term has not expired.

16 If the wind energy developer makes a search with reasonable
17 diligence, and the whereabouts of a party entitled to any notice
18 described in this subsection cannot be ascertained or such notice
19 cannot be delivered, then an affidavit attesting to such diligent
20 search for the parties shall be placed in the records of the county
21 clerk where the surface estate is actually located.

22 E. Within sixty (60) days of publishing the notification in a
23 newspaper as provided for in subsection C of this section, the owner
24 of the wind energy facility shall hold a public meeting. Notice of

1 the public meeting shall be published in a newspaper of general
2 circulation and submitted to the board of county commissioners in
3 the county or counties in which all or a portion of the wind energy
4 facility is to be located. The notice shall contain the place, date
5 and time of the public meeting. Proof of publication of the notice
6 shall be submitted to the Corporation Commission. The public
7 meeting shall be held in one of the counties in which all or a
8 portion of the wind energy facility is to be located.

9 F. With regard to the surface estate upon which the owner of a
10 wind energy facility intends to construct a wind energy facility, at
11 least sixty (60) days before entering upon the surface estate for
12 the purposes of commencement of construction of the wind energy
13 facility, the owner shall provide written notice, by certified mail,
14 of its intent to construct the wind energy facility to:

15 1. Any operator, as reflected in the records of the Corporation
16 Commission, who is conducting oil and gas operations upon all or any
17 part of the surface estate as to which the wind energy developer
18 intends the construction of the wind energy facility;

19 2. Any operator, as reflected in the records of the Corporation
20 Commission, of an unspaced unit, or a unit created by order of the
21 Corporation Commission, who is conducting oil and gas operations for
22 the unit where all or any part of the unit area is within the
23 geographical boundaries of the surface estate as to which the wind
24

1 energy developer intends the construction of the wind energy
2 facility; and

3 3. As to tracts of land not described in paragraphs 1 and 2 of
4 this subsection on which the wind energy developer intends to
5 construct a wind energy facility, all lessees of oil and gas leases
6 covering the mineral estate underlying any part of the tracts of
7 land that are filed of record with county clerk in the county where
8 the tracts are located and whose primary term has not expired.

9 The notice shall contain a map or plat of the proposed location,
10 with sufficient specificity of all of the various elements of the
11 wind energy facility to be located on the governmental section which
12 includes all or any part of the tracts of land described in
13 paragraphs 1, 2 and 3 of this subsection and the approximate date
14 that the owner of the wind energy facility proposes to commence
15 construction. If the wind energy developer makes a search with
16 reasonable diligence, and the whereabouts of a party entitled to any
17 notice described in this subsection cannot be ascertained or such
18 notice cannot be delivered, then an affidavit attesting to such
19 diligent search for the parties shall be placed in the records of
20 the county clerk where the surface estate is actually located.
21 Within thirty (30) days of receiving ~~said~~ such notice, any operator,
22 as described in paragraphs 1, 2 and 3 of this subsection shall
23 reciprocate, in writing by certified mail, certain site, operational
24 and infrastructure information, with sufficient specificity, to be

1 shared with the owner of the wind energy facility to assist both
2 with the safe construction and operation pertaining to the surface
3 estate. This information should include ~~ALTA~~ American Land Title
4 Association (ALTA) surveys of existing subsurface and surface
5 improvements on the property, if any, as well as other technical
6 specifications for existing improvements such as pipe size,
7 material, capacity and depth.

8 G. The owner of a wind energy facility shall not commence
9 construction on the facility until the notification and public
10 meeting requirements of this section have been met. If an owner of
11 a wind energy facility fails to submit the information as required
12 in this section, the owner shall be subject to an administrative
13 penalty from the Corporation Commission not to exceed One Thousand
14 Five Hundred Dollars (\$1,500.00) per day, per violation as provided
15 by law.

16 SECTION 23. AMENDATORY 47 O.S. 2021, Section 1135.5, as
17 last amended by Section 3, Chapter 397, O.S.L. 2022 (47 O.S. Supp.
18 2022, Section 1135.5), is amended to read as follows:

19 Section 1135.5. A. Service Oklahoma is hereby authorized to
20 design and issue appropriate official special license plates to
21 persons wishing to demonstrate support and provide financial
22 assistance as provided by this section.

23 Special license plates shall not be transferred to any other
24 person but shall be removed from the vehicle upon transfer of

1 ownership and retained. The special license plate may then be used
2 on another vehicle but only after such other vehicle has been
3 registered for the current year with a licensed operator.

4 Special license plates shall be renewed each year by Service
5 Oklahoma or a licensed operator, unless authorized by Service
6 Oklahoma to be renewed for a period greater than one (1) year.
7 Service Oklahoma shall notify by mail all persons issued special
8 license plates. The notice shall contain all necessary information
9 and shall contain instructions for the renewal procedure upon
10 presentation to a licensed operator or Service Oklahoma. The
11 license plates shall be issued on a staggered system.

12 Service Oklahoma is hereby directed to develop and implement a
13 system whereby licensed operators are permitted to accept
14 applications for special license plates authorized under this
15 section. The licensed operator shall confirm the applicant's
16 eligibility, if applicable, collect and deposit any amount
17 specifically authorized by law, accept and process the necessary
18 information directly into such system and generate a receipt
19 accordingly. For performance of these duties, licensed operators
20 shall retain the fee provided in Section 1141.1 of this title for
21 registration of a motor vehicle. The licensed operator fees for
22 acceptance of applications and renewals shall be paid out of the
23 ~~Oklahoma~~ Tax Commission Reimbursement Fund. Beginning January 1,
24 2023, the licensed operator fees for acceptance of applications and

1 renewals shall be paid out of the Service Oklahoma Reimbursement
2 Fund.

3 If fewer than one hundred of any type of special license plates
4 authorized prior to January 1, 2004, are issued prior to January 1,
5 2006, Service Oklahoma shall discontinue issuance and renewal of
6 that type of special license plate. Any such authorized special
7 license plate registrant shall be allowed to display the license
8 plate upon the designated vehicle until the registration expiration
9 date. After such time the expired special license plate shall be
10 removed from the vehicle.

11 For special license plates authorized on or after July 1, 2004,
12 no special license plates shall be developed or issued by Service
13 Oklahoma until Service Oklahoma receives one hundred prepaid
14 applications therefor. The prepaid applications must be received by
15 Service Oklahoma within one hundred eighty (180) days of the
16 effective date of the authorization or the authority to issue shall
17 be null and void. In the event one hundred prepaid applications are
18 not received by Service Oklahoma within such prescribed time period
19 any payment so received shall be refunded accordingly.

20 B. The special license plates provided by this section are as
21 follows:

22 1. University or College Supporter License Plate - such plates
23 shall be designed and issued to any person wishing to demonstrate
24 support to any state-supported or private university or college. As

provided in this section, an amount of the fee collected shall be apportioned as provided in Section 1104.1 of this title;

2. Environmental Awareness License Plate - such plates shall be designed, subject to the criteria to be presented to Service Oklahoma by the Department of Environmental Quality in consultation with the Oklahoma Arts Council, and issued to any person wishing to demonstrate support to implement the statewide general public ~~environmental education program~~ Environmental Education Program created pursuant to the provisions of the Oklahoma Environmental Quality Code. Such plates shall be designed and issued to any person in any combination of numbers and letters from one to a maximum of seven, as for personalized license plates. A dealer's license plate issued pursuant to Section 1116.1 or 1128 of this title may be designated an Environmental Awareness License Plate upon payment of the fee imposed by this section and any other registration fees required by the Oklahoma Vehicle License and Registration Act. As provided in this section, an amount of the fee collected shall be apportioned pursuant to Section 1104.2 of this title;

3. Firefighter License Plate - such plates shall be designed for any career or retired firefighter, volunteer or paid. Firefighters may apply for firefighter plates for up to four vehicles with a rated capacity of one (1) ton or less or for a motorcycle upon proof of a fire department membership by either an

1 identification card or letter from the chief of the fire department.
2 Retirees who are eligible for such plates shall provide proof of
3 eligibility upon initial application, but shall not be required to
4 provide proof of eligibility annually. The surviving spouse of any
5 deceased firefighter, if the spouse has not since remarried, may
6 apply for a firefighter license plate for one vehicle with a rated
7 carrying capacity of one (1) ton or less or for a motorcycle upon
8 proof that the deceased firefighter was a member of a fire
9 department by either an identification card or letter from the chief
10 of the fire department. The license plate shall be designed in
11 consultation with the Oklahoma State Firefighters Association.

12 As provided in this section, an amount of the fee collected
13 shall be deposited to the Oklahoma State Firemen's Museum Building &
14 Memorial Fund for support of the Oklahoma State Firefighters Museum
15 and the Oklahoma Fallen and Living Firefighters Memorial;

16 4. Wildlife Conservation License Plate - such plates shall be
17 designed, subject to the criteria to be presented to Service
18 Oklahoma by the ~~Oklahoma~~ Department of Wildlife Conservation in
19 consultation with the Oklahoma Arts Council, and issued to any
20 person wishing to demonstrate support for wildlife conservation in
21 this state through the Wildlife Diversity Fund, provided for in
22 Section 3-310 of Title 29 of the Oklahoma Statutes. Such plates may
23 be designed and issued to any person as for personalized license
24 plates.

1 As provided in this section, an amount of the fee collected
2 shall be apportioned pursuant to subsection D of Section 3-310 of
3 Title 29 of the Oklahoma Statutes;

4 5. Child Abuse Prevention License Plate - such plates shall be
5 designed, subject to the criteria to be presented to Service
6 Oklahoma by the Office of Child Abuse Prevention in the State
7 Department of Health and the ~~Oklahoma Committee to Prevent Child~~
8 ~~Abuse~~ Child Abuse Prevention Action Committee, and issued to any
9 person wishing to demonstrate support for the prevention of child
10 abuse.

11 As provided in this section, an amount of the fee collected
12 shall be deposited in the Child Abuse Prevention Fund;

13 6. United States Olympic and Paralympic Committee Supporter
14 License Plate - such plates shall be designed and issued to any
15 person wishing to demonstrate support for the United States Olympic
16 and Paralympic Committee. The plates shall be issued to any person
17 in any combination of numbers and letters from one to a maximum of
18 seven, as for personalized license plates. The plate shall contain
19 the official United States Olympic and Paralympic Committee logo.
20 Service Oklahoma shall be authorized, if necessary, to enter into a
21 licensing agreement with the United States Olympic and Paralympic
22 Committee for any licensing fees which may be required in order to
23 use the United States Olympic and Paralympic Committee logo or
24 design. The licensing agreement shall provide for a payment of not

1 more than Twenty-five Dollars (\$25.00) for each license plate
2 issued;

3 7. Oklahoma History License Plate - such plates shall be
4 designed and issued to any person wishing to demonstrate interest in
5 Oklahoma history. As provided in this section, an amount of the fee
6 collected shall be deposited to the Oklahoma Historical Society
7 Revolving Fund to be used for educational purposes;

8 8. Historic Route 66 License Plate - such:

- 9 a. vehicle plates shall be designed to honor historic
10 Route 66, also known as the "Mother Road". As
11 provided in this section, an amount of the fee
12 collected for each vehicle license plate shall be
13 apportioned to the Oklahoma Historical Society
14 Revolving Fund to be distributed to the Oklahoma Route
15 66 Museum located in Clinton, Oklahoma, and
16 b. motorcycle plates shall be designed in consultation
17 with the Oklahoma Route 66 Association, Inc. Service
18 Oklahoma shall be authorized to enter into a licensing
19 agreement with the Oklahoma Route 66 Association,
20 Inc., for any licensing fees which may be required in
21 order to use the Oklahoma Route 66 Association, Inc.,
22 logo or design. The licensing agreement shall provide
23 for a payment to the Oklahoma Route 66 Association,
24

1 Inc., of not more than Twenty Dollars (\$20.00) for
2 each motorcycle license plate issued;

3 9. Heart of the Heartland License Plate - such plates shall be
4 designed and issued to any person wishing to honor the victims of
5 the terrorist bombing attack on the Alfred P. Murrah Federal
6 Building in downtown Oklahoma City on April 19, 1995. As provided
7 in this section, an amount of the fee collected shall be deposited
8 in the Heart of the Heartland Scholarship Fund, as established in
9 Section 2282 of Title 70 of the Oklahoma Statutes;

10 10. Emergency Medical Technician License Plate - such plates
11 shall be designed and issued to any person who is an emergency
12 medical technician. Such persons may apply for an emergency medical
13 technician license plate for each vehicle with a rated carrying
14 capacity of one (1) ton or less upon proof of an emergency medical
15 technician's license. The license plate shall be designed in
16 consultation with the ~~state association of emergency medical~~
17 ~~technicians~~ Oklahoma Emergency Medical Technicians Association. As
18 provided in this section, an amount of the fee collected shall be
19 apportioned to the Emergency Medical Personnel Death Benefit
20 Revolving Fund created in Section 1-2505.2 of Title 63 of the
21 Oklahoma Statutes;

22 11. Fight Breast Cancer License Plate - such plates shall be
23 designed to demonstrate support for the prevention and treatment of
24 breast cancer in this state. ~~As provided in this section, an amount~~

1 ~~of the fee collected shall be apportioned to the Breast Cancer Act~~
2 ~~Revolving Fund;~~

3 12. Crime Victims Awareness License Plate - such plates shall
4 be designed and issued to any person wishing to demonstrate
5 awareness of and support for victims of crimes. The license plates
6 shall be designed in consultation with the ~~Oklahoma Crime Victims~~
7 ~~Centre~~ Crime Victims Compensation Program. As provided in this
8 section, an amount of the fee collected shall be apportioned to the
9 Attorney General's Revolving Fund for the Office of the Attorney
10 General, which is hereby directed to use such funds to contract with
11 a statewide nonprofit organization to provide services to crime
12 victims;

13 13. ~~Oklahoma Safe Kids Association~~ Safe Kids Oklahoma License
14 Plate - such plates shall be designed and issued to any person
15 wishing to demonstrate support and awareness of the ~~Oklahoma Safe~~

17 designed in consultation with the Oklahoma Safe Kids Association.
18 As provided in this section, an amount of the fee collected shall be

22 14. Oklahoma Four-H Club License Plate - such plates shall be

24 the Four-H Foundation, and issued to any person wishing to

1 demonstrate support of the Oklahoma Four-H Club. Such plates may be
2 designed and issued to any person as for personalized license
3 plates. As provided in this section, an amount of the fee collected
4 shall be apportioned to the OSU Extension Service License Plate
5 Revolving Fund created in Section 1104.4 of this title;

6 15. Agricultural Awareness License Plate - such plates shall be
7 designed, subject to criteria to be presented to Service Oklahoma,
8 by the Oklahoma Department of Agriculture, Food, and Forestry in
9 consultation with the Oklahoma Arts Council, and issued to any
10 person wishing to demonstrate support of the Department's Ag in the
11 Classroom Education Program. As provided in this section, an amount
12 of the fee collected shall be apportioned as provided in Section
13 1104.3 of this title;

14 16. Oklahoma Statehood Centennial License Plate - such plates
15 shall be designed and issued to any person wishing to commemorate
16 the centennial of Oklahoma's admission to statehood in 1907. The
17 license plates shall be designed in consultation with the Oklahoma
18 Capitol Complex and Centennial Commemoration Commission. As
19 provided in this section, an amount of the fee collected shall be
20 deposited in the Oklahoma Department of Commerce Revolving Fund
21 created in Section 5012 of Title 74 of the Oklahoma Statutes;

22 17. Support Education License Plate - such plates shall be
23 designed, subject to criteria to be presented to Service Oklahoma by
24 the State Department of Education in consultation with the Oklahoma

1 Arts Council, and issued to any person wishing to demonstrate
2 support for education in this state. All licensed operators shall
3 display a sample of the Support Education License plate in the area
4 of the business accessed by the public. Twenty-three Dollars
5 (\$23.00) of the fee collected shall be apportioned as follows:

- 6 a. five percent (5%) shall be deposited to the Education
7 Reform Revolving Fund,
- 8 b. five percent (5%) shall be deposited to the Oklahoma
9 State Regents for Higher Education Revolving Fund,

15 shall be designed and issued to any person wishing to demonstrate
16 support for the Boy Scouts of America. The plates shall be issued
17 to any person in any combination of numbers and letters from one to
18 a maximum of seven, as for personalized license plates. The plate
19 shall contain the official Boy Scouts of America logo. Service
20 Oklahoma shall be authorized, if necessary, to enter into a
21 licensing agreement with the Boy Scouts of America for any licensing
22 fees which may be required in order to use the Boy Scouts of America
23 logo or design. The licensing agreement shall provide for a payment
24

1 to the Boy Scouts of America of not more than Twenty Dollars
2 (\$20.00) for each license plate issued;

3 20. Urban Forestry and Beautification License Plate - such
4 plates shall be designed, subject to criteria to be presented to
5 Service Oklahoma, by the Oklahoma Department of Agriculture, Food,
6 and Forestry in consultation with nonprofit organizations in this
7 state that develop and operate programs to encourage urban forestry
8 and beautification, and issued to any person wishing to demonstrate
9 support of such programs. As provided in this section, an amount of
10 the fee collected shall be apportioned as provided in Section 1104.5
11 of this title;

12 21. Oklahoma State Parks Supporter License Plate - such plates
13 shall be designed, subject to criteria to be presented to Serve
14 Oklahoma by the Oklahoma Tourism and Recreation Department, and
15 issued to any person wishing to demonstrate support for the Oklahoma
16 state parks system. Twenty-three Dollars (\$23.00) of the fee
17 collected shall be deposited in the Oklahoma Tourism and Recreation
18 Department Revolving Fund. Such money shall be designated for and
19 may only be expended for the support of Oklahoma state parks;

20 22. Adoption Creates Families License Plate - such plates shall
21 be issued to any person wishing to demonstrate support of pregnant
22 women who are committed to placing their children for adoption and
23 wishing to provide assistance to guardians, adoptive parents and
24 other created families to assist in the adoption and placement of

1 children in permanent, safe homes. The license plates shall be
2 designed and final terminology delivered in consultation with the
3 Oklahoma Adoption Coalition and the Department of Human Services.
4 Twenty-five Dollars (\$25.00) of the fee collected shall be deposited

1 shall be authorized to enter into a licensing agreement with the
2 Stillwater School District for any licensing fees which may be
3 required in order to use the school district's logo or design. The
4 licensing agreement shall provide for a payment to the Stillwater
5 School District of not more than Twenty Dollars (\$20.00) for each
6 license plate issued.

7 C. The fee for such plates shall be Thirty-five Dollars
8 (\$35.00) per year of renewal and shall be in addition to all other
9 registration fees provided by the Oklahoma Vehicle License and
10 Registration Act. The fee shall be apportioned as follows:

11 1. Twenty Dollars (\$20.00) per year of renewal or any other
12 amount as provided in this title of the fee shall be apportioned as
13 provided or deposited in a fund as specified within the paragraph
14 authorizing the special license plate;

15 2. Eight Dollars (\$8.00) per year of renewal of the fee shall
16 be deposited in the ~~Oklahoma~~ Tax Commission Reimbursement Fund to be
17 used for the administration of the Oklahoma Vehicle License and
18 Registration Act. Beginning January 1, 2023, Eight Dollars (\$8.00)
19 per year of renewal of the fee shall be deposited in the Service
20 Oklahoma Reimbursement Fund to be used for the administration of the
21 Oklahoma Vehicle License and Registration Act; and

22 3. Any remaining amounts of the fee shall be apportioned as
23 provided in Section 1104 of this title.

SECTION 24. AMENDATORY 68 O.S. 2021, Section 500.6a, is amended to read as follows:

Section 500.6a. All revenue from the tax of eight one-hundredths of one cent (\$0.0008) per gallon imposed pursuant to the provisions of subsection B of Section 500.4 of Title 68 of the Oklahoma Statutes, and penalties and interest thereon, collected by the Oklahoma Tax Commission shall be apportioned and distributed monthly as follows:

1. For the fiscal year beginning July 1, 1999, one-third shall be paid to the State Treasurer and placed to the credit of the Oklahoma ~~Aeronautics Commission~~ Department of Aerospace and Aeronautics Revolving Fund and two-thirds shall be apportioned pursuant to the provisions of Section 500.6 of Title 68 of the Oklahoma Statutes;

2. For the fiscal year beginning July 1, 2000, two-thirds shall be paid to the State Treasurer and placed to the credit of the Oklahoma ~~Aeronautics Commission~~ Department of Aerospace and Aeronautics Revolving Fund and one-third shall be apportioned pursuant to the provisions of Section 500.6 of Title 68 of the Oklahoma Statutes; and

3. For the fiscal year beginning July 1, 2001, and for each fiscal year thereafter, all such revenue shall be paid to the State Treasurer and placed to the credit of the Oklahoma ~~Aeronautics Commission~~ Department of Aerospace and Aeronautics Revolving Fund.

1 SECTION 25. AMENDATORY 68 O.S. 2021, Section 6005, as
2 amended by Section 1, Chapter 148, O.S.L. 2022 (68 O.S. Supp. 2022,
3 Section 6005), is amended to read as follows:

4 Section 6005. For the fiscal year beginning July 1, 2022, and
5 all subsequent fiscal years, one hundred percent (100%) of the
6 revenues derived pursuant to the provisions of Sections 6001 through
7 6007 of this title shall be paid monthly by the Oklahoma Tax
8 Commission to the State Treasurer and shall be placed to the credit
9 of the Oklahoma ~~Aeronautics Commission~~ Department of Aerospace and
10 Aeronautics Revolving Fund.

11 SECTION 26. AMENDATORY 74 O.S. 2021, Section 5003.12, is
12 amended to read as follows:

13 Section 5003.12. A. This act shall be known and may be cited
14 as the "Aerospace Commerce Economic Services Act".

15 B. There is hereby created within the Oklahoma Department of
16 Commerce, the Aerospace Commerce Economic Services (ACES), whose
17 purpose shall be to create a partnership of service providers to
18 more effectively respond to the needs of the aviation, aerospace and
19 defense industries in the areas of education and training, research,
20 and economic development. ACES will focus available resources to
21 promote cooperation and collaboration among businesses,
22 manufacturers, military installations, commercial aviation,
23 educational institutions, nonprofit research institutions and state
24 government for the purpose of strengthening the economy of ~~the State~~

1 ~~of Oklahoma~~ this state. Contingent upon the availability of funds,
2 the Oklahoma Department of Commerce may employ established program
3 processes or may contract with other qualified entities to operate
4 ACES. The Oklahoma Department of Commerce shall partner with the
5 Oklahoma ~~Aeronautics Commission~~ Department of Aerospace and
6 Aeronautics to implement the provisions of this ~~act~~ section.

7 C. ACES is designed to coordinate and integrate the various
8 aerospace resources that currently exist within state and local
9 agencies. The primary goal of ACES is to establish a common
10 statewide strategy for the growth of the Oklahoma aerospace
11 industry. ACES will focus the collective aerospace resources, all
12 or new aerospace resources, to achieve one or more of the following
13 objectives into an integrated, coordinated statewide effort that
14 will:

15 1. Increase contracts between companies in the aviation,
16 aerospace and defense industries in ~~Oklahoma~~ this state and the
17 Department of Defense and its prime contractors;

18 2. Create and retain more high-wage, high-skill jobs;

19 3. Strengthen collaborations between businesses and aviation,
20 aerospace and defense interests;

21 4. Reduce the flow of federal defense contract dollars out of
22 state;

23 5. Expand the aviation, aerospace and defense industries in
24 ~~Oklahoma~~ this state;

1 6. Provide engineering and technical assistance;

2 7. Provide more suppliers for Oklahoma military installations
3 and the aviation, aerospace and defense industries;

4 8. Reduce costs for the Department of Defense and Oklahoma
5 military installations and increase the competitiveness of aviation,
6 aerospace and defense businesses in ~~Oklahoma~~ this state;

7 9. Create and align goals to grow aerospace business to a top
8 industry in ~~Oklahoma~~ this state by providing a forum to bring
9 agencies, industry and government together;

10 10. Enhance Oklahoma's supply chain utilization in the industry
11 to fill existing gaps in supplier networks;

12 11. Develop a recruitment strategy to attract new businesses
13 that reside or have a presence in ~~Oklahoma~~ this state; and

14 12. Create a forum for all aerospace stakeholders in ~~Oklahoma~~
15 this state to come together to pool ideas and resources to advance
16 aerospace in the state. State aerospace stakeholders include but
17 are not limited to Federal Aviation Administration, ~~Veterans~~
18 ~~Administration~~ Oklahoma Department of Veterans Affairs, Tinker Air
19 Force Base, all Oklahoma military installations, chambers of
20 commerce, Oklahoma Space Industry Development Authority, Oklahoma
21 Department of Commerce, Oklahoma State Regents for Higher Education,
22 Oklahoma ~~Aeronautics Commission~~ Department of Aerospace and
23 Aeronautics, federal Small Business Administration, Unmanned Aerial
24 Systems Cluster Initiative of Oklahoma and Kansas, Oklahoma

1 Manufacturing Alliance, Oklahoma CareerTech, Oklahoma Center for the
2 Advancement of Science and Technology, ~~Governor's~~ Unmanned Aerial
3 Systems Alliance of Oklahoma, Unmanned Aerial Systems Council and
4 Oklahoma Bid Assistance Network.

5 D. ACES shall establish an Aerospace and Defense Industry
6 Integrator. The integrator shall be used to engage key players from
7 the government, academia and other key stakeholders to create an
8 industry-wide vision and strategic map that details a plan to
9 enhance the industry. The integrator shall initiate the following
10 activities:

11 1. Assessing the current state of the industry, developing and
12 defining a vision for the future of the industry;

13 2. Identifying supplier network gaps and developing solutions
14 to fill those gaps;

15 3. Identifying funding requirements and developing funding
16 opportunities; and

17 4. Establishing ongoing mechanisms to monitor activities and
18 devising a process that includes the development and reporting of
19 metrics to track and manage ongoing progress.

20 E. In order to streamline the use of resources with the goal of
21 eliminating duplication of efforts, ACES shall act as a facilitator
22 for the collection and sharing of information and activities
23 concerning the aviation, aerospace and defense industries. ACES
24 shall provide coordination and assistance for the plans and

1 activities of state agencies, task forces, departments, boards,
2 commissions and other entities that have responsibilities or duties
3 regarding the aviation, aerospace and defense industries with the
4 goal of eliminating duplication of effort.

5 F. ACES shall support and foster the growth of the aviation,
6 aerospace and defense industries. ACES shall acquire aerospace
7 executive expertise and provide consulting services to the aviation,
8 aerospace and defense industries, government agencies and
9 organizations across ~~the State of Oklahoma~~ this state in order to
10 strengthen the policy framework, economic development initiatives
11 and activities of the state.

12 G. ACES may accept funding that includes, but is not limited
13 to:

- 14 1. Monetary contributions;
- 15 2. Contractual arrangements;
- 16 3. In-kind services;
- 17 4. Federal- and state-appropriated dollars;
- 18 5. Private and public foundation grants; and
- 19 6. Fee-for-service products.

20 SECTION 27. This act shall become effective November 1, 2023.
