11 making appropriations to the State Board of
12 Education, the Oklahoma Arts Council, the State Board

Disabilities, the Oklahoma Medical Marijuana
Authority, the Department of Mental Health and
Substance Abuse Services, the Oklahoma State

1 University Medical Authority, the University
2 Hospitals Authority, the Oklahoma Department of
3 Veterans Affairs, the Oklahoma Commission on Children
4 and Youth, the Office of Disability Concerns, the
5 Department of Human Services, the Office of Juvenile
6 Affairs, the State Department of Rehabilitation
7 Services, the Oklahoma Department of Agriculture,
8 Food, and Forestry, the Oklahoma State University
9 Veterinary Medicine Authority, the Oklahoma
10 Department of Commerce, the Oklahoma Conservation
11 Commission, the Rural Economic Action Plan Fund, the
12 Corporation Commission, the Department of
13 Environmental Quality, the Oklahoma Historical
14 Society, the J.M. Davis Memorial Commission, the
15 Department of Labor, the Department of Mines, the
16 Oklahoma Tourism and Recreation Department, the
17 Oklahoma Water Resources Board, the Alcoholic
18 Beverage Laws Enforcement Commission, the Department
19 of Corrections, the Oklahoma State Bureau of
20 Investigation, the Council on Law Enforcement
21 Education and Training, the Board of Medicolegal
22 Investigations, the Oklahoma State Bureau of
23 Narcotics and Dangerous Drugs Control, the Department
24 of Public Safety, the Office of the Attorney General,
the Court of Criminal Appeals, district attorneys and
the District Attorneys Council, the Supreme Court,
the Oklahoma Indigent Defense System, and the Pardon
and Parole Board; establishing amounts; identifying
sources; providing purposes and restrictions;
authorizing certain deposits and uses; clarifying
timeline for certain executions of the measure; and
providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

EDUCATION

SECTION 1. There is hereby appropriated to the State Board of
Education from any monies not otherwise appropriated from the
General Revenue Fund of the State Treasury for the fiscal year
ending June 30, 2024, the sum of One Billion Three Hundred Twelve

1 Million Four Hundred Nineteen Thousand One Hundred Fifty-seven
2 Dollars (\$1,312,419,157.00) or so much thereof as may be necessary
3 for the financial support of public schools.

4 SECTION 2. There is hereby appropriated to the State Board of
5 Education from any monies not otherwise appropriated from the
6 Education Reform Revolving Fund created by Section 34.89 of Title 62
7 of the Oklahoma Statutes, the sum of One Billion Thirty-six Million
8 Seven Hundred One Thousand Three Hundred Sixty-six Dollars
9 (\$1,036,701,366.00) or so much thereof as may be necessary for the
10 financial support of public schools.

11 SECTION 3. There is hereby appropriated to the State Board of
12 Education from any monies not otherwise appropriated from the Common
13 Education Technology Revolving Fund, the sum of Forty-seven Million
14 Twenty-five Thousand Seven Hundred One Dollars (\$47,025,701.00) or
15 so much thereof as may be necessary for the financial support of
16 public schools.

17 SECTION 4. There is hereby appropriated to the State Board of
18 Education from any monies not otherwise appropriated from the
19 Oklahoma Education Lottery Trust Fund of the State Treasury for the
20 fiscal year ending June 30, 2024, the sum of Twenty-seven Million
21 Seven Hundred Eighty-seven Thousand Five Hundred Dollars
22 (\$27,787,500.00) or so much thereof as may be necessary for the
23 financial support of public schools.

1 SECTION 5. There is hereby appropriated to the State Board of
2 Education from any monies not otherwise appropriated from the
3 Oklahoma Education Lottery Trust Fund of the State Treasury for the
4 fiscal year ending June 30, 2022, the sum of Nine Million Two
5 Hundred Eighty-six Thousand Eight Hundred Twenty Dollars
6 (\$9,286,820.00) or so much thereof as may be necessary for the
7 financial support of public schools.

8 SECTION 6. There is hereby appropriated to the State Board of
9 Education from any monies not otherwise appropriated from the
10 Mineral Leasing Fund of the State Treasury for the fiscal year
11 ending June 30 2024, the sum of Four Million Seven Hundred Seventy-
12 one Thousand Fifteen Dollars (\$4,771,015.00) or so much thereof as
13 may be necessary for the financial support of public schools.

14 SECTION 7. There is hereby appropriated to the State Board of
15 Education from any monies not otherwise appropriated from the
16 General Revenue Fund of the State Treasury for the fiscal year
17 ending June 30, 2024, the sum of One Hundred Twenty-one Million
18 Thirty-nine Thousand Twenty-six Dollars (\$121,039,026.00) or so much
19 thereof as may be necessary for the support of public school
20 activities.

21 SECTION 8. There is hereby appropriated to the State Board of
22 Education from any monies not otherwise appropriated from the
23 General Revenue Fund of the State Treasury for the fiscal year
24 ending June 30, 2024, the sum of Three Hundred Fifty-nine Million

1 One Hundred Ninety-three Thousand Four Hundred Seventy Dollars
2 (\$359,193,470.00) or so much thereof as may be necessary for the
3 Certified Employee Health Benefit Allowance.

4 SECTION 9. There is hereby appropriated to the State Board of
5 Education from any monies not otherwise appropriated from the
6 General Revenue Fund of the State Treasury for the fiscal year
7 ending June 30, 2024, the sum of One Hundred Ninety-four Million Two
8 Hundred Eleven Thousand Three Hundred Fifty-nine Dollars
9 (\$194,211,359.00) or so much thereof as may be necessary for the
10 Support Personnel Health Benefit Allowance.

11 SECTION 10. There is hereby appropriated to the State Board of
12 Education from any monies not otherwise appropriated from the
13 General Revenue Fund of the State Treasury for the fiscal year
14 ending June 30, 2024, the sum of Nineteen Million One Hundred Forty-
15 five Thousand Three Hundred Sixty-six Dollars (\$19,145,366.00) or so
16 much thereof as may be necessary for administrative and support
17 functions of the State Department of Education.

18 SECTION 11. There is hereby appropriated to the State Board of
19 Education from any monies not otherwise appropriated from the
20 General Revenue Fund of the State Treasury for the fiscal year
21 ending June 30, 2022, the sum of Forty-five Million One Hundred
22 Ninety Thousand Dollars (\$45,190,000.00) or so much thereof as may
23 be necessary for the purchase of textbooks and instructional
24 materials.

1 SECTION 12. There is hereby appropriated to the State Board of
2 Education from any monies not otherwise appropriated from the
3 Oklahoma Education Lottery Trust Fund of the State Treasury for the
4 fiscal year ending June 30, 2024, the sum of Three Million Eighty-
5 seven Thousand Five Hundred Dollars (\$3,087,500.00) or so much
6 thereof as may be necessary for transfer to the School Consolidation
7 Assistance Fund.

8 SECTION 13. There is hereby appropriated to the State Board of
9 Education from any monies not otherwise appropriated from the
10 Oklahoma Education Lottery Trust Fund of the State Treasury for the
11 fiscal year ending June 30, 2022, the sum of One Million Thirty-one
12 Thousand Eight Hundred Sixty-nine Dollars (\$1,031,869.00) or so much
13 thereof as may be necessary for transfer to the School Consolidation
14 Assistance Fund.

15 SECTION 14. There is hereby appropriated to the State Board of
16 Education from any monies not otherwise appropriated from the
17 Oklahoma Education Lottery Trust Fund of the State Treasury for the
18 fiscal year ending June 30, 2024, the sum of Three Million Eighty-
19 seven Thousand Five Hundred Dollars (\$3,087,500.00) or so much
20 thereof as may be necessary for transfer to the Teachers' Retirement
21 System Dedicated Revenue Revolving Fund.

22 SECTION 15. There is hereby appropriated to the State Board of
23 Education from any monies not otherwise appropriated from the
24 Oklahoma Education Lottery Trust Fund of the State Treasury for the

1 fiscal year ending June 30, 2022, the sum of One Million Thirty-one
2 Thousand Eight Hundred Sixty-nine Dollars (\$1,031,869.00) or so much
3 thereof as may be necessary for transfer to the Teachers' Retirement
4 System Dedicated Revenue Revolving Fund.

5 SECTION 16. There is hereby appropriated to the State Board of
6 Education from any monies not otherwise appropriated from the
7 General Revenue Fund of the State Treasury for the fiscal year
8 ending June 30, 2021, the sum of Eighty-seven Million Seven Hundred
9 Thousand Dollars (\$87,700,000.00) to be transferred to the Ad
10 Valorem Reimbursement Fund, created pursuant to Section 193 of Title
11 62 of the Oklahoma Statutes, for the purpose of reimbursing counties
12 for school districts that claim a loss of revenue due to a tax
13 exemption granted pursuant to the provisions of Section 6B of
14 Article X of the Oklahoma Constitution.

15 SECTION 17. There is hereby appropriated to the State Board of
16 Education for deposit in the State Public Common School Building
17 Equalization Fund created by Section 32 of Article X of the Oklahoma
18 Constitution, from any monies not otherwise appropriated from the
19 General Revenue Fund of the State Treasury for the fiscal year
20 ending June 30, 2022, Forty-four Million Dollars (\$44,000,000.00) to
21 be distributed as redbud school grants as provided in Section 3-104
22 of Title 70 of the Oklahoma Statutes.

23 SECTION 18. For the fiscal year ending June 30, 2024, the State
24 Board of Education is hereby authorized to transfer from the

1 Teachers' Retirement System Dedicated Revenue Revolving Fund to the
2 Teachers' Retirement System of Oklahoma the sum of Four Hundred
3 Sixty Million One Hundred Fifty-two Thousand Two Hundred Ten Dollars
4 (\$460,152,210.00) and from appropriations provided in Sections 14
5 and 15 of this act, in the amounts provided in those sections for
6 the purposes prescribed in Section 34.93 of Title 62 of the Oklahoma
7 Statutes.

8 SECTION 19. There is hereby appropriated to the Oklahoma Arts
9 Council from any monies not otherwise appropriated from the General
10 Revenue Fund of the State Treasury for the fiscal year ending June
11 30, 2024, the sum of Three Million Seven Hundred Thirty Thousand
12 Thirty Dollars (\$3,730,030.00) or so much thereof as may be
13 necessary to perform the duties imposed upon the Council by law.

14 SECTION 20. There is hereby appropriated to the State Board of
15 Career and Technology Education from any monies not otherwise
16 appropriated from the General Revenue Fund of the State Treasury for
17 the fiscal year ending June 30, 2024, the sum of One Hundred Sixty
18 Million Two Hundred Six Thousand Five Hundred Sixty-eight Dollars
19 (\$160,206,568.00) or so much thereof as may be necessary to perform
20 the duties imposed upon the Board by law.

21 SECTION 21. There is hereby appropriated to the State Board of
22 Career and Technology Education from any monies not otherwise
23 appropriated from the Oklahoma Education Lottery Trust Fund of the
24 State Treasury for the fiscal year ending June 30, 2024, the sum of

1 Three Million Three Hundred Ninety-six Thousand Two Hundred Fifty
2 Dollars (\$3,396,250.00) pursuant to Section 713 of Title 3A of the
3 Oklahoma Statutes for allocation and general operating budgets of
4 the institutions and for other programs, construction, renovations,
5 or repairs administered by the State Board of Career and Technology
6 Education.

7 SECTION 22. There is hereby appropriated to the State Board of
8 Career and Technology Education from any monies not otherwise
9 appropriated from the Oklahoma Education Lottery Trust Fund of the
10 State Treasury for the fiscal year ending June 30, 2022, the sum of
11 One Million One Hundred Thirty-five Thousand Fifty-six Dollars
12 (\$1,135,056.00) pursuant to Section 713 of Title 3A of the Oklahoma
13 Statutes for allocation and general operating budgets of the
14 institutions and for other programs, construction, renovations, or
15 repairs administered by the State Board of Career and Technology
16 Education.

17 SECTION 23. There is hereby appropriated to the Office of
18 Educational Quality and Accountability from any monies not otherwise
19 appropriated from the General Revenue Fund of the State Treasury for
20 the fiscal year ending June 30, 2024, the sum of One Million Three
21 Hundred Sixty-seven Thousand Two Hundred Nine Dollars
22 (\$1,367,209.00) or so much thereof as may be necessary to perform
23 the duties imposed upon the Office by law. Of those funds
24 appropriated, the sum of Sixty Thousand Dollars (\$60,000.00) shall

1 be deposited in the Teacher Certification Scholarship Revolving Fund
2 created pursuant to Section 6-187C of Title 70 of the Oklahoma
3 Statutes. Of those funds appropriated, the sum of One Hundred
4 Eighty Thousand Dollars (\$180,000.00) shall be deposited in the
5 Education Leadership Oklahoma Revolving Fund created pursuant to
6 Section 6-204.3 of Title 70 of the Oklahoma Statutes.

7 SECTION 24. There is hereby appropriated to the Office of
8 Educational Quality and Accountability from any monies not otherwise
9 appropriated from the General Revenue Fund of the State Treasury for
10 the fiscal year ending June 30, 2022, the sum of Five Hundred
11 Thousand Dollars (\$500,000.00) or so much thereof as may be
12 necessary to perform the duties imposed upon the Office by law.

13 SECTION 25. There is hereby appropriated to the Oklahoma
14 Educational Television Authority from any monies not otherwise
15 appropriated from the General Revenue Fund of the State Treasury for
16 the fiscal year ending June 30, 2024, the sum of Two Million Eight
17 Hundred Seventy-nine Thousand Four Dollars (\$2,879,004.00) or so
18 much thereof as may be necessary to perform the duties imposed upon
19 the Authority by law.

20 SECTION 26. There is hereby appropriated to the Oklahoma State
21 Regents for Higher Education from any monies not otherwise
22 appropriated from the General Revenue Fund of the State Treasury for
23 the fiscal year ending June 30, 2024, the sum of Eight Hundred
24 Fifty-five Million One Hundred Twenty Thousand One Hundred Eighty-

1 eight Dollars (\$855,120,188.00) or so much thereof as may be
2 necessary for allocation by the Oklahoma State Regents for Higher
3 Education pursuant to the provisions of Article XVII-A of the
4 Oklahoma Constitution for the education and construction,
5 renovations, or repairs administered by the Oklahoma State Regents
6 for Higher Education. Of those funds appropriated, the sum of Three
7 Million One Hundred Forty-nine Thousand Eight Hundred Ninety-seven
8 Dollars (\$3,149,897.00) shall be transferred to the Oklahoma Tuition
9 Equalization Grant Trust Fund to implement the provisions of the
10 Oklahoma Tuition Equalization Grant Act.

11 SECTION 27. There is hereby appropriated to the Oklahoma State
12 Regents for Higher Education from any monies not otherwise
13 appropriated from the General Revenue Fund of the State Treasury for
14 the fiscal year ending June 30, 2024, the sum of Seventeen Million
15 Eight Hundred Forty-six Thousand Seven Hundred Ninety-seven Dollars
16 (\$17,846,797.00) or so much thereof as may be necessary for
17 expenditures for concurrent enrollment pursuant to Section 628.13 of
18 Title 70 of the Oklahoma Statutes.

19 SECTION 28. There is hereby appropriated to the Oklahoma State
20 Regents for Higher Education from any monies not otherwise
21 appropriated from the General Revenue Fund of the State Treasury for
22 the fiscal year ending June 30, 2024, the sum of Four Million Two
23 Hundred Thirty-two Thousand Nine Hundred Seventy-four Dollars
24 (\$4,232,974.00) or so much thereof as may be necessary for the

1 general operating budget of the administrative offices of the
2 Oklahoma State Regents for Higher Education.

3 SECTION 29. The Oklahoma State Regents for Higher Education are
4 hereby authorized to expend during the fiscal year ending June 30,
5 2024, the sum of Forty-seven Million Twenty-five Thousand Seven
6 Hundred One Dollars (\$47,025,701.00) from any monies not otherwise
7 appropriated from the Higher Education Capital Revolving Fund of the
8 State Treasury for allocation by the Oklahoma State Regents for
9 Higher Education pursuant to the provisions of Article XIII-A of the
10 Oklahoma Constitution for the education and general operating
11 budgets of the institutions and for other programs, construction,
12 renovations, or repairs administered by the Oklahoma State Regents
13 for Higher Education.

14 SECTION 30. The Oklahoma State Regents for Higher Education are
15 hereby authorized to expend during the fiscal year ending June 30,
16 2024, the sum of Forty-seven Million Twenty-five Thousand Seven
17 Hundred One Dollars (\$47,025,701.00) from any monies not otherwise
18 appropriated from the Oklahoma Student Aid Revolving Fund of the
19 State Treasury for allocation by the Oklahoma State Regents for
20 Higher Education pursuant to the provisions of Article XIII-A of the
21 Oklahoma Constitution for the education and general operating
22 budgets of the institutions and for other programs, construction,
23 renovations, or repairs administered by the Oklahoma State Regents
24 for Higher Education.

1 SECTION 31. There is hereby appropriated to the Oklahoma State
2 Regents for Higher Education from any monies not otherwise
3 appropriated from the Oklahoma Education Lottery Trust Fund of the
4 State Treasury for the fiscal year ending June 30, 2024, the sum of
5 Twenty-four Million Three Hundred Ninety-one Thousand Two Hundred
6 Fifty Dollars (\$24,391,250.00) pursuant to Section 713 of Title 3A
7 of the Oklahoma Statutes for allocation by the Oklahoma State
8 Regents for Higher Education pursuant to the provisions of Article
9 XIII-A of the Oklahoma Constitution for construction, renovations,
10 or repairs administered by the Oklahoma State Regents for Higher
11 Education or for any other purpose authorized by Section 713 of
12 Title 3A of the Oklahoma Statutes.

13 SECTION 32. There is hereby appropriated to the Oklahoma State
14 Regents for Higher Education from any monies not otherwise
15 appropriated from the Oklahoma Education Lottery Trust Fund of the
16 State Treasury for the fiscal year ending June 30, 2022, the sum of
17 Eight Million One Hundred Fifty-one Thousand Seven Hundred Sixty-
18 four Dollars (\$8,151,764.00) pursuant to Section 713 of Title 3A of
19 the Oklahoma Statutes for allocation by the Oklahoma State Regents
20 for Higher Education pursuant to the provisions of Article XIII-A of
21 the Oklahoma Constitution for construction, renovations, or repairs
22 administered by the Oklahoma State Regents for Higher Education or
23 for any other purpose authorized by Section 713 of Title 3A of the
24 Oklahoma Statutes.

1 SECTION 33. There is hereby appropriated to the Commissioners
2 of the Land Office from any monies not otherwise appropriated from
3 the Commissioners of the Land Office Fund of the State Treasury for
4 the fiscal year ending June 30, 2024, the sum of Six Million Seven
5 Hundred Three Thousand Four Hundred Twenty-one Dollars
6 (\$6,703,421.00) or so much thereof as may be necessary to perform
7 the duties imposed upon the Office by law.

8 SECTION 34. There is hereby appropriated to the Oklahoma
9 Department of Libraries from any monies not otherwise appropriated
10 from the General Revenue Fund of the State Treasury for the fiscal
11 year ending June 30, 2024, the sum of Five Million Thirty-six
12 Thousand Three Hundred Fifteen Dollars (\$5,036,315.00) or so much
13 thereof as may be necessary to perform the duties imposed upon the
14 Department by law.

15 SECTION 35. There is hereby appropriated to the Health Care
16 Workforce Training Commission from any monies not otherwise
17 appropriated from the General Revenue Fund of the State Treasury for
18 the fiscal year ending June 30, 2024, the sum of Seven Million Two
19 Hundred Sixty-eight Thousand Six Hundred Twenty-nine Dollars
20 (\$7,268,629.00) or so much thereof as may be necessary to perform
21 the duties imposed upon the Commission by law.

22 SECTION 36. There is hereby appropriated to the Health Care
23 Workforce Training Commission from any monies not otherwise
24 appropriated from the General Revenue Fund of the State Treasury for

1 the fiscal year ending June 30, 2022, the sum of Four Hundred
2 Thousand Dollars (\$400,000.00) or so much thereof as may be
3 necessary to perform the duties imposed upon the Commission by law.

4 SECTION 37. There is hereby appropriated to the Oklahoma Board
5 of Private Vocational Schools from any monies not otherwise
6 appropriated from the General Revenue Fund of the State Treasury for
7 the fiscal year ending June 30, 2024, the sum of Three Hundred One
8 Thousand Dollars (\$301,000.00) or so much thereof as may be
9 necessary to perform the duties imposed upon the Board by law.

10 SECTION 38. There is hereby appropriated to the Board of
11 Trustees of the Oklahoma School of Science and Mathematics from any
12 monies not otherwise appropriated from the General Revenue Fund of
13 the State Treasury for the fiscal year ending June 30, 2024, the sum
14 of Seven Million Four Hundred Forty-six Thousand Three Hundred
15 Seventy-three Dollars (\$7,446,373.00) or so much thereof as may be
16 necessary to perform the duties imposed upon the Board by law.

17 SECTION 39. There is hereby appropriated to the Oklahoma Center
18 for the Advancement of Science and Technology from any monies not
19 otherwise appropriated from the General Revenue Fund of the State
20 Treasury for the fiscal year ending June 30, 2024, the sum of
21 Sixteen Million Eight Hundred Forty-six Thousand Five Hundred Forty-
22 two Dollars (\$16,846,542.00) or so much thereof as may be necessary
23 to perform the duties imposed upon the Oklahoma Center for the
24 Advancement of Science and Technology by law. Of those funds

1 appropriated, the sum of Seven Million One Hundred Thirty-six
2 Thousand Thirty-four Dollars (\$7,136,034.00) shall be deposited in
3 the Research Support Revolving Fund, created pursuant to Section
4 5060.11 of Title 74 of the Oklahoma Statutes, provided Three Million
5 Dollars (\$3,000,000.00) shall be dedicated to Applied Research and
6 Development for Industry Innovation. Of those funds appropriated,
7 the sum of Two Million One Hundred Five Thousand Eight Hundred
8 Seventeen Dollars (\$2,105,817.00) shall be deposited in the Seed-
9 Capital Revolving Fund, created pursuant to Section 5060.21 of Title
10 74 of the Oklahoma Statutes.

11 SECTION 40. There is hereby appropriated to the Oklahoma
12 Accelerator Revolving Fund created by Enrolled House Bill No. 1030
13 of the 1st Extraordinary Session of the 59th Oklahoma Legislature,
14 from any monies not otherwise appropriated from the Oklahoma
15 Accelerator Program Fund at the Oklahoma Department of Commerce, the
16 sum of Thirteen Million Seven Hundred Fifty Thousand Dollars
17 (\$13,750,000.00) to be budgeted and expended in accordance with law.

18 FINANCE

19 SECTION 41. There is hereby appropriated to the Oklahoma Tax
20 Commission from any monies not otherwise appropriated from the
21 General Revenue Fund of the State Treasury for the fiscal year
22 ending June 30, 2024, the sum of Thirty-seven Million One Hundred
23 Seventy-four Thousand Four Hundred Seventeen Dollars
24 (\$37,174,417.00) or so much thereof as may be necessary to perform

1 the duties imposed upon the Commission by law. Of those funds
