15	SECTION 1. NEW LAW A new section of law to be codified	ł
16	in the Oklahoma Statutes as Section 1210.198 of Title 70, unless	
17	there is created a duplication in numbering, reads as follows:	
18	A. The State Board of Education shall award grants subject to	2
19	the availability of funds, to public school districts for the	
20	purpose of employing school nurses, school counselors, and mental	
21	health professionals to provide services and support to students.	
22	B. The grants shall be awarded to public school districts	
23	annually based upon the following conditions:

The districts shall provide half of the funding for the
 grants and the State Board of Education shall provide the other half
 of the grant funding;

2. School nurses, school counselors, and mental health
professionals employed through the grant program shall complete a
training program prescribed by the State Department of Education;

3. School nurses, school counselors, and mental health
professionals may be employed by a district on a full-time or parttime basis, or may be employed on a contract basis with a private,
third-party provider; and

4. School nurses, school counselors, and mental health professionals employed through the grant program shall spend a minimum amount of time on their respective nursing and counseling duties as required by the State Department of Education.

- 16 1. "Mental health professionals" means:
- a. licensed professional counselors (LPCs),
- 18 b. licensed alcohol and drug counselors (LADCs),
- 19 c. school psychologists,
 - d. licensed marriage and family therapists (LMFTs),
