3 TRANSFER: Of the funds originally appropriated to the Office of 4 the Attorney General pursuant to Section 124 of Enrolled Senate Bill 5 No. 1040 of the 2nd Session of the 58th Oklahoma Legislature, the 6 Director of the Office of Management and Enterprise Services shall 7 transfer the sum of Seven Million Eight Hundred Ninety-six Thousand 8 Five Hundred Sixty-seven Dollars (\$7,896,567.00) to the Federal 9 Overreach and Extraordinary Litigation Revolving Fund created by 10 Enrolled House Bill No. 4066 of the 2nd Session of the 59th Oklahoma 11 Legislature to be budgeted and expended in accordance with law. SECTION 3. This act shall become effective July 1, 2024. 12

SECTION 4. It being immediately necessary for the preservation of the public peace, health or safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
