The proposed Fee Schedule for maximum rates paid for 8 reimbursement to medical providers, as amended and updated pursuant 10 to paragraph 14 of subsection H of Section 50 of Title 85A of the 11 Oklahoma Statutes, and submitted to the President Pro Tempore of the 12 Senate, the Speaker of the Oklahoma House of Representatives and the 13 Governor, is hereby approved as required by paragraph 14 of 14 subsection H of Section 50 of Title 85A of the Oklahoma Statutes. 15 SECTION 2.
