7 FLOOR SUBSTITUTE

An Act relating to state government; creating the Oklahoma Fusion Center; providing for the separation of the Oklahoma Counter Terrorism Intelligence Center from the Department of Public Safety; transferring all funds and property to new agency; allowing personnel to retain employment positions and status; authorizing agency to contract with the Office of Management and Enterprise Services for payroll and administrative services; directing the Office of Management and Enterprise Services to coordinate the transfer of property and personnel; abolishing certain division within the Department of Public Safety upon completion of transfer; creating the Oklahoma Fusion Center Commission; providing for membership; requiring appointments within certain time frame; stating manner by which members serve their terms; designating the Executive Director as ex officio member and Secretary; providing for the selection of a chair and vice-chair; providing quorum requirement; providing exemption from dual officeholding prohibition; stating powers and duties of the Commission; allowing reimbursement for certain expenses; establishing meeting and vacancy requirements; providing for clerical staff and meeting space; directing the Commission to comply with the Oklahoma Open Meeting Act, Oklahoma Open Records Act, and the Administrative Procedures Act; stating powers and duties of the Oklahoma Fusion Center; providing for the appointment of an Executive Director; stating qualifications; authorizing the appointment of assistants and personnel; creating the Oklahoma Fusion Center Revolving Fund; providing sources of funds; providing for use of funds;

prescribing procedures for expenditures; providing for codification; and providing an effective date.

- BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
- SECTION 1. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 52.1 of Title 74, unless there is created a duplication in numbering, reads as follows:
 - A. There is hereby created an agency of state government to be designated the Oklahoma Fusion Center.
 - B. Beginning November 1, 2024, the Oklahoma Counter Terrorism
 Intelligence Center shall cease to be under the control of or in any manner affiliated with the Department of Public Safety and shall become a separate and distinct agency of the state, to be known as the Oklahoma Fusion Center. All unexpended funds, property, records, equipment, software, software licenses, personnel, grants, and outstanding financial obligations and encumbrances related to the Oklahoma Counter Terrorism Intelligence Center shall be transferred to the Oklahoma Fusion Center. All personnel shall retain their employment positions and status as unclassified employees, as well as any leave, sick, and annual time earned, and any retirement and longevity benefits which have accrued during their tenure with the Oklahoma Counter Terrorism Intelligence Center.

C. The Oklahoma Fusion Center may contract with the Office of Management and Enterprise Services for payroll or other administrative services.

- D. The Office of Management and Enterprise Services is hereby directed to coordinate the transfer of funds, allotments, purchase orders, outstanding financial obligations, and encumbrances provided for in subsection B of this section. The transfer of personnel shall also be coordinated with the Office of Management and Enterprise Services.
- E. The Oklahoma Fusion Center is authorized to rent, lease, or own appropriate office space and property to conduct its business.
- F. The division within the Department of Public Safety known as the Oklahoma Counter Terrorism Intelligence Center shall be abolished by the Office of Management and Enterprise Services after the transfer is completed.
- SECTION 2. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 52.2 of Title 74, unless there is created a duplication in numbering, reads as follows:
- A. There is hereby created the Oklahoma Fusion Center Commission, which shall be an advisory body to the Executive Director of the Oklahoma Fusion Center.
- B. The Oklahoma Fusion Center Commission shall consist of twelve (12) members as follows:
 - 1. Four of the members shall be:

- 1 a. the Commissioner of Public Safety or designee,
 - b. the Director of the Oklahoma State Bureau of Investigation or designee,
 - c. the Director of the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control or designee, and
 - d. the Director of Intelligence of the Department of Corrections or designee; and
 - 2. Eight of the members shall be:
 - a. two members appointed by the Oklahoma Association of Chiefs of Police, one of whom shall be a chief of police of a municipality with a population over forty thousand (40,000), as determined by the latest Federal Decennial Census, and one of whom shall be a chief of police of a municipality with a population under forty thousand (40,000), as determined by the latest Federal Decennial Census,
 - b. two members appointed by the Oklahoma Sheriffs'

 Association, one of whom shall be a sheriff of a

 county with a population over forty thousand (40,000),

 as determined by the latest Federal Decennial Census,

 and one of whom shall be a sheriff of a county with a

 population under forty thousand (40,000), as

 determined by the latest Federal Decennial Census,

c. one member who is a district attorney selected by the District Attorneys Council,

- d. one member appointed by the Speaker of the Oklahoma House of Representatives, who represents a tribal law enforcement entity of one of the Five Civilized Tribes whose primary tribal headquarters are located in this state,
- e. one member appointed by the Speaker Pro Tempore of the Oklahoma State Senate, who represents a tribal law enforcement entity of one of the Five Civilized Tribes whose primary tribal headquarters are located in this state, and
- f. one member appointed by the Governor, who represents a tribal law enforcement entity of a federally recognized American Indian Tribe or nation whose primary tribal headquarters are located in this state.
- C. Appointments to the initial Oklahoma Fusion Center Commission shall be made within forty-five (45) days of the effective date of this act.
- D. Each member of the Oklahoma Fusion Center Commission shall serve at the pleasure of their appointing authority.
- E. The Executive Director of the Oklahoma Fusion Center appointed by the Commission shall be an ex officio member of the Commission and shall act as Secretary. A chair and vice-chair shall

- be elected annually from the membership of the Oklahoma Fusion

 Center Commission. A majority of the members of the Commission

 shall constitute a quorum for the transaction of business and for

 taking any official action. Official action of the Commission must

 have a favorable vote by a majority of the members present.
- F. Members who serve on the Commission shall be exempt from dual office-holding prohibitions pursuant to Section 6 of Title 51 of the Oklahoma Statutes.
 - G. The Oklahoma Fusion Center Commission shall be the rulemaking body for the Oklahoma Fusion Center and shall have the power and duty to:

- 1. Establish the policies of the Oklahoma Fusion Center;
- 2. Adopt and promulgate rules as necessary and appropriate to carry out the duties and responsibilities of the Oklahoma Fusion

 Center:
 - 3. Appoint an Executive Director and other staff for its operation; and
 - 4. Prepare a budget for expenditures necessary for the Commission and the Oklahoma Fusion Center.
- H. Members appointed pursuant to subsection B of this section shall serve without compensation but shall be reimbursed for their actual and necessary expenses incurred in the performance of their duties in accordance with the provisions of the State Travel Reimbursement Act.

I. The Oklahoma Fusion Center Commission shall meet as often as necessary at a place and time to be fixed by the Commission.

Special meetings may be called by the chair or by four members of the Commission by delivery of written notice to each member of the Commission.

- J. Any vacancy occurring on the Oklahoma Fusion Center

 Commission shall be filled for the unexpired term of office in the same manner as provided for in subsection B of this section.
- K. The Oklahoma Fusion Center shall provide clerical staff to perform designated duties of the Oklahoma Fusion Center Commission.

 The Oklahoma Fusion Center shall also provide space for meetings of the Commission.
- L. Except as provided in Section 24A.28 of Title 51 of the Oklahoma Statutes, the Oklahoma Fusion Center Commission shall act in accordance with the provisions of the Oklahoma Open Records Act and shall be subject to the provisions of the Oklahoma Open Meeting Act and the Administrative Procedures Act.
- SECTION 3. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 52.3 of Title 74, unless there is created a duplication in numbering, reads as follows:
 - The Oklahoma Fusion Center shall have the power and duty to:
- 1. Establish and maintain an information clearinghouse in order to accept and appropriately process information provided by law

1 enforcement agencies, public safety agencies, private sector
2 agencies, and concerned citizens;

- 2. Provide informative reports and assessments, both strategic and tactical, for homeland security initiatives;
- 3. Provide real-time support to law enforcement and public safety agencies;
- 4. Consolidate information and data on suspicious activities and threats from all jurisdictions within Oklahoma;
- 5. Facilitate communication and collaboration with multidisciplinary partners including local, state, and federal law enforcement and nongovernmental organizations; and
- 6. Provide early warning of incidents at the local, regional, and state levels.
 - SECTION 4. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 52.4 of Title 74, unless there is created a duplication in numbering, reads as follows:
 - A. The Executive Director of the Oklahoma Fusion Center shall be appointed by the Oklahoma Fusion Center Commission. The Executive Director of the Oklahoma Fusion Center shall have a bachelor's degree from an accredited college or university and at least five (5) years of experience in law enforcement. The Executive Director shall be subject to an Oklahoma and national criminal history background check conducted by the Oklahoma State Bureau of Investigation prior to appointment by the Commission.

B. The Executive Director shall receive a law enforcement commission by either the Oklahoma State Bureau of Investigation, the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control, or the Oklahoma Department of Public Safety.

- C. The Executive Director may appoint necessary assistants and other personnel to perform the work of the agency and may prescribe their titles and duties and fix their compensation.
- SECTION 5. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 52.5 of Title 74, unless there is created a duplication in numbering, reads as follows:

There is hereby created in the State Treasury a revolving fund for the Oklahoma Fusion Center to be designated the "Oklahoma Fusion Center Revolving Fund". The fund shall be a continuing fund, not subject to fiscal year limitations, and shall consist of any monies received from gifts, bequests, devises, contributions or grants, public or private, including federal funds unless otherwise prohibited by federal law or regulation, and receipts from any other source. All monies accruing to the credit of said fund are hereby appropriated and may be budgeted and expended by the Oklahoma Fusion Center for general operations of the agency. Expenditures from said fund shall be made upon warrants issued by the State Treasurer against claims filed as prescribed by law with the Director of the Office of Management and Enterprise Services for approval and payment.
