1 SECTION 1. AMENDATORY 51 O.S. 2021, Section 24A.16, is
2 amended to read as follows:

3 Section 24A.16 A. Except as set forth in subsection B of this
4 section, public educational institutions and their employees may
5 keep confidential:

- 6 1. Individual student records;
- 7 2. Teacher lesson plans, tests and other teaching material; and
- 8 3. Personal communications concerning individual students; and
- 9 4. Contracts for use of a student athlete's name, image or
10 likeness disclosed to a postsecondary institution.

11 B. If kept, statistical information not identified with a
12 particular student and directory information shall be open for
13 inspection and copying. Except as provided in subsection C of this
14 section, each educational institution may choose to designate
15 specific information which shall be classified as directory
16 information for students attending the educational institution. In
17 accordance with the Family Educational Rights and Privacy Act,
18 Section 1232g of Title 20 of the United States Code and Part 99 of
19 Title 34 of the Code of Federal Regulations, "directory information"
20 includes a student's name, address, telephone listing, date and
21 place of birth, major field of study, participation in officially
22 recognized activities and sports, weight and height of members of
23 athletic teams, dates of attendance, degrees and awards received,
24 and the most recent previous educational institution attended by the

1 student. Any educational agency or institution making public
2 directory information shall give public notice of the categories of
3 information which it has designated as directory information with
4 respect to each student attending the institution or agency and
5 shall allow a reasonable period of time after the notice has been
6 given for a parent to inform the institution or agency that any or
7 all of the information designated should not be released without
8 prior consent of the parent or guardian or the student if the
9 student is eighteen (18) years of age or older.

10 C. All educational agencies or institutions which are not the
11 primary custodians of student directory information of students
12 attending the educational institution, but which are allowed to
13 access the information for educational purposes, shall be prohibited
14 from releasing or selling any or all student directory information
15 unless disclosure is authorized by the Family Educational Rights and
16 Privacy Act, Section 1232g of Title 20 of the United States Code and
17 Part 99 of Title 34 of the Code of Federal Regulations, or Section
18 3-168 of Title 70 of the Oklahoma Statutes.

19 D. A public school district may release individual student
20 records for the current or previous school year to a school district
21 at which the student was previously enrolled for purposes of
22 evaluating educational programs and school effectiveness.
