




I move to amend Engrossed House Bill No. 1349, by the attached floor substitute (Request #2144) for the title, enacting clause and entire body of the measure.



15 ~~BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:~~

16 SECTION 1. NEW LAW A new section of law to be codified  
17 in the Oklahoma Statutes as Section 427.26 of Title 63, unless there  
18 is created a duplication in numbering, reads as follows:

19 A. There is hereby created the Oklahoma Medical Marijuana  
20 Authority Advisory Board.

21 B. The Oklahoma Medical Marijuana Authority Advisory Board  
22 shall consist of the following members and all appointees shall  
23 serve their terms at the pleasure of the appointing authority and  
24 may be removed or replaced without cause:

1           1. One member appointed by the Governor who shall be a chief of  
2 police, or a designee, of a municipality with a population over one  
3 hundred thousand (100,000), as determined by the latest Federal  
4 Decennial Census;

5           2. One member appointed by the Governor who shall be a sheriff,  
6 or a designee, of a county with a population under twenty-five  
7 thousand (25,000), as determined by the latest Federal Decennial  
8 Census;

9           3. One member appointed by the Governor who shall be an elected  
10 official either of a municipality with a population under one  
11 hundred thousand (100,000), as determined by the latest Federal  
12 Decennial Census or of a county with a population under twenty-five  
13 thousand (25,000), as determined by the latest Federal Decennial  
14 Census;

15           4. One member who is a district attorney appointed by the  
16 Governor selected from a list submitted by the District Attorneys  
17 Council;

18           5. One member who is a licensed physician appointed by the  
19 Governor selected from a list submitted by the State Board of  
20 Medical Licensure and Supervision;

21           6. One member who is a licensed medical marijuana commercial  
22 grower appointed by the Governor;

23           7. One member who is a licensed medical marijuana processor  
24 appointed by the Speaker of the House of Representatives;

1       8. One member who is a licensed medical marijuana dispensary  
2 owner appointed by the Speaker of the House of Representatives;

3       9. One member who is a licensed medical marijuana transporter  
4 appointed by the President Pro Tempore of the Senate; and

5       10. One member who is a licensed medical marijuana testing  
6 laboratory owner appointed by the President Pro Tempore of the  
7 Senate.

8       C. Each member of the Oklahoma Medical Marijuana Authority  
9 Advisory Board shall serve a term of four (4) years from the date of  
10 appointment. Members of the Board shall not serve more than two (2)  
11 consecutive terms. The Executive Director of the Oklahoma Medical  
12 Marijuana Authority shall be an ex officio member of the Board, but  
13 shall be entitled to vote only in case of a tie vote.

14       D. A chair and vice chair shall be elected annually from the  
15 membership of the Oklahoma Medical Marijuana Authority Advisory  
16 Board. A majority of the members of the Board shall constitute a  
17 quorum for the transaction of business and for taking any official  
18 action. Official action of the Board must have a favorable vote by  
19 a majority of the members present.

20       E. Appointed members who serve on the Board shall be exempt  
21 from dual-office-holding prohibitions pursuant to Section 6 of Title  
22 51 of the Oklahoma Statutes.

23       F. The Oklahoma Medical Marijuana Authority Advisory Board may  
24 assist the Oklahoma Medical Marijuana Authority with the following:

1 1. Examining the policymaking of the Oklahoma Medical Marijuana  
2 Authority;

3 2. Recommending rules as necessary and appropriate to carry out  
4 the duties and responsibilities of the Oklahoma Medical Marijuana  
5 Authority; and

6 3. Reviewing contracts between the Authority and vendors.

7 G. Members appointed pursuant to subsection B of this section  
8 shall serve without compensation but shall be reimbursed for  
9 expenses incurred in the performance of their duties in accordance  
10 with the State Travel Reimbursement Act.

11 H. The Oklahoma Medical Marijuana Authority Advisory Board  
12 shall meet as often as necessary to conduct business but shall meet  
13 not less than four times a year, with an organizational meeting to  
14 be held prior to January 1, 2024. In addition, special meetings may  
15 be called by the Executive Director of the Oklahoma Medical  
16 Marijuana Authority. At the conclusion of each meeting, the Board  
17 shall prepare a report of any recommendations to be presented to the  
18 Governor, the President Pro Tempore of the Senate, the Speaker of  
19 the House of Representative, and the Executive Director of the  
20 Authority.

21 I. Any vacancy occurring on the Oklahoma Medical Marijuana  
22 Authority Advisory Board shall be filled for the unexpired term of  
23 office in the same manner as provided for in subsection B of this  
24 section.

1 J. The Oklahoma Medical Marijuana Authority shall provide  
2 clerical staff to perform designated duties of the Oklahoma Medical  
3 Marijuana Authority Advisory Board. The Oklahoma Medical Marijuana  
4 Authority shall also provide space for meetings of the Board.

5 K. The Oklahoma Medical Marijuana Authority Advisory Board  
6 shall act in accordance with the provisions of the Oklahoma Open  
7 Meeting Act, the Oklahoma Open Records Act, and the Administrative  
8 Procedures Act.

9 SECTION 2. This act shall become effective November 1, 2023.
