17	Section 131. Except as provided in Section 132 of this title or				
18	Section 163 of Title 51 of the Oklahoma Statutes:				
19	1. Actions for the following causes shall be brought in the				
20	county in which the subject of the action is situated:				
21	a. for the recovery of real property, or of any estate,				
22	or interest therein, or the determination in any form				
23	of any such right or interest,				
24	b. for the partition of real property,

1	c. for the sale of real property under a mortgage, lien,
2	or other encumbrance or charge, and
3	d. to quiet title, to establish a trust in, remove a
4	cloud on, set aside a conveyance of, or to enforce or
5	set aside an agreement to convey real property; and
6	2. For all damages to land, crops, or improvements thereon,
7	actions shall be brought in the county where the damage occurs; and
8	3. For disputes related to repairs or improvements made on real
9	property or fixtures attached to real property, actions shall be
10	brought in the county where the real property is located.
11	SECTION 2. It being immediately necessary for the preservation
12	of the public peace, health or safety, an emergency is hereby
13	declared to exist, by reason whereof this act shall take effect and
14	be in full force from and after its passage and approval.
