12          all active classroom teachers; directing certain  
13          appropriation to be distributed based on average  
14          daily membership; establishing maximum distribution  
15          amount; providing allowable expenditures for  
16          appropriated funds; prohibiting severability of act  
17          provisions; providing for conditional enactment;  
18          providing an effective date; and declaring an  
19          emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:  
SECTION 1. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2024, the sum of One Hundred Fifty Million Dollars (\$150,000,000.00) for the financial support of public schools. A portion of these monies and monies appropriated in Section 3 of this act shall be used to increase salaries of all public school district

1 active classroom teachers, as defined in Section 17-101 of Title 70  
2 of the Oklahoma Statutes, in the amount of Two Thousand Five Hundred  
3 Dollars (\$2,500.00) per active classroom teacher for the 2023-2024  
4 school year. If a person employed as an active classroom teacher by  
5 a school district during the 2022-2023 school year was receiving a  
6 salary greater than the step level indicated by the state or local  
7 Minimum Salary Schedule for the 2022-2023 school year, the person  
8 shall receive a salary increase in the amount of Two Thousand Five  
9 Hundred Dollars (\$2,500.00) greater than his or her salary for the  
10 2022-2023 school year, provided the person remains employed by the  
11 same district and the hours or duties of the person are not reduced.

12 SECTION 2. There is hereby appropriated to the Oklahoma Student  
13 Fund of the State Treasury created in Enrolled House Bill No. 1935  
14 enacted by the First Session of the 59th Oklahoma Legislature from  
15 any monies not otherwise appropriated from the General Revenue Fund  
16 of the State Treasury for the fiscal year ending June 30, 2024, the  
17 sum of Fifty Million Dollars (\$50,000,000.00) to be distributed in a  
18 proportional manner the same as redbud school grants provided for in  
19 subsection B of Section 3-104 of Title 70 of the Oklahoma Statutes.

20 SECTION 3. There is hereby appropriated to the Oklahoma Student  
21 Fund of the State Treasury created in Enrolled House Bill No. 1935  
22 enacted by the First Session of the 59th Oklahoma Legislature from  
23 any monies not otherwise appropriated from the General Revenue Fund  
24 of the State Treasury for the fiscal year ending June 30, 2024, the

1 sum of Three Hundred Million Dollars (\$300,000,000.00) to be  
2 distributed to public school districts in the state based on the  
3 average daily membership of the preceding school year for the school  
4 district to be utilized as provided in this section, but in no event  
5 shall any district receive more than Two Million Dollars  
6 (\$2,000,000.00). The appropriated monies may only be used for the  
7 following expenditures:

8 1. Teacher and support staff salaries, not including salaries  
9 of administrators;

10 2. Programs and facilities related to instruction in science,  
11 technology, engineering, and mathematics;

12 3. Textbooks, curriculum, or other instructional materials  
13 including, but not limited to, supplemental materials or associated  
14 online instruction applications or materials;

15 4. Computer hardware or other technological devices,  
16 educational software, and applications that are used to meet  
17 curriculum needs and bolster academic outcomes of students;

18 5. Increasing classroom capacity and additional institutional  
19 space for academic instruction if the school is at full academic  
20 capacity;

21 6. Instruments, supplies, accessories, and materials that  
22 provide instruction in drama, music, speech and debate, agriculture,  
23 or other similar activities;

1       7. Fees for nationally standardized assessments including, but  
2 not limited to, assessments used to determine college admission and  
3 advanced placement examinations as well as tuition and fees for  
4 tutoring, remediation, or preparatory courses for the assessments;

5       8. Summer education programs and specialized after-school  
6 education programs; provided, however, that such expense shall not  
7 include before-school or after-school child care;

8       9. Student support services, including only health,  
9 psychological, guidance, therapy, and attendance services; and

10       10. Tuition and fees for concurrent enrollment at an  
11 institution within The Oklahoma State System of Higher Education  
12 only for amounts that are not paid by the Oklahoma State Regents for  
13 Higher Education.

14       SECTION 4. The provisions of this act shall not be severable,  
15 and if any provision of this act or the application thereof to any  
16 person or circumstances is held invalid, such invalidity shall  
17 invalidate the other provisions or applications of this act.

18       SECTION 5. The provisions of this act shall be contingent upon  
19 the enactment of Enrolled House Bill No. 1935 of the First Session  
20 of the 59th Oklahoma Legislature.

21       SECTION 6. This act shall become effective July 1, 2023.

22       SECTION 7. It being immediately necessary for the preservation  
23 of the public peace, health or safety, an emergency is hereby  
24

1 declared to exist, by reason whereof this act shall take effect and  
2 be in full force from and after its passage and approval.
