11 An Act relating to state government; amending 74 O.S.
12 2021, Section 250.4, which relates to the salaries of
13 statewide elected officers; increasing salaries to
14 certain amounts for certain officers; making
15 increases applicable to terms beginning after certain
16 date; and providing an effective date.

16 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

17 SECTION 1. AMENDATORY 74 O.S. 2021, Section 250.4, is
18 amended to read as follows:

19 Section 250.4 Pursuant to provisions of the Constitution of the
20 State of Oklahoma from and after the beginning date of a term of
21 office which commences in, or after, January ~~2016~~ 2024, the
22 following officers of the State of Oklahoma shall be annually
23 compensated for their services, payable monthly, as follows:

1 1. The Governor shall receive a salary of ~~One Hundred Forty-~~
2 ~~seven Thousand Dollars (\$147,000.00)~~ One Hundred Ninety-nine
3 Thousand Dollars (\$199,000.00);

4 2. The Lieutenant Governor shall receive a salary of ~~One~~
5 ~~Hundred Fourteen Thousand Seven Hundred Thirteen Dollars~~
6 ~~(\$114,713.00)~~ One Hundred Fifty-five Thousand Dollars (\$155,000.00);

7 3. The Attorney General shall receive a salary of ~~One Hundred~~
8 ~~Thirty-two Thousand Eight Hundred Twenty-five Dollars (\$132,825.00)~~
9 One Hundred Eighty Thousand Dollars (\$180,000.00);

10 4. The State Superintendent of Public Instruction shall receive
11 a salary of ~~One Hundred Twenty-four Thousand Three Hundred Seventy-~~
12 ~~three Dollars (\$124,373.00)~~ One Hundred Fifty-five Thousand Dollars
13 (\$155,000.00);

14 5. Each member of the Corporation Commission shall receive a
15 salary of ~~One Hundred Fourteen Thousand Seven Hundred Thirteen~~
16 ~~Dollars (\$114,713.00)~~ One Hundred Fifty-five Thousand Dollars
17 (\$155,000.00);

18 6. The State Treasurer shall receive a salary of ~~One Hundred~~
19 ~~Fourteen Thousand Seven Hundred Thirteen Dollars (\$114,713.00)~~ One
20 Hundred Fifty-five Thousand Dollars (\$155,000.00);

21 7. The State Auditor and Inspector shall receive a salary of

1 8. The State Insurance Commissioner shall receive a salary of

5 9. The Commissioner of Labor shall receive a salary of ~~One~~

8 SECTION 2. This act shall become effective January 1, 2024.
