11 An Act relating to the Oklahoma Capitol Improvement
12 Authority; providing for allocation of funds from the
13 Legacy Capital Financing Fund; authorizing
14 utilization of certain amount for the purpose of
15 benefitting the Department of Public Safety;
16 requiring certain recapitalization payments;
17 authorizing certain distributions; authorizing and
18 limiting utilization of memoranda of understanding;
19 providing for codification; providing an effective
20 date; and declaring an emergency.

23 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

24 SECTION 1. NEW LAW A new section of law to be codified
in the Oklahoma Statutes as Section 187A-12 of Title 73, unless
there is created a duplication in numbering, reads as follows:

A. In addition to any other authorization provided by law, the
Oklahoma Capitol Improvement Authority is authorized to utilize
available funds from the Legacy Capital Financing Fund created by

1 Section 187B of Title 73 of the Oklahoma Statutes, in the amount of
2 Seventy-four Million Dollars (\$74,000,000.00) for the benefit of
3 Department of Public Safety to further the construction of a
4 centralized training center and related facilities.

5 B. LCF Recapitalization Payments shall be made related to the
6 distribution of proceeds provided in subsection A of this act, in
7 accordance with the provisions of the Legacy Capital Financing Act.

8 C. The Authority may distribute funds authorized pursuant to
9 subsection A in one or more tranches.

10 D. The Authority may enter memoranda of understanding with
11 agencies, departments, and subdivisions of the state as needed, to
12 facilitate the provisions of this act, provided that such memoranda
13 of understanding do not constitute a legal obligation of the State
14 of Oklahoma or impede the administration of the provisions of the
15 Legacy Capital Financing Act.

16 SECTION 2. This act shall become effective July 1, 2024.

17 SECTION 3. It being immediately necessary for the preservation
18 of the public peace, health or safety, an emergency is hereby
19 declared to exist, by reason whereof this act shall take effect and
20 be in full force from and after its passage and approval.
