

1 used for registering voters. Such registration application shall
2 contain the following information:

3 1. The applicant's full name and date of birth, county and
4 place of residence, and mailing address pursuant to the provisions
5 of subsection G of this section;

6 2. A space or section to designate a political party recognized
7 by the laws of the State of Oklahoma with which the applicant
8 chooses to be affiliated;

9 3. The Oklahoma driver license or identification card number if
10 the applicant has been issued a current and valid driver license or
11 identification card by Service Oklahoma, or if the applicant does
12 not have a valid Oklahoma driver license or identification card, the
13 last four digits of the voter's Social Security number;

14 4. An oath of the eligibility of the applicant to become a
15 registered voter; and

16 5. Such other information as may be deemed necessary by the
17 Secretary to identify such applicant and to ascertain his or her
18 eligibility.

19 B. A voter registration application shall be signed by the
20 applicant in writing. The applicant shall personally subscribe his
21 or her name to or make his or her mark on the application, and no
22 agent, representative or employee of the applicant may sign or mark
23 on the applicant's behalf. The signature or mark must be the
24 original, handwritten signature, autograph or mark of the applicant.

1 No facsimile, reproduction, typewritten or other substitute
2 signature, autograph or mark will be valid. Notwithstanding any law
3 to the contrary, the Secretary of the State Election Board shall
4 prescribe procedures to authorize any person incapable of personally
5 making a mark to complete a voter registration application with
6 assistance of an official of any voter registration agency or
7 licensed operator specified in Sections 4-109.2 and 4-109.3 of this
8 title. Provided, for applications submitted electronically, in lieu
9 of the signature requirements set forth in this subsection, the
10 applicant shall consent to the use of his or her driver license or
11 identification card signature as provided in Section 4-109.4 of this
12 title.

13 C. Persons who do not indicate a recognized political party or
14 political organization on their registration application shall be
15 designated as Independents.

16 D. Any person may apply in writing to the Secretary of the
17 State Election Board for permission to print, copy or otherwise
18 prepare and distribute the registration applications designed by the
19 Secretary of the State Election Board. The Secretary may revoke any
20 such permission at any time.

21 E. All registration applications shall be distributed to the
22 public at no charge.

23 F. The Secretary also shall prescribe procedures to accept and
24 use the National Mail Voter Registration Form, or its successor, as

1 required by the National Voter Registration Act of 1993. Provided,
2 to be accepted as a valid voter registration application, the form
3 shall include the applicant's original, handwritten signature,
4 autograph or mark as described in subsection B of this section.

5 G. Applicants for voter registration or for change of voter
6 registration in any way shall provide a residence address and, if
7 different from the residence address, a mailing address. A
8 residence address shall include the street address of the residence,
9 including a full house number, street name or number, apartment or
10 suite number, if applicable, and zip code. If a street address is
11 not available for the residence, applicants shall provide such
12 information as the Secretary of the State Election Board deems
13 necessary for voter registration purposes. A post office box may
14 not be given as a residence address. A mailing address, which shall
15 include the city and zip code, may be the actual emergency
16 notification or 911 address on file in the local community, a rural
17 route and box number, a post office box number or a street address.
18 The secretary of a county election board may utilize global
19 positioning system (GPS) technology to ensure a voter is assigned to
20 the appropriate precinct.

21 H. A full or partial Social Security number or driver license
22 number in a voter registration record or a voter registration
23 application shall not be considered a public record and shall be
24

1 kept confidential by the State Election Board and each county
2 election board.

3 SECTION 2. This act shall become effective November 1, 2023.
