3 SENATE BILL NO. 1293

5 An Act relating to the security of public buildings;
6 directing certain entities to contract with the
7 Department of Public Safety for certain services;
8 amending 73 O.S. 2021, Section 173, which relates to
9 the Oklahoma Capitol Improvement Authority; removing
10 certain references; providing for codification; and
11 providing an effective date.

12 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

13 SECTION 1. NEW LAW A new section of law to be codified
14 in the Oklahoma Statutes as Section 1096 of Title 64, unless there
15 is created a duplication in numbering, reads as follows:

16 The Commissioners of the Land Office and the Office of
17 Management and Enterprise Services shall contract with the
18 Department of Public Safety for security and law enforcement
19 services in all facilities under the jurisdiction of the Offices or
20 Department within "State Capitol Park" in Oklahoma City and the
21 Executive Center at 201 West 5th Street and appurtenances thereto in
22 Tulsa.

23 SECTION 2. AMENDATORY 73 O.S. 2021, Section 173, is
24 amended to read as follows:

25 Section 173. A. The Oklahoma Capitol Improvement Authority may
26 contract with the Office of Management and Enterprise Services to

1 maintain grounds and for housekeeping, maintenance and repair of
2 properties under the jurisdiction of the Authority.

3 B. The Oklahoma Capitol Improvement Authority and the Office of
4 Management and Enterprise Services shall contract with the
5 Department of Public Safety for security and law enforcement
6 services in all facilities under the jurisdiction of the Authority
7 or Department within "State Capitol Park" in Oklahoma City ~~and the~~
8 ~~J. Howard Edmondson Office Building, Robert S. Kerr Office Building~~
9 ~~and appurtenances thereto in Tulsa.~~

10 C. The Oklahoma Capitol Improvement Authority shall provide
11 office and operations space for Office of Management and Enterprise
12 Services' functions.

13 D. The Office of Management and Enterprise Services shall
14 establish accounts for the Office of Management and Enterprise
15 Services, by building or other improvement, as the Director of the
16 Office of Management and Enterprise Services considers necessary to
17 properly account and identify receipts and expenditures related to
18 construction, repair, maintenance, insurance and other operating
19 expenses of buildings and improvements owned, used or occupied by or
20 on behalf of the Oklahoma Capitol Improvement Authority, where the
21 services are carried out by contract with the Authority.

22 SECTION 3. This act shall become effective November 1, 2024.
