9	An Act relating to the Cemetery Merchandise Trust Act; amending 36 O.S. 2021, Sections 7125, 7127,
10	7128, 7131, and 7133, which relate to permit application, surety bond, annual reporting, and
11	violations; requiring certain applications and fees to be submitted and paid electronically; adding
12	certain report to documents required for issuance of permit; requiring renewal fee prior to reinstatement
13	of certain permit; modifying renewal procedures for expired permits; requiring certain report from
14	expired permits, requiring certain report from expired permit holders; conforming language; requiring certain updates to permit holder
15	information by certain date; requiring certain permit holder to respond to certain inquiries by certain
16	date; requiring surety to provide notice to Insurance  Commissioner by certain date; requiring annual report
17	to be filed electronically; removing minimum amount for certain civil penalty assessed for certain
18	violation; conforming language; updating statutory language; and providing an effective date.

21	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
22	SECTION 1. AMENDATORY 36 O.S. 2021, Section 7125, is
23	amended to read as follows:
24	

1 Section 7125. A. Each organization desiring to accept money or 2 anything of value for prepaid cemetery merchandise shall file an application for a permit with the Insurance Commissioner, and shall 3 at the time of filing the application pay one initial filing fee of 4 5 Two Hundred Dollars (\$200.00), along with any transaction or other applicable fees. All applications shall be filed and the fee shall 6 be paid electronically in a form and manner prescribed by the 7 Commissioner. The Commissioner shall issue a permit upon the 8 9 receipt of the application, the annual report in accordance with 10 Section 7128 of this title, and payment of the filing fee fees, and upon making a finding that the applicant has complied with the 11 12 Cemetery Merchandise Trust Act and the rules as may be established pursuant to the Cemetery Merchandise Trust Act by the Commissioner. 13 All applications shall be signed by the organization requesting the 14 permit, and shall contain a statement that the applicant will comply 15 with all the requirements as established pursuant to the Cemetery 16 Merchandise Trust Act. All permits shall expire on March 15 of the 17 year following the year the permit is first issued, unless renewed. 18 Permits shall be renewed for a period not to exceed the succeeding 19 March 15 upon the payment of a renewal fee of Two Hundred Dollars 20 (\$200.00). Late application for renewal of a permit shall require a 21 fee of double the renewal fee. No application for renewal of a 22 permit shall be accepted after April 15 of each year. Late 23 24 applicants shall be required to reapply as if they were a new

1 applicant, and pay an application fee equal to an amount that is 2 double the renewal fee in addition to any fines that may have been imposed with respect to an expired permit The renewal application 3 shall be filed and the fee shall be paid electronically in a form 4 5 and manner prescribed by the Commissioner. A permit that expires for failure to submit a renewal application may be reinstated within 6 ninety (90) days after the expiration date by electronically 7 submitting a fee in an amount that is double the renewal fee in a 8 9 form and manner prescribed by the Commissioner and any other transaction or fees deemed necessary by the Commissioner. The 10 Insurance Commissioner shall require a permit holder whose permit 11 12 has been expired for more than ninety (90) days to reapply as if a new applicant and pay an application fee equal to an amount that is 13 double the renewal fee, in addition to any fines imposed. All 14 applications received more than ninety (90) days following the 15 expiration of a permit shall include a detailed report of services 16 provided in this state during the period of the permit expiration. 17 The Commissioner may cancel a permit or refuse to issue a 18 permit or refuse to issue a renewal of a permit for failure to 19

permit or refuse to issue a renewal of a permit for failure to comply with any provisions of the Cemetery Merchandise Trust Act or any rules promulgated thereto by the Commissioner, after reasonable notice to the permittee and opportunity for hearing before the Commissioner in accordance with Article II of the Administrative Procedures Act.

- C. No organization shall be entitled to a new permit after cancellation, or refusal by the Commissioner to renew a permit, but shall thereafter be issued a new permit upon satisfactory proof of compliance with the Cemetery Merchandise Trust Act and rules promulgated by the Commissioner.
  - D. Any person or organization aggrieved by the actions of the Commissioner may appeal therefrom to the Oklahoma Insurance

    Department as provided by the Administrative Procedures Act.
  - E. Each permit holder shall electronically submit, in a form and manner prescribed by the Commissioner, any change of legal business name, "doing business as" or assumed name, address, or contact email address, and any necessary fees within thirty (30) days after the change occurred. Any submission of a change under this subsection that is received more than thirty (30) days after the change occurred shall be accompanied by a fee of Fifty Dollars (\$50.00).
  - F. Upon receipt of any inquiry from the Insurance Commissioner,

    a permit holder shall furnish the Commissioner with an adequate

    response to the inquiry within twenty (20) days from the date of

    receipt of the inquiry.
- 21 SECTION 2. AMENDATORY 36 O.S. 2021, Section 7127, is 22 amended to read as follows:

- Section 7127. A. As an alternative to the trust requirements of Section 7126 of this title, an organization may purchase a surety bond in an amount not less than the minimum funding requirement.
- B. The surety bond shall be made payable to the State of Oklahoma for the benefit of the Insurance Commissioner and all purchasers of prepaid cemetery merchandise. The bond shall be approved by the Commissioner.

- C. The Commissioner may establish by rule the requirements and guidelines for the surety bonds required pursuant to this section.
- D. A surety bond maintained under the provisions of this section or Section 7124 of this title may be cancelled canceled or terminated by the surety only by providing notice to the Commissioner, no later than ninety (90) thirty (30) days before the effective date of the cancellation or termination. Notwithstanding the cancellation, termination, or expiration of a bond maintained under this section or Section 7124 of this title, the surety shall remain liable for obligations arising during the term of the bond and prior to the termination, cancellation or expiration.
- SECTION 3. AMENDATORY 36 O.S. 2021, Section 7128, is amended to read as follows:
- Section 7128. Each organization shall <u>electronically</u> file an annual report with the Insurance Commissioner on or before March 15 of each year in a <u>the manner and</u> form as the Commissioner may require, showing the name of the financial institution holding the

1	cemetery merchandise trust fund and the amount of the trust fund
2	under each contract on the preceding December 31, and also showing
3	the method of determination of the wholesale costs made pursuant to
4	Section 7126 of this title. The total required deposits to the
5	cemetery merchandise trust fund during the year shall also be
6	reported. Each cemetery is responsible for maintaining satisfactory
7	books and records, which will adequately justify all information
8	contained in the annual report required by this section. Any
9	organization which has discontinued the sale of prepaid cemetery
10	merchandise, but which still has funds deposited in a cemetery
11	merchandise trust fund or surety, shall not be required to obtain a
12	renewal of its permit, but it shall continue to make annual reports
13	to the Commissioner until all the funds have been disbursed pursuant
14	to the Cemetery Merchandise Trust Act. A filing fee of Two Hundred
15	Dollars (\$200.00), and any transaction or other applicable fees,
16	shall accompany each report. If any officer of any organization
17	fails or refuses to file an annual report, or fails or refuses to
18	cause it to be filed within thirty (30) days after the organization
19	has been notified by the Commissioner that the report is due and has
20	not been received, the officer shall be guilty of a misdemeanor and
21	shall be punished as prescribed in Section 7134 of this title.
22	SECTION 4. AMENDATORY 36 O.S. 2021, Section 7131, is
23	amended to read as follows:

Section 7131. A. The Insurance Commissioner, may, after notice and an opportunity for hearing, initiate an action to recover payments required to be redeposited to the cemetery merchandise trust pursuant to the Cemetery Merchandise Trust Act or to recover other monies received or disbursed in violation of the Cemetery Merchandise Trust Act.

- B. The Commissioner may, after an opportunity for hearing, censure a permittee or may suspend or revoke a permit for violation of any provision of the Cemetery Merchandise Trust Act or any rules promulgated by the Commissioner. In addition to, or in lieu of, any censure, suspension or revocation, a permittee may be subject to a civil penalty of not less than One Hundred Dollars (\$100.00) nor more than One Thousand Dollars (\$1,000.00) per occurrence or violation.
- SECTION 5. AMENDATORY 36 O.S. 2021, Section 7133, is amended to read as follows:

Section 7133. Whenever any officer of any organization refuses to submit the books, records, papers and instruments of an organization to the examination and inspection of the assistants or examiners of the Insurance Commissioner, or refuses or neglects to establish or maintain a cemetery merchandise trust fund in accordance with the requirements of the Cemetery Merchandise Trust Act within ninety (90) days after a written demand to establish or maintain a cemetery merchandise trust fund is made by the

1	Commissioner, or in any manner obstructs or interferes with the
2	examination of its cemetery merchandise trust fund, or refuses to be
3	examined on oath concerning any of the affairs of its cemetery
4	merchandise trust fund, the Commissioner may make application for
5	receivership in the manner of a domestic insurer pursuant to
6	Sections 1901 through 1920 of Title 36 of the Oklahoma Statutes, in
7	addition to the penalties and other enforcement provisions of the
8	Cemetery Merchandise Trust Act.
9	SECTION 6. This act shall become effective November 1, 2023.
