7	An Act relating to aircraft and airports; amending 3
8	O.S. 2021, Sections 65.1, 65.2, 65.4, 65.5, 65.6, 65.7, 65.8, 65.10, 65.12, 65.15, 65.16, and 65.17,
9	which relate to the Municipal Airports Act; defining terms; modifying definition; modifying language to
10	include vertiports as municipally owned air facilities; extending certain tax exemption to
11	include vertiports and air navigation properties; amending 3 O.S. 2021, Section 82, as amended by
12	Section 2, Chapter 126, O.S.L. 2023 (3 O.S. Supp. 2023, Section 82), which relates to definitions;
13	defining terms; amending 3 O.S. 2021, Section 85, as amended by Section 5, Chapter 126, O.S.L. 2023 (3
14	O.S. Supp. 2023, Section 85), which relates to powers and duties of the Department; modifying language to
15	include vertiports and air navigation facilities; amending 3 O.S. 2021, Section 421, as last amended by
16	Section 15, Chapter 365, O.S.L. 2023 (3 O.S. Supp. 2023, Section 421), which relates to the
17	establishment of clearinghouse of unmanned aircraft systems; modifying duties of clearinghouse;
18	authorizing entry into certain partnerships; and providing an effective date.

21	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
22	SECTION 1. AMENDATORY 3 O.S. 2021, Section 65.1, is
23	amended to read as follows:
24	

Section 65.1 As used in this act, unless the text otherwise requires:

3 (a) "Airport" means an area on land or water that is used, or 4 intended to be used, for the landing and taking off of aircraft, and 5 includes its buildings and facilities, if any.

6 (b) "Air navigation facility" means any facility - other than 7 one owned and operated by the United States - used in, available for 8 use in, or designed for use in, aid of air navigation, including any 9 structures, mechanisms, lights, beacons, markers, communicating 10 systems, or other instrumentalities, or devices used or useful as an 11 aid, or constituting an advantage or convenience, to the safe taking 12 off, navigation, and landing of aircraft, or the safe and efficient 13 operation or maintenance of an airport, and any combination of any 14 or all of such facilities.

(c) "Airport hazard" means any structure, object of natural growth, or use of land which obstructs the airspace required for the flight of aircraft in landing or taking off at an airport <u>or</u> vertiport or is otherwise hazardous to such landing or taking off of aircraft.

(d) "Helipad" means a small designated area, usually with a prepared surface, on a heliport, airport, landing or takeoff area, apron or ramp, or movement area used for takeoff, landing or parking of helicopters.

(e) "Heliport" means an area of land, water or structure used or intended to be used for the landing and takeoff of helicopters and includes its buildings and facilities, if any.

(f) "Municipality" means any county, city, or town<u>, or</u> <u>political subdivision</u> of this state. "Municipal" means pertaining to a municipality as herein defined.

7 (g) "Person" means any individual, firm, partnership, 8 corporation, company, association, joint stock association, or body 9 politic; and includes any trustee, receiver, assignee or other 10 similar representative thereof.

(h) "Vertiport" means an area of land, water, or structure used or intended to be used for the landing and takeoff of VTOL aircraft.

13 (i) "VTOL aircraft" means an aircraft which has vertical 14 takeoff and landing capability.

SECTION 2. AMENDATORY 3 O.S. 2021, Section 65.2, is amended to read as follows:

17 Section 65.2 (a) Establishment, Operation, Land Acquisition. 18 Every municipality is authorized, out of any appropriations or other 19 monies made available for such purpose, to plan, establish, develop, 20 construct, enlarge, improve, maintain, equip, operate, regulate, 21 protect and police airports, vertiports, and air navigation 22 facilities, either within or without the territorial limits of such 23 municipality and within or without the territorial boundaries of 24 this state, including the construction, installation, equipment, _ _

1 maintenance and operation at such airports of buildings and other 2 facilities for the servicing of aircraft or for the comfort and 3 accommodation of air travelers, and the purchase and sale of 4 supplies, goods and commodities as an incident to the operation of 5 its airport properties. For such purposes the municipality may use 6 any available property that it may now or hereafter own or control 7 and may, by purchase, gift, devise, lease, eminent domain 8 proceedings or otherwise, acquire property, real or personal, or any 9 interest therein including easements in airport hazards or land 10 outside the boundaries of an airport, vertiport, or airport site as 11 are necessary to permit safe and efficient operation of the airport 12 or vertiport or to permit the removal, elimination, obstruction-13 marking or obstruction-lighting of airport hazards or to prevent the 14 establishment of airport hazards.

(b) Acquisition of Existing Airports. Any municipality may by purchase, gift, devise or lease acquire existing airports, <u>vertiports</u>, and air navigation facilities, provided however it shall not acquire or take over any airport or air navigation facility without the consent of the owner thereof.

(c) Establishment of Airports on Public Waters and Reclaimed Lands. For the purposes of this act, a municipality may establish or acquire and maintain, within or bordering upon the territorial limits of the municipality, airports in, over and upon, any public waters of this state, any submerged lands under such public waters, and any artificial or reclaimed lands which before the artificial making or reclamation thereof constituted a portion of the submerged lands under such public waters; and may construct and maintain terminal building, landing floats, causeways, roadways and bridges for approaches to or connecting with any such airport, and landing floats and breakwaters for the protection thereof.

7 (d) Limitation on Design and Operation of Air Navigation
 8 Facilities. All air navigation facilities established or operated
 9 by municipalities shall be supplementary to and coordinated in
 10 design and operation with those established and operated by the
 11 federal and state governments.

SECTION 3. AMENDATORY 3 O.S. 2021, Section 65.4, is amended to read as follows:

14 Section 65.4 Except as may be limited by the terms and 15 conditions of any grant, loan, or agreement pursuant to Section 13 16 of this act, every municipality may by sale, lease or otherwise, 17 dispose of any airport, vertiport, air navigation facility or other 18 property, or portion thereof or interest therein, acquired pursuant 19 to this act. Such disposal by sale, lease, or otherwise, shall be 20 in accordance with the laws of this state, or provisions of the 21 charter of the municipality, governing the disposition of other 22 property of the municipality, except that in the case of the 23 disposal of another municipality or agency of the state or federal 24 government for aeronautical purposes incident thereto, the sale, _ _

¹ lease, or other disposal may be effected in such manner and upon ² such terms as the governing body of the municipality may deem in the ³ best interest of the municipality.

⁴ SECTION 4. AMENDATORY 3 O.S. 2021, Section 65.5, is ⁵ amended to read as follows:

6 Section 65.5 A. Under Municipal Operation. In operating an 7 airport, vertiport, air navigation facility or aircraft maintenance 8 or manufacturing facility owned, leased or controlled by a 9 municipality, such municipality may, except as may be limited by the 10 terms and conditions of any grant, loan, or agreement pursuant to 11 Section 65.13 of this title, enter into contracts, leases and other 12 arrangements for a primary term not exceeding fifty (50) years with 13 any persons:

14 1. Granting the privilege of using or improving such airport, 15 <u>vertiport</u>, air navigation facility or aircraft maintenance or 16 manufacturing facility or any portion or facility thereof, or space 17 therein for commercial purposes;

18 2. Conferring the privilege of supplying goods, commodities, 19 things, services or facilities at such airport, <u>vertiport</u>, air 20 navigation facility or aircraft maintenance or manufacturing 21 facility; or

3. Making available services to be furnished by the municipality or its agents at such airport, <u>vertiport</u>, air navigation facility or aircraft maintenance or manufacturing ¹ facility. In each case the municipality may establish the terms and ² conditions and fix the charges, rentals or fees for the privileges ³ or services, which shall be reasonable and uniform for the same ⁴ class of privilege or service and shall be established with due ⁵ regard to the property and improvements used and the expenses of ⁶ operation to the municipality.

7 B. Under Other Operation. Except as may be limited by the 8 terms and conditions of any grant, loan, or agreement pursuant to 9 Section 65.13 of this title, a municipality may by contract, lease 10 or other arrangement, upon a consideration fixed by it, grant to any 11 qualified person for a term not to exceed five (5) years the 12 privilege of operating, as agent of the municipality or otherwise, 13 any airport or vertiport owned or controlled by the municipality; 14 provided, that no such person shall be granted any authority to 15 operate such airport or vertiport other than as a public airport 16 facility or to enter into any contracts, leases, or other 17 arrangements in connection with the operation of the airport or 18 vertiport which the municipality might not have undertaken under 19 subsection A of this section.

SECTION 5. AMENDATORY 3 O.S. 2021, Section 65.6, is amended to read as follows:

22 Section 65.6 To enforce the payment of any charges for repairs 23 or improvements to or storage or care of, any personal property made 24 or furnished by the municipality or its agents in connection with

¹ the operation of an airport, vertiport, or air navigation facility ² owned or operated by the municipality, the municipality shall have a ³ lien on such property, which shall be enforceable by the ⁴ municipality as provided by law.

5 SECTION 6. AMENDATORY 3 O.S. 2021, Section 65.7, is 6 amended to read as follows:

7 Section 65.7 Any authority vested by this act in a municipality 8 or in the governing body thereof, for the planning, establishment, 9 development, construction, enlargement, improvement, maintenance, 10 equipment, operation, regulation, protection and policing of 11 airports, vertiport, or other air navigation facilities established, 12 owned or controlled, or to be established, owned or controlled by 13 the municipality may be vested by resolution of the governing body 14 of the municipality in an officer or board or other municipal agency 15 whose powers and duties shall be prescribed in the resolution; 16 provided, however, that the expense of such planning, establishment, 17 development, construction, enlargement, improvement, maintenance, 18 equipment, operation, regulation, protection and policing shall be a 19 responsibility of the municipality.

SECTION 7. AMENDATORY 3 O.S. 2021, Section 65.8, is amended to read as follows:

Section 65.8 (a) Scope. A municipality, which has established or acquired or which may hereafter establish or acquire an airport, <u>vertiport</u>, or air navigation facility, is authorized to adopt, amend

1 and repeal such reasonable ordinance, resolutions, rules, 2 regulations and orders as it shall deem necessary for the 3 management, government and use of such airport, vertiport, or air 4 navigation facility under its control, whether situated within or 5 without the territorial limits of the municipality. For the 6 enforcement thereof, the municipality, may, by ordinance or 7 resolution, as may by law be appropriate, appoint airport guards or 8 police, with full police powers, and fix penalties, within the 9 limits prescribed by law, for the violation of the aforesaid 10 ordinances, resolutions, rules, regulations and orders. Enforcement 11 may also be conducted by airport officers holding a commission from 12 and employed by an airport trust as defined in, and pursuant to and 13 in accordance with, the provisions and requirements of the Oklahoma 14 Campus Security Act, and who, as a result of which, hold full police 15 powers. Said penalties shall be enforced in the same manner in 16 which penalties prescribed by other ordinances, or resolutions of 17 the municipality are enforced. To the extent that an airport, 18 vertiport, or other air navigation facility controlled and operated 19 by a municipality is located outside the territorial limits of the 20 municipality, it shall, subject to federal and state laws, rules and 21 regulations, be under the jurisdiction and control of the 22 municipality controlling or operating it, and no other municipality 23 shall have any authority to charge or exact a license fee or 24 occupation tax for operations thereon. _ _

(b) Conformity to Federal and State Law. All ordinances, resolutions, rules, regulations or orders which are issued by the municipality shall be kept in substantial conformity with the laws of this state or any regulations promulgated or standards established pursuant thereto, and, as nearly as may be, with the federal laws governing <u>aerospace and</u> aeronautics and the rules, regulations and standards duly issued thereunder.

8 SECTION 8. AMENDATORY 3 O.S. 2021, Section 65.10, is 9 amended to read as follows:

10 Section 65.10 The cost of planning and acquiring, establishing, 11 developing, constructing, enlarging, improving, or equipping, an 12 airport, vertiport, or air navigation facility, or the site 13 therefor, including buildings and other facilities incidental to the 14 operation thereof, and the acquisition or elimination of airport 15 hazards, may be paid for wholly or partly from the proceeds of the 16 sale of bonds or notes of the municipality, as the governing body of 17 the municipality shall determine. For such purposes a municipality 18 may issue general or special obligation bonds, revenue bonds or 19 other forms of bonds or notes, secured or unsecured, including 20 refunding bonds, in the manner and within the limitations prescribed 21 by the laws of this state or the charter of the municipality for the 22 authorization and issuance of bonds or notes thereof for public 23 purposes generally. Any bonds or notes issued by a municipality 24 pursuant to this act which are payable, as to principal and _ _

1 interest, solely from the revenues of an airport, vertiport, or air 2 navigation facility (and such bonds or notes shall so state on their 3 face) shall not constitute a debt of such municipality within the 4 meaning of any constitutional or statutory debt limitation or 5 restriction. In any suit, action or proceeding involving the 6 security, or the validity or enforceability, of any bond or note 7 issued by a municipality, which bond or note states on its face that 8 it was issued pursuant to the provisions of this act and for a 9 purpose or purposes authorized to be accomplished by this act, such 10 bond or note shall be conclusively deemed to have been issued 11 pursuant to this act for such purpose or purposes.

SECTION 9. AMENDATORY 3 O.S. 2021, Section 65.12, is amended to read as follows:

14 Section 65.12 The revenues obtained by a municipality from the 15 ownership, control or operation of any airport, vertiport, or air 16 navigation facility, including proceeds from the sale of any 17 airport, vertiport, or portion thereof of an air navigation facility 18 property, shall be deposited in a special fund to be designated the 19 "Airport Fund", which revenues shall be appropriated solely to, and 20 used by the municipality for, the purposes authorized by this act. 21 SECTION 10. AMENDATORY 3 O.S. 2021, Section 65.15, is 22 amended to read as follows:

Section 65.15 (a) Authorization. For the purposes of this section, unless otherwise qualified, the term "public agency"

1 includes municipality, as defined in this act, an agency of the 2 state government and of the United States, and any municipality, 3 political subdivision and agency of another state, but shall not 4 include institutions of higher education constituting the Oklahoma 5 State System of Higher Education under Section 1, Article 13A, 6 Constitution of the State of Oklahoma; or other institutions 7 coordinated with the State System of Higher Education under Section 8 4, Article 13A, Constitution of the State of Oklahoma; and the term 9 "governing body" means the governing body of a county or 10 municipality, and the head of the agency if the public agency is 11 other than a county or municipality. All powers, privileges and 12 authority granted to any municipality by this act may be exercised 13 and enjoyed jointly with any public agency of this state, and 14 jointly with any public agency of any other state or of the United 15 States to the extent that the laws of such other state or of the 16 United States permit such joint exercise or enjoyment. If not 17 otherwise authorized by law, any agency of the state government when 18 acting jointly with any municipality, may exercise and enjoy all of 19 the powers, privileges and authority conferred by this act upon a 20 municipality.

(b) Agreement. Any two or more public agencies may enter into agreements with each other for joint action pursuant to the provisions of this section. Concurrent action by ordinance, resolution or otherwise or the governing bodies of the participating

1 public agencies shall constitute joint action. Each such agreement 2 shall specify its duration, the proportionate interest which each 3 public agency shall have in the property, facilities and privileges 4 involved, the proportion to be borne by each public agency of 5 preliminary costs and costs of acquisition, establishment, 6 construction, enlargement, improvement, and equipment of the 7 airport, vertiport, or air navigation facility, the proportion of 8 the expenses of maintenance, operation, regulation and protection 9 thereof to be borne by each, and such other terms as are required by 10 the provisions of this section. The agreement may also provide for; 11 amendments thereof, and conditions and methods of termination of the 12 agreement; the disposal of all or any of the property, facilities 13 and privileges jointly owned upon said property, facilities and 14 privileges, or any part thereof, ceasing to be used for the purposes 15 provided by this act, or upon termination of the agreement; the 16 distribution of the proceeds received upon any such disposal, and of 17 any funds or other property jointly owned and undisposed of; the 18 assumption or payment of any indebtedness arising from the joint 19 venture which remains unpaid upon the disposal of all assets or upon 20 a termination of the agreement; and such other provisions as may be 21 necessary or convenient.

(c) Joint Board. Public agencies acting jointly pursuant to this section shall create a joint board which shall consist of members appointed by the governing board of each participating

1 public agency. The number to be appointed, their term and 2 compensation, if any, shall be provided for in the joint agreement. 3 Each such joint board shall organize, select officers for terms to 4 be fixed by the agreement, and adopt and amend from time to time 5 rules for its own procedure. The joint board shall have power to 6 plan, acquire, establish, develop, construct, enlarge, improve, 7 maintain, equip, operate, regulate, protect, and police any airport, 8 vertiport, or air navigation facility or airport hazard to be 9 jointly acquired, controlled and operated, and such board may 10 exercise on behalf of its constituent public agencies all the powers 11 of each with respect to such airport, vertiport, air navigation 12 facility or airport hazard, subject to the limitations of subsection 13 (d) of this section.

(d) Limitations on Joint Board. (1) Expenditures. The total expenditures to be made by the joint board for any purpose in any fiscal year shall be determined by a budget approved by the governing bodies of its constituent public agencies.

18 (2) Acquisitions Beyond Sums Allotted. No airport, <u>vertiport</u>, 19 air navigation facility, airport hazard, or real or personal 20 property, the cost of which is in excess of sums therefor fixed by 21 the joint agreement or allotted in the annual budget, may be 22 acquired by the joint board without the approval of the governing 23 bodies of its constituent public agencies.

24

1 Eminent Domain. Eminent domain proceedings under this (3) 2 section may be instituted only by authority of the governing bodies 3 of the constituent public agencies of the joint board. If so 4 authorized, such proceedings shall be instituted in the names of the 5 constituent public agencies jointly, and the property so acquired 6 shall be held by said public agencies as tenants in common until 7 conveyed by them to the joint board.

8 (4) Disposal of Real Property. The joint board shall not
9 dispose of any airport, <u>vertiport</u>, air navigation facility or real
10 property under its jurisdiction except with the consent of the
11 governing bodies of its constituent public agencies, provided that
12 the joint board may, without such consent, enter into contracts,
13 leases, or other arrangements contemplated by Section 5 of this act.

14 (5) Police Regulations. Any resolutions, rules, regulations or 15 orders of the joint board dealing with subjects authorized by 16 Section 8 of this act shall become effective only upon approval of 17 the governing bodies of the constituent public agencies provided 18 that upon such approval, the resolutions, rules, regulations or 19 orders of the joint board shall have the same force and effect in 20 the territories or jurisdictions involved as the ordinances, 21 resolutions, rules, regulations, or orders of each public agency 22 would have in its own territory or jurisdiction.

(e) Joint Fund. For the purpose of providing a joint board with moneys for the necessary expenditures in carrying out the

1 provisions of this section, a joint fund shall be created and 2 maintained, into which shall be deposited the share of each of the 3 constituent public agencies as provided by the joint agreement. 4 Each of the constituent public agencies shall provide its share of 5 the fund from sources available to each. Any federal, state or 6 other contributions or loans, and the revenues obtained from the 7 joint ownership, control and operation of any airport or air 8 navigation facility under the jurisdiction of the joint board shall 9 be paid into the joint fund, which said joint fund shall be kept and 10 maintained at such place or places as shall be mutually agreed 11 between the constituent agencies. Disbursements from such fund 12 shall be made by order of the board, subject to the limitations 13 prescribed in subsection (d) of this section.

SECTION 11. AMENDATORY 3 O.S. 2021, Section 65.16, is amended to read as follows:

16 Section 65.16 The acquisition of any land or interest therein 17 pursuant to this act, the planning, acquisition, establishment, 18 development, construction, improvement, maintenance, equipment, 19 operation, regulation, protection and policing of airports, 20 vertiports, and air navigation facilities, including the acquisition 21 or elimination of airport hazards, and the exercise of any other 22 powers herein granted to municipalities and other public agencies, 23 to be severally or jointly exercised, are hereby declared to be 24 public and governmental functions, exercised for a public purpose, _ _

1 and matters of public necessity; and in the case of any county, are 2 declared to be county functions and purposes as well as public and 3 governmental; and in the case of any municipality other than a 4 county, are declared to be municipal functions and purposes as well 5 as public and governmental. All land and other property and 6 privileges acquired and used by or on behalf of any municipality or 7 other public agency in the manner and for the purposes enumerated in 8 this act shall and are hereby declared to be acquired and used for 9 public and governmental purposes and as a matter of public 10 necessity, and, in the case of a county or municipality, for county 11 or municipal purposes, respectively.

SECTION 12. AMENDATORY 3 O.S. 2021, Section 65.17, is amended to read as follows:

14 Section 65.17 Any property in this state acquired by a 15 municipality for airport, vertiport, or air navigation purposes 16 pursuant to the provisions of this act, and any income derived by 17 such municipality from the ownership, operation or control thereof, 18 shall be exempt from taxation to the same extent as other property 19 used for public purposes. Any municipality is authorized to exempt 20 from municipal taxation any property, acquired within its boundaries 21 by a public agency of another state, for airport, vertiport, or air 22 navigation purposes, and any income derived from such property, to 23 the extent that such other state authorizes similar exemptions from 24 taxation to municipalities of this state. _ _

SECTION 13. AMENDATORY 3 O.S. 2021, Section 82, as amended by Section 2, Chapter 126, O.S.L. 2023 (3 O.S. Supp. 2023, Section 82), is amended to read as follows:

Section 82. As used in the Oklahoma Department of Aerospace and
 Aeronautics Act, unless the context otherwise requires:

6 1. "Aeronautics" means the science, art and practice of flight 7 including, but not limited to, transportation by aircraft and 8 matters relating to air commerce; the operation, construction, 9 repair or maintenance of aircraft, aircraft power plants and 10 accessories including the repair, packing and maintenance of 11 parachutes; the design, establishment, construction, extension, 12 operation, improvement, repair or maintenance of airports, 13 restricted landing areas or other air navigation facilities; and 14 instruction in flying or ground subjects pertaining thereto;

¹⁵ 2. "Aeronautical hazard" means any structure, object of natural ¹⁶ growth or use of land, which obstructs the airspace required for the ¹⁷ flight of aircraft in landing or taking off at an airport that is ¹⁸ otherwise hazardous to the operation and navigation of aircraft;

¹⁹ 3. "Air navigation facility" means any facility used in, ²⁰ available for use in, or designed for use in, aid of air navigation ²¹ including landing areas, any structures, mechanisms, lights, ²² beacons, markers, communicating systems or other instrumentalities ²³ or devices used or useful as an aid, or constituting an advantage or ²⁴ convenience, to the safe taking off, navigation and landing of

aircraft, or the safe and efficient operation or maintenance of an airport and any combination of any or all of such facilities;

³ 4. "Aircraft" means any contraption now known, or hereafter
⁴ invented, used or designed for navigation of or flight in the air or
⁵ airspace;

6 5. "Airman" means any individual who engages, as the person in 7 command, or as a pilot, mechanic or member of the crew, in the 8 navigation of aircraft while under way, and any individual who is 9 directly in charge of the inspection, maintenance, overhauling or 10 repair of aircraft, aircraft engines, propellers and appliances;

11 6. "Airport" means an area of land or water that is used, or 12 intended to be used, for the landing and takeoff of aircraft, and 13 buildings and facilities, if any;

14 7. "Airspace" means that portion of the atmosphere overlying a 15 designated geographical area considered as subject to territorial 16 jurisdiction or international law in respect to its use by aircraft, 17 guided missiles, and rockets;

18 8. "Commercial service airport" means an airport meeting the 19 current Federal Aviation Administration definition for commercial 20 service airport;

9. "Commission" means the seven members of the Oklahoma
 Aerospace and Aeronautics Commission as appointed by the Governor;
 10. "Department" means the Oklahoma Department of Aerospace and

¹ 11. "Director" means the Director of the Oklahoma Department of ² Aerospace and Aeronautics;

³ 12. "General aviation airport" means an airport not meeting the ⁴ criteria for definition as a commercial service or reliever airport;

⁵ 13. "Helipad" means a small, designated area, usually with a ⁶ prepared surface, on a heliport, airport, landing or takeoff area, ⁷ apron or ramp, or movement area used for takeoff, landing or parking ⁸ of helicopters;

9 14. "Heliport" means an area of land, water or structure used 10 or intended to be used for the landing and takeoff of helicopters 11 and includes its buildings and facilities, if any;

D. The Department may establish air markers throughout the state.

E. The Department may purchase and install roadside signs directing highway traffic to airports, subject to approval of the State Transportation Commission.

F. The Department shall:

19 1. Draft and recommend necessary legislation to advance the 20 interests of the state in aerospace and aeronautics;

21 2. Represent the state in aeronautical matters before federal 22 agencies and other state agencies; and

3. Participate as party plaintiff or defendant or as intervener on behalf of the state or any municipality or citizen thereof in any

Hearings shall be 4 open to the public and shall be held upon such call or notice as the 5 Commission shall deem advisable. ¹ Aerospace and Aeronautics Act. The Department shall furnish to the ² agencies of the United States its cooperation, services, records, ³ and facilities, insofar as may be practicable.

3. The Department shall report to the appropriate agency of the
United States all accidents in aeronautics in this state of which it
is informed and shall, insofar as is practicable, preserve, protect,
and prevent the removal of the component parts of any aircraft
involved in an accident being investigated by it until the federal
agency institutes an investigation.

L. The Department may organize and administer an aerospace education program in cooperation with universities, colleges and schools for the general public. The Department may also plan and act jointly in a cooperative aviation research or high technology program. As part of these programs, the Department may issue aviation communication films and publications.

16 Μ. The Department shall administer an airport inspection 17 program for all public-use airports within this state. The 18 inspection program shall occur on a three-year cycle and shall be 19 administered by the Oklahoma Department of Aerospace and 20 Aeronautics. Airport owners, including individuals and 21 municipalities, shall provide access to airport facilities for 22 conducting the inspections. The Department shall provide a written 23 report to each public-use airport detailing the findings of such 24 inspections. _ _

SECTION 15. AMENDATORY 3 O.S. 2021, Section 421, as last amended by Section 15, Chapter 365, O.S.L. 2023 (3 O.S. Supp. 2023, Section 421), is amended to read as follows:

4 Section 421. A. The Oklahoma Department of Aerospace and 5 Aeronautics is hereby established as the clearinghouse for unmanned 6 aircraft systems (UAS) and advanced air mobility (AAM) in this state 7 and shall be designated as the agency of this state for the 8 promotion, enhancement and development of UAS and AAM as well as any 9 associated infrastructure necessary to ensure the safe integration 10 and use of this new technology within the state. In the operation of this clearinghouse, the 17 Department shall cooperate, assist and coordinate with the federal 18 government, agencies of this state, tribal entities, municipalities 19 and other persons in the development of unmanned aircraft systems 20 throughout the state to ensure the acceptance of this technology and 21 the successful integration of UAS into the National Airspace System. 22 Contingent upon the availability of funds, the Oklahoma Department 23 of Aerospace and Aeronautics may use established program processes 24 or may contract with other qualified entities to carry out the _ _

B.
