SECTION 1. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2024, the sum of One Billion Three Hundred Twelve Million Four Hundred Nineteen Thousand One Hundred Fifty-seven Dollars (\$1,312,419,157.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 2. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Education Reform Revolving Fund created by Section 34.89 of Title 62 of the Oklahoma Statutes, the sum of One Billion Thirty-six Million Seven Hundred One Thousand Three Hundred Sixty-six Dollars (\$1,036,701,366.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 3. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Common Education Technology Revolving Fund, the sum of Forty-seven Million Twenty-five Thousand Seven Hundred One Dollars (\$47,025,701.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 4. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2024, the sum of Twenty-seven Million

Seven Hundred Eighty-seven Thousand Five Hundred Dollars

(\$27,787,500.00) or so much thereof as may be necessary for the

financial support of public schools.

SECTION 5. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2022, the sum of Nine Million Two Hundred Eighty-six Thousand Eight Hundred Twenty Dollars (\$9,286,820.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 6. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Mineral Leasing Fund of the State Treasury for the fiscal year ending June 30 2024, the sum of Four Million Seven Hundred Seventy-one Thousand Fifteen Dollars (\$4,771,015.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 7. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2024, the sum of One Hundred Twenty-one Million Thirty-nine Thousand Twenty-six Dollars (\$121,039,026.00) or so much thereof as may be necessary for the support of public school activities.
