10 COMMITTEE SUBSTITUTE

11 An Act relating to the Oklahoma Department of  
12 Agriculture, Food, and Forestry; requiring that  
13 portions of certain funds be utilized for certain  
14 purposes; providing budgeting and expenditure  
15 limitations and procedures; and providing for lapse  
16 of funds under certain conditions.

17 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

18 SECTION 1. From the funds appropriated to the Oklahoma  
19 Department of Agriculture, Food, and Forestry in Enrolled House Bill  
20 No. 1004 of the 1st Extraordinary Session of the 59th Oklahoma  
21 Legislature, the sum of Two Million Dollars (\$2,000,000.00) shall,  
22 under the direction of the Commissioner of Agriculture, be allocated  
23 to wildland fire response resources.  
24

1 SECTION 2. From the funds appropriated to the Oklahoma  
2 Department of Agriculture, Food, and Forestry in Enrolled House Bill  
3 No. 1004 of the 1st Extraordinary Session of the 59th Oklahoma  
4 Legislature, the sum of Ten Thousand Dollars (\$10,000.00) shall,  
5 under the direction of the Commissioner of Agriculture, be allocated  
6 to advancing leadership in agricultural businesses.

7 SECTION 3. From the funds appropriated to the Oklahoma  
8 Department of Agriculture, Food, and Forestry in Enrolled House Bill  
9 No. 1004 of the 1st Extraordinary Session of the 59th Oklahoma  
10 Legislature, the sum of Six Million Nine Hundred Fifty Thousand  
11 Dollars (\$6,950,000.00) shall, under the direction of the  
12 Commissioner of Agriculture, be allocated to rural fire departments  
13 for replacement of equipment and gear burned during fires including  
14 truck chassis.

15 SECTION 4. From the funds appropriated to the Oklahoma  
16 Department of Agriculture, Food, and Forestry in Enrolled House Bill  
17 No. 1004 of the 1st Extraordinary Session of the 59th Oklahoma  
18 Legislature, the sum of One Hundred Thousand Dollars (\$100,000.00)  
19 shall, under the direction of the Commissioner of Agriculture, be  
20 allocated to rural fire coordinators to administer a wet hydrant  
21 program.

22 SECTION 5. From the funds appropriated to the Oklahoma  
23 Department of Agriculture, Food, and Forestry in Enrolled House Bill  
24 No. 1004 of the 1st Extraordinary Session of the 59th Oklahoma

1 Legislature, the sum of Two Million One Hundred Thousand Dollars  
2 (\$2,100,000.00) shall, under the direction of the Commissioner of  
3 Agriculture, be used for providing grants to incorporated  
4 municipalities affected by the extreme weather event that began  
5 February 7, 2021, and ended February 21, 2021, as provided for in  
6 Enrolled Senate Bill No. 1091 of the 2nd Session of the 58th  
7 Oklahoma Legislature.

8 SECTION 6. Appropriations made by this act, not including  
9 appropriations made for capital outlay purposes, may be budgeted for  
10 the fiscal year ending June 30, 2024 (hereafter FY-24) or may be  
11 budgeted for the fiscal year ending June 30, 2025 (hereafter FY-25).  
12 Funds budgeted for FY-24 may be encumbered only through June 30,  
13 2024, and must be expended by November 15, 2024. Any funds  
14 remaining after November 15, 2024, and not budgeted for FY-25, shall  
15 lapse to the credit of the proper fund for the then current fiscal  
16 year. Funds budgeted for FY-25 may be encumbered only through June  
17 30, 2025. Any funds remaining after November 15, 2025, shall lapse  
18 to the credit of the proper fund for the then current fiscal year.  
19 These appropriations may not be budgeted in both fiscal years  
20 simultaneously. Funds budgeted in FY-24, and not required to pay  
21 obligations for that fiscal year, may be budgeted for FY-25, after  
22 the agency to which the funds have been appropriated has prepared  
23 and submitted a budget work program revision removing these funds

1 from the FY-24 budget work program and after such revision has been  
2 approved by the Office of Management and Enterprise Services.
