11 An Act relating to the Oklahoma Department of
12 Commerce; making an appropriation to certain
13 revolving fund under the control of the Oklahoma
14 Department of Commerce; identifying source;
15 establishing amount; requiring and limiting
16 expenditure for certain purposes; providing for
17 noncodification; and declaring an emergency.

18 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

19 SECTION 1. NEW LAW A new section of law not to be
20 codified in the Oklahoma Statutes reads as follows:

21 There is hereby appropriated to the Workforce Coordination
22 Revolving Fund, created in Enrolled House Bill No. 1021 of the 2nd
23 Extraordinary Session of the 58th Oklahoma Legislature, from any
24 monies not otherwise appropriated from the Statewide Recovery Fund
of the State Treasury created in Enrolled House Bill No. 3349 of the

1 2nd Session of the 58th Oklahoma Legislature, the sum of One Million
2 Three Hundred Sixty-eight Thousand Twenty-nine Dollars
3 (\$1,368,029.00) to be administered in accordance with the provisions
4 of Enrolled House Bill No. 1021 of the 2nd Extraordinary Session of
5 the 58th Oklahoma Legislature.

6 SECTION 2. It being immediately necessary for the preservation
7 of the public peace, health or safety, an emergency is hereby
8 declared to exist, by reason whereof this act shall take effect and
9 be in full force from and after its passage and approval.
