11 An Act relating to the Commissioners of the Land
12 Office; making an appropriation; identifying source;
13 establishing amount and purpose; providing for
14 noncodification; and declaring an emergency.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. NEW LAW A new section of law not to be
17 codified in the Oklahoma Statutes reads as follows:

18 There is hereby appropriated to the Commissioners of the Land
19 Office (Fund 702) from any monies not otherwise appropriated from
20 the General Revenue Fund of the State Treasury for the fiscal year
21 ending June 30, 2022, the sum of Five Million Two Hundred Thousand
22 Dollars (\$5,200,000.00) or so much thereof as may be necessary for
23 the agency to settle obligations and litigation related to
24 unanticipated agency costs as a result of severe weather.

1 SECTION 2. It being immediately necessary for the preservation
2 of the public peace, health or safety, an emergency is hereby
3 declared to exist, by reason whereof this act shall take effect and
4 be in full force from and after its passage and approval.
