COMMITTEE SUBSTITUTE

An Act relating to higher education; authorizing
establishment of certain program; requiring program
to meet certain standards; providing for
codification; providing an effective date; and
declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. NEW LAW A new section of law to be codified
in the Oklahoma Statutes as Section 3308.1 of Title 70, unless there
is created a duplication in numbering, reads as follows:

The Board of Regents of the University of Oklahoma is hereby
authorized to establish within the College of Nursing at the
University of Oklahoma a program for the education, training, and
graduation of Certified Registered Nurse Anesthetists. Such program

1 shall meet the standards set forth by the Council on Accreditation
2 of Nurse Anesthesia Educational Programs.

3 SECTION 2. This act shall become effective July 1, 2024.

4 SECTION 3. It being immediately necessary for the preservation
5 of the public peace, health or safety, an emergency is hereby
6 declared to exist, by reason whereof this act shall take effect and
7 be in full force from and after its passage and approval.
