11 An Act relating to childbirth; creating the Choosing
12 Childbirth Revolving Fund; specifying type of fund
13 and source of monies; providing for expenditure of
funds; providing for codification; providing an
effective date; and declaring an emergency.

16 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

17 SECTION 1. NEW LAW A new section of law to be codified
18 in the Oklahoma Statutes as Section 1-740.20 of Title 63, unless
19 there is created a duplication in numbering, reads as follows:

20 There is hereby created in the State Treasury a revolving fund
21 for the State Department of Health to be designated the "Choosing
22 Childbirth Revolving Fund". The fund shall be a continuing fund,
23 not subject to fiscal year limitations, and shall consist of all
24 monies received by the Department from appropriations provided for

1 the purpose of funding services under the Choosing Childbirth Act.
2 All monies accruing to the credit of the fund are hereby
3 appropriated and may be budgeted and expended by the Department for
4 the purpose provided for in this section. Expenditures from the
5 fund shall be made upon warrants issued by the State Treasurer
6 against claims filed as prescribed by law with the Director of the
7 Office of Management and Enterprise Services for approval and
8 payment.

9 SECTION 2. This act shall become effective July 1, 2024.

10 SECTION 3. It being immediately necessary for the preservation
11 of the public peace, health or safety, an emergency is hereby
12 declared to exist, by reason whereof this act shall take effect and
13 be in full force from and after its passage and approval.
