16	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
17	SECTION 1. NEW LAW A new section of law to be codified
18	in the Oklahoma Statutes as Section 1-740.20 of Title 63, unless
19	there is created a duplication in numbering, reads as follows:
20	There is hereby created in the State Treasury a revolving fund
21	for the State Department of Health to be designated the "Choosing
22	Childbirth Revolving Fund". The fund shall be a continuing fund,
23	not subject to fiscal year limitations, and shall consist of all
24	monies received by the Department from appropriations provided for
