12 An Act relating to the Oklahoma State Bureau of  
13 Investigation; establishing the Oklahoma State Bureau  
14 of Investigation Centennial Revolving Fund; providing  
15 purpose; providing for codification; providing an  
16 effective date; and declaring an emergency.

17 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

18 SECTION 1. NEW LAW A new section of law to be codified  
19 in the Oklahoma Statutes as Section 150.19b of Title 74, unless  
20 there is created a duplication in numbering, reads as follows:

21 There is hereby created in the State Treasury a revolving fund  
22 for the Oklahoma State Bureau of Investigation to be designated the  
23 "Oklahoma State Bureau of Investigation Centennial Revolving Fund".  
24 The fund shall be a continuing fund, not subject to fiscal year  
limitations, and shall consist of all monies received by the

1 Oklahoma State Bureau of Investigation from gifts, donations, or any  
2 other source. All monies accruing to the credit of the fund are  
3 hereby appropriated and may be budgeted and expended by the Oklahoma  
4 State Bureau of Investigation for the purpose of celebrating the  
5 centennial of the Oklahoma State Bureau of Investigation.

6 Expenditures from the fund shall be made upon warrants issued by the  
7 State Treasurer against claims filed as prescribed by law with the  
8 Director of the Office of Management and Enterprise Services for  
9 approval and payment.

10 SECTION 2. This act shall become effective July 1, 2023.

11 SECTION 3. It being immediately necessary for the preservation  
12 of the public peace, health or safety, an emergency is hereby  
13 declared to exist, by reason whereof this act shall take effect and  
14 be in full force from and after its passage and approval.
